The Farmers' Institute at Carsonville was not altogether a "howling success." The faculty of the Agricultural College are reported as having done their part.

A delegate convention, for the purpose of placing in nomination, a Republican candidate for Judge of the Twenty-fourth Judicial Circuit of Michigan, will be held at the Court House, in Bad Axe, on Thursday, the 9th day of March, at two o'clock in the afternoon. The counties comprising the Circuit will be entitled to representation in said convention as follows: Huron, 10 delegates; Sanilac, 11; Tuscola, 13.

John W. Hover, a farmer living near Sebawaing, committed suicide early Saturday morning, by hanging himself in his barn. Dissatisfied with his wife for joining the Baptist Church, he forbade her to return home. She stayed with her daughter several days at Akron, when Hover got her back. But he couldn't get over his wife's action and hanged himself. He requested that he be cremated at Detroit. He was about 50 years of age.

For the Michigan crop report for February, issued by the secretary of state, returns were received from 740 correspondents, representing 550 townships. The report shows that the wheat fields of Michigan have been well covered with snow since the first of January. On the 15th ult. the average depth of snow in the state was 13.19 inches, and on Feb. 1, it was 12.55 inches. The total number of bushels of wheat marketed by farmers in January was 1,245,129, and the total number of bushels marketed in the six months, August to December, was 9,354,744 or 493,951 less than marketed in the same months last year.

A serious and painful accident befell Ivy Law, the fourteen-year-old son of David Law, while en route to this place on Wednesday, with a load of hay. When between T. Duma's and Andrew Swieglar's, a sudden gust of wind upset the load and he, with another brother, was thrown very forcibly onto the fence at the side of the road, in such a manner as to break his right leg badly between the knee and ankle. Dr. McLean was immediately summoned and found the bones protruding through the flesh and the wounds bleeding profusely. The fracture has been reduced and it is thought that the boy will, with good care, fully recover the use of his injured limb.

A business man residing in B— had two sons, handsome, manly little fellows, three and five years old. One day, after starting to his place of business, the man was seen to return hurriedly to the house, which he entered and immediately ascended to the chamber where his sons were supposed to be innocently playing. The father entered the room and demanded the cigar which he had seen his five-year-old boy smoking at the window. With a ready falsehood the child sought to cover his act; but upon examining a box full of cigars on a table, left there by himself, not one but several cigars were found to be on fire, having caught from the lighted one thrust recklessly among the others by the detected young smoker.

Fourteen years later friends were called to the bedside of this son. Thin as a skeleton, with yellow skin, deep purple rings under the sunken eyes, lips parched and black, no food had passed his lips for days, no food could ever again reach his stomach which was so drawn and puckered and ridged, that a common washboard resembled it most, so stated the attending physician. But the most terrible trouble was the throat, completely closed to food.

"Oh, mother! mother, I am willing to die, if by my death Charlie can be saved. Tell him to come to me. Oh, Charlie! brother!" catching his brother's hands with a death grip, promise me to quit cigarette smoking; look at me, I can't stop now. I will be dead in a short time, but you can save yourself. Will you promise me, Charlie? Charlie's fingers grew cold, while his whole frame shook with convulsive weeping. "I can't! I can't stop now," was the stifled, agonizing cry of this slave—only sixteen years of age.

A day or two more and Charlie's only brother was dead. The father, home from business, the aged grandfather in his easy chair, and Charlie, sit about in the darkened rooms all through the civilized, waiting days before the interment of the hope of the household—the eldest born. Where did they turn for consolation? To the Lord who gives and takes away? No! no—but the very air was blue and heavy with tobacco smoke. The dead boy was laid away in the church-yard. Did keen sorrow or remorse fill each breast with contrition? If so, it was soon drowned with the fumes of pipe, cigar and cigarette.

What civilized, not to say Christian man, having at heart the welfare of his only remaining son, with the terrible experience of the effects of nicotine poison on the system of one son, would not have tried to save the other? Only a befogged intellect, a heart with the washboard ridges—descriptive of the fallen son's digestive organs—thickened and brutalized, could have presented such an inhuman picture as the above has shown to us.—[Union Signal.]

'Twas Ever Thus.

Another One of the Many Games Played by Swindlers Upon the Un-Suspecting.

Rate Butler, a wealthy young farmer and stock raiser of the neighboring township of Burnside, lately arrived home from Chicago, where he had very exciting experiences with a gang of sharks whose victim he became through an advertisement in a certain Detroit morning paper, several weeks ago, says the North Branch Gazette. A young mare with a record down in the twenties was offered for sale at \$300.00. The extraordinary low price asked was on account of the alleged death of its owner, and a widow wished to realize immediately on the animal. Mr. Butler went to Chicago and purchased the mare. Upon arriving home, however, he soon discovered that he had been badly swindled. The animal was no more than an ordinary roadster and not worth more than half the price paid. Then he quietly made another visit to the Windy City; this time to get even. In spite of discouraging advice from a city lawyer of whom he sought counsel, he constituted himself a detective and by ingenious stratagem, as ingeniously enforced, within a few hours had his man landed in jail. He demanded \$200 as the price of settlement, which was paid after considerable equivocating, by a pal of the prisoner. The Michigan farmer at once became quite a hero among the officers whose services he secured to make the arrest. A Sad Accident.

A sad accident occurred at Vassar on Thursday evening. As the train from Port Huron, on the F. & P. M. Ry., due at Vassar at 8:49, reached the Michigan Central crossing, the brakeman called "Vassar." All trains are obliged to stop within four hundred feet of the crossing and as it came to a stand still, a young lady passenger, Miss Cora Jacobs, of Watrousville, started to leave the rear coach. She had scarcely left her seat before the train started again, and thinking she was going to be carried by Vassar, she hastened to the forward end of the car and jumped off.

The train at the time was almost upon the crossing, and in jumping the unfortunate girl struck the cattle guard, fell partly under the moving train. The train proceeded to the depot, where the trainmen were notified, and at once proceeded to the scene of the accident. It was soon learned that the lady was badly injured, the car having crushed her left leg in a shocking manner. She was at once conveyed to the Hotel Columbia, and Drs. Morris & Rogers summoned. It was found necessary to amputate the leg just below the knee. Miss Jacobs was also badly injured about the back, and although she survived the operation, it is yet doubtful if she will recover. The young lady had been on a visit with friends in Canada, and was returning to her home in Watrousville, when the sad accident occurred.—[Caro Democrat.]

The Millionaire Shot in the Back by a Crank.

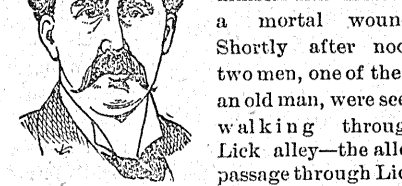
WHO THEN ESSAYS SELF-MURDER.

Probability That the Bonanza King Will Recover From His Wound.

But the Death of His Assailant Only a Matter of Hours—Desperation at Losing His Property at Stock Gambling the Cause of the Would-Be Assassin's Deed—Exasperated That Mackey Could Buy His Wife a \$150,000 Jewel, the Lunatic Seeks Revenge for His Own Losses in the Same Business That Made His Victim Rich.

SAN FRANCISCO, Feb. 25.—The life of John W. Mackey was attempted yesterday by W. C. Rippey, an old man who was undoubtedly insane, and who, after attempting Mr. Mackey's assassination, turned the weapon upon himself and inflicted a mortal wound.

Shortly after noon two men, one of them an old man, were seen walking through Lick alley—the alley passage through Lick House from Sutter to Post street. Persons who noticed the two men paid no attention to them until suddenly two shots in rapid succession were fired, and the man who had fired them—the older—was seen to fall near the end of the alley. The other, who seemed to be wounded, was at once helped into a buggy and driven rapidly away, while the old man lay bleeding in a unconscious on the street.

Identification of the Shooter. An immense crowd of men assembled and the police soon arrived. A patrol wagon was called and the wounded man was hurried to the receiving hospital. There the doctor found that the suicidal Lick had passed through the heart and had passed through the back, from under the skin of which it was extracted. At the time of the operation the man was unconscious and pulseless. The wound was pronounced fatal. There was little on the dining man's person to indicate who he was. He had in his pocket a letter addressed to a morning paper in which the writer stated that he was 73 years of age, signed "W. C. Rippey," and there was also upon him an envelope bearing the name, Dr. L. L. Lincoln. On the back of the letter were the words, "The end is not yet." Upon a sheet of paper under the heading "Food for Reflection," were the words: "Forty-one hundred and fifty thousand dollars for me to apply to place on the forehead of his wife—a sufficient amount to have saved at least five hundred of his victims from suicidal graves. Just think of it! To create it upon his tomb."

Lost His Money in Stock Gambling. Shortly before 3 o'clock Dr. August A. Dressel called at the receiving hospital and fully identified the dying man as W. C. Rippey. He said he knew Rippey very well. He used to come to his place every day and read papers before he went down town. He did not come in this morning as usual and he seemed very much distressed over something as he passed about 9 o'clock. He was born in Cincinnati, O., and leaves a wife and family there. At one time he was worth over \$100,000 and made about \$50,000 on the Comstock. He came to San Francisco and began gambling in stocks. His money soon began to go and then he opened a cash grocery store. That venture failed and about four years ago he was running a bar and dining room on the steamer which plies between San Francisco and Stockton.

Knew All the Old-Timers. "At one time he lived in Denver and owned quite a lot of property, but it also went in his stock speculations. Lately the old man was almost without means and was in a very despondent frame of mind. He knew all the old-timers in California. When no one else could identify a man old man Rippey was called upon and he generally succeeded. About six months ago he identified a man named Waldron and two weeks ago identified a man named Maloney who jumped off the wharf. Maloney was an old friend of Rippey and, like him, had lost every cent he ever had in stocks. Maloney and Rippey were rich men in the old days and both committed suicide from the same cause."

THE WOUNDED MILLIONAIRE.

Not Fatally Shot—His Statement of the Attempted Assassination.

The news spread rapidly, and Mr. Mackey had hardly reached his room before it was besieged with friends anxious to know whether his wound was serious. As he had not yet been examined by a surgeon it was thought advisable to receive no one. Assurance was, however, sent out to his friends that he did not consider his wound serious, and that he was not confined to his bed. Mr. Mackey's statement of the affair is as follows: "I was walking down Sutter street, bound for my room to pack my valise, as I intended to go to Virginia City this afternoon. When I reached Lick alley I thought it would be a short cut to the hotel. I had hardly taken two steps into the alley when I heard a pistol shot. I paused for a moment, rather startled, for I had not seen any one in the alley when I entered it, and did not at first know from which direction the report of the pistol

came. Suddenly a voice exclaimed: 'Mr. Mackey, you have been shot,' and looking up I saw the gentleman who brought me to my room—Mr. Bonner—on the other side of the alley.

Bonner Saw the Dust Fly.

"No, I am not," I replied. "Yes you are," he insisted, "for I saw dust fly from your coat when the bullet struck you." I put my hand around under my coat and sure enough, when I looked at my hand it was covered with blood. I then felt pain in my back. It all happened in a second, and turning half way around I saw my assailant standing at the head of the alley with his pistol pointed at me. I then hurried across to the east of the alley, and as I did so I saw the old man put the pistol, as I thought, to his mouth and fire it again. He then reeled and fell, and I continued up the alley until we reached Mr. Bonner's cart and he drove me to the Palace."

When Mr. Mackey was asked if he knew the man who had shot him he said: "I never knew of a man named Rippey. I had a good look at the old man who shot me, and I am certain I do not know him. I cannot give any reason for the assault."

Doctors Dig Out the Bullet.

When Mr. Mackey reached his room at the hotel he removed his garments without assistance and waited for a physician. Dr. Keeney and Dr. John F. Morse arrived about the same time. After a brief examination they stated that the wound was not fatal. The bullet entered under the right shoulder-blade, and glanced toward the right. It was suggested that the physicians should delay probing for the bullet until Mr. Mackey became more composed, but the wounded man insisted that the operation should be proceeded with immediately. Soon after 2 o'clock the physicians extracted the bullet. Dr. Morse said that the bullet entered below the right shoulder-blade and ranging slightly to the right struck the vertebrae, brooding below in one of the spinous processes.

The Wound Somewhat Dangerous.

Dr. Morse said that the wound was not necessarily fatal, but that his patient was that in cases of gunshot wounds there was always fear of blood poisoning or lockjaw. When closely questioned Dr. Morse said that it was too soon after extraction of the bullet to foretell the termination of the wound, but that Mr. Mackey was resting quietly. Richard V. Dey telegraphed to Mrs. Mackey in London and young Mackey in New York that Mr. Mackey had been shot, but that the wound was not considered dangerous. After extraction of the bullet he wired giving the above statement of the patient's condition.

At a late hour last night Mr. Mackey's condition was unchanged, and his physicians think he will recover. Rippey was still alive, but unconscious. His death was only a question of a few hours.

I want to go where the flowers blow
On the mountains high and hoary;

Where the shores are shoal and sandy;
I want to walk where the flowers talk
On the banks of the Rio Grande.

In the lap of the hills unhidden.
I love the larks where the honey bees
Are making sweets from the clover,
And when I walk where the flowers talk
I just feel good all over.

"The author offers no apology for the publication of these rhymes. They were inspired largely by nature and nature's God. If you have a kick coming, kick higher."

Francis Bret Harte ceased some years ago to be an American poet, and since 1880 could hardly be called an American writer, even in prose. Indeed for the last few years of his residence in New York he was lecturer and collaborator rather than writer. In 1878 he was appointed United States consul to Crefeld, Germany, whence he was transferred in 1880 to Glasgow, remaining consul there till a new administration came in.

He was born Aug. 25, 1834, in Albany, and in 1854 went to California with his widowed mother. Life was pretty hard

with him for the next seven years, and as teacher, miner, compositor and editor he gained much more experience than money.

Little by little, however, some clever local sketches he had written for the papers on which he worked as compositor gained a reputation on the coast, and in 1864 he was appointed secretary of the United States branch mint, with leisure enough to cultivate his gifts.

On one side of the pyramid are the words "Tropico de Cancer: Zona Torrida." On the other side is an inscription to the effect that the pyramid was created in 1891 under the direction of Don Tomas Milan, the superintendent of the Mexican National railroad. In South America there is near the coast a series of stone pillars extending for some distance, showing the position of the equator.

All passenger train on the Mexican Central pause a minute at this pyramid to enable passengers to look at the spot where they leave one geographical zone and pass into another. As a matter of fact, however, the country where the Tropic of Cancer crosses the railroad is far more temperate in climate than it is northern Mexico and southern Texas. The railroad has been carried up grade until it has reached the elevated plateau of central Mexico, where wheat and other products peculiar to cool, temperate climates are grown, as well as many subtropical products. All who see the Tropic of Cancer pyramid, therefore, may derive from it the interesting information that a temperate or tropical climate does not depend entirely upon distance from the equator, but is largely influenced by elevation above the sea. And the great Mexican plateau, on account of its lofty altitude, is a more temperate region than a larger territory north of it, just as the great plateau of southern Africa, extending far north, carries a comparatively temperate climate far toward the equator.

POPULISTS SUBMIT.

The Kansas Supreme Court Does the Business.

TWO OF THE JUDGES IN AGREEMENT

And the Third Against Jurisdiction—The Dunsmore House Declared Illegal—Differently Over State Treasurer Biddle's Opinions—The Loss of the Legal Fight Gains Into Conference, but It Looks Like a Waterloo for Them—Talk About the Senatorship—Another Candidate Put Up.

TOPEKA, Kan., Feb. 27.—The supreme court Saturday morning, Chief Justice Horton rendering the decision, Justice Johnson concurring, and Justice Allen (Pop) dissenting, sustained the Douglas, or Republican, house as the legal and constitutional house of representatives of the Kansas legislature, and incidentally declared that the Populists had no standing. The opinion of the chief justice was given orally, and occupied an hour and forty minutes to deliver. Justice Allen delivered a dissenting opinion, holding that the supreme court had no jurisdiction in the case, and that as the Populist house had been recognized by the governor and senate it was a de facto organization and its act were good in law.

Will Need an Extra Session.

The decision of the court perhaps puts an end to a condition affairs more unique and exciting than anything which has thrilled Kansas since the border wars. The rival houses, which have been struggling for the mastery, sometimes by force and at last through the judiciary, will now perhaps unite in one body and transact much-needed business. The acts of the Populist house having been declared to be illegal, all the appropriation bills will have to be passed over again. The present session of the legislature expires by limitation March 3, and it is necessary to hold an extra session in order to transact the necessary business.

Populist Members of the House and Senate Held a Meeting Behind Closed Doors Saturday Evening to Consider Future Action in View of the Decision of the Supreme Court.

A committee was appointed to confer with the governor and report to a meeting to be held Monday. Speaker Dunsmore said after the Populist house would be no question about the Populist members becoming a part of the Douglas house provided the Republicans would agree to favor the passage of an appropriation bill to reimburse State Treasurer Biddle for the money paid out to members and in which he says "Recent developments in the authority of the legislative appropriation act which appropriated \$30,000.

Nearly this amount was paid out by the treasurer before he was enjoined. Not one-half the expenses so far incurred were provided for in the bill.

Speaker Douglas is one who opposes the Unionists' arrangement of this kind is made the treasurer or his bondsmen would be left to hold the bag. Some of the Populist members who are getting tired declare that unless the Republicans are willing to make an agreement to treat them fairly they will resign. As soon as the Populist house heard that the court had decided it to be the legal body it extended the time of acting on the resolution in regard to vacating the seats of the Populists until this afternoon.

The Question of the U. S. Senator.

Chambers, Democrat, declared Saturday in the Republican house that he would do nothing to reopen the senatorial matter, as he had received many letters from prominent Democrats in the Seventh district asking him not to be a disturber. A letter was received here Saturday from Senator Chandler, of New Hampshire, in which he says "Recent developments in Kansas cast a doubt upon John Martin's admission to the senate."

SENATORIAL PLANS KNOCKED OUT.

Waggener Withdraws Without Notice—The Late Boom.

The Republicans and anti-fusion Democrats are at sea over the sudden and unexpected withdrawal of B. E. Waggener from the senatorial race. The plans were all laid to elect Waggener today or tomorrow, but since he withdrew without even giving a word of warning or notification they feel very sore and do not conceal it. Democrats and Republicans charge that Martin has made a deal with representatives of the Gould interests to secure Waggener's withdrawal.

Think They Can Elect Rossington.

Last night a boom was started for Colonel Rossington, a stalwart Democrat, for senator. The Republican leaders say they can get four or five Populist votes for him. This, with the solid Republican strength, will elect. They also claim that the supreme court decision knocking out the Populist house also knocks out Martin, and that, if all the other acts of the alleged Populist house are illegal, Martin was not elected. Therefore it will be easy to get several votes from Populists for a straight Democrat on the ground that the other election was illegal.

Telegrams were received here from leading Democrats in Washington and New York saying that Rossington, if given 83 votes, will be seated. The Populists have agreed to respect the supreme court decision, and will march into representative hall this afternoon and take their seats in the Republican house.

Death of Rufus Hatch.

NEW YORK, Feb. 24.—Rufus Hatch, formerly a prominent Wall street man, and president of the Pacific Mail and closely connected with the Panama Railway company, died at his home in Spuyten Duyvil yesterday afternoon. He was a prominent figure on the street for fifteen years. Mr. Hatch has for a long time suffered from a complication of kidney and liver trouble. He was born in Kennebecport, Me., in 1837.

Fire Among the Commission Houses.

Before the flames were subdued that structure and the one adjoining, 193 South Water street, were destroyed. The loss on buildings and contents aggregated \$50,000. 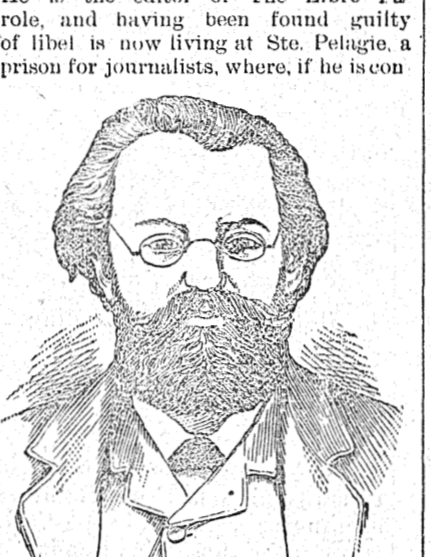

HOSTILE TO THE HEBREWS.

A Frenchman Who Gets in Jail for Expressing His Opinions.

Paris produces various remarkable types of character, and among them must be numbered Edouard Drumont, who looks like a Hebrew and is the most anti-Semitic newspaper man in France. He is the editor of The Libre Parole, and having been found guilty of libel is now living at Ste. Pelagie, a prison for journalists, where, if he is con-

demned to remain within four high walls, he enjoys a certain amount of liberty, the rules of Ste. Pelagie being anything but severe.

He had trouble at college when a lad, and after holding an official appointment for a few months resigned, declaring that he "would rob the state no longer."

Then he went to writing, and as a journalist, dramatic author and maker of books has proved remarkably successful and fairly successful. His notoriety, however, is based on his war against the Jews. He was born in 1844 and is six feet tall, with black hair, black eyes and a thick black beard. He has a high forehead and a large mouth, and he always wears spectacles. When not in prison he resides alone in the Rue de l'Universite. He is a widower and has no children.

In addition to "La France Juive," which ran through 150 editions, Drumont has written many other works. In 1878 he brought out "The National Holidays" in Paris, in 1879, "My Old Paris," which was "crowned" by the French academy. He then wrote a novel, "Le Dernier des Tremolins," which was a tremendous failure. After these publications he came out as a pamphleteer and placed himself at the head of the anti-Semitic movement in France. After "La France Juive" came "La fin du Monde" ("The End of the World"), "La Derniere Bataille" ("The Last Battle"), "Le Testament d'un Antisemite" ("The Will of an Anti-Semite") and a few months ago "Le Secret de Fourmies," which created another sensation.

When called upon to explain the final end that he dreams of in his formidable campaign against the Jews he was wont to reply, "I wish to see formed an immense court of justice, whose duty it shall be to revise all fortunes that have been wrongfully acquired, and which shall decide at the same time what measures are to be adopted to place such persons in a position that they shall be no longer able to continue their plunderings."

NATIONAL LEGISLATURE.

5 copies of the Proceedings in the Senate and House.

WASHINGTON, Feb. 21.—Hansbrough presented to the senate yesterday North Dakota legislative resolutions favoring election of senators by the people, and expressed himself as an advocate of that plan. The sundry civil bill was then taken up and amendments agreed to increasing the amount of the bill. Allison and Gorman both urged care in appropriating money. Wolcott made an attack on the geological survey, but couldn't get the appropriation reduced. Without completing the bill an executive session was held and the senate adjourned.

In the house there was much filibustering and business proceeded slowly. The bill for a bridge between New York and New Jersey was passed and a bill to pay war claims aggregating \$30,000 was defeated. Then under suspension of the rules the naval appropriation bill, carrying over \$21,000,000, was passed, and the agricultural bill was passed in the same manner.

WASHINGTON, Feb. 22.—Lindsay, the successor of Carlisle, took his seat in the senate yesterday. The sundry civil bill was considered until past 10 o'clock last night. The principal discussion was over increases for various purposes, including pensions nearly all of which were agreed to. The bill was not completed at adjournment.

In the house some progress was made on the postoffice bill, but the most of the day was devoted to filibustering against the car coupler bill.

At 3:30 a. m. the house was still in session with no prospect of adjournment.

WASHINGTON, Feb. 23.—The first thing done in the senate yesterday was the reading of Washington's far-well address by Senator Manderson, president pro tem., after which the sundry civil bill was taken up and passed, with all the amendments. The conference report on the fortifications bill was agreed to, and the consular and diplomatic appropriations taken up and considered until executive session, after which the senate adjourned.

The house did not adjourn Tuesday's session until 6:30 yesterday morning, a private agreement having been reached for a vote on the car coupler bill Monday. Yesterday's session began at 11 a. m. with a dozen members present. Hatch antagonized the postoffice bill with the anti-option bill, but was beaten, and the former bill was passed and the Indian bill taken up.

WASHINGTON, Feb. 24.—The senate yesterday passed the diplomatic and consular and the military academy bills in less than an hour, and besides that nearly completed consideration of the legislative, executive, and judicial bill. An amendment was agreed to giving to the minister of the United States at any European court the same title as that of the country's representative in the United States bears.

The feature of the house meeting was the general ovation given to the naval secretary elect when he entered. He tried to slip in unobserved, but couldn't and the members without regard to politics rose and cheered him. Hatch tried again to get up the anti-option bill, but was again beaten and the Indian appropriation bill resumed and considered without final action. The conference report on the army bill was agreed to. The sundry civil bill with senate amendments was referred to the appropriation committee.

WASHINGTON, Feb. 25.—The senate put in yesterday on the legislative appropriation bill. The house clause abolishing the Utah commission was stricken out and a provision inserted appropriating \$44,575 for clerks to senators. The amount for the civil service commission was increased. An amendment requiring cause to be shown before the veteran soldier members of the Capitol police could be removed was withdrawn. Cockrell and Wolcott opposing it. The bill was not completed.

Hatch again antagonized the Indian bill with the anti-option bill, and was again defeated in the house. The bill was held in committee, but not passed. Holman asked for a formal non-concurrence in the senate amendments to the sundry civil bill, except the Sherman bond amendment, but Hatch objected. A night session was attempted to pass private pension bills, but there was no quorum present.

WASHINGTON, Feb. 27.—After four hours of debate the senate Saturday passed the legislative appropriation, insisted on its amendments and asked a conference. The clause providing for "slum" investigation was stricken out. An attempt to proceed to executive business was defeated—26 to 21—and after paying tribute to the memory of Representative Spinola, of New York, the senate adjourned.

There was noise and filibustering in the house. Holman wanted to formal non-concurrence in the senate amendments to the sundry civil bill—except the Sherman bond amendment—without debate. Bland insisted that the agreement to do this carry with it an agreement also to non-concurrence in the Sherman amendment, but there are a number of Democrats who do not think that way and so Holman could not agree. Hatch antagonized the appropriation bills again with the anti-option bill, but was beaten and the sundry civil bill was taken up and the amendments considered. Filibustering then began and Bland made a long financial speech. Later tributes were paid to the memory of Senator John Burroughs, of Virginia, and then the house adjourned.

Michigan Republicans Nominate.
DETROIT, Feb. 23.—The Republican state convention was held yesterday at Harmonic hall and nominations were made for justice of the supreme court and regents of the University of Michigan. For justice Hon. Frank A. Hoover, of Charlevoix, was nominated, and Frank W. Fletcher, of Alpena, and Dr. Hermann Keifer, of Detroit, were the successful candidates for regents.

Money Up for Corbett and Mitchell.
BOSTON, Feb. 27.—Charley Mitchell, the fighter, and his backer, Abington Baird, arrived here yesterday and registered at the Parker house. In the afternoon, after a private consultation with David H. Blanchard, Baird said the money was all up for the Mitchell-Corbett fight, but would give no particulars regarding it.

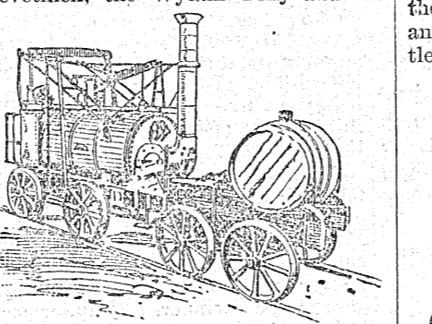
Gresham Visits Cleveland.
LAKEWOOD, N. J., Feb. 25.—Judge Gresham arrived in Lakewood at 5:30 p. m. yesterday, and was driven to the Cleveland cottage. He will be Mr. Cleveland's guest until this afternoon, when he will leave for Chicago. Gresham had an hour's conference yesterday with ex-Secretary John W. Foster, at New York.

Prohibition Nominations.
LANSING, Mich., Feb. 23.—At the Prohibition state convention here yesterday Myron H. Walker, of Grand Rapids, was nominated for justice of the supreme court, Robert C. Sanford, of Plymouth, and J. P. McCullough, of Adrian, were named for regents of the state university.

AN INTERESTING RELIC.

The Wylam Dilly Engine to Be Shown at the World's Fair.

Among the relics of great historic interest to be shown at the Chicago World's fair will be the Wylam Dilly, one of the first three engines to be operated on railways. The station engine house and engine built on the Leicester and Swanton railway in 1832 by Robert Stephenson are still in use, but the first engine to be operated on rails were the Trevethick, the Wylam Dilly and the



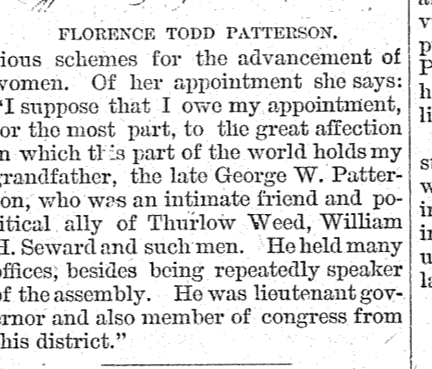
THE WYLAM DILLY ENGINE.

Puffing Billy. On Christmas eve, 1801, the first named drew a car with the first load of passengers ever moved by steam on a railway. The fate of that engine has never been traced.

Seeing the success of Mr. Trevethick, who constructed it, Mr. Hodly, of the Wylam colliery, went to work to improve the method and in 1831 turned out the two locomotives above named. The Puffing Billy, so called from the noise made by its two blast pipes, long since went the way of old iron, but the Wylam Dilly is so far preserved that it needed but a few repairs to make it workable at Chicago. The first locomotive engine used in America was long since turned into scrap iron.

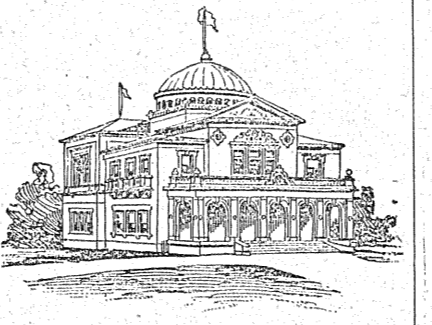
How the World's Fair is Advertised.
No enterprise in the history of the world has ever been so thoroughly advertised as the World's fair. The department of publicity and promotion is responsible for this. Interesting matter is collected and collated by competent writers and put into type in several languages. The progress of the work is recorded every week. The regular supply of news is sent to 15,000 newspapers, 10,000 journals and periodicals and 5,000 class or trade papers. From the mailing rooms of the department of publicity and promotion have gone forth the lithographs and other papers which have become so familiar to the public. For several months there was an average distribution of over 30,000 pictures per month. The average number of electrotypes now supplied to newspapers is over 500 a month. Competent writers are employed, who supply to magazines and newspapers any special articles which they may desire in connection with the World's fair.

A Young Woman Manager.
Of the many talented ladies managing the women's exhibit at the Columbian exposition Miss Florence Todd Patterson, of Westfield, N. Y., is probably the youngest. At any rate she is the youngest of the members constituting the state board of New York. She was graduated from Vassar in 1888, has since traveled abroad and taken much interest in va-

rious schemes for the advancement of women. Of her appointment she says: "I suppose that I owe my appointment, for the most part, to the great affection in which this part of the world holds my grandfather, the late George W. He was lieutenant governor and also member of congress from this district."



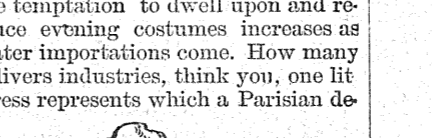
ARKANSAS BUILDING.

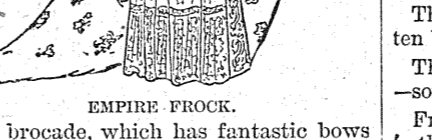
EMPIRE PROCK.
