The law concerning stray animals is not as well known as it should be. If you take up a stray animal you must within ten days give notice to your township clerk, who must make an entry of the same; then you advertise the animal in your local paper, and sixty days after such advertisement has appeared you apply to a justice of the peace to sell the animal. He issues a warrant to the constable, who gives ten days' notice by posters and you get your expenses. The penalty for taking a stray animal and not giving notice is \$5; and besides the owner can come upon your place and take it away without paying you anything.

An effort is being made by Henry Stewart and several others to have Cass City designated as the place for holding of the summer normal. There is no reason why it could not be held very satisfactorily here, as we have a pleasant and commodious school building, and good board can be obtained at moderate rates. Last year Caro raised a small bonus to secure the Normal, and Cass City can do the same if necessary. If our citizens are called upon, we hope they will give what encouragement they can towards securing the normal. Should the normal be held at this place, the instructors and students will be accorded a hearty welcome.

Decoration Day was observed with more than the usual degree of earnestness in Cass City this year. Not only the comrades of the departed "boys in blue," but their wives and sons bedecked the graves with beautiful flowers, and participated in the other ceremonies. The weather clerk evidently desired to retribute for his bad conduct on former occasions, and the day was a beautiful one. The Tennant House Rink, where the indoor exercises were held, was filled to overflowing. At the conclusion of this program, the school children, 136 in number, Milo Warner Post, Sons of Veterans, and numerous citizens, headed by the cornet band, commenced the march to the cemetery, returning about six o'clock.

By doing this a passenger can start from Cass City on the morning train and arrive in Lapeer at 8 p. m., with ample time at Lapeer for dinner, and no expense for sleeping or dining car.

LYNCHED SULLIVAN.

THE MOSSASSIN AND ASSAULT

After Pleading Guilty Sullivan Tries to Succeed by Cutting His Throat, but the 1,200 Enraged Citizens Complete the Job—An Awful Act.

William Sullivan, the famous Durand murderer who was captured at Detroit after a chase of almost five months and who was landed in the county jail at Corunna after a great amount of strategy on the part of Sheriff Jacobs to keep him out of the hands of the mob...

When Sullivan was caught in Detroit it was a serious question how to get him to Corunna safely, but it was done and the baffled mobs, which had gathered at that place and Durand in hopes of getting their hands on him, were beaten for the time.

The proposition to bond Ludington for \$15,000 for improvements was defeated by a majority of 300. Spring Lake is rising from the ruins of the recent fire. The frames for a large number of buildings are up.

Dr. C. J. Olmsted has been appointed city physician of Hudson, with the munificent salary of \$20 a year. Pine lumbering is played out near Meredith. The Wells Stone Co. will remove their big mill to Minnesota.

K. B. Dougherty, of Elk Rapids, has resigned his position as law clerk in the general land office at Washington. Joseph Geone's house and barn were burned with all contents in Chocolay township, near Marquette; loss, about \$2,000.

The 39th sanitary convention under the auspices of the state board of health will be held at Hillsdale, July 6 and 7. The ninth annual reunion of the Raisin Valley seminary students will be held June 1 at W. H. Colyer's near Blissfield.

The strike of the Calumet & Hecla trammers is off, the company winning. Such men as were wanted were taken back. Quite a number of the leaders were discharged. Willie Chaplin and Bertie Ling, two 17-year-old boys went in swimming in the swollen river at Fowlerville and Chaplin was drowned, while Ling was rescued with great difficulty.

Elmer Jones, of Otisville, has become insane. He tried to get some poison to commit suicide, but was unable to do so, so he drank a gallon of kerosene and a quart of bluing. S. V. HIS WEAPONS.

The Duel Between Virchow and Bismarck Which Was Never Fought.

The recent absurd revival of dueling in several countries of the continent of Europe has recalled a story which was the delight of Berlin some years ago, and which capably satirized this barbarous custom. Dr. Virchow, the eminent man of science, had been sharply criticizing Prince Bismarck, who was then chancellor. At the end of a particularly severe attack, Bismarck felt himself personally affronted, and sent seconds to Virchow with a challenge to fight a duel. The man of science was found in his laboratory hard at work at experiments which had for their object the discovery of a means of destroying trichinae, which were making great ravages in Germany. "Ah," a challenge from Prince Bismarck, oh? Well, well, as I am the challenged party, I suppose I have the choice of weapons. He's they are." He held up two large sausages, which seemed to be exactly alike. "One of these sausages," he said, "is filled with trichinae—it is deadly. The other is perfectly wholesome. Externally they can't be told apart. Let his excellency do me the honor to choose whichever of these he wishes, and eat it, and I will eat the other." Though the proposition was as reasonable as any dueling proposition could be, Prince Bismarck's representatives refused it, says the Argonaut. No duel was fought and no one accused Virchow of cowardice.

History of Tobacco.

Tobacco was noted by Columbus on his very first voyage. It was first cultivated by John Rolfe in 1612, and as early as 1619 a lot of 20,000 pounds was shipped to England. In 1732 a tobacco factory was started on the Rappahannock river, and about 1760 the first south of the James river was built in Mecklenburg county. In 1745 the exports from Virginia amounted to 42,341 hogsheds of about 1,000 pounds each, and increased till 1757, after which there was a decline until after the revolution. It is now grown in most of the southern states with Kentucky in the lead.

There are stone bridges in China dating from 1,000 B. C.

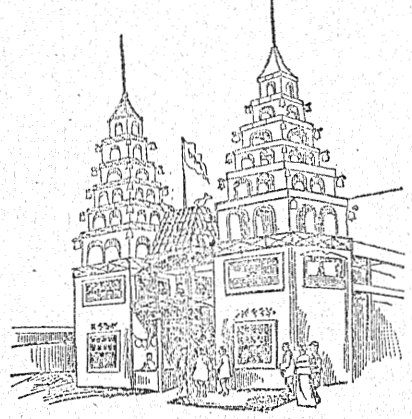
CHINA AT CHICAGO.

QUEER EXHIBITS FROM THE FLOWERY KINGDOM.

The Great Chinese Dragon and the Josses of the Various Chinese Sects—The Oriental Theater and the Long Play—in the Village.

STARTLING COLORS mark a chandelier that was hung in the Chinese theater at Jackson Park the other day. It is not quite so large as the great elect officers in the Manufactures Building, but what it lacks in size it makes up in brilliancy of color.

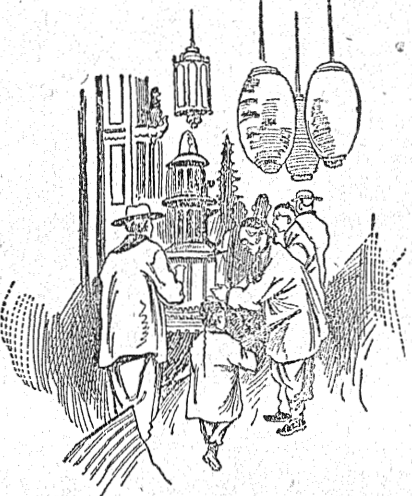
Something of a pagoda shape, four stories high, it stands thirty-five feet in height and six feet square, weighs 1,400 pounds and carries 116 lamps. It is covered with small figures, representing the different stages of Chinese theatrical life. The chandelier was made in Canton and is said to be worth \$3,000. Footlights are taboored by the celestials, and this great chandelier, lighted by electricity, forms the only illumination for the home of the Chinese Theatians. The work of installation in the Chinese building has been completed. The first floor is given up to shops and the restaurants. Back of this is the theater, and an especially good company has been engaged to play a star engagement during the Exposition. The play is an historical one of the "continued in our next" order. The first chapter was

given when the theater opened, and the manager hopes, if his actors do not strike, to be able to finish the play before the Exposition closes by giving two performances a day. On the second floor is a museum of modern Chinese articles. Josses in many shapes stand in a row at the upper end. Some of them are very grotesque, and all have finger nails two inches long. The chief joss sits in the center and is clad in hand-embroidered robes. In front of the deities are five ornamental silver incense urns. These are used in the joss houses and in the private dwellings of the wealthy to perfume the atmosphere. On a very large screen is an etched exhibit of the primitive agricultural implements of China. The plow consists of a couple of bent pieces of wood, and the plowshare is also made of wood, except that the point is tipped with iron very roughly made. Oxen are used to drag the plow and the harness is entirely primitive. It is made of plaited grass and fits over the head of the ox and is connected to the plow by grass rope.

Another peculiar tool is the rice scythe. It is a "V"-shaped stick in one side of which is set a small blade. One of the ends is thrown around the rice the twit gathered in one hand, then the blade is passed through the bunch. This old instrument is very old. Manager King says that it was used to cut rice 400 years before Columbus discovered America. None of the many articles in the big room is for sale but all are shown as home decorations. In the center are two ornate tables for the josses. They are most gaudy and are embroidered with little mirrors set in the pattern. In the middle of the room is the dragon of China. It is thirty-six feet long and mounted on a pedestal. The eyes are large mirrors and the scales are made of burnished brass. When the build-

ing was opened to the public the most expensive joss on the grounds was unveiled. It is the dragon flag, embroidered in silk. It cost \$3,000 and is designed for the Emperor after the exposition closes.

Superstitions of Criminals.

Criminals have a deep-rooted belief in the power of talismans and in the protecting properties of charms and amulets. According to an experienced detective attached to the Criminal Investigation Department, the burglar invariably carries in his pocket a small lump of coal for luck. To this safe-guard he pins his faith, and, with his "bit of change" in his pocket, he appears, he may defy the authorities, however shrewd they may be. Sometimes, when searched at the police office, there are found concealed in the burglar's pocket a piece of chalk, lucky stones and rings and rusty horseshoe nails. Relying on such articles for his safety in the moment of peril, he parts with them most reluctantly, and often stipulates with the turnkey for their return to him on his liberation from prison.

Military Forces of India.

In 1891 the combined forces of British and native troops in India were raised to over 71,000 British and 2,100,000 natives—total of regular army 2,900,000, or 50,000 more than in 1881. But the addition has not been to the regular armies of India alone. The feudatory Princes of India, of their own free will, now maintain a body of imperial contingent troops, at present 14,000 in number, but eventually to be raised to 21,000, beside temporary or irregulars. A new volunteer force of Europeans has also grown up. The Anglo-Indian and Eurasian Volunteers, in 1891, numbered 23,000, including cavalry and infantry, of whom 20,000 were declared efficient. A reserve system has been organized alike for the native army and for the European volunteer corps. In 1891 7,000 time-expired soldiers of the native infantry and 2,150 European volunteers stood on the roll of the reserve.

FIRES IN DWELLINGS.

FEW HOUSES HAVE MEANS OF ESCAPE EXCEPT THE DOORWAYS.

A Trap-door in the Roof Seems to Be the Only Suggestion for a Means of Escape in Case the Stairway of a House in the City is on Fire During the Night.

Two deaths from suffocation in a burning dwelling have again called the attention of all thinking people to the fact that dwelling houses are not provided with any practical means of escape in case of fire occurring in the lower floor during the night. Investigation by a reporter shows that the law is mute on the subject of escapes from dwellings. Neither the laws governing the bureau of building inspectors nor those applying to the bureau of fire touch on the subject. Both bureaus agree in saying that some means of exit other than the stairways should be provided, and both favor the introduction of trapdoors in the roofs as the most feasible and most effective plan. It is stated on good authority that these trapdoors, while one of the best means of escape, cannot be found in more than one house in 200 on the average through the city.

Chief Baxter of the fire department and president of the bureau of fire escapes said: "There were 1,531 fires last year, and 485 of these were in dwellings. Fortunately but few people met their deaths from dwelling house fires during the year. This is not always the case, however, and I have seen quite a large number of fatal results from such fires—the deaths a few years ago as the result of the fire in the King residence at Seventeenth and Pine streets, for instance, and many others not quite so appalling nor of such prominence. In most of these cases the fatality would not have been so great had some means of escape, other than stairways, been provided.

"There certainly should be some new clause in our fire escape laws, and the most important one would be one requiring trapdoors in the roof of every house, or some equally feasible means of exit. The present laws are particularly stringent regarding fire escapes on hotels in the city, but neglect altogether the dwellings. It would seem more proper to take care of the permanent population than transient visitors to the city, from which class the hotels derive their income.

"Of the dwelling house fires which occurred last year," the chief continued, "146 were caused by defective fires. It is fair to presume that the majority of fires from this cause occur at night after the fires have been fixed and the family has retired. In fixing heater fires for the night the general method used is to open wide the fire draft and close the bottom draft. The heat ascends up the chimney then, and any defect in the flue may cause a fire. Before the family are awakened the whole lower room may be in flames, and escape by means of the stairway may be impossible. The family would then probably have to jump from the windows, unless the house had one of the illegal frame kitchens in the rear.

"They could then jump on that and from there to the fence. If trapdoors were provided in the roof, however, they could easily ascend and escape either to an adjoining house or at least escape suffocation by running along the roofs out of danger until the fire department arrived. These trapdoors have been suggested, but it is claimed that they would furnish means for burglars to enter the houses from those adjoining. The popular sentiment, though, would seem to indicate that most people prefer to take chances of being robbed of a few dollars than to take the risk of being burned to death."

Harmon Boorse, a member of both bureau of building inspectors and the bureau of fire escapes, said he had always been in favor of building trapdoors in every house. "The law," he said, "forbids the erection of frame kitchens, but at present these furnish the only means of escape from a dwelling after exit by the stairway has been cut off. Statistics prove that fire very seldom occurs in these outside kitchens. A prominent insurance agent told me only a day or two ago," he continued, "that the majority of dwelling house fires were caused by defective flues in the cellars where the heater flue enters the chimney."

James C. Moore, a prominent builder erecting from 200 to 500 dwellings a year and a member of the Operative Builders' association, denounced in outspoken terms the present system of building without providing a means of escape from the upper floors except by the stairways. He said: "It is an outrage on the community.

"As dwelling houses are built in these days, not one in 200 on the average is provided with a trapdoor or scuttle in the roof. I have always favored this manner of building."—Philadelphia Press.

AT THE BOTTOM OF THE SEA.

No Trace of Wreckage in the Deepest of the Ocean's Depths.

An extraordinary circumstance that has been noticed with interest and that always creates surprise when first learned, is the entire absence of foreign matter in the deeper part of the ocean's floor. Of all the vessels lost in midocean, of all the human beings that have been drowned, of all the marine animals that have perished, of all the clay, sand and gravel let fall by dissolving icebergs, of all the various substances drifted from every shore by shifting currents—not a trace remains; but in their place water from 1,000 to 2,500 fathoms in depth covers the uniform deposit of thick, bluish, tenacious slime, called globigerina ooze.

A bit of this under a powerful lens is a revelation of beauty not readily forgotten, writes J. C. Beard in the Cosmopolitan. The ooze is composed almost entirely of the daintiest, most delicately beautiful shells imaginable. At depths greater than 2,500 fathoms the bottom of the sea consists mainly of products arising from exposure, for almost incalculable periods, to the chemical action of sea water, of pumice and other volcanic matters. This finally results in the formation of the red clay deposits that are considered characteristics of the profoundest depths of the ocean. Carbonate of lime, which, in the form of the shells of foraminifera, makes up so large a part of the globigerina ooze, is here almost entirely absent.

Sea water is very nearly a universal solvent and before any shell, large or small, reaches the bottoms of these tremendous abysses, it is chemically eaten up, literally dissolved—a result which the enormous pressure of the water must materially hasten.

At 1,000 fathoms the weight of the water pressing on all sides of an object immersed to that depth, is nearly one ton to the square inch, or more than one hundred times that sustained at the sea level, and at the greatest depths the pressure is so increased that it seems nothing could withstand it—in fact, heavy metal cylinders let down with the sounding apparatus are sometimes, on being drawn up again to the surface, found bent and collapsed; strongly made glass vessels which the metal encased are shattered into fragments.

PRONUNCIATION OF ST. LOUIS

A Question That May Have to Be Settled by Municipal Authority.

"Of the many momentous local problems that are shaking St. Louis to its very foundation and one, in fact which agitates to a greater or less degree the entire country," said Colonel Pat Dyer to a Washington Star representative, "is the correct pronunciation of the name of my prosperous city. I have just arrived from St. Louis, and when I left there the discussion was heated. Shall it be St. Louis or St. Lewis? A gentleman once said to me that he could distinguish a Western man from an Eastern man by his pronunciation of St. Louis and Iowa, and I guess he's right. Thank heaven the pronunciation of Arkansas is a matter of judicial and legislative settlement. The house of delegates and council, the legislative body of the city, will probably soon be called upon by petition to determine the question as was the legislature of Arkansas. Then there will be fun, I assure you. Nearly everybody out West and most of the people of the city say 'St. Lewis.'"

"Nevertheless, St. Louis, as we all know, is the correct pronunciation; though if we give the French pronunciation to Louis why should we not give it to Saint, which not one man in a thousand, unless he is a French scholar, can twist around his tongue. So it is with the pronunciation of Iowa. The Iowan and the Western man say 'I-oway,' with a long accent on the 'I,' and make 'way' of 'wa.' The Eastern man says 'Iowah,' with the accent on the last syllable."

"We have instead of the customary aldermen or common council or supervisors two legislative city bodies—the house of delegates, similar to the house of representatives, and the council, bearing the same relation to the other as wards and the other at large. We are probably the only city in the United States that has such a dual legislative body, and at first glance it would appear cumbersome and unnecessary for a city. But one acts as a check upon the other, and so long as it pleases us we are content."

INDIA RUBBER CURTAINS. One of the recent industries added to the already numerous manufactures carried on in Chemnitz, Saxony, is the production of curtains made of india rubber as the main ingredient. The material employed for this purpose consists of seventy-five per cent of india rubber, five per cent of wool dust, five per cent of pulverized fruit stones, ten per cent of bleached amber varnish and five per cent of bleached leather waste, to these being also added, if deemed necessary, a quantity of infusorial earth. The various substances thus named are together worked up with bisulphide of carbon in the most perfect manner into a thick mass, and from this are rolled out thin leaves, which are capable of being decorated with the greatest variety of ornamental patterns, and several of these leaves are combined to form a curtain.

CHINESE GARDENS. The Chinese gardeners are the most expert fruit growers in the world. Marco Polo even asserted that they produce pears of the most delicious fragrance and weighing ten pounds each.

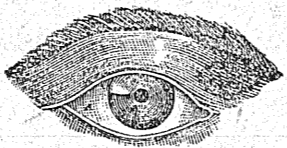

Black Dyphtheria.

Last Friday afternoon, a young man
 apparently twenty-five years of age,
 muffled about the neck with flannels,
 and having a sickly, feeble appearance,
 boarded the east bound S. T. & H.
 passenger train at Reese. His general
 air of debility and languor as he entered
 the coach attracted the attention of
 Conductor Hubert, who asking him if
 he was sick and what ailed him, to
 which the young man replied, "nothing."
 When the conductor took up his
 ticket he noticed that it had the Osceola
 stamp on the back, and the destination
 was Bad Axe. At Tarry, a small flag
 station south of Bay Port, the train was

 missing. Supposing that he had got off

 the switch lock at Bay Port Junction,

 recovered from its effects and shortly
 afterwards left this vicinity, and on
 Friday last he was on his way home
 to die, realizing, undoubtedly, that he
 was afflicted with a fatal disease.

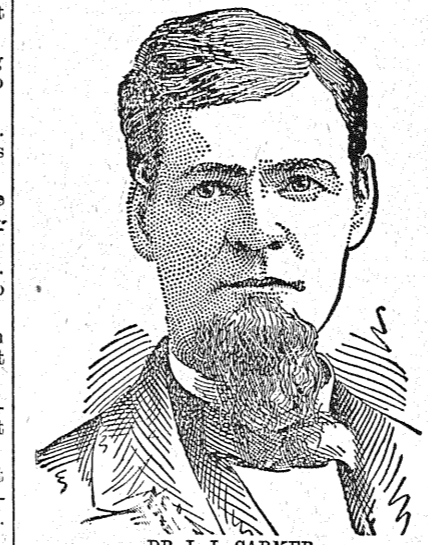

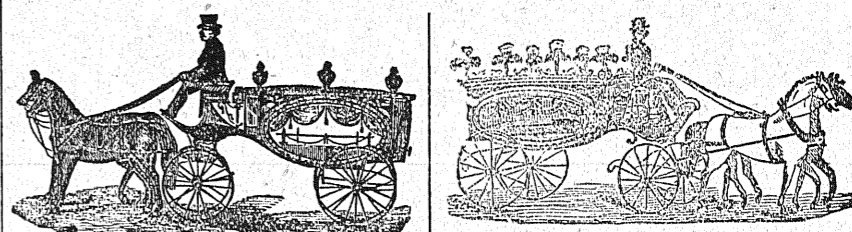
