## **Elkland Township** financially robust

The Elkland Township was assessed to help pay for Board voted to raise the fees the new computer tax sysfor fire department runs at its regular meeting Monday night at the Elkland Township Fire Hall and the budget presented at the annual meeting that followed indicated that the township is in robust financial condition. Chief Dick Root told the that Elkland board Township's fees are the lowest in the Thumb. He cited Kingston, \$450; Caro, \$300, and Mayville, \$500, as typical charges of other departments. The board then voted to boost Elkland's fee from \$150 to \$300 per run.

Many insurance companies will pay up to \$500 per run for service, Root told the board.

According to the budget presented at the annual meeting, the township's revenues in the general fund exceeded expenses by some \$50,000 in 1991. Some of that surplus was because less than budgeted was spent on roads last year because residents on 2 streets who petitioned for work changed their minds.

Part of the surplus will be used this year on road construction. Asphalt will be placed on one mile each of Schwegler and Koepfgen Roads, north of M-81. The

Tuscola County Road Commission will contribute \$22,000 toward the project and it is estimated that Elkland Township's share will be \$20,000. Bids will be taken for the work.



In other business during the 23/4-hour session, the board approved a stricter immunization policy proposed by Faith Fahrner, school nurse. The proposal states all students will comply with the state required immunizations as well as currently recommended immunizations by Dec. 31 of each year or be excluded from classes until the immunizations are obtained.

Fahrner said the currently recommended immunizations, now under review by the state legislature for possible inclusion in the state requirements for school attendance, are DPT (fifth dose), Polio (fourth dose) and measles, mumps and rubella (second dose).

### **REQUIRED BY LAW**

Immunizations already required by law are DPT (4 doses), polio (3 doses), measles (one dose) and a 10year Td booster. Measles, rubella and mumps inoculations must be administered after 15 months of age; if not, a second dose is required. The Td booster must be administered 10 years after the previous DPT shot was given.

Fahrner said she proposed including the recommended immunizations in the school's policy because she believes they will be required by the state in the near future. "I just want to get

## **Cass City** retirees air meet


Sixteen members of the Cass City Retired Persons met Thursday in the Hills and Dales Hospital meeting room.

Taking up running, biking, or any sport to improve your physical health sounds great, but it is not always easy to get started. How do you do it? How much should you do?

First, get the right equipment. Proper equipment will make participation in your sport more enjoyable and help prevent injuries. Advice can be obtained from reputable salesmen or knowledgeable friends already in the sport.

It is often helpful to talk to your physician to get an exercise prescription. After listening to your heart and lungs and evaluating your physical condition, he can tell you where to start and how fast to progress. You may start with jogging a half mile, or just walking briskly. Exercising three to five times a week is enough to improve your fitness and health. It is wise to allow a day of rest for your body to repair and rebuild the muscle cells that have been exercised. After more strenuous exercise, a couple days of rest is important. Once you establish a base to start at, you can normally increase the amount of training by about 10% per week. Increasing faster is apt to cause problems with tendonitis, stress fractures, or other "overuse" injuries. The zeal of getting started and the desire to improve quickly can often cause a negative effect; when a person develops an injury, it is discouraging and decreases the enjoyment of the sport. This causes many people to give up. Slow and steady improvement will make any sport more enjoyable.





