Mural or sign?

Cass City VFW painting back in spotlight

The Cass City Village Council Monday vowed to settle a dispute with members of Cass City VFW Post 3644 over a patriotic mural/ sign painted on the local veterans' annex building.

The controversy erupted in June 2003 when then-village Manager Frank Sheridan and members of the VFW post clashed over the large painting, which featured the Pledge of Allegiance and an eagle wrapped in the American flag.

Sheridan said the images painted on the building amounted to a "wall sign" in the village's sign ordinance, which allows such signs pro-

vided they pertain to the use of the building and meet certain size restrictions.

Sheridan said the post was repeatedly asked to apply for a sign permit, but VFW members refused, saying the painting was a mural, not a sign. VFW members later refused to apply for a zoning variance.

The issue has remained on the back burner, although unresolved since, but village Trustee Don Richards pushed for action during Monday's regular council

meeting. Richards said the council's failure to back up Sheridan's enforcement efforts, and the lack of action on the issue, was setting a poor precedent. He proposed that interim vil-

Beet growers face million-dollar loss

State legislators are vowing to find a way to help soften the blow for sugar beet growers who stand to lose millions of dollars from the loss of thousands of tons of rotting

The setback comes in the wake of the celebration marking the historical merger of Michigan Sugar and Monitor Sugar Co. into a single grower-owner cooperative last fall.

Michigan Sugar Co. officials announced last week that sugar beet growers' December payment of \$24 per ton will be the only payment they will receive for the 2004

The news, delivered by Michigan Sugar Co. president and chief executive officer Mark Flegenheimer in a letter to grower-owners early last week, affects more than 1,200 growers in 21 Michigan counties, including the Thumb, as well as in Ohio and Ontario, Canada.

Ray VanDriessche, director of community relations for the grower-owner cooperative, said a disastrous beet storage season is to blame for what company officials are projecting will be the loss of up to 250,000 tons of beets, translating into an estimated net loss of \$32.8 million.

The difference for growers is the loss of \$9 per ton, money they would have received in regularly scheduled payments next spring and



Gagetown man kills wife, then himself

Tuscola County Sheriff's Department investigators say money problems may have contributed to a murder-suicide involving a married couple in Gagetown over the weekend.

Tuscola County Undersheriff Jim Jashinske identified the victims as Deborah Ann Pinkoski, 51, and Terry Brent Pinkoski, 52.

One of the couple's sons arrived home at about 7:45 a.m. Saturday to discover both of his parents dead in the living room of their home at 6605 Gage St., according to Jashinske, who said an investigation revealed both died of shotgun wounds.

Jashinske said the Pinkoskis both went to the Gagetown Inn Friday afternoon to attend a wedding reception.

"They had a son pick them up and drive them home at 2:30 a.m. Saturday morning," he said. "They had been having money problems and supposedly they were about to lose their house. The father had been arguing with the son, so his mother told him to go and stay with a friend for the rest of the night."

The department's investigation determined that Terry Pinkoski shot his wife while sitting in a chair. He then turned the single shot 20gauge shotgun on himself and pulled the trigger.

Jashinske said the Pinkoskis had no history of domestic violence. "I've known that couple for some time. Debby worked for my wife

at the medical care facility. She was a housekeeper up

there," he added. Jashinske said that an autopsy performed Friday verified the causes of death.

Gagetown police and the Michigan State Police Crime Lab from Bridgeport assisted deputies at the scene. The deaths remain under investi-





I'll be happy when summer comes, he said, and spring is


You don't have to be a mailman to agree with that.

A Lincoln Park woman could face prison time following her conviction last week on 2 charges stemming

Caro man faces time in prison

A Caro man charged with multiple counts of criminal sexual conduct faces a lengthy prison term.

Fredrick G. Heinz, 53, appeared in Tuscola County Circuit Court last week and pleaded no contest to 4 counts of first degree criminal sexual conduct involving a child at least 13 years of age but under 16 years.

Court records state the offenses took place between Jan. 30, 2002, and May 24, 2002, in Caro; and between August 1995 and January 2002 and between August 1994 and June 1995 in Vas-

tigation and remanded Heinz to the custody of the sheriff's department. Sentencing is to

First degree criminal sexual conduct is punishable by up to life in prison or any term of years.

from a traffic crash that claimed the lives of 2 children in the fall of 2003 in Dayton Township.

A jury handed down verdicts of guilty Thursday on charges of negligent homicide and involuntary manslaughter against Dawn M. Booterbaugh, 28, following a 3-day trial in Tuscola County Circuit Court.

A pre-sentence investigation was ordered in the case and bond was continued at \$50,000. A sentencing date has not been scheduled yet. According to troopers from the Michigan State Police post in Caro, who investi-

gated the accident, the crash occurred at about 6:18 p.m. Sept. 4, 2003, on Snover Road near Pattison Road.

Reports stated there were 5 * occupants in a vehicle driven by Booterbaugh, who lost control while cresting a hill at a high rate of speed. The vehicle left the roadway and struck some trees.

Booterbaugh's passengers included Brenda Ambris of Silverwood and her children, Brenna Ambris, one, and Jeffrey Ambris, 3, who both died in the crash. Booterbaugh's daughter, Jenna Pruitt, 4, was also in the vehicle.

A recent skydiving incident reminded me of the old Simon and Garfunkel song, "Still Crazy After All These Years." A news report says a 96-year-old Seattle man suffered a dislocated shoulder

a solo skydive. He wanted to be in the Guinness Book of World Records. The previous record holder was a 92-year-

old man from Ohio. The skydiving company took some extra precautions by putting radio receivers in both of this man's ears so they could communicate with him. That way he would know where the landing area was and how fast the ground was approaching.

I'm reminded of the 90year-old man who made a hole-in-one at a Toronto golf course several years ago. After seventy years of golf this fellow still had the strength

and the ability to hit the ball onto the green and roll it directly into the cup.

Unfortunately, his eyesight wasn't what it used to be, and he couldn't see the ball go in. His playing partner said, while attempting to qualify "Max! It's a hole-in-one. as the oldest person to make You've made a hole-in-one!"

Max's hearing wasn't too good, either; so he couldn't hear his partner cheering. Finally, Max turned up his hearing aid enough to hear what was happening.

Then he said, "A hole-inone? Nah, it couldn't be." The two men walked up to the green, and sure enough, there's the ball — right in the bottom of the cup.

So here we have a 90-yearold man with the physical ability to make a hole-in-one. But his eyes won't let him see it, his ears can't hear the cheering, and his mind won't let him believe it.

Now, I don't want to sound jealous or anything like that; but I've been playing golf since I was 17, and I've never made a hole-in-one.

Deputies identify Millington victim

The Tuscola County Sheriff's Department Friday identified the name of a man who died in a fire at his Millington Township residence early last week.

Undersheriff Jim Jashinske identified the victim as Rex B. Newberry, 53.

Deputies discovered the fire at 6:51 p.m. Monday, Feb. 21, when they arrived at the home to execute a court-ordered mental health pickup order for Newberry. Jashinske explained that Newberry's wife had obtained the order, requiring that her husband undergo a psychiatric evaluation, because she was concerned about his depression.

"Upon arriving deputies observed smoke coming from the rear of the residence," Jashinske said. 'Deputies contacted central dispatch and requested Millington-Arbela Township Fire Department to respond.

"Deputies attempted entry (into the home) from a locked rear door and a locked front door, but were unable to gain entry due to heavy smoke. They were unable to determine if anyone was inside at that time," the undersheriff said.

Fire fighters, who reported all the doors were barricaded from the inside, found Newberry's body in the rear bedroom of the house. They also discovered 4 dead dogs.

"Detectives took the dental records of the owner of the residence to assist in obtaining the identity of the victim," Jashinske said. "Initial reports from (a forensic pathologist) indicate the victim was deceased prior to the fire starting.

Sheriff's deputies were assisted at the scene by the Millington-Arbela and other area fire departments, and Michigan State Police Fire Marshals Sgt. Jerry Carter and Sgt. Geoffrey Boyer. The case remains under in-

vestigation



> "I'm glad I did it. I'm learning how other kids around the world feel when they don't eat for a period of time," Woodruff commented Saturday at the church, where the youth group members and their leaders spent the night Friday.

"I probably haven't ever gone this long without food," added Woodruff, a seventh grade student at Cass City Middle School and the daughter of Julie and Stan Woodruff.

"I hadn't really thought about it, but I thought this would be a good experi-

"It was kind of tough," said Nicole Pasanski, 13, also a seventh grade student at Cass City Middle School and the daughter of Michele and John Pasanski.

"It changed my perspective of other kids who can't eat or have fresh water, (and) how fortunate we are to have food and water," she added. "This is the first year we've

done it. They sent us some information and we thought it would be something fun to do, so we did," said Matt Roemer, who along with his wife, Angie, are youth leaders at the Gagetown Church of the Nazarene.

Interestingly, Roemer pointed out, the church's pastor, the Rev. Don Ault and his wife, Nancy, left Friday for a 2-week work and witness trip in Kenya, Africa. Funds raised from this year's famine event will be used to fight hunger and poverty in Kenya, Sudan, Chad, Southeast Asia and elsewhere. Roemer noted that World Vision's efforts include responding to a major drought in Kenya that has resulted in food shortages for 3.3 million people, including 1.5 million children.

In preparation for the 30hour famine, members of the Gagetown youth group spent a month collecting sponsorship funds from anyone interested in contributing. They also canvassed neighborhoods over the week, collecting returnable pop cans and bottles. The combined efforts raised nearly \$1,000.





night in his short Hawk career with 22 points, 12 of which were scored in the last quarter where Cass City outscored the out-manned Eagles, 22-12.







"The integrity of our ordinances is on the line here," Richards said. "Either we have ordinances that work, or ordinances with no value. I think we need to resolve this issue.'

Trustee Dwight Thabet noted there had been some discussions between the village and the VFW, but those talks fell by the wayside after Sheridan pursued what he felt was another zoning violation on the part of the local VFW post.

Thabet said the village's ordinance doesn't clearly define murals, and that he has witnessed other zoning violations in town that have been ignored. "If we go after this, we'd better start going after every one," he added. "Even if we win this one, we're going to lose."

Richards suggested that the council invite VFW representatives to the next regular meeting to discuss the mat-

"If they're willing to talk, we're willing to listen. If they're willing to talk, I think we owe it to them to listen," he said. "Clearly, we're at a stalemate, and we've got to

"We're developing solutions to address this problem," McIntosh said. "I think there'll be some things in place to help our farmers get through this. For years we've kept our farmers going, and we don't plan on changing that."

VanDriessche said company officials are very aware of the financial hardship the loss poses to its grower-owners, but the cooperative will survive the crisis.

"We'll survive, we'll go forward, but it's going to be a deficit, federal action will be difficult process for everyone to get through. It's goin be a setback," he said.

he noted, subzero temperatures gave way to warmer weather, even some record highs in the 50s, in late December and early January.

Those drastic swings in temperature made beet piles even more susceptible to "hot spots" or pockets of heat that hasten the rotting process, VanDriessche explained. In this case, those pockets reached all the way down into the piles.

The estimated losses are just that - estimates. VanDriessche said Friday. "We won't know for sure until we're done slicing, and we should be done slicing next week. Hopefully, as we go forward, adjustments can be made. (But) we probably won't be too far off from our estimates."

Aside from weather conditions, VanDriessche said, company officials are already looking at any other possible factors that may have contributed to the loss of the beets, as well as ways to prevent the problem from repeating itself.

Michigan legislators, including Senator Jim Barcia. meanwhile, are working to help growers. Barcia last Wednesday called on the state's federal delegation to seek relief for Michigan's sugar beet growers.

In a letter to U.S. Senators Carl Levin and Debbie Stabenow, as well as every member of Michigan's House delegation, Barcia urged Congress to "act swiftly to address this most recent disaster and provide financial relief to affected sugar beet growers."

Barcia pointed out that in 2003, Congress created the Sugar Beet Disaster Program to address a similar crisis in crop production in the years 2001 and 2002. Without similar federal disaster assistance for this year's disaster. he said, individual beet growers stand to lose tens of thousands of dollars in payments for their crop.

"I intend to seek relief from the state of Michigan for sugar beet growers, including possible forbearance on repayments from zero-interest loans that were extended during the last crop disaster," Barcia added. "However, with the state' severe budget required to secure the amount of assistance necessary to provide comprehensive relief."
