1,400 can carry concealed weapons

There are just over 1,400 people that carry guns unseen by the Tuscola County public eye

And these individuals aren't necessarily police officers or authority figures, they're ordinary residents with concealed weapon permits (CCW). Annually, there are between 100 and

50 CCW permits approved in Tuscola County, but the identities of those that carry them remain a mys-

Last year, state lawmakers passed a new law that makes the names of concealed weapon holders private infor-

"Essentially, it's a good thing that it's (names) not public. For anybody who is looking to do violence, they could find out who carries a firearm on a regular basis," said Doug Lautner, Michigan State Police post commander for Bad Axe and Caro and the Tuscola County Gun Board state police representative. He also added that there are personal questions on the applications that should be kept

confidential.

one that had a concealed weapon and there were some very angry people,' he said.

Since law changes in 2001 that enabled the public to carry a concealed weapon, popularity in the permits have leveled off and the gun board is not seeing as many renewals as they initially anticipated.

"There was a large rush of people who applied for permits the first year they were able to do that. We haven't had as many come back for renewal. They went out and got the permit, it wasn't as big of a deal as they thought it was," Lautner explained.

Prior to the Tuscola County gun

board approval to carry a concealed weapon, the hopeful must first un-

dergo a lengthy process.

Applicants are to complete paperwork at the county clerk's office and pass a criminal background check to confirm whether or not there have been past arrests.

Legislation requires that the applicant give a detailed description of their mental medical history during this process including: past hospitalizations, tendencies toward vio-lence or whether or not they are sui-

ground check, but where it's a bit of a gray area is mental health. It won't show up on a criminal history because it's not a crime. But it is required on your application for a CCW that you disclose whether you have had any mental health issues," said James Jashinske, undersheriff for the Tuscola County Sheriff's Depart-

Then, the applicant must undergo between 8 and 12 hours of training that includes a basic shooting and personal protection course, which are designed to teach and evaluate safe firearm handling, develop shooting skills (minimum of 3 hours spent at a shooting range), and to ensure understanding of firearms laws.

The required courses, fingerprinting and processing fees can add up to \$200.

Jashinske said there is not any evidence linking crime rates with the increase in concealed weapon permits. He believes this may be attributed to the fact that CCW licenses can be as quickly revoked as they are approved. Weapons and permits can be confiscated by the state for violating regulations

One of the more prominent violations seen by the Tuscola County Sheriff's Department takes place on the road. During a traffic stop, an individual is required to immediately inform the officer that they are carrying a concealed weapon either on their person or in their vehicle.

"The law requires the individual to tell the officer that stops them, to immediately disclose that they have these CCW licenses and that they are

Ubly Homecoming!

Celebration to honor Sleepers' library legacy

This year's Ubly Homecoming celebration will focus on more than being another summer family festival in the Thumb.

The event, slated for Thursday through Sunday, will honor the village's Sleeper Public Library and the couple whose generosity turned an idea into reality nearly 100 years

ago.
"It (library) was started by Albert E.

(Moore) Sleeper endowed and donated 2,500 volumes of books back in 1908," explained library Director Barbara J. Butch. "He also donated the space above the Citizens Bank of Merrill and Sleeper for use as a library. Rev. MacKenzie, Rev. Blake, Ben Eilber, August Schrader, Edward Baskin and D.H. Pierce were appointed as the first board of trust-

Aside from being a successful businessman and banker, Sleeper served 2 terms as Michigan's governor. Born in Vermont, Sleeper moved to Lexington, Mich., in 1884. He served in the Michigan State Senate from 1901 through 1904 and the following year became a member of the Republican State Committee, then served as state treasurer from 1909 through 1913 under 2 governors, Fred M. Warner and Chase Osborn. Sleeper was elected governor in 1916, defeat-

ing Democrat Edwin F. Sweet.

Butch said Sleeper left a lasting, positive legacy in Ubly.

"He was (generous). I think he was just a well-read, well-rounded person who gave back to the community," she added. "And what a gift - after 100 years, we're still here.

In fact, Sleeper Public Library is located in the building where Sleeper first made his donation.

"We've moved around, but we're back in the original building," Butch said, noting an expansion/renovation

Palmateer: we need employment, industry in Cass City area

Editor's note: This is the first story in a 2-part series profiling the candidates seeking the office of village president in Cass City in the fall. This story focuses on lifelong Cass City resident Carl Palmateer.

During his early days as a deputy sheriff in Tuscola County, Carl Palmateer relied on common sense to do his job. After all, there was no formal criminal justice training back in the 1950s.

went on to serve as police chief in Cass City for 10 years. He' now retired after a nearly 30-year truck driving career.

But he figures common sense is still the best approach when it comes to a new job, and that's the way he says he'll face the challenges of serving as Cass City's village president should residents elect him in the fall.

"I know enough that, if I don't know the answer, I'll find someone who has the answer," Palmateer commented Friday. "I believe you still have to have common sense when it comes to dealing with things in town. I'm not saying they're (village officials) not, but there's no way around it."

Palmateer has watched village government for many years. He recalled when retiring Village President Bert Althaver joined the council. It was a tenure that would last a combined 35 years.

"I was thinking of just running for council, but when I learned Bert was giving it up, why, I decided to run for village president," said Palmateer, who noted some village employees approached him with the suggestion. "Prob-

ably because they know me.
"I thought I'd like to try it, having been in Cass City all my life and having worked here once," he added. "I've always been up on everything here because I've always known the councilmen and employees. I see them in the restaurants, and they talk to me - some of them still call me 'chief'.

Out of Africa

Owen-Gage grad ministers in Sierra Leone

was submitted by Cass City area resident Laura Enderle, who describes her recent experiences as a missionary in Sierra Leone, Africa, after attending the Antioch Christian Training School in Naches,

Washington.
Enderle, 21, the daughter of Arlene Jamieson of Cass City and Frank Enderle of Bay City, is a 2004 graduate of Owen-Gage High School and a 2007 graduate of Delta College, where she earned an associate's degree in journalism and international

There I was, in the reality of countless children, their continuous laugh-ter, and a workforce that beat as strong as an African drum.

This was Sierra Leone, Africa, where the constant sunshine warmed the spirits of the people right along with the land. Everyone greeted us with a heart-felt smile and gazed upon us with welcoming and curious eyes.

There was no electricity except by a rare generator and the only "running" water most people saw was when a group of children passed by with filled buckets balanced on top of their

I quickly learned that every morning these people were grateful for another day because they mostly lived to survive.

In Sierra Leone the average life expectancy is only 40 years old and the infant mortality rate is over 150 deaths per every 1,000 live births. Clearly, death is real to these people and they are very hungry for the truth about what happens with life after death.

During our 3-week evangelical stay

we were fortunate to witness the everyday tasks of the natives and a little bit of what it would be like to live with 8 people in a 2-room pan body

Often the kitchens were outdoors Women cooked over an open pit in the middle of their red dirt "backyard". Normally there was only one meal of rice and some kind of spicy sauce between 3 and 4 o'clock in the afternoon when the children came home from school. Mangos were in season at this time, and we frequently found people gnawing the fruit off the pit after peeling it with their teeth. To do laundry was almost an all-day process. It included repeatedly whipoing the clothes against rocks after fetching water; or taking the clothes to a nearby stream where people would also bathe, do dishes, and children would play if they had a chance. (It was typically the children we saw getting the water and looking after

one another.)
Normally the men worked outside of the home to provide for the family, but work was inconsistent. There were gorgeous gardens throughout the village that they would tend to. Construction was popular, or we often saw people pounding stones all day long, repeatedly breaking them down to be used for cement.

Working for survival is a way of life for the Africans, so they really enjoy the simple pleasures of life.

During our VBS weekend we used a lot of balloons because they were easy, plentiful, and the children treasured them. On the way to the village community center (where both VBS and church was held) one morning we threw balloons out the windows of our van to entertain the street children that were not able to attend

One lone balloon did not make it to the hands of a child; it was floating along the road until it caught the eye of an adult woman. She was balancing a crate of glass bottles on her head as she sped up her walk toward the balloon. When the balloon caught some air, she also picked up speed until finally she reached the balloon and bent over to get it; all while still effortlessly carrying the boxed weight on her head.

The African lifestyle never failed to amaze us as we adjusted to call it home during our brief stay.

The main task of our 9-man, 7-

woman team was simple door-to-door or hut-to-hut evangelism. Five days a week we went through the village of Regent (a rural community near Freetown, the capital of Sierra Leone) with 8 other native missionaries. As a team we separated into pairs and trudged down every dirt road and foot trail we thought would lead us to a soul and built relationships with the villagers while illustrating the love of Jesus to them.

In my former thoughts I envisioned short-term mission trips involving more physical work of actually constructing a church or something along those lines. But I see now the labor we poured into these people's hearts built the church far stronger than any steeple could endure.

We diligently asked and answered questions about life, death, eternity, God and Jesus. With grateful hearts the people would often give up the only wooden bench in their homes for us to stay and share with them.

The literacy rate among Sierra eoneans is only 35 percent, and although I think it was higher in our area still the bulk of their knowledge of God came by word of mouth. The villagers would stop whatever they were doing to listen to us.

Shortly after our first interactions with the people it was sad to discover how confused they were about the

Sometimes we would ask individuals if they were Christians and their response would be, "Of course, I am a good Christian, I go to mosque on Friday and church on Sunday.

The statistics say that 60 percent of the population is Muslim, but from my experience it seems many of them just want to make sure all of their bases are covered.

Since Islam is a works-based religion, we explained that no individual could earn their way to God because no matter how good the person, God is holy, perfect, and cannot tolerate That is why we need a savior; and not just any man could have died on the cross to pay our death penalty, it had to be God (Muslims do not believe Jesus is God).

Another common concern we explained was the gift of salvation, when Jesus died on the cross for our sins. There were many people we encountered that believed you had to work for your salvation and earn blessings from the Lord. They did not fully understand grace: unearned favor from God.

Different "religious" groups that appeared to be Christian to the Africans would come in and have a "Flaming Bible Holy Spirit Revival" or "A Night of Casting out Demons" where the offering plate would be passed out several times during the service. The people would be deceived into thinking this would get them a better life on earth, or even into heaven.

We explained that when you give to God expecting something in return, it makes Him something less than all-powerful, therefore God would no longer be God. And our salvation would no longer be a gift from God, it would be a business transaction ini-

These were just a few of the frequent conversations we got to have while becoming friends with the natives and experiencing life as a social minority. The time spent in the village rew us in so many ways. We were challenged to get out of our comfort zone, depend on the Lord and learn scripture to new depths

It was a great privilege for me to experience Africa after studying Third World Development in college. The course focused on the variety of reasons why the third world countries are in the state that they are in; why people are starving to death and have

no clean water to drink; why the countries are over populated and the effects it has on the land, the people and the economy.

I realized how so much humanitarian aid rarely gets to the people who need it most. Also, no matter how much aid is poured into the country. every problem is intricately intertwined and it seems most of these countries are stuck in an endless cycle of poverty and un-develop-


The main lesson I learned while serving this poor African community is that nothing else matters other than having a personal relationship with

If we do not have the Bread of Life, the Word of God, to feed our souls, it does not matter how much, or how little we eat to nourish our physical bodies. If we do not have the Living Water, the Holy Spirit, we could have an abundance of clean water flowing from the faucet, but it is not going to preserve our lives for long.

Our souls were made for eternity and our time here on earth is temporary Everyone has the same fate because death is inevitable regardless of our circumstances here on earth.

The amount of humanitarian resources available is insignificant when you realize people are dying daily in every country without the knowledge of needing Jesus as their savior. And it does not matter how you die, whether of starvation, aids, cancer, or a fatal accident. What matters is where you will live for eternity. ±

Anyone can go to Africa and bring back breathtaking pictures of their simple and vivid ways of life, but what did we do to make a difference? The Lord used us to provide His people & with water for their souls and we gave them a true taste of the love of Jesus.

Cass City Post Office marks 50 years of delivery

A half century ago, the mail wasn't just a step outside the door or a quick stroll down the driveway.

Prior to August of 1957, Cass City residents had to make a daily trip to the local U.S. Post Office to pick up

This summer marks the 50th anniversary of a letter carrier postal service in Cass City, which was one of the first small towns in the area to have such services at that time, said 27-year post office employee and former Postmaster Bill Zinnecker.

"It (home delivery) was fairly well established in towns bigger than us,





Forty-seven percent of the Huron and Tuscola County residents who participated in the survey listed jobs and the economy as their No. one concern.

Palmateer: Cass City needs more industry

"I've got no personal agendas. Being retired. I've got the time, so I just want to see what I can do for the vil-

Palmateer's career in law enforcement started early - his 4-year stint in the U.S. Navy included working as a station police officer at a naval air station in Pensacola, Fla. Later, in the late 1950s, he took a job as a Tuscola County Sheriff's deputy. At that time, it was on-the-job training, recalled Palmateer, who said he had to purchase is own firearm and ammunition.

"The whole deal, back then, was just common sense. They had no schools you could go to to get certified. There was no such thing," he said.

'It was different. When I was with the sheriff's department, I was the only deputy on at night, covering the whole county at 26 years of age, Palmateer said. He recalled his closest shave with death involved an in-Paul Berry, who would go on to serve stopped a young man who was brandishing a shotgun. The suspect fired, hitting the badge on Palmateer's hat, but the young deputy wasn't

Palmateer was also a licensed pilot and owned his own airplane during his days with the department, so he was also called upon to help find prisoners who had escaped, along with the occasional search and rescue of

Palmateer was hired as Cass City's police chief in 1962, and in the 10 years that followed, he recalled handling everything from walking parking meters to investigating countless fatal car accidents to nabbing a pair of Jackson prison escapees in town.

"I still keep up on it (police work) and I keep in touch with (Cass City Police Chief) Craig Haynes. And, of course, my boy - he talks to me a lot about police work," Palmateer said,

referring to his son, Jim, who works as a border patrol agent in the Upper

After leaving police work, Palmateer spent the next 28 years working as a truck driver for various companies, retiring from Holland Motors 10 years

Today, Palmateer and his wife, Joyce, have 5 grown children sons and 2 daughters - along with 6 grandchildren. Both say they're concerned about the future of Cass City.

"The main thing is, when you look-down Main Street - all the vacancies, that's my biggest concern," he said. But it's everywhere, not just here. It's a terrible shame. Where did every-

body go?" Palmateer is quick to say he doesn't have all the answers, but that he hopes he can play a role in making some positive things happen in the

"We need employment. We need industry here," he said.

Brown: wind farm jobs should go to the residents in the Thumb

State Rep. Terry Brown (D-Pigeon) said recently that he is working with John Deere Wind Energy to ensure that Thumb-area residents - not illegal immigrants or out-of-state workers - are employed on the Harvest Wind Farm project.

The wind farm is an important economic project for the Thumb, and Thumb workers must be the driving force behind building it," Brown said

There are plenty of workers right here in Huron and Tuscola counties who are qualified for these renewableenergy jobs. With so many families struggling in this tough economy, we must provide our local workers with as many employment opportunities as possible."

Brown said he was extremely disappointed to learn that a contractor involved in the project, Sanderfoot Wind and Excavating Inc. of Appleton, Wis., apparently employed at least 2 illegal immigrants at the site near Elkton where 32 wind turbines will be built. Those 2 were arrested on a traffic stop in Huron County last week.

Brown said he called officials from John Deere Wind Energy, the developer for the privately-funded Harvest Wind Farm project, today to make it clear that hiring out-of-state workers and illegal immigrants is unaccept-

"I believe that the folks at John Deere are working very hard to do the right thing," Brown said. "I will continue working closely with them to make sure that the economic benefits of this project stay right here at home. Michigan workers are building the new economy, and the center of that new economy is right here in the Tip of the Thumb."

Brown also praised state police for their success in identifying illegal immigrants and dealing appropriately with these situations. "If we all work together to find solutions to these problems, we can keep our residents working and our communities strong," Brown said.



Mother, daughter author and illustrate Octagon Barn book

A young local artist recently illustrated the book her mother wrote for the Thumb Octagon Barn over 10

The artists' names were withheld from the committee while they made their decisions from a total of 4 entries, said Diane Rapson Gabil, a committee member and the school tours director at the barn.

The most challenging thing was that people had different views of what the story actually said and the way it would be illustrated. What happened was, they didn't all illustrate the same thing, it was trying to illustrate between apples and oranges," she said.

But in the end, Sheppard's drawings were selected based on their childlike appearance, a style that appealed to the committee.

Sheppard, who anxiously waited nearly 2 months, was ecstatic when she discovered she had been selected to illustrate the book. "I was happy and thought I had done it the best that I could," she explained. "I've always known about the book since I was little. I didn't know that I would illustrate it some day. It's been around since I was a baby.

After her drawings were chosen, Laura was asked to draw more pictures to coincide with other parts of the story.

She was given 4 weeks to submit the 15 illustrations, each taking roughly 4 hours to complete.

"It was really hard. They took awhile, especially the cow because it was so hard to draw," she said. "I had to print a lot of photos of the





Couple in hot water

"Drug paraphernalia and a rifle were found in a car parked in the driveway of the home, while a loaded shotgun was located near the entry door of the home," Gray said. "Marijuana growing paraphernalia was found throughout the property and home. Two sets of scales, a small amount of processed marijuana, a small amount of suspected cocaine and several types of prescription narcotics were also located in the home.

Gray said officers interviewed a 34-year-old man and 30-year-old woman living in the home. Both were released pending the results of crime laboratory results.

"Based on the presence of 3 children (ages 7, 11 and 12) living in the home, the criminal drug activity carried on in their presence, the loaded shotgun accessible to them, the overall squalid conditions in the home, and suspected child pornographic materials located in the home, the Michigan Department of Human Services was contacted and the children removed from the premises," Gray said. "An investigation into the welfare of the couple's 3 children and potential neglect/abuse charges is being pursued by the sheriff's department detective division and the Department of Human Services.

The drug task force is seeking charges against both suspects of manufacturing marijuana (fewer than 200 plants), a 7-year felony; possession of cocaine (felony); possession

of a firearm in the commission of a felony (also a felony punishable by a mandatory 2-year prison term); maintaining a drug house (2-year "high misdemeanor"); possession of a controlled substance (could be a felony or misdemeanor); and possession of marijuana (misdemeanor)

The Sanilac County Sheriff's Department, Michigan State Police and Deckerville police all assisted in the investigation.

The recent investigation followed a series of search warrants executed in

by drug task officers in the Sandusky and Lamotte Township areas. A young Lamotte Township couple is facing multiple drug charges after the drug team found more than 2 pounds of marijuana in their travel trailer along M-53.

Gray reminds residents that they can anonymously report suspected drug activity in the county by calling 1-800-544-DRUG(3784).

Those that carry concealed weapons will face similar charges if they are caught carrying in "pistol free zones" which include: schools, public or private day care centers, stadi-ums or sports arenas, taverns where the primary source of income is alcohol, churches, entertainment facilities, hospitals, dorms, classrooms, universities, casinos, courtrooms and of-

"The ironic part of it is I've had people say 'with all of these restrictions. I don't even want one anvmore," Jashinske said.

But many aren't after the permit for

day-to-day usage.

Popular uses of the permit include carrying the gun while traveling to large cities or to remote areas for protection. Many like the comfort of having the right to use deadly-force in self-defense in their own home. Others simply undergo the process just to exercise their constitutional right to bear arms.





Documentary critiques

U.S. health care system

What is your opinion of the current U.S. health care system?

Michael Moore's newest documentary is making people think about healthcare reforms. The director best known for his documenta-ries "Fahrenheit 9/11", "Bowling for Colum-bine" and "Roger & Me," released "Sicko" in

the United States on June 29. The film focuses on medical insurance companies and a comparison to the health care insurance program in other countries. Moore argues that citizens in Canada, the United Kingdom and France have working universal health care systems for their citizens, under which citizens do not live with the fear and uncer-



tainty of losing health care when they need it most. The film also spotlights the stories of people who have been denied health care, either by lacking health insurance or were denied coverage for a par

ticular ailment. Raymond Verellen, 52, of Snover, said he doesn't know enough about the current U.S. health care system to assess how he feels about it. "I don't have any form of health care," Verellen explained. "I have an agency I go in case I really need it (help), but I'm not really versed in what it (health care system) is.

Currently 45 million residents in the United States do not have health insurance. The amount of money spent for healthcare needs annually equates to \$2.1 trillion a year, which adds up to about 16 percent of the entire U.S.
