# AMBER Alert helps rescue 2-year-old boy

Reene lauded the AMBER Alert system and quick action by law enforcement authorities for the rescue of a 2year-old Unionville boy whose father allegedly assaulted him and then fled with the child Thursday.

The incident began at about 9:25 a.m. when Sgt. Scott Jones of the Tuscola County Sheriff's Department investigated a complaint involving Jason Gary Allen, 32, at a residence in Unionville.

Reene said Allen had been observed by a neighbor engaging in assaultive and threatening behavior, both inside and outside the residence, toward his 2-year-old son at about 2:30 a.m. that lasted about one hour. He said investigators found blood on bedding inside the residence and on a variety of items near a child's blanket/towel, and that preliminary tests for human blood were positive in an unattached garage at the residence.

"Evidence of the use of chlorine

bleach was found both inside the residence and in the driveway at a location between the residence and ga-- chlorine bleach is commonly used by defendants/suspects to destroy biological evidence," noted Reene, who said Allen failed to report to work Thursday.

Based on additional evidence gathered at the residence in Unionville, Reene authorized a 3-count felony warrant charging Allen with arson preparation to burn property valued at \$20,000 or more (punishable by up

mum penalty of 5 years in prison, and malicious destruction of property valued at \$1,000 or more but less than \$20,000 (punishable by up to 5 years in prison).

'At approximately 3:30 p.m. on Aug. 2, an AMBER Alert was issued in an attempt to immediately locate and ensure the safety of the defendant's 2-year-old son. Descriptions of the defendant, 2-year-old son and vehicle driven were all provided," Reene said. "After this time the investigation continued at the residence in Unionville with additional investigation of the crime scene completed by the Michigan State Police Department's Crime Lab and the Tuscola County Sheriff's Depart-


Hours later, at about 11 p.m., officers with the Dewitt Township Police Department located the suspect's vehicle at a motel. "Officers of that department were assisted by officers from the Bath Township Police Department and Clinton County Sheriff's Department in apprehending the suspect and taking the child into protective custody," Reene said. "The 2-year-old boy was transported to a local hospital for evaluation of observable injuries

Reene commended Sgt. Jones, Detective Glen Skrent and Detective Patrick Woidan, all of the Tuscola County Sheriff's Department, along with officers Steve Murphy and Don Rochford and Sgt. Travis Rawson of the Dewitt Township Police Depart-

"exemplary work on this case.
"The AMBER Alert worked in the exact manner for which it was designed," he added. "Through extraordinary law enforcement coordination and effort, a 2-year-old child was located and returned to safety. Allen was scheduled for arraignment in Tuscola County District Court Fri-

The AMBER Alert system was established in 1996 when Dallas-Fort Worth broadcasters teamed with local police to develop an early warning system to help find abducted children. AMBER stands for America's Missing: Broadcast Emergency Response and was created as a legacy to 9-year-old Amber Hagerman, who kidnapped while riding her bicycle in Arlington, Texas, and then brutally murdered. Other states and communities soon set up their own AMBER plans as the idea was adopted across the nation.

Once law enforcement has determined that a child has been abducted, police notify broadcasters and state transportation officials. AMBER Alerts interrupt regular programming and are broadcast on radio and television and on highway signs. AM-BER Alerts can also be issued on lottery tickets, to wireless devices such as mobile phones, and over the Internet. Through the coordination of local, state and regional plans, the Department of Justice is working towards the creation of a seamless na-

# To election process

# Law changes add consistency

Renewed state election laws will effect the Cass City Village election for the first time since they were implemented in 2005.

The minor changes were made to create consistency in the election process by synchronizing voting dates to specified times in May, August, September and November to make it easier for voters to recognize

an election period. "Elections were all over the map. The state decided that elections could be held only 4 times a year, no matter what you are," said Village President

A formalization of what has been done during past elections, the Election Commission is one part of the newly implemented election laws.

The duties of the commission are to review the ballot, appoint election inspectors and ensure that election

# **Enderle missionary work** shares gospel in Turkey

Editor's note: The following story was submitted by Cass City area resident Laura Enderle, who recently described her experiences as a missionarv in Sierra Leone, Africa. after attending the Antioch Christian Training School in Naches, Washington.

In this final installment, Enderle talks about her next adventure - a 3week mission in Turkey with 2 of her fellow missionaries.

Enderle, 21, the daughter of Arlene Jamieson of Cass City and Frank Enderle of Bay City, is a 2004 graduate of Owen-Gage High School and a 2007 graduate of Delta College, where she earned an associates degree in journalism and international studies.

What happens when 3 American Christian missionaries in their 20s enter a 99.8-percent Muslim country where the words "Christian" and "missionary" are not even allowed to be spoken?

Where fear may have caused hesitation in some, Brad, 25 from Ohio, Adina, 23 of Chicago, and I prayerfully pressed on to see what the Lord

had in store for us in Turkey. While the rest of our team from the discipleship training school in Washington looked forward to their homeland after our stay in Sierra Leone together, the 3 of us strapped on our packs and continued east for another

After a shift from 16 people down to 3, our unity amongst each other grew to new depths and our dependency on the Lord became ever more central.

3-week mission.

The words "Christian" and "missionary" are not allowed to be used when talking to Turks because they immediately associate it with the CIA and consider us the worst people that could influence their culture

Another reason we did not want to speak the "C" and "M" words was because Turks assumed that all Americans are Christian; and the majority of Turks only know the Hollywood version of Americans. obviously paints a completely false picture of true Christianity.

Therefore it was essential to build relationships before being able to

share the Gospel. Since Turkey is a super relational culture this was less difficult than it would appear and the Lord gave us some clear divine ap-

pointments during our travel We were able to share with 2 waiters in Istanbul who were very curious about the truth since they had never had any actual interaction with Christians. They were full of questions and open to conversation, but still reluctant to accept Jesus as God.

In Cappadocia (inland Turkey) we took an all-day tour to an underground city where some of the first Christians hid from the Hittites and Arabians. It was remarkable to get a glimpse of how people survived in hiding without possibly ever seeing daylight. Over the years the city was dug out to be 8 levels deep with about 2,500 inhabitants. After our visit to the underground city we were privileged to witness some of the first cave churches and even a monastery carved out of volcanic rock.

On this tour I had an opportunity to share with a fellow American traveler



The project partners include the health departments and MSU extension services in all 3 counties, Hills and Dales General Hospital, Scheurer Hospital, Harbor Beach Hospital, Deckerville Hospital and Huron Medi-

The project is being funded by a federal Rural Health Care Grant. The Thumb Area Nutrition and Physical Activity Campaign is the result of a community health assessment conducted by the Thumb Rural Health Network. Results indicated that obesity is the major factor related to death rates from heart disease, diabetes and other chronic diseases.

The Thumb Steps Up Task Force has developed a community-wide campaign that goes beyond health education. Interventions include community outreach and health promotion. All 3 counties are offering assistance in getting walking groups established in various communities. 

## Rabbit Tracks

A couple of weeks ago I talked briefly about the Mackinac Bridge that was celebrating its 50th year. The note was of special interest to Carl Palmateer, Cass City native. He said that he had a part in the construction.

He drove trucks with giant building blocks that were unloaded in place at

the bridge. We took 2 trips a day, he recalled. The first was much quicker than the other because the slow trip required taking the ferry before unloading on

Probably the majority of state residents know that there are 2 ways to spell the city and the famous island at the straits dividing the upper and lower peninsulas. Quick now, is it Mackinac Island and the city of Mackinaw, or is it Mackinaw Island and the city of Mackinac?

What makes it difficult is that no matter how you spell it, it's pronounced the same (Mackinaw) and only when writing is it important to know which is which. For the record, it's Mackinac Island and the city of Mackinaw. Of course, you can always look it up to make sure. I did.

Cheryl L. Daniels first appeared on the charges last Tuesday in Tuscola County District Court and waived her preliminary examination on a 50-count warrant charging her with embezzle-ment by a public official. A short time

ordered in the case. Bond for Daniels was continued at \$28,000. "She has agreed to pay full restitution to the village of Caro regarding all embezzled funds," said Tuscola County Prosecutor Mark Reene.

The charges against Daniels were what Reene called a detailed and ex-

originally authorized as a result of haustive investigation completed by Detective Sgt. Mark Krebs of the Michigan State Police. Reene commended Krebs for his work on the case as well as cooperation from Wal-Mart Corporation officials who compiled records related to hundreds of

crimes was between January 2004 and June 2007 during which time Daniels, a 33-year employee of the village, served as deputy treasurer in charge of payroll.

Daniels faces sentencing Wednesday, Oct. 3, at 8:30 a.m. before Tuscola County Circuit Judge Patrick R.

hunt bear or moose, but not too many do that for prairie dogs. That's a mistake, I think, Prairie dogs offer several advantages over moose and bear. There are





Run by co-owners Raymond Wallace and his sister, Mrs. Sam (Bernice) Sangster, the little grocery store-gas station at the corner of M-53 and Deckerville Road hasn't changed a whole lot since their father bought the place March 12, 1935, when they moved in from Almer. Oil cans are displayed near a cold meat counter. Tobacco products hang on the wall. An old spool drawer is filled with spools in one drawer and various sundries in the rest. A certificate from the Gulf Oil Company hangs over the doorway into the living quarters and carries a 40-year recognition award. The cramped store contains much more stock than it used to, said Wallace, leaning on the meat scale. Besides the variety of canned goods, household products and sweets displayed on shelves extending from floor to ceiling, another whole room in the adjoining small house is used as a

## Derfiny looking forward to retirement after 22-year teaching stint in Cass City

As a teen, Linda Derfiny had plenty of inspiration to enter the field of education, but she decided early on that career wasn't for her.

Derfiny eventually changed her mind and went on to a 22-year stint as an instructor in the Cass City School District, including the past 16 years teaching sixth grade students. Now, she's looking forward to retirement

"My grandmother was a teacher and my mom was a teacher," recalled Derfiny, who grew up in Kalamazoo. "I thought I wanted to do something different - I wasn't sure what; I was thinking something travel related or art related — but I was irresistibly drawn to it (teaching), and I loved it."

Derfiny earned her bachelor's degree at Central Michigan University and, later, her master's degree in middle school teaching from Saginaw

Valley State University.
She took her first job in 1975, as a third grade teacher at Campbell Elementary School. "I taught for 5 years, and after Matt was born, I stayed home for 10 years, and had Michelle," Derfiny said of her children, Matt, a 1999 Cass City High School graduate who resides in Muskegon and attends Baker College, and Michelle, a 2001 Cass City yrad who lives in the Kalamazoo area, where she is employed as a corrections officer at the Kalamazoo County

The timing was perfect when Derfiny decided to resume her career.

"It was neat that when I wanted to go back, a third grade position had opened up, and that's what I had taught before," she recalled. "A few things had changed, but not much. Basically, third graders are third grad-

"I loved teaching the third grade well, third grade and sixth grade because they're so curious. They're so curious about the world and interested in everything. They're a lot of fun."

Although Derfiny has considered a travel-related job, she has managed to pursue that interest and incorporate her experiences in the classroom.

She joined a group of teachers in 2002 for a trip to Belize, in Central America, and was able to study the rain forest, coral reefs and the Mayor Puins

Three years later, she and her daughter traveled to Costa Rica, where Michelle had been an exchange student while attending Western Michigan University in 2003. "She spoke Spanish and I had the Visa card," Derfiny joked. "We traveled on buses - we traveled like the locals."

A year later Derfiny was selected for an all-expense paid study trip to Germany.

She noted each adventure provided her with opportunities to share with her students a variety of social studies topics, such as Communism, cultural differences, the challenges of not speaking the language in a foreign land, and currency exchange.

Derfiny's decision to leave the classroom for good was sparked, in part, by the school district's recent offer of retirement incentive packages to veteran instructors. The offer came at a time when she qualified for full retirement benefits.

"Dan's (her husband) been retired

for 8 years, and so I'm ready to do other things. I'm ready for more freedom myself," she said, noting Dan, who retired from his job of teaching drafting at the Tuscola Technology Center in Caro, is now self-employed, doing contract drafting design.
"I want to travel and I want to spend

more time with family and friends, and pursue hobbies that have been on the back burner - reading, gardening, oh, and stamp collecting," Derfiny added.

Asked if she'll miss not going back to class this fall, Derfiny paused for just a moment.

"I don't think it's going to bother me. It was so much work, so consuming. I was totally wrapped up in this," she said.

"Back when I started teaching, we had more freedom to present things in the way we chose to, but now there's more curriculum, there's way more testing, and there's more pressure. The state and federal government have gotten so much more involved," she explained.

# A SE VOID OF CHERIBOR

People are still being recovered from beneath the recently collapsed Minneapolis Bridge.

As many as 50 vehicles became trapped in the rubble or in the river after the eight-lane interstate bridge collapsed during Minneapolis' evening rush hour Wednesday. Twenty to 30 people were missing and at least 79 people were injured after the bridge collapsed and fell 60 feet, about 6 stories, into the Mississippi River.

The water below the collapsed bridge is 7 to 8 feet deep, which is just covering the roofs of dozens of cars that are in the water.

The bridge was undergoing nonstructural re-decking work when it collapsed.

President Bush pledged federal aid to rebuild the bridge on Thursday and a total of \$5 million is being made available to pay for traffic flow adjustments and debris removal. A 2001 study conducted by the Minne-

sota Department of Transportation suggested that the design of bridge's main truss could cause a collapse if one of two support planes were to become cracked. Jessie Bessler, 17, of Cass City, said she

"I am now terrified of driving on bridges. It seems so weird that it just fell all of a sudden," she said.



The steel arch bridge was opened in 1967. Its longest span stretches 458 feet over the river, and it was constructed with no mid-river piers to facilitate river traffic.

About 100,000 cars a day travel over the bridge, according to the Minnesota Department of Transportation.



# **Election laws**

laws and local village procedures are followed.

Delegates for the Election Commission were approved at the village meeting June 26.

A unanimous vote appointed Village Manager Peter Cristiano, Village Clerk-Treasurer Nanette Walsh and Althaver to the Election Commission.

In the past, one person, usually the Village Clerk, was responsible for the duties of the Election Commission. Walsh trusts that the extra help will ensure a smooth running of the elec-

There are additional people that will be overseeing the process, which will only help," Walsh said. Generally, though, voters won't no-

tice any substantial changes when they go to the polls on Tuesday, September 11. "Our situation isn't any different except the date and maybe

some minor rules," Walsh said.
Voters will utilize machines to cast their ballots, in which they will be instructed to mark where appropriate and then feed the card into the machine, where it will be verified and counted.

There won't be a primary election, either. Village elections are non-partisan and therefore will not include primaries to limit voting options for the general election. Because just 2 individuals are campaigning for the Village President position and there will not be a race for any of the 4 àvailable council trustee seats, September's election will not be concerned with an overflow of candi-

Participants in the election will be going to the Village Municipal building to cast their ballots, instead of the VFW hall, where all other elections take place

The election will be the first voters have seen since March of 2004. Althaver has served his term as Cass

City Village President for 3 years and six months, a position that is traditionally carried out for a maximum of

The state's attempt to gain consistency in the voting process and a charter prohibiting the shortening of a village board member's term as a result of a change in the law extended the president's duration on the coun-

As a result of the elimination of the March voting period, the council was faced with 2 options to renew the voting cycle. They could either hold an election simultaneously with the federal election in November, which takes place during even numbered years, or they could vie for a September election, which would take place exclusively during odd numbered

"We talked about it and we basically decided to go with September be-cause we thought we would get lost in the Federal election," Althaver

There are currently 1,636 registered voters in the Village of Cass City. Last November, 59 percent of the area's voters participated, which was a drastic increase from previous years.

Althaver expects a similar intensity of participation in this year's election due to the competition between vil-lage president candidates Carl Palmateer and Tom Herron, who are both lifelong Cass City residents.
"In the past when there has been

no competition for a seat, the numbers have been very low. Probably less than 100, or right around 100 voters participate," Althaver said.

Althaver opted not to seek reelection after serving on the council for more than 40 years.

Incumbents to the available council trustee seats include: Jenny Zawilinski, Jim Heiser and Mick Kirn for 4 year terms and Jeff Gillig who is seeking the single 2 year term seat.

The remaining council members, trustees Don Richards and Dwight Thabet, are completing 4-year terms that will expire in 2009.

To participate in the election, individuals must be registered voters with legal residence in the Village of

## VILLAGE OF CASS CITY TUSCOLA COUNTY, MICHIGAN **UNNECESSARY NOISE ORDINANCE ORDINANCE NO. 167**

THE VILLAGE OF CASS CITY ORDAINS:

### SECTION 1 - TITLE

This Ordinance shall be known as the Unnecessary Noise Ordinance.

### SECTION II - PURPOSE

The purpose of this Ordinance is to protect, preserve, and promote the health, safety, welfare, peace, and quiet of the citizens of the Village of Cass City through the reduction, control, and prevention of loud and raucous noise, or any noise which unreasonably disturbs, injures or endangers the comfort, repose, health, peace, or safety of reasonable persons of ordinary sensitivities.

### **SECTION III - DEFINITIONS**

"Construction" means any site preparation, assembly, erection, substantial repair, alteration, or similar action, but excluding demolition, for or of public or private rights-of-way, structures utilities or similar property.

"Demolition" means any dismantling, intentional destruction or removal of structures, utilities, public or private right-of-way surfaces, or similar property.

'Emergency work' means work made necessary to restore property to a safe condition following a public calamity or act of God, or work required to protect the health and safety of persons or property.

"Noise" means any sound which annoys or disturbs humans or which causes or tends to cause an adverse psychological or physiological effect on humans.

"Off-Road Recreational Vehicle" means any motor driven off-road recreation vehicle capable of cross-country travel without benefit of a road or trail, on or immediately over land, snow, ice, marsh, swampland, or other natural terrain, including, but not limited to, a multitrack or multiwheel drive vehicle, an ATV, a motorcycle or related 2-wheel, 3-wheel, or 4-wheel vehicle, an amphibious machine, a ground effect air cushion vehicle, or other means of transportation deriving motive power from a source other than muscle or wind.

"Person" means any individual, firm, association, partnership, joint venture, or corporation.

"Residential Area" means any real property which contains a structure or building in which one or more persons reside, provided that the structure or building is properly zoned, or is legally nonconforming, for residential use.

'Village' means the Village of Cass City, Tuscola County, Michigan.

## SECTION IV - GENERAL PROHIBITION

a) No person shall make, continue, or cause to be made or continued:

1) any unreasonably loud or raucous noise; or

2) any noise which unreasonably disturbs, injures, or endangers the comfort, repose, health, peace, or safety of reasonable persons of ordinary sensitivity, within the jurisdictional limit of the Village; or

3) any noise which is so harsh, prolonged, unnatural, or unusual in time or place as to occasion unreasonable discomfort to any persons within the neighborhood from which said noises emanate, or as to unreasonably interfere with the peace and comfort of neighbors or their guests, or operators or customers in places of businesses, or as to detrimentally or adversely affect such residences or places of business.

b) Factors for determining whether a violation of this Section exists shall include, but not limited to,

- 1) The proximity of the noise to sleeping facilities, whether residential or commercial;
- 2) The time of day or night the noise occurs;
- 3) The duration of the noise;
- 4) The volume and intensity of the noise:
- 5) Whether the noise is recurrent, intermittent or constant;
- 6) Whether the origin of the noise is natural or unnatural; and

## 7) Whether the origin of the noise is usual or unusual

## SECTION V - PER SE VIOLATIONS

By way of example, but in no respect by way of limitation, the following specific activities occurring on private property and clearly audible beyond the property line shall be deemed a per se violation of this Ordinance:

a) Unreasonable Noises: The unreasonable making of, or knowingly and unreasonably permitting to be made, any unreasonably loud, boisterous or unusual noise, disturbance, commotion or vibration in any boarding facility, dwelling, place of business or other structure, or upon any public street, park or other place or building. The ordinary and usual sounds, noises, commotion or vibration incidental to the operation of these places when conducted in accordance with the usual standard of practice and in a manner which will not unreasonably disturb the peace and comfort of adjacent residences or which will not detrimentally affect the operators of adjacent places of business are exempted from this provision.

b) Vehicle Horns, Signaling Device, and Similar Devices: The sounding of any horn, signaling device, or other similar device, on any automobile, motorcycle, or other vehicle on any right-of-way or in any public space of the Village, for more than ten (10) consecutive seconds. The sounding of any horn, signaling device, or other similar device, as a danger warning is exempt from this prohibition.

c) Non-Emergency Signaling Devices: Sounding or permitting sounding any amplified signal from any bell, chime, siren, whistle or similar device, intended primarily for non-emergency purposes, from any place for more than ten (10) consecutive seconds in any hourly period.

d) Emergency Signaling Devices: The intentional sounding or permitting the sounding outdoors of any emergency signaling device including fire, burglar, civil defense alarm, siren, whistle, or similar emergency signaling device, except in an emergency or except as provided in Subsections 1) and 2), below.

1) Testing of an emergency signaling device shall occur between 7:00 a.m. and 7:00 p.m. Any testing shall use only the minimum cycle test time. In no case shall such test time exceed

2) Sounding or permitting the sounding of any exterior burglar or fire alarm or any motor vehicle burglar alarm, shall terminate within fifteen (15) minutes of activation unless an emergency exists. If a false or accidental activation of an alarm occurs more than twice in a calendar month, the owner or person responsible for the alarm shall be in violation of this Ordinance.

e) Construction noises: The creation of noise which is clearly audible beyond the property from which it is emanating, resulting from the erection (including excavation), demolition, alteration or repair of any building, and the excavation of streets and highways, at any of the following times: prior to 7:00 a.m. and after 10:00 p.m. A deviation from such limitation shall be authorized if a permit is obtained in advance from the village manager, or the manager's designee, upon a showing that the noise will not result in an unreasonable disturbance of one (1) or more residential occupants. In cases of emergency work, construction or repair noises are exempt from this provision.

f) Unloading of materials: The creation of noise in connection with the delivery, loading and/or unloading of materials, goods or other merchandise by the use of motorized equipment, metal-tired hand trucks, racks, conveyors, or other types of equipment at any of the following times: prior to 7:00 a.m. and after 10:00 p.m., Monday - Friday; prior to 10:00 a.m. and after 10:00 p.m. on Saturdays and Sundays, where the noise from such loading and/or unloading is clearly audible more than one hundred (100) feet from the property from which the noise is emanating.

g) Off-Road Recreational Vehicles: The creation of noise in connection with the operation and use of off-road recreational vehicles in such a manner as to cause a private or public nuisance. For purposes of this section, a public or private nuisance shall be deemed to have occurred when the operation of the off-road recreational vehicle is conducted in such a manner as to unreasonably intrude on the privacy or peaceful enjoyment of residential property owners.

h) Radios, Televisions, Boomboxes, Phonographs, Stereos, Musical Instruments and similar devices: The use of operation of a radio, television, boombox, stereo, musical instrument, or similar device from any source, including a motor vehicle that produces or reproduces sound in a manner that is plainly audible to any person other than the player(s) or operator(s) of the device and those who are voluntarily listening to the sound, and which unreasonably disturbs the peace, quiet and comfort of neighbors in residential areas, or is plainly audible at a distance of 50 feet from any person in a commercial, industrial area, or public space at any of the following times: prior to 7:00 a.m. and after 10:00 p.m. or at anytime or place as to unreasonably disturb the quiet, comfort or repose of reasonable persons of ordinary sensitivities.

i) Yelling, Shouting, and Similar Activities: Yelling, shouting, hooting, whistling, or singing in residential areas or in public places, prior to 7:00 a.m. and after 10:00 p.m., or at any time or place so as to unreasonably disturb the quiet, comfort, or repose of reasonable persons of ordinary sensitivities.

j) Barking Dog: Any person within the Village who shall keep or harbor any dog which by loud, frequent or habitual barking, yelping, howling or other noise materially disturbs the peace and quiet of the neighborhood or public, or causes annoyance to persons in the neighborhood who are of reasonable and ordinary sensibilities.

## **SECTION VI - EXEMPTION**

The activities of government entities being provided for the public health, safety and/or welfare shall be exempt from this Ordinance.

## **SECTION VII - NUISANCE**

Any violation of any provision of this Ordinance is hereby declared to be a nuisance per se and enjoinable by appropriate legal action.

## SECTION VIII - VIOLATION PENALTIES

a) A person who violates a provision of this Ordinance is guilty of a misdemeanor,

punishable by a fine not to exceed \$500.00 or imprisonment not to exceed 90 days or both fine and imprisonment.

b) Each occurrence of a violation, or, in the case of continuous violations, each day a violation occurs or continues, constitutes a separate offense and may be punishable separately.

## ARTICLES IX - REPEALER

All ordinances and portions of ordinances inconsistent with this Ordinance are hereby repealed.

## ARTICLE X - SEVERABILITY

Should any provision or part of this Ordinance be declared by any court of competent jurisdictio n to be invalid or unenforceable, the same shall not affect the validity or enforceability of the balance of this Ordinance, which shall remain in full force and effect.

## ARTICLES XI - EFFECTIVE DATE

This Ordinance shall take effect immediately. This Ordinance shall be published in the manner provided by law.

## ARTICLE XII - ADOPTION



about my faith after he asked what made the 3 of us such dedicated Christians. I told him about my former view of God who was like a policeman in the sky, ready to judge everything I did wrong. I tried in my own strength to be a Christian, but continuously failed because I was consumed in sin and could not re-

Then I began to understand God's true character: one that is slow to anger, abounding in love, patient, and ready to forgive. I explained that when we recognize our sin and turn from it, the Lord promises that times of refreshment will come. God wants to take all our burdens from us and care for us, but human nature tells us to care for ourselves.

I told this Oregonian on the tour that after I recognized the true essence of Christ it was easy to surrender to Him. relationship with the Lord. It is just like a normal human relationship. When spouses truly love each other they want to serve and care intimately for one another, it is the desire of their

Another opportunity to share the gospel presented itself with our young peer tour guide through the ancient ruins of Ephesus. She surprisingly never heard the gospel and knew very little Christian history for that matter.

We had a full day of learning about the rich history of Ephesus; an early harbor city for trade and a culture center that thrived for centuries. Even the streets were marble and the people had a running water system.

This ancient culture had a pagan practice of worshiping women, specifically the goddess of nature, Diana (Artemis in Greek). The temple of Artemis was one of the 7 ancient wonders of the world that included 127 columns, 36 of them being solid gold. Only one marble column remains standing in its original place and the statue of Artemis can be seen in the museum of Ephesus along with several other statues of famous governors, doctors, warriors and more.

When the tour was finished we told Falya, our tour guide, about the book of Ephesians in the Bible and shared the good news of having Jesus Christ as our savior. She was very interested in what we had to say, possibly only for the purpose of her profession, but none-the-less the mes-

sage was given.
We do not know if any of the people we shared the gospel with accepted Jesus as their savior, but that is not for us to worry about. The Lord does the work, we are just responsible to deliver the message.

One day we rented scooters from a well-educated Muslim and for more than an hour we discussed the simi-

lam and Christianity over tea.

The Bible and The Holy Qur'an share some of the same historic books such as the Torat (books of the Law, the first 5 books of the Bible), Psalms (book of wisdom), and the Gospels (books explaining Jesus' life on earth). Also both religions acknowledge some of the same biblically historic men such as Adam, Abraham, Moses, David and even Jesus.

The main separation between the 2 religions is when Christians accept Jesus as God and do not acknowledge Muhammad as the final prophet. Also, Islam is a religion that earns their salvation according to their works through the 5 pillars of Islam, while Christians have the sacrificial gift of Jesus Christ to restore their fellowship with God.

In contrast to the typical American point of view portrayed by the mass media, Muslims are very peace-loving and hospitable people. They share some of the most basic concerns as you and I such as rising crime rates including terrorism and how to raise their children in a loving environment. They work hard to pay their bills and are in general especially joyful people.

In fact my 2 traveling friends and I often joked that we had VIP written on our foreheads because we were treated so exceptionally well by nearly everyone we encountered. It was hard to go anywhere without making a new friend. Their kindness was genuine without expecting anything in return.

One profound lesson I learned in Turkey that was articulated by the long-term missionaries we staved with in Antalya, is about unity. As a new evangelist, I naively felt like I needed to defend Christianity or support the church, but when people clearly have unlike beliefs, this automatically causes separation.

To get beyond the differences it is important to start a relationship on common ground. For example again, Islam does not believe Jesus is God. but they do believe in a god, Allah, that is all-powerful who created

tion on all the great loving qualities of God because that is always some-thing you can come back to.


I recognized that although most people value peace and unity, these virtues can easily be overlooked while searching for the truth and trying to determine what is right and wrong, especially in faith-based issues.

Also, I learned a huge lesson in relationships while abroad. In America, a society where time is money, it is easy for us to stray from what is most important. We simply do not take time to truly nourish the relationships

I wish I could go back and really pay closer attention to all the things Turks did for us to make our stay practically hassle-free and so enjoyable. Because of them I better understand the value of slowing down to take time for people and really applying love to my everyday encounters. So while Turkey is clearly a country

rich in history and formed by its culture, again it was the people that made our stay most memorable by far.
