Christina Lelito and her husband, Juan Pena, didn't think much of the shots they heard fired at about 3:30 a.m. outside their Deford area home 2 days after Thanksgiving. After all, deer hunters are seemingly every-

the family's pet, an American Kennel hunting season and having to get rest for work at 6:30 a.m., we went back to sleep," Lelito said. "The next day, where this time of year.

> to live. Someone was in our yard by our shed and shot my dog while tied out in its own yard. Lelito's husband took the family's pet to a veterinarian with gunshot vounds to the neck and muzzle. "Sparky was shaved where all the bullets or buckshot had hit him, and he had 8 holes in him about threesixteenths in diameter." Lelito said. The vet did X-rays, gave him infection medicine and put him on an IV for the weekend."

Lelito filed a report with a trooper in Caro. Based on a buckshot casing found just 10 feet away from the dog, the trooper said the firearm used was probably a 20-gauge shotgun.

Lelito still shakes her head when she thinks about the discovery.

"While it had lied on the ground, chain still hooked to its collar, I could only wonder what type of monster is loose and could do this, and would they try it next to my family?" she said. "This was real close to our house, too.

"My daughters did not have to see how cruel people can be or for that matter how stupid they can be, for it is a crime," Lelito added. "It hurt me to see my daughters see that, and also (to hear) my 3 1/2-year-old daughter, when she looked over where Sparky was found shot, say that he was in the hospital.

Lelito, whose home is located on north Kingston Road, north of Deckerville, is offering a \$200 reward for information that leads to the arrest of those responsible for the

# O-G approves insurance bid plan with ISD

Owen-Gage School officials are hoping to cash in on the potential savings offered by purchasing health insurance through a cooperative agreement with other schools in Huron County

The board of education last week approved a resolution to participate in a consortium that will collectively seek bids from insurance providers.

"This goes along with PA 106. It allows a group to join a consortium like this. In this case, the Huron County Intermediate School District (ISD) is seeking to form the consortium," explained Owen-Gage School Supt. Dana Compton "This will ba-sically align us with the ISD and all the other school districts in the county.

The consortium requires a minimum of 100 employees who are covered by the health insurance policy, but Compton said meeting that requirement won't be a problem with several

county districts participating.
Compton noted that PA 106 requires schools to seek bids for health insurance, although insurance provisions in existing collective bargaining agreements are not affected until such contracts expire, then schools must

Compton said the new requirements

certainly have the potential to save school districts money, but it's difficult to say how much.


"A lot of companies are going to get aggressive...as far as competing with each other," he said. "If we were able to get insurance \$3,000 cheaper (per employee), we'd be saving \$60,000 a year, so that's a pretty significant amount if you can make that happen.

Currently, Owen-Gage spends roughly \$16,300 per employee on health insurance. The annual tab adds up to some \$300,000. "This is a huge cost," Compton said.

Turning to a cooperative leadership arrangement that has been discussed for the past several months, the board continued to explore the possibility of sharing a superintendent with the North Huron and Port Hope school districts. The trio of school systems has a combined enrollment of roughly 900 students.

Compton, considered the top candidate for the position, said the Owen-Gage Board crunched some rough numbers and looked at the potential logistics of a cooperative agreement with the other districts.

The superintendent suggested that if the agreement were implemented, a







# Partial to pythons

### Cass City teen enjoys raising constrictors

by Tom Montgomery

When it comes to pets, Brandon Montgomery isn't exactly your dog or cat variety of animal lover. In fact, the Cass City High School freshman prefers animal friends of a more exotic nature. Specifically, snakes.

But not just any snakes; the 15-yearold is partial to pythons.

"They're different, very unique. I like that about them," said Montgomery, who recently purchased a breeding pair of ball pythons. Each measures between 4 and 5 feet in length. They are surprisingly strong for their size, eat just once a month and enjoy à diet of live rats. "They're very easy to take care of, clean.

"I've always liked snakes ever since we went up north and would catch snakes up there," he added. "I've always liked animals — snakes are just a favorite."

Montgomery, the son of Deb and Tom Montgomery of Cass City, did his homework before buying his first ball python from a Thumb area pet

"Lots of research," he said. "I researched it on the Internet, got a couple of books, and there are lots of websites that teach you how to take care of pets like these, exotic pets."

Ball pythons get their name from a tendency to curl into a ball when stressed or frightened. They are also known as royal pythons based, in part, on the story that Cleopatra wore the snake around her wrist. Ball pythons are a non-venomous python species found in Africa. They are the smallest of the African pythons and have become popular in the pet trade.

3 to 4 feet in length, although some specimens have reached 5 to 6 feet. Their build is stocky and the head is relatively small.

Experts say the species is known for its docile nature and lack of aggressiveness, although it's important to understand their behavior in order to avoid being bitten.

Ball pythons are easy to care for, but Montgomery noted the snakes

"Number one, you need to have a place big enough — about half the length of the python is how long the tank should be, at least," he explained. 'The most important thing is temperature; pythons need 80 to 90 degrees on one side of the tank and about 75 degrees on the other side so they can choose where they want to go. I have 2 heat lamps. They're specifically for reptiles. I keep one on at night and 2 on in the day to simulate the change in temperature from day to night.'

Montgomery also keeps a large water bowl in the tank which, along with the heat lamps, helps to maintain an optimum humidity level of 60 to 70

"You usually need a 'hide spot' — a box or upside down flower pot — where the snake can hide. It gives them security," he said. "One of the main things is you need to have an escape-proof container, usually you can use a fish tank as long as you have weights or clips on the top.

Bedding is another necessity, and many materials will do, according to Montgomery. "You can use things like pieces of carpet, newspaper the ink won't bother them - and there are a lot of corhmercial beddings

out there," he said, noting use of ce-Adults don't generally grow beyond dar chips is not recommended by ex-

perts because they contain chemicals and fumes that are highly toxic and could prove fatal to pythons.

He estimated his initial investment in his snakes totaled roughly \$250. "And then, to take care of them, depending on their size, \$6 to \$8 a month for food (plus) bedding."

The snakes' diet, at their current

size, consists of live rats once a month. "First it's mice, then rats. They'll probably eat medium-sized rats from now on. They won't eat anything bigger, I don't think," he

Montgomery explained that breeding pairs mate once a year, producing clutches albino python, meaning the chances are one in 4 that it could bear young with some albino characteristics. "A full albino ball python is worth well over \$1,000," he noted. Montgomery regularly handles his pythons and has never been bitten.

"Like any other snakes, their absolute last defense is biting. If you really agitate them, they might bite you," he said. "Just like any other animal, they need to be with people especially when they're young. I hold mine every day."

The pythons Montgomery has now

are not his first. His first, a young snake, died after a few weeks from a pre-existing respiratory infection, and

#### 35 YEARS AGO

Construction of the \$1 million skilled nursing home is well underway and is expected to be completely finished in about 7 months at the site in Hills and Dales subdivision in northwest Cass City. Thirty-one years later, Crane, now 52, his face lined by years of work, pushed back the easy chair in his living room and said, "Yeah, I was there." Lighting a cigarette, he recalled the fateful Sunday in 1941, the starting point of a war that eventually involved every American and changed the ways of the world. With a thoughtful look seen on every veteran's face when he starts telling war tales, Crane related that he was at Hickam Air Field by the control tower, waiting for some -17s to arrive from the States. Hickam Air Field was next to Pearl Harbor and suffered much damage during the raid. As part of the Army Air Corps motor pool, he was to pick up the officers and their luggage. The B-17s were due any minute. "We were shooting the breeze," said Crane.

"Then we saw these planes in the sky and thought it was the Navy practicing maneuvers." "It was the navy all right," he laughed. "The wrong one."
He and the other 20-odd men on that detail didn't think much of the planes approaching rapidly until they turned: sharply, and the rising sun, symbol of Japan, rose out of the sky.





"Try to be creative in using reusable materials for your gift-wraps, she added. Make it a holiday tradition in your home to be creative while saving the environment.


