## **Competition stiff for** milk processing site in Thumb location

It's been nearly a year since a discussion was held with representatives of a dairy cooperative concerning the erection of a concentrated milk processing facility in or near the

Now a decision on the location of the plant is expected before the end of the year, Peter Cristiano, village manager says. There is competition among area communities for the plant

Cristiano feels that the village has much to offer to make the Cass City site attractive to the Dairy Farmers of America

A 15-acre site would be given to the company. It's part of the 65-acre industrial park in southwest Cass City wned by the village

ing requirements. It has street access for trucks with a gross weight of approximately 176,000 pounds.

The land is in the renaissance zone

and will be eligible for tax relief.
The Cass City Waste Water treatment plant is capable of handling the sewer requirements of up to 300,000 gallons a day 365 days of the year

provided that water is pre-treated.

It is expected to use 100,000 gallons of water every day. The plant will cost its owners an estimated \$18 to \$48

Employment is expected to be between 10 and 50 full time posi-

It will be a busy place, processing 16 to 18

hours daily and then cleaning up 6 hours a day. Milk will be received 24 hours a day from 20 to 30 trucks and 10 to 12 trucks will ship the processed milk all day, every day.

The plant is designed to remove water and unwanted components that reduce weight and cut the cost The site would give the company access to village sewer and water and of moving the product to market.

## Overcrowding ends at Tuscola County Jail

Overcrowding at the Tuscola County Jail has been eliminated, at least temporarily, James E. Jashinski, undersheriff, reported this week. As of Monday morning there were 72

Authorities still believe that the relief will be temporary. The county is boarding 7 prisoners in jails outside the county and are now accepting misdemeanor warrants as it did prior to June 6. Boarding out of county is expensive, costing an average of \$35 a day for each prisoner, plus expenses for doctors and the cost of moving

The jail maximum is 80 prisoners. Since Tuscola County Circuit Judge Patrick Joslyn on Aug. 18 ordered that the inmate population be reduced by 30 percent, there has been a concentrated effort to meet the goal. Early releases and reduced time earned under PA 511 has resulted in over

4,000 days of reduced jail time. Under PA 511, prisoners earn a day reduction for each day they work on a nonprofit job. Scheduled for early release under the act are 6 in October and 10

## **Sheriff's Department** continues investigation

The Tuscola County Sheriff's Department is continuing its investigation of a hit and run crash last week At approximately 9:30 to 10 p.m., Oct 10, Christopher James Niklowicz, 21, of Caro, was walking eastbound on E. Dayton Rd. (just east of Weeden Rd. in Indianfields Township), and was struck by an unknown eastbound vehicle, which did not stop

Tuscola County Undersheriff. James Jashinske, states in a press release that Niklowicz had been out celebrating his 21st birthday and had been arguing with a friend in the car. When they got to the corner of Weeden and E. Dayton roads, Niklowicz insisted on getting out of the car because he did not want to leave the bar. Niklowicz was last seen

walking eastbound on E. Dayton Rd. A passing motorist, who stopped to render aid, found Niklowicz on his knees in the roadway. The motorist called 9-1-1. An MMR ambulance treated him and a Flight Care helicopter took Niklowicz to St. Mary's Hospital. He is in stable condition today.

There are many conflicting stories of what occurred on E. Dayton Rd. Sheriff deputies have been unable to locate any suspect vehicles at this time. Initially, Niklowicz described the vehicle that struck him as possibly a blue Pontiac GrandAm.

Since the Cass City School District representatives hired the Honeywell Company nearly 12 months ago to upgrade the facilities at school buildings in Cass City, the savings realized appear as promised.

At the time of the signing Honeywell specified that the \$1.228 million job would pay for itself in 15 years, including interest, because of energy savings.

At the time it was noted that the savings would be computed according to a formula set by law and if the work didn't pay for itself in 15 years

the company would pay the difference in cash.

Supt. Ron Wilson reported that the savings were on target and are great enough to meet the \$90,000 payment for the work.

A recently completed utility savings breakdown indicates the savings at all buildings. At the high school there were \$23,515 savings for electricity. \$19,418 for gas and \$5,970 for water At the middle school, electricity sav ings are \$7,035 and gas savings





### Brown's plan targets

### extreme drunken driving

State Rep. Terry Brown (D-Pigeon) recently announced that the state House passed a bipartisan plan that cracks down on extreme drunken drivers and aims to keep repeat offenders off Michigan roads

"Drivers who get behind the wheel when they are extremely intoxicated are putting innocent people at risk, and they must be held accountable, Brown said. "This plan will save lives by keeping more of these reckless drivers off the road. I urge my col-leagues in the Senate to act quickly on this legislation for the sake of our residents' safety and peace of mind."

The plan targets people who are arrested for extreme drunken driving with a blood-alcohol content (BAC) of at least 0.15, which is nearly twice the legal limit of 0.08. The plan will keep extremely drunken drivers and repeat offenders off the roads by requiring them to have ignition inter-

lock devices placed on their vehicles Before starting the vehicle, a driver must blow into the device. If the driver's BAC is above the pre-set limit, the vehicle will not start. The plan also requires offenders who are convicted of high BAC violations to successfully complete a rehabilitation program.

"This legislation forces these extreme offenders to face the reality of their irresponsible behavior," Brown said. "I believe these penalties will be effective in cutting down on the number of extreme drunken drivers behind the wheel. That will achieve our most important goal, which is to make Michigan's roads safer for all

Pay to play



Pay to play high school sports is always considered when administrators look for ways to cut expenses to meet tight budgets.

It was a topic for discussion in today's financial crunch at Cass City Schools and was also discussed when the district had trouble balancing its budget in previous lean years. In previous years it didn't require a

long look by school board members to decide that pay to play was not one of the budget solving answers.
I was reminded of this issue when

the Detroit News published the results of a survey conducted among 101 Southeast Michigan schools. Among these schools, 57 percent charge and 43 percent do not.

One of the arguments used against fees to play is that the savings were not great enough to dent the overall financial problems. But in the listings of the News survey big city districts-Detroit, East Detroit, Ferndale, River Rouge, etc. had no fees - while many schools in the high income metro area

charged kids to play.
It goes without saying that families with incomes of \$100,000 plus don't need to scrape to pay a fee like families with a quarter or half that much

While it's impossible to verify, another reason for not imposing fees might well be the role that high school sports teams play in the smaller com-

munities. There are no divided loyalties created when 2 or more schools are in the same district.

Inevitably, for some paying a fee to participate is simply not worth

A bigger problem is what happens if the student pays to play and he's not good enough to get significant playing time? The doting parent has always been one of the problems that coaches dread, even without a playing fee. When they pay many parents feel even stronger that the money earns the right to play.

It's not inevitable, but the chances are good that the current shortage of coaches would be exacerbated.

Especially in small towns when disgruntled parents know where you live and often see you on the street. Pay to not play is a guaranteed loser in Cass City and most other area small

## Flu shots available

Starting today (Wednesday) the Tuscola County Health Department will offer flu shots for adults on a walkin basis from 8:30 to 11 a.m. and 1 to 3

It will be the first of 4 vaccination clinics offered in October. Others are slated Friday, Oct. 19, Wednesday, Oct. 24, and Friday, Oct. 26.

Children's flu shots will be offered by appointment only by calling 989-673-8114. The price of the vaccine is \$25 and the department will bill Medicare Part B or Medicaid for adults or Medicaid or private insurance for children. Authorities point out that persons enrolled in Medicare Health Plan should go to their doctor's office for vaccination, as the cost may not be covered if received at the health department.

There are ample supplies of vaccine this year and in addition to the shots offered at the health department, they are available at Hills and Dales General Hospital, from most local physicians and at Coach Light Pharmacy.

The health department notes that new this year is a pediatric 2-dose regulation. Children 2 months through 8 years old who received one dose in their first year of vaccination should receive 2 doses in their second season of vaccination.

Worth repeating are precautions that help avoid the flu.

•Avoid close contact with people who are sick. When you are sick avoid becoming close to others.

 Stay at home when you are sick. •Cover your mouth and nose with a tissue when coughing or sneezing. It may prevent those around you from getting sick.

·Clean your hands often to help pro-

tect from germs.
•Avoid touching your eyes, nose or mouth. Germs are often spread when a person touches something that is contaminated with germs and then touches his or her eyes, nose or mouth.

The state of Michigan's economy has affected everyone, including teens. But the good news is most teens are able to find jobs, and it is quite difficult.

"It took me almost a year (to get a job at McDonald's)," said Ashley Deel, 17, who had been affected by the economic depression (of sorts) in the state of Michigan. Even though she is a teenager, a minor, and in the care of her parents, finding a job is still difficult, "My sister (had gotten) job...I started

applying...online...paper...and I even know the managers. They don't have enough positions available for all of the people who are applying". She had gotten the job just before last year's school year ended. What Ashley likes about her job is working with people and the fact that McDonald's tries to better the worker's work experience. "I'm not giving up my job anytime soon!"
A new face at Ashley's job is, Drew

Rohlfs, 17. He had previously worked at Subway and switched over to McDonald's within the past 2 weeks. Drew had been trying to get hired there for four months. His jobs before Subway had been: a paper route and Mantey's (a shucking corn job). "I liked the people I served...I liked working with food!" Drew told me of his previous job and he also hopes

his new job incorporates it too.

Cass City Diner, formerly Gaffney's is still a buzz in some talks, because the business is still so new, and a good "hang-out" for some people. The waitresses are very nice and have to juggle, not just work, but also college (or high school), maybe another job, the low pay of being a waitress, and long days and nights.

"It's still hard...even if you're a teenager," said Lauren Brzuchowski, 20, who is attending SVSU and Delta College. She also juggles her job.

She and other teenagers are affected by Michigan's poor economy because Lauren has to drive from Saginaw (where you'd think it would be easy to find a job) to Cass City to work at her job. Lauren is lucky to get tips, although some people in this town tend not to tip any of these diner waitresses fairly, and also has flexible hours to finish any homework d exams, etc.

The waitresses, such as Cassandra Simpson, 17, are only paid \$2.65 per hour so they are really reliant on re-ceiving tips. "You get to interact with people...some will tell you a funnly story...I am a people person and I want to be a pediatrician. will hopefully help her with a career one day.





### 5YEARSAGO

The Cass City Red Hawks continued to roll along undefeated in the Greater Thumb West with an easy win over Valley Lutheran Thursday -32. The Hawks now have the next games at home. Thursday the Hawks meet Bad Axe in a league game and Tuesday the team meets Harbor Beach. Both games will be watched closely. Bad Axe played Cass City to the wire before falling, 41-39, the closest any league team has been to the Hawks this season. This will be the only meeting in the regular season against Harbor Beach, one of the teams in this year's district tourna-

Memphis showed why it is leading the North Central South Thursday by defeating visiting Owen-Gage, 45-32. The Yellowiackets are undefeated in the league and boast a 14-1 record overall. The game was the first of 2 tough challenges in a row for the Bulldogs. The team was to have played Tuesday against league-leading Port Hope. If Owen-Gage is to remain in the chase for the North Central Thumb North title they will have to reverse the results of the first game between the schools. The Blue Stars are leading the league with a 9-3 record. Owen-Gage is at 7-4. A Bulldog victory puts the teams even in the important loss column.

The Ĉass City Red Hawks posted a satisfying win over a well-regarded Sandusky Redskin team Tuesday, 46sprinting to the win with a rally in the final minutes of the first half and the early moments of the third quarter. The Hawks continued the home court domination of visiting squads that started 2 years ago after the loss to Reese, Oct. 5, 2000. Cass City broke out of a 14-all tie with 5 unanswered points keyed by a trey by Sarah Hobbs to lead at the half, 19-14. The Hawks stretched that lead to 8 points in a seesaw third quarter.

### 10 YEARS AGO

When Gary Drabek accepted the position of postmaster in Cass City nearly 4 years ago, he had the opportunity to hire another clerk for the local office. Drabek declined because he figured talk of increasing automation by the postal service would be-come reality soon. He was right. In July, the Cass City Post Office began receiving mail from Saginaw already sorted by route. But the carriers still had to sort the mail in the order of their deliveries before heading out on the road. Typically, the office's 4 rural and 2 city carriers each sort 3 trays of mail. The trays contain 300 to 400 pieces of mail each, and the carriers sort at a rate of at least 18 pieces per minute. Last week, 1,073 pieces of mail were sorted per hour at the Cass City Post Office.

A campaign that spanned 31 years by Stan Beach, a former resident who graduated from Cass City High School in 1953, has finally been successfully concluded. Beach was determined to have Marine Bruce Williams recognized for saving his life while he was a chaplain serving in Vietnam. Navy Captain Beach was wounded in action, his left leg shattered. Williams came to Beach's aid and, disregarding order to take cover. covered him with his armored jacket and flak jacket. Then he protected Beach's head with his own body. Williams was hit in the head and the pair were taken to the hospital by helicopter. The men lost touch and by the time he found the right Bruce Williams (there were 3 men in the unit with the same name), the cutoff date for nominating people for medals and awards had passed. About 2 years ago the nominations were reopened and letters to Sen. John Glenn and Rep. Paul E. Gillmor earned their support and the Navy agreed to a cer-emony recognizing Williams' heroism.

### 25 YEARS AGO

Burning wood has become increas-



ingly popular he last few years as a means of redicing costly heating bills. It has also meant many fires, usually chimney fires, which some times burn thenselves out harmlessly. but sometime result in major damage, and it may eventually result in increased insurance rates. Higher rates haven't happened yet, but they may, according to tiree local insurance agents. "I imagine there will come a day when insurance companies say, We have to sucharge those policies (of homeowners who burn wood)' said Alan Klcoof Harris-Hampshire Agency. Whether they might, explained Ed Doer of Doerr Insurance Agency, ultimaely depends on the number of claims that result from wood burning caused fires. Bob Copeland of Copeland and Gornowicz Insurance Agercy thinks rates will eventually increase "unless we can cut down on therate of fires we have

been having.' It wasn't too long ago that the Cass City School Board met once a month and once in a great while held a special meeting. The government makes more money than the dealer does on the sale of an average gallon of gasoline. The recent school woes changed all that. There's been a meeting about every veek recently. Plans for this week off have been followed, but the board will make it up next week when there will be two special meetings. The first is Monday when goals will be discussed, the second is Thursday. Notelling how long the first will last but the second should be short and sweet. That's because it was called to open bids for the

opening of tax anticipation notes showing how much lenders will charge to borrow money. The meeting is required by law and shouldn't last more than a few minutes. (From Rabbit Tracks)







## Brown addresses foreclosure epidemic

Stepping in where the federal government has failed to act, State Representative Terry Brown today announced an aggressive state House plan to fight the epidemic of foreclosures by establishing programs to allow certain homeowners struggling with risky adjustable-rate mortgages (ARMs) to refinance and secure a fixed-rate loan instead. The plan is part of a broader approach that Brown and his colleagues are taking to get Michigan back on the road to economic recovery.

"More and more working families in the Thumb are losing their homes because they just can't keep up with the payments on their adjustable-rate mortgages," Brown "Homeowners who are stuck with ARMs have few options, and the current system pushes them right into foreclosure. This plan allows struggling homeowners to put the brakes on that process and restructure their finances to make their mortgage payments more reasonable and more

The plan would allow certain borrowers to secure a fixed-rated loan through the Michigan State Housing Development Authority (MSHDA). The loans are financed through the sale of tax-exempt and taxable bonds and notes to private investors - not from state tax revenues

Eligible borrowers fall into 2 categories: those whose housing expenses are increasing dramatically due to their adjustable-rate mortgage, and those who have missed payments on their ARMS and are unable to work out an agreement with their lender to avoid a foreclosure. Both types of borrowers would have to meet income and credit score requirements.

Michigan ranks fourth in the nation in foreclosures, according to the latest figures from RealtyTrac, an online foreclosure firm, and second in the nation when it comes to the percentage of mortgage delinquencies that are subprime adjustable-rate mort-gage delinquencies, according to MŠHDA

Subprime borrowers who are steered by brokers into signing adjustablerate mortgages are often not informed of the inherent risks nor given the option of fixed-rate loans

Some lenders and brokers write

loans they know borrowers cannot afford for the sole purpose of pocketing the fees. Federal home-loan agencies Fannie Mae and Freddie Mac estimate that 30 to 50 percent of all borrowers with subprime loans could have qualified for more affordable mortgages.

This plan builds on the Michigan Home Loan Protection Act, a House legislative package announced this summer. The Michigan Home Loan Protection Act will:

Ban predatory lending practices, such as encouraging borrowers to default.

\* Protect consumers from being steered toward high-cost loans when they would otherwise qualify for a traditional loan.

Give aggrieved homeowners legal recourse so they can independently enforce these consumer protections against unscrupulous lenders.

Brown pointed out that foreclosures in Tuscola and Huron counties have just about doubled over the past few years, according to each county's register of deeds. As of Wednesday, there had been 214 foreclosures this year in Tuscola and 68 in Huron.

"We cannot allow the devastating experience of losing one's home to keep happening to families in the Thumb and throughout Michigan,' Brown said. "We need the twopronged approach that this legislation provides: first, it prevents prospective homebuyers from being taken advantage of by unscrupulous Second, it helps lenders. homeowners who are struggling under adjustable-rate mortgages find a way to meet their responsibilities by switching to a more reasonable fixedrate loan. This plan will go a long way toward fighting the foreclosure epidemic that is threatening our families, our communities and our state's economic recovery."

Brown also announced that he will hold a town hall meeting to provide residents with information and resources to help them avoid foreclosure. The meeting on avoiding foreclosure, which will feature a guest speaker from MSHDA, will take place at 6:30 p.m. Monday, Nov. 5, at Arbela Township Hall near Millington. Everyone is welcome to attend







### Cass City High School offers educators certificate program

Teachers in the Cass City Public Schools and the surrounding area can now enhance their technological expertise through a graduate certificate program in educational technology being offered locally through a partnership with Michigan State Uni-

The special curriculum, developed and administered by the MSU College of Education's Educational Technology Certificate Program, is targeted at Michigan's in-service K-12 teachers who need to earn graduate credits toward licensure renewal or who seek to learn new ways that technology can enhance and support the learning process

The goal of the 3-course, 9-credit class is to prepare educators to use and integrate technology into today's educational settings more efficiently and effectively.

Lyle Severance, technology director at the Cass City Public Schools, announced the program will be of-fered at the Cass City High School Media Center beginning Oct. 19. Teachers may now also take it online, offering them even more flexibility for utilizing technology resources for their own teaching and for student learning in the classroom.

This educational outreach effort by MSU has enabled more than 2,500 teachers statewide to participate in the program at the local level, and the program continues to grow every year, according to organizers.

"For the purpose of educational technology in Michigan, there is but

one single goal: prepare Michigan students to become productive citizens in a global society," said Dr. Joseph Codde, director of the Educational Technology Certificate Program, which began in 1995. "Technology has become an integral part of our global society. Therefore, teachers must consider how they integrate technology to achieve that

The educational technology courses focus on how to use technology as a tool for teaching and learning, and as a manager of instruction. Participants can begin the cer-tificate without extensive knowledge of technology beforehand. Among other topics, participants learn to use the Internet and general productivity software as resources for classroom learning. In addition, a strong focus is put on using technology as a tool that students can learn "with" and not just "from."

Examples of this include instruction in the use of Web 2.0 technologies

and web-based collaboration tools. Teachers will learn how to create a blog, how to edit a wiki and how to create a podcast, along with learning about other web-based collaboration tools such as Google Apps and Zoho Online Office.

"By offering the program locally," Severance said, "teachers are able to learn in their own environments, among their peers, without traveling to East Lansing"

"The program is based upon authentic work from the participants' own classrooms," said Codde. "Each person brings actual activities and uses them as the focus of their assignments. The work is also specific to the participant's grade and/or discipline, and is done using the same computers the teachers are already using or will likely be using once they complete the program."

"It's also a great way to earn 9 graduate credits required for renewing a teaching license," Severance said. The MSU program now also offers

teachers the opportunity to earn their Educational Technology (NP) Endorsements and even a master's degree in Educational Technology. These options are available through attendance at a series of classes or online, allowing educators the ability to learn from the comfort of their own home. Teachers must complete the initial three-course, nine-credit program, however, before moving on to these advanced programs.

At Campbell Elementary savings are \$7,537 for electricity, \$8,295 for gas and \$1,387 for water.

In the early childhood center electricity savings are \$1,750 and gas savings, \$615.

Total savings in all buildings are \$83,491.

The new lights in all buildings furnish more light with 2-bulb fixtures than previous lights did with 4-bulb fixtures. Coupled with the energy saving lights is the computer system that automatically turns out lights when the room is vacant.

Water costs are reduced because of new fixtures that greatly reduce the amount needed to flush toilets

New boilers in Campbell Elementary and the high school add to the fuel savings.


