911 surcharge will up cell phone bills

Cellular phone users will have to dig a bit deeper to pay their bills this summer following the Michigan Public Service Commission's (MPSC) approval last week of 911 surcharges for cell phones users in 68 counties.

In 46 of those counties, including Tuscola, Huron and Sanilac, regulators approved a lower rate than requested by the counties.

Previously, counties were allowed to impose 911 fees only on landlines. But under the new rules, which go into effect in July, wireless phone users will pay surcharges ranging from 18 cents to \$2.51 a month, depending on where they live. Landline users will pay the same fees, but the amounts have been reduced because cell phone users will now be paying their fair share.

The action stems from a new state law that also lowered the state's 29cent 911 surcharge on cell phone bills, with landline users now paying that charge as well.

The ability to charge cell phone us-

ers will result in a decrease of more than 50 percent in landline surcharges in many cases, because both cell phone and landlines will now be charged. The 2008 fees approved by the MPSC range from 32 cents to

Tuscola County Central Dispatch Director Bob Klenk acknowledged that charging cell phone users for 911 service is a fair approach. "That's one thing this did accomplish - it's an equitable sharing of the cost for 911," he said.

However, Klenk disagrees with the method state officials used to determine the new surcharges.

'We had applied for (a surcharge of) \$2.09," said Klenk, who noted the approved rate is \$1.80 per month. "We're a little disheartened the MPSC didn't take the Emergency Telephone Committee's recommendation.

Klenk explained that the state's formula to determine the new surcharges involved multiplying each county's population by the estimated number of telephone devices. "Tuscola really doesn't fit into that formula," he added, noting Tuscola County's new surcharge of \$1.80 was based on an estimate of 54,187 phone devices, including nearly 22,000 landlines. Klenk estimates, however, that the number of devices totals just under 47,000, \$2.09 a month.

The state estimates the surcharge

coming year than it did in 2007.

In other Thumb counties, Huron County charged \$3.61 a month for 911 service in 2007 and generated \$715,618, according to state figures, which estimate Huron will generate \$734,940 in 2008 based on a monthly surcharge of \$1.87. Sanilac County, meanwhile, generated \$206,000 in 2007 with a surcharge of 80 cents, compared to projected 2008 revenue of \$211,562 with a 44-cent monthly surcharge.

The PSC limited the total extra 911 revenue to be collected to no more than 2.7 percent higher than what counties collected last year.

Statistics show that cell phones outnumber landlines in Michigan today. Klenk said he's seen the same trend in Tuscola County, where 49 percent of 911 calls in 2007 were made from cell phones. "It's been steadily increasing from year to year," he said.

In double homicide

Murder suspect due in court

Ubly resident Mark John Soule, 49, faces a preliminary examination next week in Sanilac County District Court on a pair of open murder charges stemming from the deaths of his girlfriend and her daughter early last week.

The charges carry a maximum penalty of life in prison. Bond in the case has been set at \$750,000 cash.

Soule was arraigned in Sanilac County District Court Tuesday, March 11, 2 days after he allegedly murdered the victims at the residence Soule shared with his girlfriend, Janice Boal, 50. The other victim was identified as Boal's 30-year-old daughter, Stacey Ann Kredell of Bad Axe.

According to Sanilac County Undersheriff Garry Biniecki, Soule called Sanilac County Central Dispatch Monday, March 10, at 7:20 a.m. and reported that he had killed 2 people. Deputies responded to the scene in the 1300 block of Charleston Road in Austin Township.

"Investigators located 2 deceased female victims inside a pole building," Biniecki said. "Based on information at the scene, the caller was taken into custody as a prime suspect in what investigators believed to be a double homicide.

An autopsy conducted March 11 confirmed that both Boal and Kredell died as a result of fatal stab wounds from a sharp cutting instrument. The



The investigation into the murders is continuing, according to Biniecki.

Second suspect enters plea in store break-in

A second Tuscola County teen has pleaded guilty on charges stemming from the burglary of a Gagetown business in January.

Kenneth M. Brown, 18, of Gagetown, entered the pleas during his appearance last week in Tuscola County Circuit Court.

Brown pleaded guilty to breaking and entering a building with intent to commit larceny, a 10-year felony; conspiracy to commit breaking and entering, also a felony punishable by up to 10 years in prison and a \$10,000 fine; and larceny of property valued at \$200 to \$1,000, a misdemeanor with a maximum penalty of 4 years in prison and/or a \$5,000 fine. Charges of larceny in a building and conspiracy will be dismissed as part of a plea agree-

A pre-sentence investigation was ordered in the case and bond was continued at \$5,000. Sentencing is to be scheduled.

Brown was among 5 teens suspected of breaking into the Allway Stop Market by breaking a window at the business during the early morning hours of Jan. 22. Business owner Don Montreuil, alerted at his home by an alarm at the store, arrived in time to catch and detain one of the suspects until police could arrive. The other suspects fled, dropping what Montreuil described as an estimated \$700 worth of merchandise, including tobacco products and alcohol.

Investigators have since identified all of the suspects, 2 of whom are minors. All reside in the Owendale and Gagetown communities.

One of the suspects, Nathan E. Minkler, 18, entered pleas of guilty in circuit court last month to charges of breaking and entering a building with intent to commit larceny, conspiracy, and a reduced charged of larceny involving property valued at less than \$22. He is awaiting sentencing.

The break-in wasn't the first for Montreuil, who reported he's been hit before by suspects using the same method of entering his Gagetown business (breaking a side window) and making off with several hundred dollars worth of cigarettes and beer.

Then I read about a study of name brand medications versus generic versions of the same drug. It is well: known that many folks get better results from name brands than from generics, even though the active ingredient and the dosage are the same Medical science would say this shouldn't happen, but it does.

The common explanation is that inactive ingredients are different in the brand names and the generics. There's something there that doesn't show up on the label. A secret confin ponent, so to speak.

To test this hypothesis researchers split a large group of subjects into two sets. One group was told they were getting the expensive brand name drugs, while the others received the cheap generics.

Low and behold, more than 80 percent of those receiving the expensive drugs said they felt better afterwards. Only 60 percent of the group receiving the cheaper drugs said they felt.

There was one small catch in this study, also. Both groups actually got a placebo — with no active ingredient whatsoever.

What does this tell us about humannature? I can't say for sure, but if I was a doctor I would surely keep some placebos on hand.

Now I know that this is nothing but day dreaming, waiting for the snow to melt, and has absolutely nothing to do with reality.

What is real, according to a story in the Bay City Times that reviewed the announcement by an environmental protection agency that Bad Axe should repay the Agency \$262,440 that was misspent building a drinking water plant and piping it to the village from Port Austin. Users are paying \$27 a month for the arsenic removal and are expected to do so for 40 years.

Cass City was one of the first to change its system to eliminate arsenic to meet EPA demands and Peter Cristiano says that the new system's average cost per user is \$52.15 per month. That includes garbage removal that costs some \$8 per month, sewer charges, the new building and the cost of updating all peripheral equipment.

Although there has been a steady increase in the cost of water, Cass City still is either the lowest or among

Some of the most beloved children's books of all time were written by Dr. Seuss. As a child, most adults can remember their parents tucking them in and reading "Green Eggs and Ham", "The Lorax", or "The Cat in the Hat". But most people don't know the tale of the man who actually wrote these

The real name of this author is Theodor ("Ted") Seuss Geisel. Seuss was his mother's maiden name and also the name that he used with all of his books. The real question is why he chose to go by the name of Dr. Seuss for all of his books instead of his original name. An answer is given by looking at his life when he went to Dartmouth College and worked hard to become the editor in chief of the Jack-O-Lantern, Dartmouth's humor magazine. Yet he continued to contribute to this magazine by merely signing his name as "Seuss", thereby creating the beginning of an everlasting legacy.

If you haven't read the book, here's a guideline to the movie. The famous lines in this movie are that 'a person's a person, no matter how small'. Just by watching this movie and seeing these lines come to life, it can truly make an impact in your heart or mind. Also by learning about the life of Theodore Seuss Geisel, you can understand why he was.

While his books are amazing, the pictures that go along with them are mesmerizing. This artist admitted that he never really learned to draw, but obviously had the raw talent to achieve the high standards of each book he chose to write. His school notebooks often included bizarre creatures that framed sporadic notes he had taken in class. While his work is very distinct to adults and children, his editor for the last 11 years of his life admits that he despised when his writing and illustrations were referred to as "whimsical."

While most might suppose that his books were his greatest accomplishments, he thought that his greatest work wasn't a particular book or lavish gardens, but the Lion Wading Pool at Wild Animal Park in San Diego, which he donated in 1973

Dr. Seuss died September 24, 1991, and ever since then over 200 million copies of his books have found homes all around the world. Sales have continued to climb at more than 22 million since 1991.

These statistics are proof that even though a great author has become deceased, people all over the world can still appreciate the greatness of legendary books.



Green leading charge to boost jobs in the county

A former county commissioner and state representative will lead the charge in an innovative project designed to rebuild Tuscola County's economy and create jobs by encouraging and assisting new business owners.

Mike Green was recently named the Tuscola Enterprise facilitator and will serve the program by providing business counseling services and assisting residents in navigating the intimidating process of starting a small business.

The Mayville resident's resume includes a stint as a member of the Tuscola County Board of Commissioners from 1985 through 1992, and he served as state representative for District 84 from 1995 through 2000. Green brings varied experience to the position; he has been a farmer, retired from General Motors, and served on many county boards and commissions over the years. He is also a

County Green's selection for the newly created position stems from dozens of meetings involving several county leaders over the past 2 1/2 years. The focus of their discussions has been approaches to "Rebuild Tuscola County Through Entrepreneurship". Specifically, the group made a call to utilize an ombudsman to provide busi-

nesses with counseling services.
While the Tuscola County Economic Development Corporation (EDC) partially serves this function as a Small Business and Technology Development Center, limited time and resources clearly do not meet the demands of this sector of economic development, according to a statement released by the Tuscola Enterprise Public Relations Committee, which noted the need for additional work in entrepreneurial development was reinforced by an extensive study completed in 2006 by the Community Assessment Team of MSU Extension.

Through a number of statewide conferences, county leaders decided to utilize the Enterprise Facilitation model developed by Dr. Ernesto Sirolli more than 20 years ago.

Green, as executive director of Rural Partners of Michigan, was the first county resident to hear Sirolli speak. "I attended a Rural Partners annual conference when I heard about the Sirolli model," Green said. "My wife and I drove to Buffalo to hear (him) speak. I was so impressed that I approached county officials about inviting him to Tuscola County. I never dreamed I would be the one to implement the program in our area. I am excited about completing the training and working with my first client."

County officials explained that the Sirolli model helps communities to capture the passion, imagination and resources of its people" to create and expand successful enterprises and local jobs.

Tuscola County will be the first area east of the Mississippi River to host an Enterprise Facilitation project and could serve as an example and pilot for more projects in Michigan as well as on the East Coast.

As the local facilitator, Green was nired by and will work with a community-based board of management to provide free, confidential business management and networking advice to aspiring entrepreneurs as well as existing business owners. The local board of management was formed in November 2007 and is composed of more than 50 volunteer civic and com-

munity leaders. Green, one of 57 applicants for the

job, said the Tuscola Enterprise program will emphasize a client-driven approach, meaning that all the motivation and drive has to come from the person who wants to own their own business.

Although Green is already well known in the county, he will receive referrals from the local board of management once he completes his Sirolli training in early April. Based on those referrals and a limited amount of other publicity, prospective business owners can approach him with their dreams and ideas - some very vague and others well defined.

"Working without a pre-defined 'playbook', Mike's job is to get to know something about the person, determine where they are trying to go and where they are along the road, and then help them objectively assess their passion and their idea," board of management members explained. "If the client feels that the results of that assessment are positive, Mike will support them in any way possible as they try to shape their dream into an operational business setting on a sound foundation." Officials emphasized that all services will be free, and that they will strive to obtain funding to pay for Green's

work, his expenses and basic administrative costs.

Tuscola County and communities within the county along with residents and businesses provide a portion of the funding. Other sources to-date have included the U.S. Department of Agriculture, MSU and regional corporations.

The Sirolli program will work handin-hand with the Tuscola County EDC, according to Tuscola County Board of Commissioners Chairman Jerry Peterson, who said the 2 entities will enhance each other's efforts.

"Businesses and residents need to come together to financially support the project for it to be successful," Peterson added. "We must be willing to invest in ourselves to turn this dramatic decline around. "We must take responsibility and solve them together as a community."



Originally from the Gagetown area, Wallace's entry into municipal government came somewhat naturally, as her dad, the late Bob Osborn, served as supervisor in Huron County's Grant Township for many years. He later served as Huron County register of deeds for 18 years.

"So I grew up with this," Wallace said. "The sad thing is, he died in May of '82 and I started (as Elkland Township) clerk in November of '82, so he didn't get to know that I followed in his footsteps.

Wallace was initially appointed to complete the final 2 years of then-Clerk Carol Ware's 4-year term. Wallace was elected to her first full term in 1984. "And that election - I'll tell you - that was a Reagan election,

and I had no idea how big a presidential election would be," said Wallace, who recalled she didn't know at the time that absentee ballots could be counted early on election day as long as the ballots were sequestered. The ballots weren't tallied until after the election, and a day that began at 6 a.m. didn't end until 4 a.m. the next day, when Wallace delivered the re-

sults to the county courthouse. "I

learned the hard way," she added.

Wallace described the job of clerk as both satisfying and trying at times. The average workweek is 20 hours, she said, but there are weeks when you put in 60 hours. "And there's always phone calls, there's always something that pertains to township (business). "It's always like you're on call, because you get phone calls anytime, and it's a zoo at election time.

"Working with the public is one of the things I really enjoy," Wallace said, adding one of her favorite activities in the past was helping senior citizens fill out homestead exemption forms at the fire hall. She was able to complete many of her duties at her residence, however. "For me, it worked out well because my kids were young, and I could work out of

my office at home." Wallace and her husband, Dick, who retired from Chemical Bank 12 years ago, have 2 grown sons, Tom, a banker in Mount Pleasant, and Steve. who works as a chef in Phoenix, Ariz. They also have 6 grandchildren.

Wallace said elections - and there could be 5 in all this year should Democrats manage to conduct a "doover" of the presidential primary are her least favorite part of the job. "I have to haul everything, I mean everything we have, down from the fire hall and from here to the VFW hall," she explained. "We rent a U-

Haul now.' On the other hand, working with the voters has been enjoyable, according to the clerk, who said many of her duties are routine, but important just the same. One aspect of the job Wallace won't miss is having to be available for each election, and for regular and/or special meetings each month. "It does tie you down," she said.

Wallace figures she won't have any trouble keeping busy in retirement. given her membership in the Tom Thumb Singers and her time volunteering with the Friends of the Thumb Octagon Barn. She's also very active in the First Presbyterian Church in Cass City, where she's served as treasurer for 40 years. "When I get a job, I just don't know enough to get

out of it," she joked. Township clerks like Wallace are unsung heroes, according to Tuscola County Clerk Margie White-Cormier.

"They're hardworking people, they do what they have to do, in spite of the changes - all of the changes (in state and federal rules and regulations), and without any extra pay in most cases. They do it because it's the right thing to do for the benefit of the voters," said White-Cormier, who cited the election consolidation law enacted in 2005 as an example. Wallace stepped up and organized the handling of school elections, she

"We're losing a good one there," White-Cormier added, referring to Wallace. "I'm going to miss her.


