

Fuel prices hammering area farmers

Some people can make adjustments to deal with the rising cost of fuel. Unfortunately for farmers, it's hard to make cutbacks.

"You can't make many changes," life-long farmer Roger Root said. "When you have to fill up your trac-tor, you have to fill it up. Can't use anything else."

Fuel prices hurt farmers because they affect everything. "Just about everything they do uses fuel," said Dave Pratt, agriculture agent at the Tuscola County Michigan State University Extension Office. Because fuel prices have gone up, so have the prices of fertilizer, herbicides and pesticides. Fuel is needed to create these things, Pratt said.

Arthur Severance, a farmer in Sanilac County's Evergreen Township, said fertilizer prices have gone up drastically. "Starter fertilizer right now is about \$430 per ton. In 2007, it was \$326 per ton. Starter fertilizer for soy beans is \$551 a ton and was \$294 last year."

Severance has been farming his entire life. He said he thinks that the increase in fuel and fertilizer prices will cause farmers to cut down on fer-

rector, the price of equipment and repair has also inflated in part due to fuel cost. "Increasing energy cost ripples through everything they do," he said.

Severance agreed. "I just bought some parts, I'm sure it (fuel) affects those prices. It's not necessarily the fuel costs that are the biggest problem, though. It's what fuel will do to other expenses and commodities we need. It's going to make everything more expensive.

Dennis Stein, farm management agent for the Tuscola County MSU Extension Office, pointed out that different crops have different costs. "Wheat prices are at about a \$60 per acre increase from last year," he said. Nitrogen, which is used in fertilizer, has gone up about \$45 an acre.

"The cost of pesticides and fertilizer is getting to be a real problem," Root said. Pratt added that the cost of fertilizer has probably tripled in the last year and a half.

However, though the fuel prices can put a major strain on the agriculture business, a clear positive is that commodity prices are also going up. "The good news is that commodity prices have increased," Pratt said. "Corn, soybeans and wheat are good crops right now."

The Owen-Gage Board of Education, during a rescheduled monthly meeting Thursday, voted to endorse the C-PS School District's position. That position, Owen-Gage School Supt. Dana Compton explained, is that Memphis' action was unilateral, arbitrary and inappropriate. "And, they (C-PS) felt if they (Memphis) are going to be part of the NCTL, they need to be part of the NCTL for junior high and high school both," he said.

Vicki Scasny will be the first to admit that when it comes to even the most basic automotive maintenance task or repair, she used to be like a deer caught in the headlights. Not anymore.

Scasny, 17, just completed her junior year at Cass City High School as well as her first year in the Autobody Technology program at the Tuscola Technology Center in Caro. Granted, in terms of gender, she was literally in a class by herself at the tech center, where she was the only female in a class of 27 students at the beginning of the year.

But Scasny excelled in the course and worked to fit in with her male counterparts. She also caught the attention of officials at the Michigan Department of Education.

Scasny is one of 34 students from

across the state who were recently honored with "Breaking Traditions" awards for being successful in career and technical education program areas that are considered non-traditional for their gender.

"These students are breaking tradition and leading the way in the 21st century global economy," Gov. Jen-nifer M. Granholm said. "Michigan's future depends on providing all students with a quality education that helps prepare them for college, the workplace and beyond."

Added state Supt. of Public Instruction Mike Flanagan, "These outstanding students are preparing themselves to enter a career that will benefit them individually and benefit Michigan by increasing diversity in our state's workforce. By their determination and dedication to pursuing careers in an area non-traditional for their gender, they are role models for peers who may be considering such

The Haire Net Smoking ban with casino exemption?

Officially it's a battle between smokers and non-smokers, but actually it's a battle for voter approval between the Republicans and Democrats. On the face of it, there are more arrows in the state Senate quivers than in the House's. What the Senate, led by the Republicans, has passed is a public no smoking ban without exceptions. What the Democrats propose is no smoking with wholesale exceptions to allow smoking in cigar shops, cigar bars, bingo halls and race tracks. It also exempts the 3 Detroit casinos.

There is no longer a doubt that second hand smoke is a health hazard. It has made it easier for restaurants to voluntarily ban smoking. Smoking bans are in effect at about a third of Michigan restaurants.

The House approved, 65-39, a smoking ban with exceptions. That won't fly in the Senate, which has already refused a bill that included excep-

"The ceremony is an opportunity for the residents of Cass City and surrounding areas to replace flags, no longer fit for public display, in a patriotic and highly dignified manner," explained Debra L. Kranz, event cosponsor. "The flags collected will be properly disposed of in honor of the men and women proudly serving in our nation's law enforcement, fire protection and EMT agencies, and in memory of those who have sacrificed their lives in the protection of our local communities and nation." Kranz said the event will begin with a special ceremony recalling what the various elements of the American flag represent, followed by the singing of

"America the Beautiful" and reciting of the Pledge of Allegiance. "The ceremony will then conclude as the unusable flags are destroyed, in the most respectful manner, accompanied by the soft playing of taps in the background and the signing of the "Star Spangled Banner."

U.S. flags are "retired" when they become worn, torn, faded or badly soiled.

"The traditional method of retirement is to incinerate the flag, but this does not mean that the entire flag is dropped into a fire," Kranz explained. "The flag ceases to be a flag when cut into pieces; it is cut with scissors, stripe by stripe. The stripes are removed from the total blue area, and then dismembered, each stripe at time."

Members of Boy Scout Troop 594 will take part in the ceremony by read citing a short phrase to accompany the cutting and handoff of each stripe.

In the aftermath of the Sept. 11 terrorist attacks, American patriotism soared to a level not witnessed since the World War II era. Service picks Cass **River watershed for** "rapid assessment"

Natural Resources Conservation Service of Michigan officials recently announced the selection of the Cass River watershed for completion of a "rapid watershed assessment".

The 580,000-acre watershed covers portions of 6 counties, including Huron, Tuscola, Sanilac and Lapeer.

Rapid watershed assessments provide initial estimates of where conservation practices would best address the concerns of the community, according to Gary Lee, state conservationist for the Natural Resources Conservation Service of Michigan. Using geographic information systems to evaluate land-use concerns, he explained, the assessment will help local leaders set priorities and determine the best course of action to achieve those priorities. The USDA Natural Resources Conservation Service has selected Resource Conservation and Development Coordinator James Hergott, who is stationed in Bay City, to lead this effort at the local level. Hergott has been working for the past year with a group from the Frankenmuth area on issues relating to dam restoration and

recreational issues, including acces trails and greenways.

"This group, while at the outlet end of the watershed, has a good handle on impacts the whole watershed has on their problems and will be looking to develop a watershed management plan in the near future," Hergott said: "The rapid watershed assessment will help us get there.'

A technical committee will be formed to review information gathered, recro ommend additional informational needs and develop an action plan of Information to be gathered will include mapping the land cover, precipitation, land capability, land ownership, population density, and son 2: cial and economic data. The mapping may also include spe-cialized and localized detail. For example, road crossings with high erod ible soil potential may be mapped for the future investigation to determine the ... impact of runoff and sedimentation to area rivers and streams. Sheriff: beware of fraudulent e-mails

Huron County Sheriff Kent D. Tibbits is urging residents to be aware of what he's calling an unusual number of fraudulent e-mails circulating in the area

"These e-mails tell the person who received the message that they are targets of an assassination, and that a close friend has hired the assassin to kill them," Tibbits explained. "The sender of the e-mail goes on to say that for a fee, such as \$300 to \$3,000. the sender will forward the identity of the friend who hired him to kill the person receiving the message.

"This is just another scam taking the place of the Nigerian lottery scam that surfaced years ago," the sheriff added.

Tibbits said his detectives have been in touch with the Federal Bureau of Investigation (FBI), and they report that this scam is not unique to Huron County, but is being circulated around the country.

"The FBI recommends that if you receive such a scam e-mail, then Google the website www.ic3.gov and follow the complaint instructions. This website is a clearinghouse for Internet scams and goes directly to Washington, D.C.," he said.

The stories, written by Chronicle summer intern Emily Davis, will appear regularly this summer and focus on a variety of professionals in the community, from a local contractor to a daycare provider to a veterinarian. The goal of the series is to share with our readers some insight into what it takes to tackle various jobs and why those interviewed decided on their chosen fields.

Being able to work with kids makes Jeff Willis' job worthwhile.

Willis, who has been the principal of Deford Christian Academy for 2 years, started going to Deford Christian Church when he was about 15 or 16 years old. Once the church started the school, Willis transferred and spent his junior and senior year of high school there. "I've always wanted to work here. It's nice being

"I don't do too much with hands-on classroom work," he said. "But I have filled in when necessary.'

Deford Christian Academy is a K-12 school currently with 24 students. A small school gives Willis the chance to see more individual traits of the students. "The exciting part is every kid is different. Every child works at their own schedule.'

Even though Willis has only been the principal of the academy for 2 years, he has seen changes in the students. "Some kids do well in smaller classes. We're not a reform school, but we do give kids a chance to see what works for them. I've seen kids struggle and then catch on as they go through school here."

Willis is very proud of the teachers at the academy and showed respect for teachers in general. "The challenge to be able to affect kids is tremendous. Teachers have to have big hearts. I really appreciate our teach-

To Willis, it seems the biggest dif-

ference between a public and private school would be the size. "I haven't worked in a public school, but I think it would be a bigger scare to deal with hundreds of students."

In his own job, Willis said he gets nervous talking to parents. "It's not hard to deal with parents, but it can be scary. I'm nervous dealing with parents even though I get to know them well. Sometimes, and I am the same way, parents don't like change? He also does not enjoy having to expel students. Though, luckily, he has only had to do it once.

Deford Christian Academy uses the Accelerated Christian Education curriculum and has a high academic quality, Willis said. "Kids rise to chal-lenges really easily," he said.

"My main motivation is to reach of to young people and let them see Christian education. The big thing the kids. Spending time with them what I enjoy most."

At the Track and Field Division 3 finals

SEVERAL HAWKS EARN ALL STATE HONORS

A banner track season, which included the school's first back-to-back regional championship, ended for Cass City over the weekend at the Division 3 state finals in Comstock Park.

Coaches Amy and Scott Cuthrell's Red Hawk thinclads were well represented at the season-ending meet with 10 participates, including 4 who achieved all state honors by finishing among the top 8 athletes in each event.

Senior Chris Zawilinski ended his Cass City career on a high note, placing 5th in the high jump with a leap of 6'3".

"Chris was able to end his senior year with the highest track award. He has played a key role in the track program for 4 years and has been one of the areas' elite high jumpers. He is respected in both the high jump and minning and is going to be greatly missed," Coach Amy Cuthrell said. Also earning all state accolades for the Hawks were juniors Lukas Varney and Austin Babich.

Varney placed 5th in the 1600-meter run with a time of 4:27, while Babich placed 6th in the 200-meter dash at 23:24.

"Lukas cannot ever be underestimated. He was seeded 21st going into the race and finished with a 5th place performance, as a dual sport athlete it seems almost unthinkable to be able to achieve all that he has. He is now a 2-time all state miler with unlimited potential for a successful senior year. The field of athletes in the distance races in division 3 are some of the deepest in the state, making this accomplishment memorable," said Cuthrell. She added, "Austin proved that he has some of the fastest legs in the state. Although not making the finals in the 100-meter dash he was able to showcase his talent in the 200meter. Austin was able to finish 6th, making him a first time all state sprinter for Cass City. As the school record holder in 3 events, we look forward to his return next season."

Cass City's final all state honors were award to Jennica Richards, who placed 8th in the 100-meter hurdles. "Jennica has proven all season that she was the elite in the hurdle events. She advanced through the preliminaries to successfully become an all state hurdler. Her junior year has been nothing short of successful. She now is a school record holder combined with all state status. She works very hard for her successes and as a junior will have another year to showcase her talents.'

Also making the trip to the finals for Cass City were Chris Summersett, Ty Burk, Clark Walsh, Mark Koepf, Josh Inbody and Chris Childs.

Early deer season set this fall

A special early antlerless firearm deer hunting season on private land has been scheduled for Sept. 18-22 in 5 counties of the state's Modified Accredited TB zone and Michigan's Zone 3, which includes most of southern Lower Michigan and most of the Thumb.

'This was the brainchild of the Michigan Department of Natural Resources (DNR) and the Natural Resources Commission," said Rebecca Park, a Michigan Farm Bureau associate legislative counsel. "When it was proposed, Farm Bureau and the Michigan United Conservation Clubs (MUCC) got together to help ensure this new season would be a success. There were some changes from the original proposal, which was to have the hunt in October, but in the end, it was thought best to have it earlier and let the deer settle back down before bow season opens the first of October. That way, it should not have any effect on bow hunter success, which is also an important part of controlling the deer population.

"The fact that different groups from the hunting and farming communities have recognized that there are too many deer in some parts of the state is a major breakthrough," Park said. "It's a great opportunity that I hope Farm Bureau members will use to their advantage and allow responsible hunters on their land."

The advantages - thinning the deer herd, which will in turn lessen crop damage and reduce the risk of disease transmission - come with some conditions.

"This is a private-land only hunt," Park said, "so farmers and landowners need to allow responsible hunters on their land. Everyone wants this hunt to be safe, so a farmer may have stipulations that hunters need to follow. We want this to be a win-win for everyone."

Some Farm Bureau members have already agreed to work cooperatively with the MUCC, Park said.

"On these farms, MUCC will select a 'sponsor hunter' who will help identify a child or disabled veteran who might not otherwise have an opportunity to hunt, and will take the responsibility for training them about safety and hunting protocols," she said. "Normal firearm season regulations will be in place, including the hunter orange requirements and the need for a license.

Theft of anhydrous ammonia poses a risk

Theft of anhydrous ammonia for the production of methamphetamines occurs in Michigan, including the Thumb area, and poses a serious risk for our farmers.

Anhydrous ammonia, which corn growers use to supply nitrogen to their corn crop, is a key ingredient in methamphetamine "meth" production. Meth brings unwanted, undesirable criminals into growers' fields and on their farms.

"The link between the manufacturing of meth and corn production is certainly not one most people would immediately make," said Jody Pollok-Newsom, Corn Marketing Program of Michigan (CMPM) executive director. "However, since the link does exist, we are asking our growers to keep a close eye on their nurse tanks and to immediately report any suspicious activity to the proper authorities or the meth tip line, 1-866-METH-TIP." In response to the growing problem of anhydrous ammonia theft, the Michigan Commission of Agriculture established Anhydrous Ammonia Safety and Security Practices (AASPs) in 2006. Sellers and end users of anhydrous ammonia who are in compliance with these practices will have liability protection in the event of a theft. Handlers must implement at least 2 of the following to comply with the AASPs: a. Storage in a tank that is properly equipped with a functioning tank or valve lock that is used at all times except when the seller or end user is taking anhydrous ammonia from the tank or filling the tank. b. Storage with a substance added to the anhydrous ammonia that is or that contains a dye that will, on release from the container that holds the anhydrous ammonia, stain objects that it comes in contact with. including skin and clothing, in a highly visible manner. The tank shall have decal stickers or other signage indicating the dye is present. c. Nurse tank storage with an inhibitor that will, when used in the illegal production of methamphetamine, reduce the purity or usability of the drug. d. Security cameras or other video surveillance equipment with recording capability that provides for the identification of trespassers and other persons on the property within the vicinity of the storage tank(s).

g. Nurse tank stewardship that includes all of the following: removing tank hoses when not in use, parking tanks downwind of sensitive areas; not leaving tanks sitting in a field overnight, and not keeping full tanks on site any longer than absolutely necessary.

Makers of meth have been known to steal small quantities of anhydrous ammonia using plastic gas cans, propane tanks, or other crude and elementary containers, but they have also been known to try to steal complete tanks. This is especially troug bling for officials this time of year, as anhydrous ammonia is readily avails able since growers are getting into the fields for spring planting.

Jay Drozd, CMPM secretary and a corn grower from Allegan, has experienced anhydrous ammonia theft on his farm. "On-farm anhydrous ammor nia tanks have been a prime target of

Growers are cautioned to be careful and are encouraged to call the tollfree, anonymous hotline if they suspect any meth activity on their farm," he said.

"The job of Michigan farmers to produce our food, feed and fuel is way too important to take any chances, when it comes to meth production and the stealing of anhydrous ammonia," said Pollok-Newsom. "By partnering with other agricultural or ganizations and the Michigan State Police, we can help spread the message to farmers that this continues to be a very dangerous problem in Michigan."

Home repairs focus of grant money

State Senator Jim Barcia (D-Bay City) last week lauded \$455,000 in Michigan State Housing and Development Authority (MISHDA) grants awarded to Sanilac, Bay/Arenac and Huron counties.

Look for con artists

DTE Energy and its Detroit Edison and MichCon subsidiaries are warning customers to look out for con artists posing as utility workers in order to gain access to homes and personal property. These impostors frequently strike in the spring as the weather warms up. They often prey upon the elderly.

"Unfortunately, there are unscrupulous people out there who may pose as Detroit Edison and MichCon employees to take advantage of our customers," said Michael Lynch, DTE Energy's director of corporate security. "We urge customers to be cautious to prevent these criminals from entering their homes."

One common scam involves thieves posing as utility employees, asking the homeowner for payment of an outstanding bill and threatening to shut off service if it's not paid on the spot. Sometimes these thieves work in pairs. One will distract the homeowner while the other searches the house for money and other valuables.

"That's one good thing," Severance added. "The price of soybeans is about \$12 a bushel. A year ago it was about \$5. Corn is about twice what it was a year ago and wheat is also up. The price of commodities is definitely higher and helps offset some costs. However, with agriculture, you don't know if the prices will drop or plummet." Unfortunately, farmers don't set the prices of commodities so it is unsure when things could change. Even with commodity prices going up, the price of fuel is still an issue. "People are going to compare and go for the best prices," Severance

go for the best prices," Severance said. "They may not be as loyal to one dealer as they used to be. The prices have made me a lot more conscientious on how I'm farming." "DTE Energy employees never collect money from customers at their homes or businesses," said Lynch. "If someone comes to your door claiming to be a DTE Energy employee and asks for payment, call the police."

DTE Energy field employees carry photo identification badges that identify them as DTE Energy employees. Customers who are not sure about an employee's identification, or who want to verify the nature of the work to be done at their homes, should call DTE Energy at (800) 477-4747.

"We want customers to know that if they have any questions about someone claiming to represent Detroit Edison or MichCon, they can call us for verification before they open their doors," said Lynch.

It is a felony for people to impersonate public utility workers, whether or not they actually gain entrance to a home and commit a crime.

Lynch said customers should keep the following tips in mind to avoid becoming a victim:

• All Detroit Edison and MichCon employees and contractors carry photo identification badges, and are required to display their badge if asked. Customers are encouraged to ask for identification.

• Do not allow people into your home who claim to offer a Detroit Edison or MichCon refund. DTE Energy employees NEVER deliver cash refunds or rebates to customers' homes. DTE Energy employees also NEVER collect money from customers at their homes.

• Do not pay for tree-trimming work by individuals claiming to be from Detroit Edison or a Detroit Edison contractor. The utility does not charge for line clearance work. Additionally, before tree-trimming crews enter a neighborhood for scheduled line clearance work, customers are notified about the work to be done.
