Foundation giving hit by the economy

Foundation wasn't immune to Michigan's economic woes in 2008, and the organization's distribution figures from 2009 reflect the losses that everyone experienced that year.

However, foundation Executive Director Ken Micklash said Thursday that the foundation has since rebounded.

And, in the process, the organization still managed to pay out thousands of dollars in 2009, although the total is dwarfed by previous years' distributions.

"Though the year was primarily one of regrowth from the economic downturn of 2008, the foundation, in partnership with the 60-plus funds it maintains for the Tuscola County community, did grant over \$30,000 in scholarships and grants," said High School student. Micklash, of Cass City.

Holiday accidents claim 2 in Thumb

Investigators say alcohol and excessive speed appear to have been factors in a fatal crash that claimed the life of a Caro man early last week in Tuscola County's Fairgrove Township.

The accident was one of 2 reported recently by sheriff's deputies in Tuscola and Sanilac counties.

According to Tuscola County Undersheriff Glen Skrent, Tuscola deputies assisted Akron police at the scene of a one-vehicle crash Dec. 26 on Gilford Road.

"The officers found that a vehicle driven by Nicholas Smith, 31 years old, was westbound on Gilford Road Department and Sanilac EMS. near Unionville Road. The vehicle left the roadway and struck some trees, then a house," Skrent reported.

"One subject, Clayton Hunt, 48 years old, from Caro, was ejected and dead at the scene. Smith and a passenger, Donna Pachmeyer, were pinned in and removed by Jaws of local church Life. They were transported to

Covenant Hospital by helicopter." Sanilac County Sheriff's deputies responded to a 2-vehicle rollover traffic accident early last week near the intersection of Wheeler Road and West Sanilac Road (M-46) in Elmer Township.

"Upon arriving on scene, deputies observed an overturned semi tractortrailer and a vehicle in the eastbound ditch," Undersheriff Bradley A. Roff

He said the car involved, a 1999 Nicole Kardell of Sandusky, who was traveling westbound on M-46 when she lost control and spun into the eastbound lane and was struck by the semi tractor-trailer.

"The Saturn spun into the south ditch and caused Kardell to be pinned in the vehicle. The semi. driven by 28-year-old Marcos Fonseca of Marcellus, continued east and overturned on its side at the intersection," Roff said.

Kardell was pronounced dead at the scene after being extracted from the vehicle by Sandusky fire fighters. Fonseca was transported to a Thumb area hospital, where he was treated for non-life threatening injuries.

Cass City Police Chief Craig Haynes identified the suspects as Alexander D. Davis, 17, Cass City, and Derek W. Damm, 18, of Fostoria.

Haynes said citizen tips led police to the teens after investigating the theft of 4 speakers from the First Saturn, was driven by 18-year-old Baptist Church, 6420 Houghton St., Cass City, Nov. 17. The property is valued at a combined \$800, and damage to a door frame in the pastor's office was estimated at \$150,



School board circus must come to end

It isn't difficult to get a round of applause these days at a Cass City Board of Education meeting.

The recipe is simple: criticize the existing school board and administration, or simply imply these folks are just short of being the devil incarnate, and a small contingency of supporters on hand will clap, hoot and holler

One resident recently referred to the district as becoming a laughing stock in the Thumb for its decisions over the past several months.

She was right in some respects, but for many of the wrong reasons, in our

Now, we'll be the first to agree that the present administration and school board could have handled some issues with a more measured response there probably isn't a board of education or administrative staff in Michigan that couldn't honestly say the same about themselves. And there's no doubt personality conflicts have come into play big time when it comes to relations among the administration, teacher's union and some

However, we'd also like to point out a few of the things this administration and school board have accomplished.

How about eliminating an unanticipated \$1.5-million debt 4 years ago? How about securing, with voter approval, \$6.8 million in capital improvement projects without increasing taxes? How about building a modest (compared to experts' recommendations) fund balance of more than \$800,000, even though the state's economy has forced schools to do with much less funding year to year while enrollments continue to shrink and expenses soar?

Where has the applause been for those achievements? For that matter, where have the folks who support Cass City's administration and school board members been on meeting nights?

We can't remember a time recently when it was more unpleasant to serve on the Cass City Board of Education. The members accept no pay but most of them continue to serve for the good of the district as a whole, regardless of the rude (and worse) comments they were subjected to in 2009. Much of that abuse has come from a group of citizens directly affected by cuts — they've lost their job with the district, or they know or are related to someone who has.

Frankly, we don't fault former employees for being bitter. Losing a job after years of service has to be traumatizing at best. We firmly believe, however, that the board's decisions have been motivated by a staunch resolve to keep the district financially viable, and to continue funneling every dollar possible into the classroom.

We think it's ironic that many of those who are first in line to criticize are last in line when it comes to considering running for a board seat themselves. Of course, it isn't an easy job, and most new board members will tell you that there's a serious learning curve when it comes to understanding school finances and working as a group to overcome any issue that gets in the way of educating students.

The challenges are many. For example, school officials have been accused of being less than honest when it comes to just how much money the district has to work with, because the figures keep changing. We wonder if any of the folks making these allegations have kept up with finances at the state level. The fact is, Lansing's projections for school funding have changed virtually on a weekly basis over the past year, and that's after all of Michigan's schools are forced to adopt budgets before they even know how much funding they can depend on from the state in the first

When it comes right down to it, if the Cass City Public Schools is becoming a laughing stock, the administration and board as a whole can't be held accountable alone. Those citizens who have failed to demonstrate simple courtesy and respect during board meetings can share in the blame. A laughing stock? We don't believe the Cass City School District has become that. Yet. But we could be well on our way unless attitudes

Let's face it; the coming year promises to be another monumental challenge financially for schools throughout Michigan, including Cass City, and we're convinced that the board and administration, regardless of who occupies those offices, will be forced to make more, unpleasant decisions

that are bound to affect someone you know. It was said at a recent school board meeting that students in our community are certain to take a lesson or 2 from how school officials are handling various matters in the district.

We agree wholeheartedly. But we also have to ask what sort of lessons our children are learning from citizens who are unhappy with those currently charged with making decisions on behalf of the school. That it's okay to accuse them of being liars, when they back those accusations up with more opinion and emotion than fact? That respect isn't necessary when things don't go your way?

If those are the sorts of lessons our students are learning these days, then yes, the district should be considered a laughing stock. That's true especially if residents who support the district's decisions, or at least the board's and administration's efforts on behalf of the Cass City Public Schools, fail to voice their support in the coming months.

The next school election will be held in the spring, and veteran Trustee Randy Severance has already made it clear he won't seek another term.

We can only hope that those considering running to fill that vacancy will do so for the right reasons — not to bring their own personal agenda with them and further polarize what was once a unified board of education, but to serve the Cass City Public Schools and its students.

European lifestyle she is used to. But there have been some surprises. Cabucak said she was given the impression that school in the United States would be so easy, that she



Retiring chief says 2009 a quiet year for his department

Ron Pawloski won't remember his final year as Elkland Township Fire Chief because 2009 was a particularly busy one for his department. But he'll remember the year nonetheless.

Pawloski will no doubt remember his trip to the fire hall Thursday — his last official day on the job — when he collected his helmet and took his name down from the ranks of active firemen.

"It's going to be hard, I know," commented Pawloski, who ended his tenure after 37 years with the department, including the past 13 years as chief. And in all that time, he can't remember a quieter year than 2009.

"As far as fire runs, this has been the lowest fire run year since I've been chief. We only had 60 actual runs," he said, noting the second lowest year was 2000, when the department responded to 63 alarms. It's been so quiet, Cass City fire fighters were asked to respond to only 3 runs throughout December; 2 were false alarms and the other a reported chimney fire.

Pawloski recalled flooding last February that resulted in his department being called out to assist a motorist whose vehicle was caught in high water. "Other than that, it's been the normal grass and brush fires. There was nothing that really stuck out," he said. "But that's alright. It's been a very light year, and that's good."

Pawloski said he hopes the reduction in calls can be attributed, at least in part, to his department's emphasis during his tenure on fire safety, with local fire fighters inviting youngsters and the community to visit the fire hall and participate in various programs on the topic, and by encouraging everyone to purchase and install smoke alarms.

While Pawloski is now officially retired, he acknowledged it's going to take awhile to get used to not being on-call 24 hours a day, 7 days a week.

"When I see the fire trucks going, it's going to be hard for me not to respond or wonder what's going on," he said.

'It's been an interesting job, a very gratifying job. I'm going to miss it. I will," he added. "It (fire department membership) will be a family forever."






