## New BackPack Program takes aim at pupils' weekend hunger

# **Cuthrell** out as high school football coach

The Cass City Board of Education last week bucked the recommendation of Supt. Ron Wilson and Athletic Director Don Markel to retain Scott Cuthrell as the district's varsity football coach.

contract renewal for Cuthrell.

In the end, trustees Craig Bellew, Sloane Stimpfel and Randy Severance signed the pact, while board President Doug Lautner and trustees Jim Turner, Jim Veneziano and David Osentoski did not.

Wilson then instructed Markel to prepare a contract for the next candidate in line for the post - veteran Cass City JV football Coach Ed Stoutenburg. Board members had not acted on that contract as of press time.

Wilson set a deadline for the trustees after the board failed to sign mittee members pushed to have the Cuthrell's contract during a rescheduled monthly meeting in December. Cuthrell was dismissed as the coach last fall after 10 years on the sidelines. School officials subsequently appointed a 7-member panel and charged it with recommending a new the decision back to Wilson and coach who would take the local pro- Markel. From an initial list of 9 applicants, the committee interviewed 3 finalists, including Cuthrell, and, on a split vote, recommended retaining Cuthrell.

According to Wilson, a majority of board members expressed concern about the football program, which prompted he and Markel to recom-Wilson set a deadline of 2 p.m. mend that Cuthrell be retained, but Friday for board members to sign a make some staffing changes. "That recommendation was questioned, so we went ahead and didn't renew any of the contracts," Wilson said, adding the position was posted and a committee was formed to interview prospective varsity football coaches.

Wilson acknowledged appointing a committee - something that hadn't been done before to recommend the hiring of a coach — turned out to be a poor idea. But he also pointed out that the goal was to involve the community in the decision.

After the committee recommended Cuthrell on a 4-3 vote, some comcommittee disbanded and to start the process over again, but Wilson said that wasn't an option.

During last month's meeting, the board opted to take no action on Cuthrell's contract, in effect kicking

Designed to provide extra support

for kids who typically receive free or reduced priced lunches at school, this innovative program is currently helping families in Tuscola County as well as Saginaw, Lapeer, Genesee and Midland counties.

The project began in 2004 with 50 backpacks in 2 elementary schools. Today, the Food Bank of Eastern Michigan serves nearly 2,500 children in 32 schools.

According to Kathleen Payton, program coordinator for the Food Bank of Eastern Michigan, food provided to students is child-friendly, nonperishable, easily consumed and vitamin fortified, and the backpacks are discreetly distributed to the kids.

The program, Payton said, costs a minimum of \$100 per child for an entire school year, which includes the food, backpack and deliveries. Youngsters love the backpacks, said

### **Canadian** authorities arrest drug suspects

Canadian authorities have made several arrests in connection with the investigation of a major drug trafficking ring that made headlines in the Thumb after federal, state and local agencies foiled the attempted drop-off of \$10 million worth of illicit drugs in Sandusky.

The investigation in the Thumb began Nov. 6 at the Sandusky City Airport and resulted in the arrests a short time later of 2 Canadian men.

According to reports recently published in the Kapuskasing Northern Times, Ontario, the Royal Canadian Mounted Police, several Greater Toronto Area police forces and the Canada Border Services Agency are investigating the ring and have made a total of 7 arrests so far. They say the suspects utilized small aircraft to make several flights from Canada to Michigan, delivering large amounts of Ecstasy and marijuana to small airfields.

The newspaper reported that authorities have seized a small airplane belonging to one of the suspects.

Investigators allege the group dropped off some 100 pounds of marijuana and 300 pounds of Ecstasy pills in Sandusky last November. U.S. federal Please turn to page 8.

### **Schools sign** up for funds to implement new reforms

A number of area school districts, including the Cass City Public Schools, opted last week to sign memorandums of understanding (MOUs) in hopes of cashing in on a share of up to \$400 million in federal "Race to the Top" (RTTT) school reform funding.

School officials still have questions about the funding and the strings that will be attached, as well as what the new education reforms will cost them to implement.

However, those concerns, which prompted the Cass City Board of Education to put off its decision to participate during a rescheduled monthly meeting in December, were largely made moot when Michigan Gov. Jennifer Granholm signed a 5bill legislative package last week that reforms Michigan's education system and allows the state to compete for the federal dollars.

Cass City School Supt. Ron Wilson said he and board President Doug Lautner signed an MOU to participate after reviewing the latest information on the program last week. The board in December authorized the pair to act on its behalf.

In the end, Wilson said, schools are going to be forced to implement the reforms, regardless of whether or not they apply for RTTT money.

### **Backpack Program** deserves our support

Veteran public school teachers will tell you their job involves much more than filling young minds with information.

*Chances are good they'll say being an educator today* involves wearing many hats - teacher, parent, counselor, mentor, and more - in part because of changes in society and family structure over the years. Good teachers, not to mention other school staff members, try to fulfill all of those roles because they understand the importance of making sure their students are ready to learn.

Good schools pay attention to the whole student, including their physical needs, which is why we applaud the Cass City Public Schools for implementing the BackPack Program.

The BackPack Program is a project of the Food Bank of Eastern Michigan that works to reduce child hunger, educate and promote healthy lifestyles. The effort provides children at risk of hunger with a backpack of nutritious food every weekend and on school holidays throughout the school year.

A \$100 donation provides enough food for one child for the entire school year.

If there was ever a need for this sort of program, it's now in Michigan, where hard times have eroded incomes, and unemployment and poverty rates are among the worst in the nation.

According to the latest figures from the Michigan League for Human Services, the state's poverty rate jumped to 17th highest in the county in 2008, up from 23rd in 2005. Roughly one in every 7 Michigan residents lives in poverty - that's about \$22,000 a year or less for a family of 4. Young children are especially affected, with more than 22 percent living in poverty. "These numbers mean that many families are newly poor and many more need help meeting their basic needs," said Sharon Parks, president and CEO of the Michigan League for Human Services. "Unfortunately, it also means that at a time when our resources are strained, services are not easily stretched to help all those who need it."

I get a kick out of TV reporters interviewing Christmas shoppers. Each fall the reporters show up in shopping malls to get a grip on consumer sentiment.

They talk with storekeepers and shoppers to see how everyone feels about all the stuff they're buying. Then we hear about it on the evening news.

Invariably the news people show a lady with her arms full of packages and saying, "Oh, I don't know. The economy is so bad, I don't think we are going to buy much this year.

I always want to shout, "Then, what are you doing in the stores? Get out of the mall. Go home and save some money!" That's kind of old fash-

ioned, I guess. What is consumer confidence if not the ability to buy things we can't afford?

Just recently I read that consumer confidence is so puny these days that people are actually saving



money. There's a vicious rumor for you. The last time folks saved their money was years ago.

Those were the days before credit cards, government grants, and deficit financing. People paid cash, made due, or did without. It all seems sort of quaint now.

Years ago my wife and I stopped at a little grocery in northern California to buy something for lunch. A sign behind the counter said. "Sorry we can not put deli sandwiches on credit." And a sign on the register said, "All grocery accounts must be paid by the 15th of each month."

"Can you imagine someone charging a sandwich?" I asked my wife. "If I couldn't afford a deli sandwich. I think I would find something a little less expensive."

Then, we drove down the road to San Francisco and spent the night. The hotel charged us to park the car, and a cup of coffee cost more than I expected the next morning. Folks were running around like crazy wanting \$20 for this and \$30 for that.

I kept thinking about the plight of the cities and their need for more funds, but I couldn't feel sorry for them. I can't imagine why city people choose to live the way they do.

I just wanted to ask, "Hey, what's the matter with you folks? If you'd move up the road a couple hundred miles you could park your car for nothing - and buy deli sandwiches with the money saved."

The organization's report, issued in late December, found that the median household income in Michigan has fallen below the average of other states. When adjusted for inflation, it declined more than 10 percent since 2001.

The American Recovery and Reinvestment Act alleviated some of the pain with additional food and unemployment benefits assistance, but the fast-rising traditional poverty rates, high unemployment rate and falling incomes are still affecting many families.

"These numbers are not just statistics - they represent real people. We constantly hear from emergency food and shelter providers that demand is rising so fast they can't keep up," said Karen Holcomb-Merrill, director of the league's state fiscal policy project. "For all of us lucky enough to have a job or other means, we need to make sure to donate to local food banks and shelters."

### Childhood poverty, abuse on the rise in state and county

lect continue to rise in Michigan, but child deaths are down dramatically, the latest Kids Count report finds.

The Kids Count in Michigan Data Book 2009, released Tuesday, examines county-level trends in child well-being with a focus on Place Matters - looking at trends in rural, mid-sized and urban counties. The report ranks the 83 counties on 15 measures of child well-being, with No. one ranking being the best in the state.

"The data certainly show a mix of trends both good and bad," said Jane Zehnder-Merrell, a senior research associate at the Michigan League for Human Services and director of the Kids Count in Michigan project. "Michigan's high unemployment and declining family income take a toll on kids' lives, but we are seeing improvements in some areas of health and education.'

'The RTTT ship is about to leave port, and virtually everyone, except the unions, is happy to be on board," Olson said. "Flanagan invited the unions to come along, but he wasn't willing to let them intentionally sink the ship with their childish stall tactics."

Aside from Cass City, several Tuscola County districts, including Kingston, Mayville, Caro. Millington and USA, had signed and filed MOUs last week. Among those, Kingston was the only district whose paperwork included the signature of its union president.

In the Owen-Gage School District, Supt. Dana Compton said school officials have also filed an MOU to participate.

Compton indicated part of the reason for that decision is Flanagan's assurance that schools that change their minds will be allowed to back out. "When that happened, that really left us with an open field to say, he said.

However, Compton figures the education reform measures included in another series of unfunded mandates.

# **Company recalls** vaccine

MedImmune, the maker of the nasal spray monovalent 2009 H1N1 flu vaccine, is recalling about 4.7 million doses of the product because the potency has slightly decreased.

Michigan has received more than 114,000 doses of the vaccine. Health departments, clinics or private doctors' offices across the entire state received the recalled doses, but there are no safety concerns.

While the antigen content of these doses is now below the specification limit for the product, the Centers for Disease Control and Prevention and the Federal Drug Administration are in agreement that the small decrease in potency is unlikely to result in a clinically significant reduction in immune response among persons who have received the vaccine. For this reason, there is no need to revaccinate people who have received vaccine from these batches.

Providers are being asked to return any vaccine that remains unused to the manufacturer from the specified lots. The CDC also notes the following:

•All doses successfully passed prerelease testing for purity, potency and safety

•There is no need to re-administer a dose to those who received vaccine from these batches. The vaccine potency is only slightly below the "specified" range. The vaccine in these batches is still expected to be effective in stimulating a protective response despite this slight reduction in the concentration of antigen.

•All children less than 10 years old should get the recommended 2 doses of H1N1 vaccine approximately a month apart for the optimal immune response. Therefore, children less than 10 years old who have only received one dose of vaccine thus far should still receive a second dose of 2009 H1N1 vaccine.

The Michigan Department of Community Health (MDCH) encourages residents to get the H1N1 vaccine as it is available to everyone in the state. In addition to being vaccinated, residents can help stop the spread of the virus by washing hands thoroughly and often; covering mouths when sneezing or coughing; and staying home from work or school if sick.
