Council approves **\$7,500** purchase Monday night

Village council members in Cass City Monday voted to approve the purchase of a sweeper conveyor system and the sale of a used pickup truck during their regular monthly meeting, the first of 2010.

Highlighting the 35-minute gathering was Public Services Committee member Jenny Zawilinski's request for the expenditure of \$7,540 for a new complete conveyor assembly for the village's 1994 Elgin Sweeper.

"The sweeper is in good condition and this replacement part should give the sweeper another 10 years of being in good condition," said Zawilinski.

Village employee Ed Nizzola will install the new conveyor system on the sweeper, saving the village an estimated \$3,000. Following a unanimous vote, the conveyor system will be purchased from Bell Equipment, Lake Orion, the only supplier of the product according to officials.

Turning to the sale of the village's 1992 Dodge pickup, Budget and Finance Committee member Don Richards recommended the sale, as is, in the amount of \$777 to Cass City resident Steve Meeker.

Before voting to approve Meeker's high offer, Richards stated 2 bids were received, ranging from \$751 to

In other business, the council appointed Mick Kirn to serve as the ex-officio village council representative on the planning board.

Personnel and Public Safety Committee member James Heiser spearheaded Kirn's selection to the Planning Commission Board, effective immediately, saying, "The village manager concurs with this appointment and this appointment is to run concurrently with his term of office on the village council."



As a youngster, Graham recently recalled, her father would take her and the neighbor children to Belle Isle to swim in the Detroit River. Her father worked at Ford Motor Co., but liked Buicks, so that's the kind of car her parents drove. On Sunday evenings, she said, the family would often walk to Sander's and enjoy its famous ice





Cass City youngsters have learned a lesson

Haiti may seem like a million miles away from Cass City, but that hasn't stopped some local residents from stepping up and trying to lend a hand in the wake of the small country's catastrophic earthquake Jan. 12.

The Caribbean island nation was hit by a magnitude 7.0 earthquake. According to Red Cross officials, the quake impacted some 3.5 million people, or a third of the impoverished nation's population.

The disaster was described as one of the worst earthquakes in history, with an estimated 200,000 people dead and 250,000 injured.

Subsequent rescue efforts were hampered by a number of factors: both national and international authorities suffered great losses in the quake, taking out many of the leaders best suited to organize a response; woefully inadequate infrastructure and a near-complete failure in telephone and Internet communications complicated efforts to reach millions of people; fears of looting and violence kept aid groups and governments from moving as quickly as they would have liked; and pre-existing poverty and malnutrition put some at risk even before the quake struck.

Still, hundreds of relief organizations and governments responded by pledging millions of dollars in aid.

And, in tiny Cass City, some folks quickly got together to do their part by organizing an Italian dinner fundraiser prior to Friday night's home basketball game with Vassar to help the relief effort.

Sure, the amount raised in town certainly paled in comparison to the hundreds of thousands of dollars others have contributed. But if every penny counts — and we're certain they do — the local effort was more than worth it.

Perhaps more important was the lesson that effort taught our community's youngest citizens who, time after time, have watched their parents, neighbors and others rally around area residents battling life-threatening diseases or injuries by raising cash to cover medical expenses.

The lesson is an important one: caring for others, nearby or far away, is a big part of what we are as a commu-

It's gratifying to see that the kids — our future leaders — have learned well.

For example, Campbell Elementary School teacher Yvonne Sherman reported that 2 students in her fourth grade class approached her about organizing something for the Haiti relief effort. "One came and asked about a bottled water drive and the other suggested that we collect spare change," she told her fellow school staff members in a note early last week, adding it was decided to pursue the "spare change" idea.

"The money will be collected in buckets on the stage during the lunch time starting Wednesday. The drive will run through next week Wednesday (today)," Sherman said. "I think this is a great opportunity for my students to be involved in giving back."

Sherman was (and is) right in her assessment, and we applaud her for encouraging her students to learn a lesson that is certain to make them better citizens.

That bodes well for the tiny town of Cass City and its future.

We need to do all we can to help

We all know times are tough, and a number of us have had to tighten our belts. There are many of our neighbors, however, that will be facing serious hardships this winter. The very real consequences of a household going without heat hit close to home last season, resulting in a preventable death.

We need to do all we can to prevent this from happening in our communities. In doing so, Human Development Commission (HDC) is asking for your support for the annual Walk For Warmth (W4W) event.

"With so many people out of work, families are struggling to keep their households afloat," said Ragan Cudney, HDC Community Services Manager. "Sometimes it hits a point where they just can't make it happen anymore, and that's when Walk For Warmth funding is needed to help them get by and keep the heat on until times get better."

Walk For Warmth (W4W) is a statewide event sponsored by Community Action Agencies, such as HDC, to raise money to help local families in need heat their homes. Local citizens gather pledges and walk a one-mile route in the cold to keep others warm. Last year, with the support of community volunteers and businesses, HDC raised over \$39,000 to help struggling families and senior citizens in Huron, Lapeer, Sanilac and Tuscola coun-

Money raised in each county stays in that county. Funds raised truly help your neighbors, not someone in the next county.

While typical local residents spend 7 percent of their income on heating fuel in the winter, Walk For Warmth recipients spend over 30 percent of their budget to heat their homes. More than 62 percent of those who seek HDC's help with fuel payments receive no public assistance, and 56 percent are employed or have become recently unemployed.

The 20th annual Walk For Warmth (W4W) event is scheduled for Feb. 27. Walker registration begins at 9 a.m., with simultaneous walks in all 4 counties starting at 9:30







Wedding day

bride or the groom, it goes without saving that you want to look your best on your child's wedding day. While tradition offers guidelines for choosing appropriate wedding attire for mothers of brides and grooms, choices abound.

for mothers is to follow the couple's cues about the style and tone of their nuptials. Before purchasing an ensemble for the big day, talk with the bride and groom about their vision for the wedding. It's also a good idea for mothers to postpone purchasing their own wedding attire until the bride has selected her wedding dress and those of her attendants. It may also be useful to know if the couple has selected a color scheme for their wedding. These decisions will be helpful in determining the style, colors and level of formality that will be appropriate for the mothers.

Mothers' dresses should complement the attire of the wedding party, but do not have to match the bridesmaids, the wedding colors or each other. In fact, the only color that is off limits is white, which is reserved for the bride. While wearing black to weddings is gaining popularity, it is not a common color for mothers particularly the mother of the bride. In general, mother-of-the-bride and groom dresses tend to be solid colors rather than intricate prints, which can be distracting and look out of place in photos.

Timing is everything

Traditionally, the mother of the bride selects her dress first, and the mother of the groom then chooses something similar in style. If either mother has questions about their choice of wedding attire, they should consult the bride. Clear communication between the mothers or between each mother and the bride will not only make the shopping process both pleasant and productive, but will ensure that one mother doesn't 'outdo" or overshadow the other.



Personal style and preference aren't the only things that dictate certain wedding day decisions. In fact, a host of style guidelines exist to help brides and grooms make the right choices on their big day.


For example, while a man might have a specific tuxedo style in mind for his wedding day, something such as the time of the ceremony can dictate which styles are appropriate.

A morning ceremony, for instance, typically calls for a cutaway, or morning coat, with the ushers in matching strollers.



ing from the board. Some of this can be seen in the coaching situation and also where board members have been independently contacting vendors and other suppliers. That is totally outside the board's role and function. It shows that members either don't understand their role or are deliberately stepping outside it,"

"There is no room on the school board for personal axes to grind, paybacks, single interest representation or carrying the water for a particular group while on the board," Falatko continued.

"The board has the primary responsibility for the system's finances, goals, selecting a competent superintendent, and generating an outcome that is a good education for the children. If someone wants to run for the board for any other reason than this, please don't. You will only screw up the board and, ultimately, the school system. Save it for the 'letters to the editor' or this 5 minutes of public comment," he said.

"Many businesses like mine are tied directly to the quality of our schools in our ability to recruit needed talent. Therefore the quality of the schools is the biggest 'make or break' item in the recruitment process after the quality of the opportunity itself," he

"I ask you to please evaluate how you may have strayed from your role over the past several months, re-educate yourselves if necessary, and stay within the proper role of the board."

RACE TO THE TOP

Turning to financial matters, school Supt. Ron Wilson updated the board on the district's efforts to collect some Race To The Top funding.

A number of area school districts, including the Cass City Public Schools, signed memorandums of understanding (MOUs) earlier this month in hopes of cashing in on a

al RTTT school reform funding.

School officials still had questions about the grants and the strings that would be attached to the money, but those concerns were largely made moot when Michigan Gov. Jennifer Granholm signed a 5-bill legislative package this month that reformed Michigan's education system, allowing the state to compete for the federal dollars.

"The bottom line is, most of the stuff they have contained in the state legislation is contained in the Race To The Top (requirements), and many of the items in the agreement, (Cass City Schools) is already doing," Wilson said at the time, referring to the decision made by himself and school board President Doug Lautner to sign and file a MOU with the Tuscola Intermediate School District. "We're going to have to follow the rules. We might as well get some money."

The RTTT program was designed to reward states for past accomplishments and create incentives for future improvements in education, including adopting standards and assessments that prepare students for success in college and the workplace; recruiting, developing, retaining and rewarding effective teachers and principals; building data systems that measure student success and inform teachers and administrators on how they can improve their practices; and turning around the lowestperforming schools.

Cass City's share of the federal money is estimated at \$125,000, according to Wilson.

The education reforms signed into law by Granholm will:

• Allow the state to intervene in the lowest-performing school districts.

•Permit new, high-quality charter schools to open if they meet certain standards, and permit the closure of

Need help? Just ask Kayla Zmierski, the reigning spelling bee champ. An eighth grader, Kayla has made it to regionals 3 times and finally brought home the golden bee trophy this year.

At spelling bees, students in fourth grade through ninth are asked to stand before a panel of judges and spell words. They're words that may sound easy enough, but are actually tricky to spell, to words that may have been previously unheard of, such as "Laodicean", last year's national winning

The aim of Scripps National Spelling Bee is to 'help students improve their spelling, increase their vocabularies, learn concepts and develop correct English usage that will help them all their lives' and this is accomplished through intense study time and memorization.

Kayla commented, "Doing well takes dedication. Every day you have to memorize new words. It's mostly memorization so you don't necessarily have to excel in school to win."

When you step up in front of the judges, you only get one shot to get things right. Kayla says she always makes sure she spells slowly, with annunciation, and while looking at the ceiling to avoid any unintentional errors. One wrong letter, one slip of the tongue, can result in catastrophe. Catastrophe is the unfortunate end of a tale told by former spelling bee participants.

Students remember the county spelling bee they attended in fourth grade as one tainted with controversy.

One student, excited when he got the word 'factory', widely regarded as the easiest on the list, exclaimed "Factory 'fee'-f-a-c-t-o-r-y, factory". Though it was spelled right, the sound 'fee' disqualified his answer, or at least the judges thought so. The judges turned down this slip of the tongue, but this was not the end of the story. The judge's decision was contested, but the final verdict was not in favor of this ill-fated student. As for whether this decision was right, that will be left to the record books.

Many high school students have better memories regarding spelling bees. Angie Simpson can recall the many bees she attended. "It was fun but I remember what it felt like to go out. The last word I got when I was in fourth grade was marriage; I spelled it without the 'i'. I thought it was such a stupid mistake, I will never forget it," she recalled.

Kayla, on her way to the state tournament in March, has put in the work and studying. But she says she won't be too hard on herself if she doesn't make it as far as she hopes. "I just want to do my best. I'm just glad I got to states. If I do bad, I do bad," she said.

There is only one winner in spelling bees, only one person can finish first, only one can stay standing until the end.

Yet those who do not make it to the end can at least leave knowing that they can spell raspberry, Wednesday, carburetor, and even know the difference between a lot and alot.
