## **Troopers** investigate explosion

Michigan State Police troopers from the Bad Axe post are continuing their investigation into an explosion at a residence in Huron County's Brookfield Township.

According to Trooper Brian McComb, officers were dispatched to the area of Pobanz Road between Huron Line and Bach roads Thursday after Owendale Fire Chief Matt Roemer discovered the explosion while traveling down Pobanz Road.

"The house had all the windows blown out and was lifted off the cement block foundation," McComb reported. "The residence, which has been vacant since last fall, is on the west side of Pobanz Road.'

A state police fire marshal from the Gladwin post arrived and determined that the explosion had occurred in the basement of the home. A buildup of propane is suspected to have been the cause.

McComb said the date of the explosion is unknown.

Troopers were assisted at the scene by the Owendale Fire Department and Detroit Edison.

# Fritz case remanded back to district court

A former Owen-Gage softball coach charged with multiple counts of criminal sexual conduct will get another day in Tuscola County District Court.

Cory D. Fritz, 26, of Sebewaing, was scheduled to go on trial last Wednesday in Tuscola County Circuit Court. However, his attorney requested that the case be remanded back to district court for a preliminary examination, even though Fritz previously waived his district court preliminary exam. "The defendant has a right to a preliminary exam and that is what is being

exercised at this point," county Prosecutor Mark E. Reene commented. Fritz, a 2001 Owen-Gage High School graduate, faces 20 counts of third degree criminal sexual conduct, a felony punishable by up to 15 years in prison.

The charges stem from allegations that Fritz had multiple sexual encounters in 2005-06 with a 14-year-old who was attending Owen-Gage High School at the time. Michigan State Police detectives are investigating the alleged sex crimes

along with a possible missing infant allegedly fathered by the suspect with the victim. Prosecutors say they believe the victim buried the remains of the baby, but Fritz has denied having any knowledge of what happened to the According to testimony entered into the record during a pre-preliminary

examination, Fritz has admitted to having sex with the teen on multiple occasions. At the time, he was 22 years old.

Fritz is free on bond, which was set at \$50,000 (10 percent cash).

# Happy anniversary, Thumb Boy Scouts

And for good reason.

The Boy Scouts of America is one of the largest youth organizations in the United States, with more than 4 million youth members in its age-related divisions.

Scouting's goal is to train youth in responsible citizenship, character development and self-reliance through participation in a wide range of outdoor activities, educational programs and, at older age levels, career-oriented programs in partnership with community organizations.

The Boy Scouts' roots actually date back to 1909, to be a breeze, but now when Chicago publisher W.D. Boyce learned of the scouting movement while visiting London. Soon after sounds when I get up after his return to the United States, Boyce incorporated the Boy Scouts of America.

Since then, the ranks of Boy Scouts have included a number of distinguished leaders.

Well-known Eagle Scouts have included Gerald R. Ford Jr., the 38th president of the United States; William C. DeVries, M.D., who transplanted the first artificial heart; J.W. Marriott Jr., president of the Marriott Corporation; and H. Ross Perot, businessman and former presidential candidate.

Also listed in the ranks of scouting over the years are several astronauts, including James Lovell, Roger B. Chaffee and Neil Armstrong, the first man to set foot on the moon. Others associated with scouting have included Hank Aaron (Silver Buffalo Award recipient), Henry Fonda (scout and scoutmaster), Harrison Ford (Life Scout), Bill Gates (Life Scout) and Jimmy Stewart (Second Class, Silver Buffalo Award recipient).

Well, you get the idea.

The Boy Scouts of America have helped to mold thousands of young men over the years into leaders who have gone on to leave a mark on their country and on their communities, and Cass City residents can be thankful for the contributions made by all of the local youths who have been or are now involved in scouting locally. # The back forty

Well, what should I do now? We've got so many gadgets, I probably should learn how to use

I don't know how we got into this fix. We used to call people and just chat about things. Now we call them and leave a message on their cell phone.

More then 1000 folks visited emergency rooms in 2008, because they fell down or ran into a wall while using their cell phone. Everyone has one now. It's getting to the point where we can't walk down the street without hearing phones.

When I go into the grocery these days, I hear folks calling home to decide what to buy. "Maybe I'll buy these bananas?" they say. "What do you think?"

I stopped at the dry cleaners a couple of months back and noticed a sign on the counter stating, "Please don't talk on your cell phone here."

When the clerk came to the desk carrying my shirts I told her, "I'm happy to see that sign. People are so involved with talking, they can't hang up their phones."

'That's certainly true here," she said. "We've had customers who walk in and start making calls. Some talked so much the others were waiting."

She said a woman answered her phone while the clerk stood at the desk. The next customer had to wait just to see what would happen.

My newspaper calls that "multitasking." A study at University Stanford proved students who do

several things at once often can't tell what they're doing.

Stanford researchers were shocked to see how this works. They found that students who liked multitasking the most did it the worst. This is the opposite of what we would expect.

One professor wondered, "Is multitasking causing them to be lousy at it, or is their lousiness at multitasking causing them to be multi-taskers?"

These researchers gave students a form asking how many types of media they used at one time. Elements such as televisions, computer-based video, music, telephone, print, and computer games were included.

Results averaged about 1.5 media at a time for those on the low end, while heavy users scored more than four. That's when researchers learned multi-taskers have trouble switching.

These people can't decide what's important. They can't organize things, and they won't ignore stuff they don't need.

Some states have found that folks with cell phones in their car can't leave them alone. This is a distraction that causes car crashes.

They've found that folks talking on the phone have trouble walking, too. They bump into trucks that are parked in the driveway.

Researchers say multitaskers are easily distracted. They always want more information; but they don't know how to use it.





# **ACT** registration open for April 10

Registration is now open for the April 10, 2010 ACT achievement test. Students who wish to take the college admission and placement exam must register before March 5.

The ACT is a curriculum-based achievement exam. It tests what students have actually learned in school, not their aptitude for learning. The ACT also measures what students need to know to be ready for entry-level collegecredit courses based on ACT College Readiness Standards. Every student's results can be tied directly to these consistent standards.

The ACT has 4 sections-English, mathematics, reading and science-and takes about 3 hours to complete. Students who take the ACT Plus Writing complete an optional writing test that requires an additional 30 minutes. Unlike other exams, students are not penalized for guessing or answering all the questions on each test section. In fact, it is beneficial for test takers to answer all questions within the time allowed.

During registration, students may select up to 4 universities to receive their score reports. ACT scores are accepted by all 4-year colleges and universities across the United States. ACT reports scores only when requested to do so by the student. Additional score reports are available for a small fee.

All students complete a detailed inventory of questions during ACT registration. Each test taker receives an ACT score report that includes a wide variety of information to assist with high school course selection, college readiness, career planning, and college admissions.

The cost for the ACT test without writing is \$32. When combined with the optional ACT Writing Test, the total cost is \$47. Students who qualify may apply for a fee waiver through their high school counselor.

The ACT website, www.actstudent.org, has helpful information, free sample items, and options to order inexpensive test prep materials to assist test takers get ready for the exam. However, the best preparation is to take rigorous core courses in school, study hard, and learn the academic skills needed in college.

Most students register online at www.actstudent.org. Students may also pick up registration forms from their high school counseling offices; these forms must be postmarked by March 5. Late registration is available until March 19 for an extra \$21 fee.





She first asked for the approval of 3 electronic meters for wells #1, #2 and #3 that will be purchased from Sparling Instruments, LLC., El Monte, California, for \$6,704.75, plus freight charges estimated at

"The purchase of automated meters will provide for flow measurements within 1/2 percent, thereby negating the need for manual reads on the weekends," Zawilinski said.


Zawilinski then requested the purchase of 2 Dual Electronic Carboy Scales for weighing chlorine and phosphate mixed into the water at the water treatment plant.

"These new computerized scales will replace the manual weighing station currently being used,' Zawilinski said.

The 2 electronic scales, with a 400pound capacity, will be purchased from Elhorn Company, Mason, Michigan for \$3,685.

Finally, for a cost of \$6,987 the council hired UIS Programmable Services, Ypsilanti, Michigan to integrate the 3 new meters and the chemical weigh scales into the current SCADA (computer) system.

# Hearing slated in custodians' suit against company

that was subsequently approved by the school board, according to the suit, which notes the district did not obtain bids from any other company.

The 2-count lawsuit alleges D.M. Burr committed "tortuous interference with a contractual relationship" and "tortuous interference with a business relationship or expectan-

"D.M. Burr intentionally and improperly interfered with plaintiff association's CBA rights for its custodian members by instigating their proposal to provide the very same custodial services" to the Cass City Public Schools, resulting in breach, disruption and/or termination of the CBA rights for the custodians."

The union, which has requested a jury trial, is seeking compensatory damages in excess of \$25,000.

In addition to the lawsuit, the union filed an "unfair labor practice" grievance against the school district.

Earlier this month, an administrative law judge with the Michigan **Employment Relations Commission** heard the case, which alleged that school officials failed to bargain in good faith when it sought employee concessions in order to avoid layoffs.

Prior to the opening of the hearing, the school district moved to dismiss the grievance based on an argument that the impact of the decision to privatize is a prohibited subject of bargaining, and that decision may not be subject to negotiations and lies within the sole discretion of the employ-

The judge agreed, finding that there was sufficient cause to dismiss the matter. However, he postponed a formal ruling pending further proceedings in the union's civil action against D.M. Burr.

# Dunn retires after 45 years of service as Gagetown fireman

Bob Dunn isn't a big talker when it comes to discussing his contributions to the Elmwood Township-Gagetown Fire Department, but his dedication to the department, his fellow fire fighters and the community speaks volumes.

Dunn has every right to toot his own horn; he recently retired after

serving as a fireman for 45 years.
"They needed firemen," the Gagetown native said of his decision to join the department back in 1964 at the age of 25. "They needed help, and I'm here.

"I was working down in Flint — I 30 years. When I started I was 18, and I was 48 when I got out. And I worked part-time here. I worked at the co-op, drove truck," said Dunn, adding his early retirement enabled him to be available for fire runs during much of his tenure with the fire department.

"I think pretty much everyone who's lived in Gagetown has been on the fire department. As long as you could drive, you're on," commented current Elmwood Township-Gagetown Fire Chief Paul Lopez, who was born a year after Dunn joined the department. Today, Lopez has more than 23 years of service in, including 13 years as chief.

Dunn's memories of the early years of fire fighting in the Gagetown area include the old-style turnout gear long black coats, pants and yellow plastic helmets — even the old metal

He remembers a time when folks would alert the department of a fire by calling the Gagetown Hotel, where the owner would flip a switch to activate the fire siren at the old village hall a couple buildings away.

His forte on the department was driving pumpers and then running the equipment at the scene of fires.

Dunn acknowledged fighting blazes is dangerous work, and that he's seen his fair share of fatal fires, but he also said that he and his fellow firemen have steered clear of injuries.

Dunn chuckled and recalled he was injured once. "Yeah, when I was painting the door on the fire hall and the ladder fell out (from under) me,' he said. "I broke my ankle."

Well, for the most part.

It was other health issues, however, that finally prompted Dunn to consider retirement. "I don't go in the houses like I used to," he confided, adding he suffered a case of pneumonia that hospitalized him for more than a month last fall.

"He was pretty active up until he got sick this past year," Lopez pointed out.

"He's always been a really good guy on there (department), always there for you," Charles Wright, a fellow veteran fireman, said of Dunn.

Wright ought to know; he joined the Elmwood Township-Gagetown Fire Department 5 years before Dunn and will mark his 50th year as a fire fighter in July.

Wright, who also put in 27 years as chief and has served as a Gagetown Village Council member for more than 30 years — village president for the past 12 years — indicated he can relate to what has kept Dunn on the department all these years.

"Just dedication," he explained. "You want to help your community and help other people. If you don't have that in you, you don't belong on

"He is a very caring person, Bob is," added Wright, whose son, Scott Wright, serves as assistant chief of the Elkland Township Fire Department.

Lopez said firemen like Dunn and Wright aren't typical when it comes to the years someone is willing to dedicate themselves as volunteer "Most guys last 20, 25 firemen. ears," he noted.

They're also not typical in that, was working at A.C. Sparkplug for even when the years force them to back off a bit from their duties, they still lend a hand.







# State's '09 corn crop new record

Against all odds, Michigan's corn farmers brought in a record corn crop in 2009.

The U.S. Department of Agriculture (USDA) reported that despite a harvest season that left thousands of acres of corn around the country still unharvested, Michigan corn farmers grew an estimated 310.8 million bushels and recorded an all-time high yield of 148 bushels per acre.

Faced with frequent spring rains that made early planting difficult, farmers hoped the hot days of July and August would make up for late planting that started them off behind schedule. However, the summer months brought unseasonably cool weather and failed to put the worries of Michigan's corn farmers to rest.

An early frost in October led many to believe the 2009 corn crop would never reach maturity. However, a few weeks of unexpectedly warm weather in November provided the corn and farmers with a little extra time. Though the harvest lasted well into the new year for many, Michigan's corn farmers once again proved that they are up to the task of meeting the increasing corn demand.

Michigan corn farmers produced this record-setting crop utilizing fewer acres. In 2009, USDA estimates 2.1 million acres were used for corn production, compared with the 2.14 million acres used to produce the previous record crop of 295 million bushels in 2008.

"While we are extremely proud of the achievements of our corn farmers in terms of production and yield improvements, we are not surprised," Michigan Corn Growers Association (MCGA) president Tom Durand, a corn farmer from Croswell, said. "Even in difficult conditions, our farmers combine the most modern technology available with a strong and determined work ethic to grow a crop that meets all needs for food, feed, fuel and fiber."

MCGA executive director Jody E. Pollok-Newsom also commented on the dedication of Michigan's corn farmers in 2009.

"We know our record corn harvest will greatly benefit the American consumer and further demonstrates our growers' level of farming excellence despite the many challenges we may face each growing season," said Pollok-Newsom.

Headquartered in Lansing, the MCGA is a grassroots-membership association that has represented the state's corn growers' political interests since the 1970s. The MCGA works cooperatively with the Corn Marketing Program of Michigan (CMPM) a legislatively-established program that utilizes one-cent per bushel of Michigan corn sold and invests in research, education, new uses and market development.

Michigan's corn industry adds more than \$1 billion to the state's economy annually and in 2009, Michigan's corn farmers harvested a record-setting crop of nearly 311 million bushels.

# Michigan tart cherries

Michigan ranks No. 1 nationally for tart cherry production, accounting for 70 to 75 percent of the annual domestic crop.

Michigan tart cherry production was 260 million pounds in 2009, up 58 percent from the 165 million pounds produced in 2008. The average yield was 10,000 pounds per acre. The preliminary farm level value was \$40.2 million.
