Sanilac officer fatally shoots man Saturday

A Sandusky City police officer shot and killed a 29-year-old Burton man, reportedly in self-defense, after responding to a traffic-related incident in the city early Saturday morning.

Sanilac County Sheriff Garry Biniecki, whose department is investigating the shooting, said Monday that an autopsy was performed Sunday, confirming the identity of the man as Kent Douglas Kramer, 29.

"The autopsy results are pending and expected to take several weeks to be completed," Biniecki said.

"Detectives worked diligently throughout the weekend, following up on leads and interviews of witnesses that have already come forward," he added.

Biniecki said the fatal altercation took place shortly after 1:14 a.m., when the Sandusky patrol officer came across a traffic-related incident at the intersection of Dawson and West Sanilac streets.

that while the Sandusky officer was result of the altercation. investigating the incident, the sus-

pect became belligerent and resisted verbal commands from the officer." Biniecki said. "The incident further escalated and the officer attempted to gain control of the suspect by the use of a Taser."


A Taser is an electroshock weapon that uses electrical current to disrupt voluntary control of muscles. Someone struck by a Taser experiences stimulation of his or her sensory nerves and motor nerves, resulting in strong involuntary muscle contractions.

Tasers were introduced as lesslethal weapons to be used by police to subdue fleeing, belligerent or potentially dangerous subjects, often when what they consider to be a more lethal weapon would have otherwise been used.

Biniecki said the Taser reportedly did not put an end to the altercation.

"The suspect continued resisting the officer's commands and, with the officer retreating, the suspect began to pursue the officer, causing the officer to resort to the use of his/her duty weapon," the sheriff reported.

Roemer named new Owendale fire chief

While the Elmwood-Gagetown Fire Department saw one of its most senior members retire in January — Bob Dunn, after 45 years on the job — the Owendale Fire Department marked the new year by welcoming a new fire chief.

The Owendale department's 17 members elected Gagetown area native Matt Roemer as the new chief, replacing Alan Kretzschmer, who has filled that role for the past 16 years. Kretzschmer is continuing to serve with the department.

Roemer, a 1993 graduate of Owen-Gage High School, has been a volunteer fireman in Owendale for the past 10 years.

"I've been assistant chief for 4 years, and over that time Al was talking about retiring. For a year now, he made up his mind that he was going to be done when his term was up," Roemer said of his decision to seek the position. "And he's (Kretzschmer) been more than willing - if I need assistance — to be there.

"As chief, you have, of course, more responsibility. The phone rings a lot more," Roemer said. "You think more about the choices you make, because it's not just (you) you're responsible for; you're also responsible for the other guys.

"Ever since I was a kid, fire fighting was something that I was always interested in. And, it was something in the community I could get involved in," said Roemer, a husband and father. He and his wife, Angie, have 2 sons, Tyler, 11, and Andrew 7.

On top of his role as fire chief, Roemer is also vice president of the Huron County Firefighters Association.

Service to the community is nothing new for Roemer's family. Roemer's grandfather, the late Ron Good, also put his time in as an Owendale Fire Please turn to page 8.



Tuscola County residents will be asked to again renew a pair of millages that fund sheriff's department road patrol and senior citizens services in the county.

The renewals are expected to be placed on the August primary election ballot.

Tuscola County Controller Mike Hoagland said the tax levies are .8953 of a mill for the road patrol, which has been repeatedly renewed since it was first approved in 1988. The levy raises roughly \$1.287 million annually. The other tax is .198 of a mill for senior citizens millage, which generates about \$285,000 a year and has also been in place for many years.

Hoagland noted the lion's share of the senior citizens millage is distributed by the Human Development Commission via a host of programs, including home-delivered meals and other senior support services such as tax assistance and housekeeping assistance. The tax also pays for seniors' flu shots.

The millages are among 8 levied in the county. All but one - a 3.9141mill allocated millage for county operations - must be approved periodically by voters. The others are: .4807 of a mill for county bridge/local streets, .15 of a mill for recycling services; .25 of a mill for medical care facility operations, one mill for the medical care facility's now-completed renovation/expansion project, .9657 for primary roads and streets, and .5616 for mosquito abatement.

Stoutenburg says coaching staff ready to roll

Cass City Athletic Director Don Markel is a fast learner.

When asked last week if the district had filled the remainder of the Red Hawk football coaching staff for next year, his reply was that the school board hasn't approved any of those contracts yet and normally doesn't do so until the fall.

Ed Stoutenburg, however, who school officials tapped to replace Scott Cuthrell at the helm of the gridiron program, believes his staff is in place.

Roaming the sidelines on the varsity level in 2010, according to Stoutenburg, will be Scott Richards, Nick Moyer and Joe Langenburg. We feel Stoutenburg's 3 assistants, all with previous varsity coaching experience, each bring something different and valuable to the table.

Stoutenburg is most familiar with Richards and he'll be his right hand man. The pair teamed up to produce several banner seasons on the junior varsity level and now hope to translate that success at the next stage.

Moyer, the only varsity coach returning from last year's team in the same capacity, is the most familiar with the players. He'll work mostly with the linemen and is the only varsity mentor with college playing experience.

Langenburg is a no-nonsense coach, big on fundamentals. His strong demeanor will complement the easy going styles of Stoutenburg, Richards and Moyer. At the junior varsity level, Cuthrell and Bill Hartzell will guide the show. We like that Cuthrell, who was replaced by Stoutenburg after 10 years of service at the top, is continuing to coach for the Red Hawks. In our opinion, he's a lifer in that respect and could have easily told Cass City to find another coach after the debacle he endured when school personnel decided to take the Red Hawk program in a new direction.



County to share in road grant funding

Tuscola County will share in transportation grant funding to improve commercial routes in the state.

Michigan Department of Transportation (MDOT) officials last week announced that \$2.8 million in new state Transportation Economic Development Fund (TEDF) Category F grants are being awarded to build or preserve commercial all-season routes and keep the state's economy moving year-round.

The funding will enable 10 communities in 8 counties, including Tuscola, to invest more than \$5.4 million in road improvements tied to economic development.

In Tuscola County, the county road commission will overlay one mile of Colling Road in Almer Township and the city of Caro, from Deckerville Road to Gilford Road.

The route serves as a commercial north-south bypass route from M-24, as well as a major haul route for the sugar beet industry. The \$166,836 project will receive \$132,836 from the state TEDF.

"These upgrades provide improved access to the state highway system that makes industry and business more efficient and sharpens their competitive edge," state Transportation Director Kirk T. Steudle said in making the grant announcement.

He said MDOT will partner with road commissions and municipalities to fund the reconstruction and construction projects, which were selected based on road condition, their connection to other all-season routes, and the percentage of commercial traffic they carry.

Funded through the Michigan TEDF, the Category F grants are used to improve access to the state's all-season road system, a vitally important part of Michigan's economy. Eligibility is limited to county, city and village road ual offender (2 prior felony convic- agencies. Applicants must provide at least a 20-percent match.

After suffering a fall in the middle of her routine during the last meet of the year with only 3 previous qualifying scores, she thought she was done for. But, her results were revealed and she got the sweet surprise of an unexpected and much needed victory, sending her to regionals.

The ladies' team this year is sending Lindsey Bliss and Vanessa Scasny for vault, Mandi Bartnik for beam and vault, Sam Swiderski for floor, and Haley Wynn for bars and vault, covering each of the different events. Each involves performing different flips or tricks while at the same time staying within the guidelines of the event.

In order to even be able to perform a trick or stunt in this challenging sport, one must be flexible, motivated, and keep a level head after failure, according to the girls.

Sam Swiderski, for instance, made it to regionals for her floor performance, which involves choreographic flips and moves acted out to music. "I was in dance so I thought I could do gymnastics," she said.

According to Haley, her next big goal is being able to do a release on the uneven bars and though she hopes for success, "It's more about doing my personal best; I don't necessarily look at it as a competition with the other girls," she commented.

Few of the girls on the team had formal training in gymnastics before they joined their freshman year, yet today all of them are confident in what they can do. 

Henderson believes bird is crossbreed

A funny thing happened on Patrick Henderson's way to bagging a deer late last year near Cass City.

Henderson says he shot a bird that appears to be part turkey and part peacock.

And he took photos to prove it.

Henderson describes the bird as having the tail of a turkey, but the neck and head of a peacock, boasting brilliant shades of teal and purple.

"It was a very odd situation I found myself in," commented the Deford resident, who says he found some other unusual, iridescent feathers in the vicinity of where he was hunting, on property near Krapf Road, about 3 miles east of the village. The land belongs to his friends, Kris and Tony Adams. "I really believe these birds — and I believe there are others in the area — are cross breeding. I'm sure he's not the only one."

His health took another turn for the worse a couple weeks ago when he suffered a stroke, leaving him paralyzed on his right side.

But that challenge hasn't dampened his enthusiasm for being outdoors. Or his excitement over the possibility that he might have discovered a new species of turkey/peacock.

Henderson talked Saturday about his hunting trip, saying he was sitting in his friend, Tony's, deer blind last December when he spotted the unusual fowl.

"I really wasn't seeing any deer, but I heard something behind me," he recalled. Before long, 35 to 40 turkeys came into sight, and a dominant tom caught Henderson's atten-

The Chicago native, who's lived in tion. "He was chasing a hen, and

"It was all just a matter of, he was the dominant bird in the flock, because he was watching everybody, he was kicking out the other jakes (younger male turkeys) and toms," he continued, adding he took aim with his 12-gauge shotgun and dropped the male with a load of no. 6 shot.

"The only reason I shot him is, I know, as a taxidermist - I know birds — and I know he's at least 50 percent peacock," said Henderson, who noted peacocks, which are members of the pheasant family, are not a protected species.

"My first impression was that somebody's peacock got out. But then I said, something's not right. Something's not right here.'

"A peacock, really — they're loners - they do not associate with other birds. They run in pairs and they hang out in trees for safety," said Henderson, who observed the bird's brightly colored neck, but also said it had a tail similar to that of a turkey, with the feathers in back varied in color and iridescent. The wings were light brown in color, but the male has no beard, he said.

The U.S. Army veteran has contacted the Department of Natural Resources in hopes of getting an expert analysis on what he has coined his "peaturkey". He hasn't heard back yet, but says he's having the bird mounted and would like to donate it to the village of Cass City or the local school district for display.

"I'm hoping that it is a new subspecies, because we don't get much credit for having a wolverine here,' Henderson said.

If the bird does turn out to be a new subspecies, Henderson figures his luck might turn the natural resources spotlight on the Thumb, and he would like nothing more than to see that happen.

"It's a once-in-a-lifetime opportunity, I guess," he said.


