DOWN ON THE FARM

New agriscience program draws close to 60 Cass City High School students in first year

When Cass City School officials decided to revive the district's agriscience program in the 2010-11 school year, high school Principal Chad Daniels was hoping to fill a single classroom with students interested in learning about agriculture-related topics and issues.

Daniels has since been pleasantly surprised with the popularity of the new class offering.

"It's grown even beyond what I thought it would," he said. At first, he added, "I was just hoping I could make one section (classroom) — at least 15 kids. But I've got 58 kids in 2 classes."

And, he said, those students are exploring a variety of career opportunities in agriculture machine repair and renewable energy sources, for example. "What we're trying to do is show these kids that agriculture is more

than milking a cow."

At the same time, first-year teacher Ashlee Gibson has made certain her students are being exposed to various projects that give them the and take care of them," explained opportunity to work with farm animals "up close and personal".

"Basically we do try to get as hands-on as possible," she said, noting her classes raised 50 broiler chickens, taking on the responsibilities of cleaning pens and feeding and watering the birds. The teens also were introduced to and participated in the entire butchering process.

The students were then allowed to participate in a Future Farmers of America (FFA) competition in Fowlerville, where their work was "unofficially" ranked 15th out of 175 schools (unofficially because Cass City Public Schools hasn't yet established its own FFA chapter). The chickens not taken to the competition were sold as a fundraiser that netted roughly \$400 for future agriscience projects.

The students also raised a pair of students and the community.'

calves that were donated by deVor Farms, Decker. "The students took care of them, they bottle fed them they had to come in on the weekends Gibson, an Alma native who earned her Bachelor of Science Degree in agriscience at Michigan State University in 2007. She said her students also learned about some of the less pleasant tasks, such as dehorning and castration, which were demonstrated by a Thumb area vet-

"Currently, we have 2 goats out in the shed that are getting ready to have babies," added Gibson, who said the goats were borrowed from her family's farm in the Alma area. Gibson says she sees great potential

in the future for Cass City's agriscience program.

"I think the students — what finance, marketing, they're learning is sticking," she said. "It's been a very positive experience, and (there has been) tons of support from the administration, the keeping it interesting. We never

Gibson's enthusiasm has rubbed

off on her students. "I took the agriculture science (class) because I thought it would be interesting to learn more about the subject. Coming into class, I didn't know what to expect. I am really glad I took the course," said senior Candace Myers. "In our class we do a lot of hands-on activities. We have raised a lot of animals and learned very much about them."

"I absolutely love the new ag program," added another senior, Lauren Walther. "We learn such a variety of things, including working hands-on with animals. We are learning about leadership. We have also discovered a variety of industries involved in agriculture - we touch on plants, crops, safety, mechanics. It's amazing how broad the topics are.

School election deadline nearing

Area residents interested in running for a term on the board of education in their school district have about 4 weeks to file nominating petitions and affidavits of identity.

The forms and instructions on where the paperwork is to be filed can be found at county clerks offices in the Thumb. The deadline to file both is Tuesday, Feb. 8, at 4 p.m. Candidates that decide to withdraw from the elections have until Friday, Feb. 11, at 4 p.m. to do so.

The last day to register for the elections is Monday, April 4, and voters will go to the polls Tuesday, May 3.

That date is also an important one for residents in several Tuscola County townships, including Elkland Township, as it will serve as the primary election day to select a candidate or candidates to fill a vacancy on the Tuscola County Board of Commissioners.

SCHOOL VOTE

In the Cass City Public School District, the 4-year terms of veteran Trustee James Turner and Trustee Craig Bellew are expiring. Turner has served on the board for 24 years, while Bellew is completing his first term.

In other area districts:

*The term now held by Owen-Gage Board of Education member Brenda Kretzschmer is expiring. Kretzschmer agreed to serve on the board following the resignation of Ron Maurer several months ago. The term is for 4 years.

*In the Kingston Community School District, incumbent Ray Wolak's 4-year term is expiring.

*Two, 4-year terms are expiring in the Ubly Community School District. They are currently held by incumbents Kelly Jo Osentoski and John Rutkowski.

Troopers: 8 killed in accidents

Preliminary reports from the Michigan State Police Criminal Justice Information Center indicate 8 people died in traffic crashes over the recent Christmas and New Year's holidays, with half of those deaths involving alcohol. Three of those killed were pedes-

Four deaths occurred between Dec. 23 and 26, 3 of which involved alcohol. In 2 cases, drivers were not buckled at the time of the crash.

The other 4 fatalities occurred between Dec. 30 and Jan. 2, one of which was alcohol-related.

This is a slight improvement over the 2009 holiday periods when 10 people died in traffic crashes. Four of those deaths were alcohol-relat-

More than 200 law enforcement agencies in 35 counties, including Tuscola County, conducted drunk driving enforcement during extra patrols funded by the Office of Highway Safety Planning (OHSP) through federal traffic safety funds, Dec. 16-Jan. 

Keep in mind that board members also have day jobs, and the time they invest in our children nets little — if any — financial compensation. In short, they serve because they care and are willing to take an active role in the local school system.

"In my short time as superintendent, I have witnessed firsthand their commitment to education on many occasions. I have found them to be very helpful and cooperative to work with," Hartel said. "Educating our children is and always will be their number one priority."

Once home, I stirred everything together - again - and created nothing short of Pièce dough résistance. One thing was for sure: I had the dough thing down pat.

The rising of the dough, however, was not so triumphant. I was beginning to understand the true meaning of desperate housewife.

My third "loaf," while edible, baked up heavy as a fruitcake. I called it progress and willed myself to gear up for a fourth attempt. I will not let this bread thing break me although I must admit my confidence is not as light and airy as it once was.

I'm cultivating a plan for mastering the yeast. The next time I "make bread" I think I'll invite my son to help. Because when it comes to the science of yeast, I now know one thing for sure: I am definitely not smarter than a third grader.



know what to expect next. Last week Miss Gibson had a goat walking around in the classroom," Walther added.

"We have been on a field trip to a dairy farm and watched our calf be sold at a livestock auction. We got to take chickens we raised at the school to a FFA competition," she said. "There is so much to learn about the agriculture industry, from growing fruits, flowers, animals, crops, trees, etc. If it wasn't for farmers and the whole agriculture industry, we would not have food, clothing, or shelter."

Daniels has offered his full support to the program, scraping up \$1,000 and asking the high school's shop class to build a shed on skids for projects involving farm animals. He then asked the shop students to renovate an existing shed. "What we're looking at is trying to expand on that," he said. Daniels is now looking at organizing a fundraising effort to construct a 40-foot by 60-foot barn for the program, based on the advice of the district's ag advisory

The board, which has played a key role in guiding the agriscience curriculum, is manned by experienced professionals in a number of fields in the Cass City area.

The members and their affiliations include Joseph Delong, beef producer; Dave Milligan and Jim Brown, cash crop farmers; Randy Severance, Pioneer Seed Company representative; Dave Osentoski, owner of Double D Diesel; Jack Laurie, farmer and legislative lobbyist; Eric Brown, Thumb National Bank; and Guthry Laurie, Walther Farms.

In addition to expanding the facilities available to agriscience students, Daniels would like to explore other possibilities, including establishing a middle school elective class related this thing," Daniels said.

School officials are also working on implementing a local FFA chapter, which could lead to what Daniels called "mega scholarship opportunities" for Cass City students.




