Cass City ministry generates enough support to buy Main Street building

You don't have to convince officials with Revive Ministries of Cass City that miracles can happen.

The local ministry's humble beginnings at the Cass City Missionary Church back in 2005 eventually led to housing the outreach in the former Millennium building next to McDonald's in the village. That arrangement ended last year when the building was sold.

However, Revive officials didn't give up, and with support generated throughout the community, the ministry is in the process of purchasing the former Burkhard Plumbing and Heating Building, located at 6400 Main St., Cass City.

"When the Millennium building was sold this past summer, Revive was faced with a new chapter," commented Jaime Fritz of Revive Ministries. "We moved the food pantry to the Cass City Missionary Church and were able to continue providing the monthly food pantry. Our clothing and housewares shoppe

was packed up and is currently being stored in various churches and buildings.

"At that time we began to explore our options and trusted that God would open doors we needed opened in order to continue providing support to the community," she said. "Over the past 5 months, we have worked hard to raise enough funds and monthly pledges to put a down payment on the Burkhard Plumbing and Heating building.

"We will be moving in February and hope to hold the February food distribution there," Fritz added. "Once we are settled in our new home, we have a lot of programs we hope to offer. We will continue with the monthly food pantries — the third Saturday of the month from 10 to 11 a.m. — crafts for kids, occasional mobile food pantries, Friday morning coffee time, clothing and housewares shoppe — opened at least 2 times per week and hopefully more — Children's Fun Fair coming in March, after-school tutoring program, etc.

"We are open to whatever God has

in store for the program and want to be obedient to his plan as he has provided us with all we have," Fritz continued.

Revive's roots date back to 2005 when the missionary church hosted "Revive", a weekend family event geared towards the community and offering a host of children's activities. The gathering was brought back in 2006 and 2007.

"When planning the 2008 event, we felt the need to further meet the needs of those in the community, so we held a clothing/food give-away and a children's fun fair. We also organized various mobile food pantries throughout the year," Fritz said. "The response was tremendous and the need within the community became even more real to us at that time.

"God opened several doors, allowing us to provide a food pantry and eventually (the) clothing and housewares shoppe. We were blessed with the opportunity to utilize the Millennium building, which allowed for us to establish 'Revive Ministries'," she explained.

"The community's response and support was incredible," she added. "People began supporting the program in a variety of ways, including volunteering and financial support. In 2009 we applied for and received our 501(c)(3) status, allowing us to expand and transition into a community ministry. During this time, we provided activities such as the monthly food pantry, children's fun fair, clothing and housewares shoppe, Friday morning coffee time, mobile food pantries, free swim days, crafts for kids, etc. Also, 'Nice Twice', a program sponsored by the United Methodist Church, shared space with us.

Although Revive Ministries has expanded over the years, one thing has not changed, and that's the need for anyone willing to lend a hand.

"The program continues to be operated 100 percent by volunteers and funded by the community," Fritz noted. "We are continually looking for volunteer support in a variety of areas in order to keep the programs going. Our goal is to be a community organization meeting the needs of those in our community. We will continue to need financial support to both purchase food and to maintain the services/programs we offer."

Board vows \$10,000 for barn project

The Cass City Board of Education Monday vowed to back its support of the high school's new agriscience program with some cold hard cash to help pay for construction of a pole barn in the future.

Meeting in regular session, the board approved a \$10,000 commitment towards the project, provided agriscience program leaders and students can raise the remaining \$30,000 needed to build the proposed 40-foot by 64-foot structure. The barn would be used, in part, to house livestock. Class instructor Ashlee Gibson frequently incorporates hands-on projects involving live animals into her curriculum.

"It (barn) is extended classroom, is what it is," commented school Supt. Jeff Hartel, who noted school officials, students and members of the program's voluntary advisory committee are already exploring fundraising ideas. "I think we should be able to do it," he said.

The board of education last year

revived the district's agriscience program after years of not offering classes that focus specifically on agricultural-related issues.

The curriculum, implemented at the beginning of the 2010-11 school year, has proven popular, drawing nearly 60 high school students who have spent the past few months exploring topics ranging from crops to renewable energy to career opportunities in agriculture. Gibson has also introduced projects that have given her students the opportunity to raise and care for chickens, a calf and goats.

School officials are now looking at establishing a local Future Farmers of America (FFA) chapter, and there are plans to possibly establish a greenhouse and community garden in the future.

Still, even after more than 34 years of dodging and keeping up with young athletes on Friday nights, Turner figures it's an easier job than serving on a school board at times.


Turner should know. His latest term on the Cass City Board of Education has brought more than its share of controversy and hard feelings among members of the community.

Great Waste State? Hopefully not anymore

Michigan will no longer be a dumping ground for Ontario's city waste, thanks to an agreement negotiated 4 years ago by U.S. senators Debbie Stabenow (D-MI) and Carl Levin (D-MI), who last week announced that Ontario's minister of environment announced that Ontario has officially met the terms of its agreement to stop shipments of waste to Michigan as of Dec. 31, 2010.

The agreement prevents more than 40,000 trash trucks hauling city waste from entering Michigan, putting a stop to 1.5 million tons of waste that otherwise would have been dumped in this state every year.

We appreciate the news from Stabenow and Levin, but we have one question: What took so long?

Not to boast, but we doubt there are few folks who could effectively argue that Michigan has not always been a gem among these United States. Still is, in our opinion.

After all, Michigan has the longest freshwater shoreline of any political subdivision in the world, bounded by 4 of the 5 Great Lakes plus Lake Saint Clair.

There's also no arguing that this state is a recreational paradise. In 2005, for example, Michigan ranked third among U.S. states for the number of registered recreational boats, behind California and Florida. Michigan has nearly 65,000 inland lakes and ponds, and a person in the state is never more than 87.2 miles from a Great Lakes shoreline.

Stabenow called the recent news "a great victory for Michigan in the fight against Canadian trash. This trash poses serious health, safety and security threats to Michigan families and our communities," she said. "Since Toronto announced that it would begin sending its trash to our state in 2003, Senator Levin and I have made stopping these garbage imports a top priority. There is still more work to be done, but (this) announcement is a major milestone in the fight to stop Canadian trash."

Levin agreed. He added, however, "Non-municipally managed trash that can come from private companies, from construction and industry, and from other sources, continues to come into Michigan. That is simply unacceptable. Along with Senator Stabenow and others, I will work to gain passage of legislation that would address the non-municipally managed Canadian trash shipments into Michigan."

We're sorry, but why is this such a complicated issue that it's taken drawn-out "agreements" to put an end to trash imports from Canadian (and other) neighbors?

Certainly, this country has made border security a priority in recent years. How difficult can it be to stop and deny access to Michigan by a garbage truck?

The truth is, it comes down to dollars and cents. Michigan's tipping fee is a bargain (21 cents per ton of garbage), compared to the much higher fees charged by other states. Wisconsin has the highest rate in the nation at nearly \$13 per ton.

But here's the rub: if we charge more to out-of-state companies, we must also charge the same rate to Michigan companies (according to the U.S. Constitution), which means the state's taxpayers will face higher charges.

That's the bottom line. So we have a choice to make: Great Lakes State or Great Waste State?

Thanks, Doug, it's been a great ride

I can't say that all of my encounters with the Michigan State Police have been pleasant ones.

In fact, the least pleasant took place a number of years ago in the Caro area, where I was heading back to Cass City from a news conference, driving and trying to figure out how I was going to put this particular story together.

Poor judgment on my part.

Instead of paying attention, I was speeding in a residential zone, and hadn't noticed the flashing lights behind me for several seconds. As soon as I did, I stopped and came face to face with a trooper who was not in a good mood, and with good reason. I was speeding, and he wanted to know - right now - if I had any clue how long he had been following me.

"No, sir."

He also wanted to know if I knew why he had stopped me. Before I could answer, he let me know in no uncertain terms. I offered him no excuses, and he read me the riot act. By the time he was done, I figured I was facing an \$800 fine and much worse when I had to go home and tell my wife.

Instead, he let me off with a warning, one I remember to this day. His decision to give me a break paid off, believe me.

Which brings me to my most pleasant memory; a "ride-along" with First Lt. Doug Lautner, a Cass City resident and commander of Michigan State Police posts in Caro and Bad Axe, who recently announced his retirement from the department after 29 years of service.

Doug offered me the invitation to ride with him on a brief patrol after he asked if I'd be interested in writing a piece on Michigan's "move over" law, which requires motorists to literally move over/slow down - depending on traffic conditions and the number of lanes available - when

approaching a stationary emergency vehicle with its emergency lights activated.

A ride-along? This was a no-brainer for me. I couldn't wait.

The first thing Doug did was demonstrate use of the radio in his patrol car, instructing which buttons to push and what to say "if something happens."

Now wait a minute, I thought. If something happens? What could happen? Nothing's going to happen, right? Right?!

We left Cass City, heading west on M-81, and over the next hour or so Doug stopped a handful of motorists for minor traffic infractions.

It was an interesting experience - not to mention the view sitting in the passenger side of a patrol car. I've seen plenty of television shows depicting police officers making traffic stops, but this was different.

The first thought that occurred to me as Doug would approach a stopped vehicle, is that an officer has no idea if he or she is about to encounter a housewife who was in a hurry, or a desperate, armed individual who has just robbed a bank and figures he has little to lose.

My second observation is that too many drivers don't pay attention to ensuring the safety of a police officer at the scene of a traffic stop - I saw a number of them whiz past us, just feet away from Doug as he talked to motorists. I hadn't realized how potentially dangerous a simple traffic stop can be.

Those lessons have stayed with me, but I can also tell you I've always appreciated Doug's willingness to discuss incidents/issues with me as a reporter, both while wearing his hat as a state trooper and in his role as president of the Cass City Board of Education. I've always appreciated his forthright approach when dealing with the media. I'm going to miss his sense of humor, too.

Thanks, Doug. It's been a great ride.



Huron County men nabbed following high-speed chase

A pair of Huron County men are behind bars after the driver of the vehicle they were in attempted to flee law enforcement officers from several departments — colliding with 2 police cruisers in the process — last Wednesday. No one was injured.

Huron County Sheriff Kelly J. Hanson said the incident began at about 8:30 p.m. when Deputy Brian Tetreau was conducting stationary radar duty on Bay Port Road, north of Kilmanagh Road, in Brookfield Township, and he witnessed a vehicle traveling at a speed of 39 miles per hour in a 25-mile-per-hour zone. Tetreau then attempted to stop the car.

"The vehicle failed to stop and continued at speeds of 40 to 45 miles an hour. Deputy Tetreau, now with only his emergency lights on, also activated his siren in an effort to stop the vehicle," Hanson reported. "He could see 2 subjects in the fleeing (car). He also requested back-up."

As the vehicles approached M-142, Sgt. Todd Schember was arriving to assist. Also nearby was Deputy Ryan Neumann responding from Caseville Township.

"Sgt. Schember attempted to stop the vehicle at that intersection and the suspect vehicle collided with the front of his patrol car," Hanson said. "He and Deputy Tetreau were able to get out of their patrol car and attempted to order the suspect driver out. The suspect vehicle appeared to be stuck but was attempting to flee from the scene. Both deputies were able to identify the driver and could see his passenger wanted to get out of the vehicle."

Deputy Neumann arrived at the scene when the suspect vehicle broke free and headed westbound on M-142, according to the sheriff. In the process, he said, the car struck the front end of Neumann's police cruiser.

"After taking into consideration the very light traffic volume, all 3 deputies began to once again pursue the fleeing vehicle," Hanson continued. "The suspect vehicle eventually turned southbound on M-25, failing to stop at that intersection. While pursuing, it was learned that the 30-year-old Caseville driver had a suspended driver's license. His 26-year-old passenger, who is a Caseville resident, also had 2 out-of-county warrants out for his arrest."

With speeds reaching up to 80 miles an hour during the chase, Sebawaing Village Officer Brandon Gettel joined the effort at the intersection of M-25 and Kilmanagh Road and set out some spike strips. However, the

suspect driver was able to evade the strips and turned eastbound on Kilmanagh Road.

"His passenger jumped out of the vehicle while it was making the turn, and patrolmen Gettel and Deputy Tetreau took him into custody," Hanson said. "Sgt. Schember and Deputy Neumann continued pursuing the vehicle, witnessing it continue to fail to stop at intersections."

The chase continued into Tuscola County, where Michigan State Police troopers from the Caro post caught up to the suspect vehicle on Dickerson Road near Colwood

Road. Tuscola County Sheriff's deputies also responded. Huron County deputies discontinued the chase once they reached M-25 and Clark Road in Tuscola County, and they learned 15 minutes later that troopers and Tuscola County deputies had the driver in custody. He was then lodged in the Tuscola County Jail.

Hanson said his department requested a felony warrant from the Huron County Prosecutor's Office, charging the driver with fleeing and eluding a police officer along with other counts.

A pre-trial hearing was ordered scheduled and bond was continued at \$5,000.

Connie LaPeer, crossing guard. The board also approved the hiring of Sandy Kelley, crossing guard, and Stacey Bliss, middle school social worker (funded by Title I dollars).

- Noted it will spend the next few weeks completing self-evaluations as well as evaluate Hartel's job performance in his first year as superintendent. Evaluation forms have been distributed and will be completed and compiled for review during the next regular school board meeting, Monday, Feb. 28, at 7 p.m. in the high school library.

- Learned Saginaw Valley State University officials have decided to discontinue use of the high school building as a satellite campus. Hartel noted the decision was based partly on the number of general education classes the university now requires students to complete on the SVSU campus. An inadequate number of local students and adults taking advantage of the satellite campus was also a factor, he said, adding school officials will now be looking to strike a similar arrangement with another university.

- Reviewed proposed revisions to the Cass City Public Schools' bomb threat response policy. Hartel explained the changes are designed to make the district's response more effective in terms of evacuation locations in the community should the need ever arise. In addition, while a threat would still result in a school "lock-down", the school day would continue under a high security alert rather than closing the doors and sending students home immediately, he said.

- Learned the Kally Maharg Scholarship will be providing some

\$1,500 in scholarship assistance to help a half-dozen students cover their expenses to attend the annual eighth grade trip to Washington, D.C., in the spring.

- Approved an annual resolution allowing a performance of the all-school play on a Sunday — March 27.

- Met in executive session to discuss the possible expulsions of 3 students.

- Recognized 3 Cass City High School students — all enrolled at the Tuscola Technology Center in Caro — who recently placed in various categories at a regional Business Professionals of America (BPA) competition. They are: Brandon Montgomery, first place in Computer Network Technology Concepts and second place in Computer Security; Mandi Bartnik, second place in Payroll Accounting and seventh place in Banking and Finance; and Mark Alfini, seventh place in Digital Media Production.



posed privatization of the Cass City School District's custodial staff a couple years ago, but after a majority vote in favor of privatization, he refused to back-up a fellow board member's call to rescind privatization a month or so later, saying he respected and would support the wishes of those board members that approved the plan. That stand drew the ire of many district residents.

And that controversy came at a time when former school Supt. Ron Wilson was the target of multiple criticisms from some in the school district. The board subsequently accepted Wilson's resignation and hired longtime Cass City educator and administrator Jeff Hartel to take over the reins. But the board members' challenges didn't end there — they also were forced to deal with a couple of student discipline issues that received plenty of media attention.

Both Bellew and Turner are among the school board candidates required to file nominating petitions and affidavits of identity in order to be placed on the ballot in the Tuesday, May 3, school elections.

The deadline to file is Tuesday, Feb. 8, at 4 p.m. Candidates that decide to withdraw from the elections have until Friday, Feb. 11, at 4 p.m. to do so. The last day to register for the election is Monday, April 4.

Turner and Bellew indicated their decisions to run again were based, in

part, on a desire to maintain board stability.

With current board President Doug Lautner eyeing retirement after 8 years on the board — not to mention a 29-year career with the Michigan State Police, the board will be light on experience in the future. Treasurer Jim Veneziano has served 3 years, while Secretary Sloane Stimpfel has 2 years of service in, Trustee Dave Osentoski has been on the board for 2 years and Alice Zaleski is in her first year as a trustee.

"That has weighed on my mind — I definitely considered not running," Turner said, adding his motivation for serving on the board hasn't changed over the years. "I guess you could say dedication to community and school," he said.

Although Bellew, who currently serves as vice president of the Cass City Board of Education, will seek another term on the board, he isn't looking at extending his tenure beyond that.

"I'm still learning. But I just think if I get reelected and get 4 more years, that will be it. That will give Jeff an opportunity to succeed," Bellew said.

"I think Jeff's the right guy for the job, and I think if we can get things stabilized for a few years, we'll be okay," Turner agreed.

"I want him (Hartel) to succeed, because if he doesn't succeed, the kids lose," Bellew added.
