



2 vying for county board seat

Races slated in Cass City, Kingston and Ubly villages

Residents will be deciding races in 3 area villages, including Cass City, when fall elections roll around Tuesday, Sept. 13. In Cass City, village President Carl

Palmateer is running opposed for another 2-year term. He has served in that capacity since October 2007.

Four citizens, including 2 incumbents, meanwhile, are seeking 3, 4year trustee terms. They are Mick Kirn, a trustee since July 2005; Jenny L. Zawilinski, who has served on the council since April 2004; and challengers William C. Hartzell and Nancy K. Barrios.

Not seeking reelection is incumbent Jim Heiser, a trustee since October

In the village of Kingston, Robin LaFond is running unopposed as village president for a 2-year term, and residents Andrew Crousore, Patricia A. Randall and Jeremy M. Romain are all seeking one of 2 available 4year trustee terms.

A pair of races are on tap in Ubly, where Mark A. Brown, Lori L. Please turn to page 8.

Two candidates are seeking the District One seat on the board, representing Akron, Columbia, Elkland, Elmwood, Fairgrove, Gilford and Wisner townships, including the villages of Cass City, Akron, Fairgrove, Gagetown and Unionville.

The candidates include Unionville area resident Roger Allen, who currently represents District One. Allen was appointed to the county board last January to fill a vacancy left by the resignation of Cass City attorney Amanda Roggenbuck, who won her second, 2-year term on the board last

Board cuts 5 teachers

The Cass City Board of Education Monday formally passed a resolution laying off 5 teachers, part of a costcutting plan designed to trim some \$600,000 from spending in the coming year.

The board unanimously approved a motion eliminating the jobs of Ashley Copeland (second grade), Mark Estelle (fourth grade), Steve Hollocker (third grade), Christina Grim (high school special education and middle school exploratory), and Andrea Ross (first grade).

The district's cost-cutting plan is the result of an anticipated deficit of \$805,000. The board opted to make up 75 percent of the total through cuts, with the remainder — just over \$210,000 — coming from the district's fund balance.

Roughly half of the cuts (about \$310,000) planned for the coming year are in the form of eliminating the 5 teaching positions.

Other reductions in spending will come in the form of eliminating textbook purchases for one year, cutting one administrative position, one retirement, less spending in the tech-

Area teen beats closed head injury after crash


To meet Kassie LaPonsie, you would never know the quiet 16year-old suffered a closed head injury just 3 months ago.

She has a beautiful smile and speaks in a soft-spoken voice. She's ready to go for another bike ride, loves spending time with her family and friends and is looking forward to her junior year at Cass City High School.

Ask her parents, Kathy and Aaron LaPonsie, both of whom are nurses, and they'll tell you their daughter's recovery was nothing short of miraculous. They credit that recovery to plenty of prayer and a landslide of support from not only family members and neighbors, but also the Cass City area community as a whole — the school staff and students, area pastors and their congregations, and dozens of folks who simply sent a card with their best wishes and few dollars to lend a hand. The list goes on.

The accident occurred on a warm spring day last April. The family had just returned to their home in Sanilac County's Evergreen Township from a spring break vacation in Florida when Kassie



Take care of yourselves and pets when it's hot

Baby, it's hot outside!

Daytime temperatures have been hovering in the 90s recently, and although we may get some relief, we still have August coming.

Which is why we're asking all area residents to take heed when it comes to the Michigan Department of Community Health's (MDCH) advisory regarding the I don't support health risks associated with extreme temperatures and humidity, and preventative measures they can take.

Anytime temperatures reach the upper 80s and above, they can cause body temperature to rise, resulting in muscle cramps, dizziness, severe heat illness and even death.

The same is true for pets. Can you imagine wearing a fur coat in these temperatures?

These are the basic facts: heat illness occurs when the body is unable to cool down. The body normally cools down by sweating. However, during extremely hot weather, sweating may not be enough to cool the body. That's when people can become overheated to the point of becoming ill.

"People should drink water frequently, even when they may not be thirsty, in order to stay hydrated,' said Dr. Dean Sienko, interim chief medical executive *for the MDCH.*

Here are a few tips to stay safe:

- Use an air conditioner or go to a cool place such as a basement, neighbor's house or shopping mall. Spending even a few hours a day in air conditioning can help reduce your risk for heat illness.
- Use a fan only when the windows are open or the air conditioner is on. Fans will not prevent illness when the temperature is in the high 90s.
 - Take a cool shower or bath.
- Keep shades and curtains closed to block the sun from coming in your home or office.
- If you must be out in the sun, wear thin and lightcolored clothing, a hat and sunglasses. Wear sunscreen (at least SPF 15) and reapply every 2 hours after swimming and exercising.
- Check on family members, neighbors and friends at least once a day.
- Never, ever leave children, the elderly or pets in parked vehicles.
- Dehydration is the first stage of heat-related illness — symptoms include dry mouth, thirst, headache, dizziness, cramps, excessive fatigue and irritability so move to a shaded or air-conditioned area, replace fluids by drinking plenty of water, and consult a physician if symptoms persist or if there is an existing condition that could be complicated by increased fluid intake.
- Be aware of the more serious stage of heat-related illness, heat exhaustion, which typically occurs when people exercise heavily or work in a warm, humid place where body fluids are lost by sweating. This fluid loss can cause reduced blood flow to vital organs and result in shock.
- Also be aware of the most severe stage of heat-related illness — heatstroke, also known as sunstroke. Symptoms include vomiting, decreased alertness or complete loss of consciousness, high body temperature or red, hot and dry skin with a rapid, weak pulse. Call 911 for immediate help and try to cool the person down. If possible, put them in a tub of cool water or shower them with a garden hose.

Drug-related crashes up

Audit shows declines in alcoholrelated crashes, fatalities and arrests, but notes increases in crashes, deaths and injuries involving drugs.

Overall, deaths resulting from alcohol and/or drug-related crashes increased slightly from 351 in 2009 to 357 in 2010, while injuries decreased from 6,271 to 6,175. However, alcohol-involved traffic deaths decreased from 299 to 283 while drug-involved fatalities went up 29 percent, from 119 in 2009 to 153 in 2010.

Part of this increase is due to increased testing to detect drug-

impaired driving. Law enforcement officers are con-



What would happen from a higher speed of a motorcycle? The helmet law may feel like it is taking away your freedom, but it really could prevent injury. A closed head injury can cause mental and physical disability, or death."

The LaPonsies know they were extremely fortunate in how quickly Kassie recovered.







Tony Hill of Cass City

Self-taught taxidermist loves variety of his work

Q: What animals do you work on

A: Mostly deer, I've done a few small mammals like coons, coyotes, squirrel, ground hogs, the smaller the animal the more tedious it gets.

From start to finish, (an animal takes) probably anywhere from 10 to 12 hours, depends on your experience I guess.

When I first started it took that (time) just to get it ready for tanning, then I upgraded to certain tools to help me get faster.

Q: What is your favorite animal to

A: I like doing fish better, deer are harder to get the flesh off, they cling to the skin, more tiresome work, you

Q: Are there a lot of women in this

A: Yes. I visit a website and you go there and there are a lot of profes-

sional taxidermists on that website, they do a real good job. **Q**: Are there tough parts to this

A: Yeah, I've done elk and they are real heavy and tough, the mannequins are a whole lot bigger, the hides alone before you even start on them will weigh at least 100 pounds, the skin on an elk around the neck is thicker, and you have to thin it down, elk are a lot more strenuous and heavy work.

Q: How do people react when you tell them your profession?

A: Depends on who I am talking to, well most of my family thinks it is pretty cool and exciting and interesting and I really haven't had anybody say it is sickening.

Q: What is your job schedule like? A: I get up at 8 a.m. and work to about 6. I take breaks in between.

Q: Does your job get easier with

A: You are doing something different all the time and with each mount vou learn something different no matter how many you have done and you apply it to the next one. Each one gets better and better.

Q: How far does your business go? **A:** I do work for people in Imlay City, Port Huron, I've done (work for) people in Roseville, Hazel Park

Crop assistance deadline set for Friday

Director for Michigan's Farm Service Agency (FSA) recently reminded producers that they have until Friday, July 29, 2011, to apply for assistance for 2009 crop losses under the Supplemental Revenue Assistance Payments (SURE) Program. The program provides crop disaster assistance payments to eligible producers on farms that have incurred crop production or quality losses due to natural disasters.

"It's vital all producers who suffered a crop loss in 2009 know assistance is available," said White. "Producers need to take the first step

their local FSA county office by Friday, July 29th."

To be eligible, producers in disaster declared counties must have suffered at least a 10 percent production loss on a crop of economic significance and obtained a policy or plan of insurance under the Federal Crop Insurance Act or the Noninsured Crop Disaster Assistance Program (NAP). Exceptions apply for socially disadvantaged producers, limited resource producers and beginning farmer and ranchers. In 2009, all disaster county or contiguous to a

Christine White, State Executive and apply for the SURE program in disaster county by the Secretary of Agriculture under a Secretarial Disaster Designation. The SURE program takes into account losses on all crops grown by a producer nationwide.

Persons or legal entities whose average non-farm adjusted gross income exceeds \$500,000 are not eligible for SURE payments. A limit of \$100,000 per person or legal entity applies to the payments for SURE and the livestock disaster programs administered by FSA.

A producer interested in signing up for 2009 SURE must do so before Michigan counties were declared a close of business July 29, 2011 at their local FSA county office.
