Single vote decides races for village trustee seats in Cass City and Kingston

Close, close, close.

Cass City Village Clerk-Treasurer, Nan Walsh. "It was a really good election."

Incumbent village President Carl Palmateer ran unopposed and won another 2-year term, receiving 113

In Kingston, voting errors cost a write-in candidate his seat on the vil-In Cass lage council.

There were 94 votes cast in all, according to Tuscola County Clerk Margie White, who said the 2 available 4-year trustee seats were claimed by Patricia A. Randall and Jeremy M. Romain, who received 51 votes and 46 votes, respectively. Write-in candidate Scott Fetting garnered 45 votes. However, White noted the county's board of canvassers negated 2 ballots for Fetting — one because the voter listed him as Doug Fetting, and the other because the resident voted for him as village president.

Also seeking one of the trustee seats was Andrew Crousore, who received 17 votes

In addition, Robin LaFond was elected village president by a narrow margin, garnering 48 votes over write-in candidate William Miller's 42 votes.

Elsewhere in the Thumb, 129 voters went to the polls in the village of Ubly, where citizens reelected incumbent Mark Brown, who ran Challenger without opposition. Likewise, vil-Bill Hartzell lage Clerk Lori White and Treasurer missed a tie Laura Ann Kramer won terms after vote by just running unopposed.

There was no contest for a pair of 2year trustee terms, won by incumbent Adam Kain and Nolan Pierson. However, challenger Barbara Butch ousted incumbent Shawn M. Wright for a lone 4-year term, receiving 78 votes over Wright's 33 votes.

Ubly voters also reelected Sleeper Public Library Board Trustee Judy Harrington to a 6-year term. She received 71 votes, defeating Janice

Over Damrow allegations

MSP closes investigation

Michigan State Police investigators Friday confirmed they've closed their probe into a myriad of allegations targeting several Huron County public officials and residents after finding no criminal wrongdoing.

Those accusations were passed on to the state police by 84th District State Rep. Kurt Damrow (R-Port Austin), who represents Tuscola and Huron counties.

Pupil numbers drop, but not like expected

The annual fall statewide student count is still 2 weeks away, and Cass City School officials are crossing their fingers.

Just a couple weeks into the 2011-12 school year, school Supt. Jeff Hartel says enrollment figures are constantly shifting. However, the district is still ahead of the game in terms of the number of kids school officials anticipated losing this year, he said.

"The last count I did was on the first day of school (Sept. 6). We were at 1,131 kids, which is 31 students less than last fall, but we had budgeted to be at 1,116 students," Hartel explained. "We're 18 students up (compared to our projection). So, we've lost kids, but not as many as we anticipated or budgeted for."

Based on the latest figures out of Lansing, Cass City School officials expect to receive \$6,846 per student this school year. The loss of 31 students would cost the district more than \$212,000. In all, Cass City's total enrollment


declined by some 300 kids between the 2006-07 school year and the 2010-11 school year. Using this year's state funding level, that translates into the loss of more than \$2 million in revenue.

There is some good news; Cass City officials expect to receive an extra, one-time payment of about \$110,000 this year by complying with the state's "best practices" requirements.

30 Thumb area youth enjoy a day in outdoors

Let's talk

It really doesn't bother me to push a button to select the language. It's not that hard.

The whole issue of immigrants, legal or otherwise, is much too complicated and serious for a light-hearted column like this.

I do think that it would be good for a foreigner who plans to live here to make an attempt to learn the language. However, it's not as easy as it might appear to someone who has grown up with American English.

I thought they were telling me that the dog wasn't riding the bike. My reaction was "How stupid! Of course the dog isn't riding the bike."

Cass City is still a safe community

A headline on the front page of the Chronicle last week may have left some folks wondering if they're living in Cass City or Detroit.

In short, the story involved a 74-year-old Caro man who showed up at an Alcoholics Anonymous meeting at a local church and, after a verbal exchange with one man, produced a loaded handgun. The man allegedly cocked the weapon and threatened one man's life, but later willingly handed the gun over to another man who confronted him.

This was a frightening confrontation, one that could have easily ended in one or more senseless, violent deaths, in spite of the fact that veteran Cass City Police Officer Bill Hartzell was on hand within a couple of minutes of being dispatched to the scene.

On the other hand, Hartzell's presence probably prevented the situation from escalating, especially considering the suspect threatened to retrieve another gun, which he had in his truck along with alcohol, prescription drugs and marijuana.

The men attending that AA meeting deserve some credit here. They demonstrated not only courage, but also a level-headed response to the suspect's actions. But let's face it, they were also very lucky. He could have easily fired off a first shot in a split second. Who knows what might have happened then.

We're not going to give any advice here regarding how to react to a situation like this — even seasoned law enforcement officers won't, because they know that anytime there's a confrontation involving a weapon, the circumstances are unique. In other words, what might work with one suspect might set off another suspect.

However, the recent past has taught us that this sort of threat is a growing one due to many factors, including economic conditions that have pushed some into taking desperate measures.

What we will say is this: whether we like it or not, this is not the same community or rural county it was, where everyone knows everyone. That is to say, the lessons to be learned here include the need for all residents to be ever vigilant when it comes to suspicious situations or individuals.

Having said that, we hope residents will keep in mind that we still live in a very safe community.

This incident is also a reminder that this community must not — at any cost — ever allow tough times to sacrifice its 24/7 police department, a luxury that only 2 other municipalities, the cities of Caro and Vassar, enjoy in Tuscola County.

Sure, a full-time police department doesn't guarantee we won't face serious threats in the future, but it does mean that help is only minutes away should the need arise.

Now, more than ever, that presence is worth its weight in gold.

from our county. The list includes myself, 2 judges — one retired several attorneys, members of our road commission and various other citizens.

'These outrageous allegations range from myself flying a drug dealer around the country during the 1990s and acts of intimidation as sheriff, to a judge running over a person, causing death, and then being covered up by the prosecutor's "Others office," Hanson said. include the road commission, where members and employees are implicated as being in conflicts of interest, to allegations of a judge and a local attorney being arrested for being with prostitutes and in possession of drugs.

"From what I've learned from my sources, a document or some type of communication of several allegations has been supplied to the MSP," the sheriff continued. "This suggests retaliation against myself and others when we felt that Mr. Damrow should comply with the law just like

any citizen in this county."

Hanson said he released information regarding the allegations to the media in an effort to expedite the investigation — not to interfere with the investigation.

'There is a need...to prevent needless circulation of what I believe to be false information that creates uncalled-for hardships respectable public servants," he said. "I feel full disclosure needs to occur, whether these allegations are true or, in fact, false.

'Since learning of this investigation, myself and others have had to take time away from day-to-day operations at our sheriff's office to address these concerns," Hanson added. "One can only imagine how much time and effort that the MSP has invested into this. This certainly has the appearance that the taxpayers' money is being spent needlessly because of a personal vendetta Mr. Damrow has with many of us in Huron County."

Calls to Damrow's Lansing office, seeking comment, were not returned by press time.



Grants boosting war on criminals

Federal funding is boosting efforts retrieve/store digital videos. to foil drug traffickers and other criminals throughout Michigan, including the Thumb.

announced that 37 criminal justice cy projects. agencies will receive \$7 million in grants to strengthen anti-drug and crime fighting efforts in the state. The funding is made possible through the Edward Byrne Memorial Justice Assistance Grant (Byrne JAG) Program and the Residential Prisoners (RSAT) Program.

In the Thumb, the Thumb Narcotics Unit (TNU) was awarded \$104,060 during the current fiscal year in the category of multijurisdictional task

The money will go towards continuation of a project for TNU, a multijurisdictional task force that covers Huron, Tuscola, Sanilac and Lapeer counties. TNU's goal is to investigate, apprehend and convict individuals involved in illegal narcotics trafficking and other related criminal offenses. The drug team, comprised of local, county and state agencies, also assists local law enforcement with non-drug violent and non-violent criminal investigations.

TNU was awarded \$77,004 in federal funding to continue its mission

also received a Byrne JAG grant, in the amount of 14,128, for technology enhancement projects in 2011.

The department is using the money to purchase 2 digital, in-car camera systems for its patrol cars, and 2 linked office computers to wirelessly ing a witness in a drug case.

Another federal grant totaling \$49,498 has been awarded to the Huron County Sheriff's Department Gov. Rick Snyder last week in 2012 for evidence-based efficien-

The department will use the funding to purchase a complete electronic ticketing solution to replace inefficient and outdated paper-based ticketing. The system will include ticket-writing software, a web-based portal for administration and an Substance Abuse Treatment for State eCommerce website for citizens to use to pay their tickets online.

"Protecting Michigan citizens is a top priority, and these grants will go a long way toward combating drug abuse and violence across the state, Snyder said of the grants. "This funding will help build stronger communities through increased drug enforcement, prevention and treatment efforts, as well as the implementation of innovative, evidence-

based technology."
Byrne JAG funds support all aspects of the criminal justice system, and the recent awards focus on multijurisdictional drug task forces, priority population drug courts and evidence-based innovative technolo-

RSAT funds, meanwhile, support the development and implementation of residential substance abuse treat-The Caseville Police Department ment programs in correctional and detention facilities.

Michigan schools receive a majority of their revenue each year in the form of a state foundation allowance, a funding amount — adding up to roughly 85 percent of schools' budgets — that is applied to the number of students in each district.

That state's formula places a heavy emphasis on the fall tally. In the past, the fall count was worth 75 percent of a district's total blended enrollment, but the formula was revised for this year, making the fall enrollment worth 90 percent.



Anderson: stay safe and play by the rules this harvest season

so too is the harvest of Michigan's agricultural bounty. And just as the game of football hasn't changed, neither have the rules for sharing the road with farm equipment.

way to stay safe this harvest season," according to Craig Anderson, manager of the Michigan Farm Bureau Agricultural Labor and Safety Services Department.

farm equipment were reported according to the Michigan Office of Highway Safety Planning. Of those, 61 occurred during the harvest months of September through December.

One of the biggest hazards is motorists not allowing enough time to brake when approaching a slowmoving farm vehicle. "Think football field," advises Anderson.

Anderson references the fall-time sport because picturing a football field is a good visual reminder of the distance required to come to a com-

Just as football is a sure sign of fall, plete stop behind slow-moving farm motorists of a vehicle that is moving equipment.

While some tractors, combines and other harvesters are able to travel on highways at up to 30 to 45 mph, most can only move at a rate of 15 to 25 mph. As Anderson explains, it "Play by the rules. That's the best takes a minimum of 240 to 300 feet for a passenger car or pickup truck with a normal brake system traveling at just 55 mph to stop behind farm equipment traveling at 15 mph.

"You'd need a stretch of road near-In 2010, 158 accidents involving ly the size of a football field to stop at those levels of speed, and it'd take only 5 seconds to close the gap between the car and a tractor," he said. "The takeaway message for motorists is to allow enough room to slow down."

Spotting slow-moving vehicles

Spotting a slow-moving farm vehicle is easy, says, Anderson. Just look for the slow-moving vehicle (SMV) sign, a reflective bright orange triangle trimmed in red on the rear of farm vehicles.

The SMV emblem is meant to warn

at slower than normal speeds or presents other hazards, and to approach with caution. The sign is required, by law, on all implements of husbandry, including tractors, combines, and other harvest equipment, said Anderson.

Unfortunately, the SMV emblem meaning is lost on many motorists because of its misuse by the public. SMV signs, which are widely available at retailers unlike most official traffic markers, are frequently used illegally as driveway markers or for other reflective or decorative purpos-

The only legal use of an SMV emblem is to mark an implement of husbandry, farm tractor, special mobile vehicle or a vehicle with a maximum designed speed of 25

"That means if you're using an SMV sign to mark your driveway stop the practice immediately. advised Anderson. "You'll not only bring yourself in compliance with the law, but you'll be doing your part to promote traffic safety."

Another helpful tip for motorists, said Anderson, is to be patient.

"A farmer will often pull off the road to allow motorists to pass when safe," he said. "But don't assume the farmer can immediately move aside to let you pass. Road shoulders may be soft, wet or steep, and this can cause a farm vehicle to tip.

"Even if you have to slow down to 20 mph and follow a tractor for one mile, it takes only three minutes of your time, which is approximately the same as waiting for one stop-

Additional road rules

Normal traffic laws apply. Do not pass in designated "No Passing Zones" or within 100 feet of intersections, railroad crossings, or bridges.

Like semi-trucks, farm equipment makes wide turns. Watch for turn signals or hand motions to indicate a farm vehicle is preparing to turn.

Yield to wide vehicles. Farm equipment may be wider than the normal traffic lane. Motorists approaching such a vehicle should pull off in a safe location to allow the large equipment to pass.

Don't assume the farmer knows you're there. Most farmers are aware of the traffic around them but the equipment they operate is loud.

Precautions for farmers

Farmers have a responsibility to take extra precautions as well, said Anderson, including the following.

Comply with all applicable laws. When it comes to SMV emblems, all farm equipment, regardless of speed, must have an SMV sign.

Replace any faded SMV signs or red reflective material on outboard edges of implements. Add extra reflective material such as truck tape or implement marking kits.





Small game hunting seasons underway through March 31

Sept. 1 with the opening of the early Canada goose season and continues until rabbit and hare season ends on March 31. Department of Natural Resources wildlife biologists across the state say hunters should find conditions similar to last year — with a couple of improved opportunities in Michigan's wood lots, farm fields and wetlands.

Rabbits

Season: Cottontail rabbits and varying (or snowshoe) hare can be hunted from Sept. 15 - March 31, statewide. The daily bag limit is 5 in combination with a possession limit

Outlook: Roughly 83,000 hunters pursue rabbits and hares in Michigan. Cottontail populations, as always, are good throughout their range over much of the state. Look for thick cover, such as briar patches and brush piles, often adjoining agricultural fields. Snowshoe hare populations, which are cyclical, are down somewhat because of declining habitat. Look for early-successional forests (such as aspen stands), and low-lying swamps with blow-downs and brush piles in the northern twothirds of the state.

Squirrels

Season: Sept. 15 - March 1. Hunters may bag 5 per day with 10 in posses-

Outlook: Both fox and gray squirrels are at moderate to high levels across much of the state. Look for areas that had good acorn or nut production last year or in wood lots adjoining corn fields. Take advantage of post deer-season hunting in January and February. About 83,000 hunters pursue squirrels each year.

Ruffed Grouse

Season: Sept. 15 - Nov. 14 and Dec. 1 - Jan. 1, statewide. The bag limit is 5 per day/10 in possession in the northern two-thirds of the state, 3 per day/6 in possession in Zone 3 (southern Michigan).

Outlook: Grouse populations are cyclical, typically rising and falling over a 10-year period, and indications are that we are at or near a peak. Grouse are denizens of earlysuccessional forests — young to moderate-aged aspen stands (with trees of a diameter ranging from a cue stick to a baseball bat) and tag alder thickets. Look for good berry and wild fruit production, too. Grouse are most numerous in the Upper Peninsula and northern Lower pheasants in Michigan. Peninsula but hunters may find local populations in areas with good habitat in southern Michigan as well Grouse and woodcock hunters are Calhoun, Clinton, Eaton, Genesee, asked to assist the DNR in monitoring populations by reporting their results. Cooperator forms can be found on the DNR web site at www.michigan.gov/ hunting select Upland Game Birds and then Ruffed Grouse.

Woodcock

Season: Sept. 24 - Nov. 7, sion. statewide. The daily bag is 3 with a possession limit of 6.

Outlook: Although woodcock populations are in long-term decline because of decreasing habitat quality, hunters can expect about the same results they enjoyed last year, when roughly 38,000 hunters said they pursued woodcock. Found in all parts of Michigan, woodcock are migratory and they are commonly associated with grouse hunting. the earth for worms and other invertebrates that are adapted to moist soils. Peak migration occurs in mid-October in the northern portions of the state. Hunters are reminded that they must have a Harvest Information Program (HIP) endorsement printed on their small game licenses to legally take woodcock. See the 2011 Michigan Hunting and Trapping Guide for details.

Sharp-tailed Grouse

Season: Oct. 10-31 in the eastern Upper Peninsula, east of M-129 and east of I-75 north of M-48. The limit is 2 daily, with 4 in possession; 6 per

Outlook: Back on the roster after nearly a decade of closed season. sharptails are birds that use grasslands and associated shrubby habitat. Think pheasant habitat. Sharp-tailed grouse feed on upland seeds and berries. They are often found in small flocks and can be difficult to approach; be prepared for relatively long-range shooting compared to ruffed grouse. Sharptail hunters are required to have a (free) sharp-tailed grouse endorsement on their hunting licenses.

Pheasants

Season: Oct. 10-31 in the Upper Peninsula, Oct. 20 - Nov. 14 in the Lower Peninsula and Dec. 1 - Jan. 1 in selected areas of Zone 3. The limit is 2 cocks daily, with 4 in possession.

Outlook: Pheasant populations have been in decline for a number of years, primarily because of changes in agricultural practices and urban sprawl, and there's no reason to assume they will improve dramatically this year. Typically, the best habitat is on private lands that have been managed for pheasants, especially those that are enrolled in farm set-aside programs. Generally speaking, hunters who enjoyed success last year should find similar hunting conditions in the same areas, though a cold wet spring may have affected this year's hatch. The best counties for pheasant hunting occur in southcentral to mid-Michigan and into the Thumb, though locally abundant populations can be found almost anywhere. Look for warm-season grasses, especially idled farm fields. daily bag limit is 2. Late-season hunters can have success in cattail and shrub lands adjoining picked agricultural fields. An estimated 46,000 hunters pursue

Season: Oct. 20 - Nov. 14. Quail can be hunted only in Branch Gratiot, Hillsdale, Huron, Ingham, Ionia, Jackson, Kent, Lapeer, Lenawee, Livingston, Macomb, Monroe, Montcalm, Oakland, Saginaw, St. Clair, St. Joseph. Sanilac, Shiawassee, Tuscola, Washtenaw and Wayne counties. The bag limit is 5 per day/10 in posses-

Outlook: Quail hunting often is associated with pheasant hunting in Michigan and bird populations are patchy at best. Fewer than 2,000 hunters report pursuing quail.

Season: Sept. 15 - Nov. 14 in 8 management units including the entire Upper Peninsula (except Isle Royale) and all counties to the south of and including Oceana, Newaygo, Mecosta, Isabella, Midland, Bay and Huron (except Wayne and Monroe). able — 3,350 general licenses that

Outlook: Fall turkey seasons are only held in areas where populations are stable to increasing, so prospects are very good. Roughly 16,000 hunters pursue wild turkeys in the fall hunt, many of them during the archery deer season.

Ducks

Seasons: Sept. 24 - Nov. 18 and Nov. 24-27 in the North Zone (Upper Peninsula); Oct. 1 - Nov. 27 and Dec. 3-4 in the Middle Zone; and Oct. 8 -Dec. 4 and Dec. 10-11 in the South Zone. The bag limit for ducks is 6 per day with no more than 4 mallards (no more than one hen), 3 wood ducks, 2 scaup (bluebill), 2 redheads, 2 pintail, one canvasback and one black duck. Five additional mergansers (no more than two may be hooded mergansers) may be taken. Possession limit is 2 days' daily bag

Outlook: Hunting prospects for Michigan's 40,000 duck hunters are good as continental populations are at or above long-term averages for most species. However, Michigan experienced decreased production this spring and local mallards figure prominently in the bag. Water conditions are very good, with high water levels providing additional marsh habitat. Good opportunities for puddle ducks, especially wood ducks, exist in beaver ponds and small inland floodings. Diving ducks, which generally begin arriving in good numbers around mid-October, should be plentiful on the Great Lakes, though bluebills populations remain below the long-term average.

Canada Geese

Seasons: The early season is Sept 1-15 except in the Upper Peninsula and Saginaw, Huron and Tuscola counties, where the season is Sept. 1-10. The daily bag limit is 5.

The regular goose seasons are Sept. 17 - Oct. 31 in the North Zone; Oct. 1 - Nov. 8, Nov. 24-27 and Dec. 3-4 the Middle Zone; and Oct. 8 - Nov. 10 and Nov. 24 - Dec. 4 in the South Zone, except in designated goose management units (GMUs). The
