Damrow case now in hands of prosecutor

Allegations that state Rep. Kurt Damrow (R-Port Austin) filed a false police report last year involving several Huron County officials and residents is now in the hands of a special prosecutor.

A spokesman at Michigan Attorney General Bill Schuette's office says Schuette has appointed Genesee County Prosecutor David Leyton to handle the case. Leyton will review the case and determine if additional investigation is warranted and whether or not the charge against prosecut-

When it comes to spring weather in Michigan, the only certainty is

uncertainty. Tuscola County Office of Emergency Management Director Pat Finn

knows that reality all too well, which is why he is reminding area residents that it's time to prepare for the worst Mother Nature can dish out in

The threat of damaging thunderstorms and tornadoes each summer is behind Michigan Severe Weather Awareness Week, established by the Michigan Committee for Severe Weather Awareness and former Michigan Gov. Jennifer Granholm.

In conjunction with the observance, slated for April 15-21 this year fire departments throughout Tuscola County will be preparing by testing their tornado sirens on a monthly basis, starting today (Wednesday) at 10 a.m. Tornado sirens will continue to be tested on the first Wednesday of

each month at 10 a.m. through October.

Finn said a tornado warning is announced with a 2-minute siren blast. The all-clear signal, he added, is 3 short blasts.

Finn noted that a severe thunderstorm or tornado 'watch" is issued whenever conditions exist for severe weather to develop. A warning, indicating that residents should

seek shelter immediately, is issued when severe weather or a tornado is spotted on radar or when a funnel cloud has been sighted. Each year, more than 1,000 tornadoes strike the United States. Since

1950, more than 239 persons have been killed due to tornadoes. According to the National Weather Service, there were 4 deaths and 31

injuries in Michigan from severe weather in 2011. All of the deaths and injuries resulted from either lightning or thunderstorm winds. Flooding, severe thunderstorms and tornadoes were responsible for about \$150 million in damages last year, down from \$360 million in damages in 2010.

Michigan had below-average severe weather activity across much of upper and lower Michigan last year. However, severe weather increased in 2011 across southern Michigan. The character of the severe weather in that region was not as significant as in 2010, but still took a substantial toll on the state.

In all, Michigan recorded 15 tornadoes in 2011, which is very close to the average of 16. Fortunately, only 4 of those tornadoes caused significant damage, and 6 of them caused no damage.

The Thumb was fortunate in that no tornadoes were recorded last year. According to statistics compiled by the National Weather Service, Please turn to page 8.



Let's keep booze out of spring celebrations

The arrival of spring means another school year is nearly complete, and soon students will be attending graduation open houses, proms and many other social events.

Unfortunately, some of those young people will be mixing alcohol with their gatherings.

Which is why we wholeheartedly applaud the Michigan Department of Community Health's (MDCH) message encouraging all adults to "Do Your Part" in preventing underage drinking.

Youth violence, traffic crashes, property crime, treatment and medical aid due to underage alcohol use costs Michigan some \$2 billion annually. Of course, there's no putting a price tag on the lives lost each year due to poor choices made by both teens and adults.

Let's face it, underage drinking only happens because adults allow it, because someone over the age of 21 has purchased, provided or assisted an underage person to obtain alcohol.

"Underage drinking is a major health concern," said Olga Dazzo, MDCH director. "Alcohol is the most commonly used and abused drug among youth in our state. It's especially troubling since youth who start to drink before age 15 are 7 times more likely to experience alcohol problems as adults."

Although strides are being made to reduce underage drinking, the Michigan Youth Risk Behavior Survey indicates that 69 percent of the state's high school students in grades 9 through 12 reported having at least one drink during their lifetime. For high school seniors, the rate is higher at 77 percent. In addition, 35 percent of those high school students reported drinking alcohol within the past 30 days.

Recently, MDCH worked with the Substance Abuse and Mental Health Services Administration to develop a video that focuses on the fact that, as adults, we all have a role in preventing underage drinking. We may be parents, siblings or other relatives, but it's also beyond family — coaches, teachers, law enforcement, clergy and retailers can have an impact as well.

Regardless of our roles and identities, adults interact with youth on a regular basis, and everyone can help send a clear message that underage drinking is not acceptable. Period.

Area residents who aren't sure what to say to a young person can find some helpful tips by watching "Do Your Part" videos, which can easily be found online at www.youtube.com/michigandch.

Take responsibility and take the time to speak out. Who knows? You might be saving a life.

State's Gov. **Snyder signs Damrow bill**

Gov. Rick Snyder recently signed legislation sponsored by state Rep. Kurt Damrow to restrict families of service members killed during active duty from contesting funeral arrangements made by the soldiers' designee.

House Bill 4639 ensures a soldier's last wishes for funeral arrangements are followed.

There have been many instances where family members have disagreed with a service member's designated person's decisions on funeral arrangements, and taken the case to said Damrow (R-Port Austin). "I am proud to have this bill signed into law-now a service member's funeral arrangement decisions will be abided by without any interference."

The bill gives the designated person the right and power to make decisions about funeral arrangements including the handling of a decedent's body, decisions about cremation and the right to possess cremated remains of the decedent.

"This bill honors a soldier's last wishes so that they may rest in peace," Damrow said.

Republicans endorse "Freedom to Work"

The Tuscola County Republican Party Executive Committee recently adopted a resolution to endorse Freedom To Work legislation.

"For the past 10 years, Michigan has been in economic decline," said Vice Chair Matthew Bierlein, who drafted the resolution. "According to the Detroit News, the state has lost 800,000 jobs and 57,000 residents, while income has fallen 22 percent. During this same time period twothirds of the states which guarantee employees individual freedom to choose regarding union membership and support have higher per capita income than do the citizens of Michigan according to the U.S. Census Bureau."

When adjusted for taxes and the cost of living, families in voluntary unionism states have been found to have over \$2,000 more disposable income each year than in states such as Michigan, where employees face the threat of being discriminated against and fired if they choose not to join or financially support a labor organization. In Tuscola County, where 15.8 percent of families are living below the poverty level, \$2,000 can make a huge quality of life difference, Bierlein said.

A lifelong resident of the Vassar area, Bierlein is preparing to run for a vacant seat on the Tuscola County Board of Commissioners in the newly redrawn 5th District. This election is his first foray into politics.

"I feel like I have to get involved," he said, adding his business background will help the county govern "more appropriately and effectively." Bierlein considers his lack of political experience a plus. "I'm not a career politician," he said. "I think I have a common-sense approach to governing, and I think I can make a difference.'

The resolution passed with unanimous support. Republican Party members feel forced unionism is a civil rights, as well as a jobs issue. The right of "freedom of association" is a fundamental right of every American, and is enshrined in our Bill of Rights.

During deliberation of the resolution, Bierlein pointed out there is bipartisan support for Freedom to Work. Part of the adopted resolution includes quoted text from President John F. Kennedy, who in 1963 signed Executive Order No. 10988, authorizing federal employees' right to "form, join, and assist" any union. However, JFK knew there was a constitutional danger in forcing compulsory dues as a condition of employment, so he added the following words in his order: "or to refrain from any such activity."

Chair Lisa Valentine said the local Republicans will ask Senator Mike Green and Representative Kurt Damrow to co-sponsor and vote for Freedom To Work legislation.



Central States Rotary Youth Exchange is a program that provides students from around the world the opportunity and support to study abroad. Student participants fall into 3 basic categories: outbound, rebound and inbound.




