POISON

Designer drug growing in popularity here, suspects hit business 3 times

A third break-in at a Bad Axe business has Huron County Sheriff Kelly J. Hanson concerned about the growing popularity of a "designer drug" commonly known as bath salts in the Thumb.

Hanson believes addicts' desperation for their next fix could lead to even more serious crimes, and that those who experiment with it are playing Russian roulette with their health and even their lives.

Hanson reported the latest break-in last week, saying Sgt. Gary Polega responded to the scene of a breaking and entering complaint at Maple Lane Discount in Bad Axe.

"This is the third time the business

at this location...had been broken into since Dec. 25," Hanson reported. "Video surveillance revealed that at 12:54 a.m., a masked individual broke the entrance door glass out and entered the business.

What is believed to be a male suspect immediately headed for a display cabinet that contained a variety of bath salts," he said, adding the suspect took 5 packs of bath salts valued at \$110, then exited the building. "This whole thing took place in less than a minute."

The suspect is described as wearing a blue or purple ski mask pulled down over his face, a hooded jacket with a large plaid design of green or gray squares and white lines, white pajama style pants with large blotches of black, and possible croc-style

slip-on shoes.

"The reference to 'bath salts' in these thefts is basically a street name. The illegal chemicals referred to...are methylenedioxypropylone and others," Hanson explained. "Normal department store-type bath salts do not contain these illegal ingredients. The illegal chemicals are believed to be purposely hidden in granular substances similar to bath salts and disguised in their packaging and marketing. Circumventing of the illegal chemicals appears to have taken place."

Hanson said bath salts have been the target of all 3 break-ins at Maple Lane Discount. Following the second burglary in late January, a suspect cooperated with deputies, and some of the thousands of dollars worth of stolen salts in that crime were recovered. In the first break-in, the thief took roughly \$340 worth of bath salts.

"It appears this business has become a lightning rod for serious addicts," said the sheriff, who noted the owner has reported that several thousand dollars of bath salts have been sold.

"With these kinds of sales and the apparent desperation of those using the salts, I feel these (crimes) could continue, and hopefully they won't resort into other levels that could involve violence as a form of getting them from that store," Hanson continued.

MONITORING SALES

"Our office has been monitoring sales of bath salts throughout our county since these ingredients became illegal in August of last year. We have been submitting random samples of bath salts to the crime lab to determine whether the law from last year applies," Hanson said. "Unfortunately, the results have shown that current products do not contain the specific illegal ingredients.

"Producers have been able to create other chemical ingredients that are not specifically prohibited by law. They have the same effect on the user, thus avoiding being illegal bath salts. Prices of these bath salts range from \$10 for a quarter ounce to \$250 for 10 ounces — obviously not the going rate for regular bath salts."

Hanson said his department has been running into bath salts use and their effects on a more regular basis. Please turn to page 6.

Local student numbers drop

The exodus of students from the Cass City School District — a trend that has frustrated local school officials for years — has continued this school year, judging by the biannual enrollment count conducted by districts across the state last Wednesday. Cass City School Supt. Jeff Hartel reported last week's tally revealed a total of 1,103 students, down 20 students from last fall. Hartel said the loss was across the board, with 6 fewer students at Campbell Elementary School, 3 fewer at the middle school and 11 fewer at the high school.

Based on Cass City's per-pupil state foundation allowance this year, 20

students translates into nearly \$137,000 in revenue, although last week's enrollment count will be used to calculate the district's funding for the 2012-13 school year.

Michigan schools receive a majority of their revenue each year in the form of a state foundation allowance, a funding amount — adding up to roughly 85 percent of schools' budgets — that is applied to the number of students in each district.

A school's enrollment is determined by "blending" 2 separate counts; one conducted in the fall and the other one during the previous February. The state's formula places a heavy emphasis on the fall tally. Prior to last year, the fall count was worth 75 percent of a district's total blended. Please turn to page 7.

"Bath Salts" FAQs

What are "bath salts"?

Bath salts are sold as a crystalline powder that has recently become available. This is a powerful drug that causes severe side effects. The Drug Enforcement Agency (DEA) in the New Orleans area has confirmed that much of the supply is coming in from China and is distributed in head shops (retail outlets that specialize in drug paraphernalia), convenience stores and through the Internet.

How are bath salts packaged?

Bath salts are sold as a crystalline powder in a small bag with names such as Ivory Wave, Blow, Red Dove, Vanilla Sky, Aura, Zeus 2, Zoom, Bliss, Blue Silk, White Lightning, Ocean, Charge, Cosmic Blast, Scarface, Hurricane Charlie, Cloud 9, Energy 1, White Dove and others.

What do bath salts contain?

This product can contain one of many "designer drugs". The most likely one currently used is MDPV (methylenedioxypropylone), but it could also contain mephedrone.

What is the pattern of abuse?

Most users are experienced drug users/abusers. Their ages range from 15 to 61 years. Some binge for 3 to 4 days. Bath salts are snorted, ingested mixed with water, injected or inserted rectally or vaginally. There is a craving for more once the binge is over.

What are the signs/symptoms of bath salts use?

Side effects include severe paranoia, violent behavior, hallucinations, chest pain, seizures, a decreased need for sleep, lack of appetite and self-mutilation. Users frequently describe the "high" as horrible and report seeing demons, monsters, foreign soldiers or aliens. Some have symptoms for 2 or 3 days, and some require long-term psychiatric care because their symptoms weren't improving.

Are there long-term health problems that result from use of bath salts?

Yes. Even a one-time use of this drug can cause long-term health effects, including kidney failure, liver failure, increased risk of suicide, long-term mental illness and self-mutilation. Death is also possible.

New poison rearing its ugly head here

They're called "bath salts", but scientists say the seemingly harmless product name can be deceiving. In fact, some bath salts can contain the chemicals methylenedioxypropylamphetamine and mephedrone.

On the street, users refer to the salts by a number of names, including Ivory Wave, Blow, Red Dove, Vanilla Sky, Zeus 2, Bliss, White Lightning, Ocean and Cosmic Blast.

The medical and law enforcement communities have another name for bath salts: poison.

Unfortunately, this "designer drug" has reared its ugly head in the Thumb area, and Huron County Sheriff Kelly J. Hanson says its popularity among addicts has led to several break-ins in Bad Axe. Use of the drug has also landed a number of individuals — young and old — in jail, hospitals and treatment centers.

Hanson fears users' desperation for the drugs could drive them to commit violent crimes, if necessary, to get their next fix.

The list of side effects connected to ingestion of bath salts is frightening and includes severe paranoia, violent behavior, hallucinations, chest pain, seizure and more. Long-term effects range from organ failure to self-mutilation to death.

Although the recent thefts of bath salts have taken place in Huron County, the growing popularity of these drugs should be a concern to all Thumb residents. After all, anyone addicted to this drug would certainly have no problem traveling from Cass City or Gagetown or Kingston to the source of their drug of choice.

We believe parents should be especially concerned, given the apparent availability of bath salts and the variety of ways the drugs can be ingested, the cost (as little as \$10 for a quarter ounce), and the unpredictable side effects that accompany experimentation with them.

Already, Hanson says, law enforcement officials have observed a number of reports involving teenagers experimenting with bath salts.

Perhaps the best advice we can offer to parents is to pay close attention to their teens' behavior and habits. In other words, if you see anything out of the ordinary, talk to your child. Seek out the advice of experts if you're concerned. Call your doctor, call Huron Behavioral Health, call the Michigan Department of Community Health.

Sure, your teen may resent the intrusion, but any measure that puts an end to their experimentation with illicit substances is worth preventing their names from being added to the list of young lives lost to drugs in our communities.

Don't wait. By the time your son or daughter lands in an emergency room, it may be too late.

My second born is 17 years old today. Like each of my children, he's brought me more joy than I ever could have imagined. Well, at least after he got over the colic. And then there was the teensiest bit of parental stress when he got in a couple of (minor) fender benders during the last few months. But between those events, we've experienced much joy. And perhaps a bump or two (or many) in the road.

Closing of Owendale Post Office is unfair

To whom it may concern,

I am writing this on behalf of the residents of Owendale. At a recent meeting at the fire hall, we — meaning a big percentage of citizens in our community — were told that we would be losing our post office services by May 15, 2012. Reason being, it's to save money.


Owendale is one among over 10,000 smaller post offices that are to be closed. It is all cut and dried. This meeting we had with Ms. Vander Silk, post office review board, was just a thing they had to do to justify their thinking. Whose, I shant know, but I do know all the costs involved were so over exaggerated it was laughable.

Our income for the past couple of years has gone down because someone saw fit to take our carrier, her case and all things pertaining to a rural route out of Owendale, and move it to Pigeon, some 8 miles away.

No mail truck stops at Owendale, yet it drives through our town on the way to a neighboring town to deliver the mail. Our mail is deposited at the Pigeon Post Office and the carrier that used to work out of our office cases route mail, then packs her car with route mail, also the Owendale Village & business mail and begins her assigned route, which also includes some of Pigeon. She finally ends up at the Owendale Post Office and unloads our mail, over 2 hours later than previously. This is service. She is paid extra for these added duties and mileage.

Now here is the kicker; Ms. Silk claims our income is down about \$1,800. Even a fifth grader could figure out why. The income she takes in from route sales now gets credited to Pigeon. That income amount could easily be \$2,000 to \$3,000.

Don't believe in global warming? A report from the National Oceanic and Atmospheric Administration (NOAA) has identified January 2012 as the fourth-warmest January on record for the contiguous United States.

In the contiguous U.S., the average temperature for January was 36.3°F which is 5.5°F above normal range. This makes the month not only the fourth warmest of its kind in history, but also the warmest since 2006.

It has also been the fifth-warmest, six-month period from August 2011 to January 2012 ever recorded in the contiguous U.S.



Deputies arrest 2 in break-in

Sanilac County Sheriff's deputies arrested last week a pair of Sanilac County men, including a Snover area resident, in connection with the Dec. 15 break-in of a workshop in Wheatland Township.



Cody VanBlaricum The break-in took place in the 3500 block of Wheatland Road, according to Sanilac County Sheriff Garry Biniecki, who said the suspects allegedly stole several firearms and power tools.



Derrick Grifka "Deputies Shelly Park, James Leen and Sgt. Mark Siemen responded and processed the scene," said Biniecki, who added the officers canvassed the area and conducted interview as well

as posted information with area news sources.

"Over the next few weeks, Deputy Shelly Park remained focused as the lead investigator on the case, working the leads and obtaining statements and search warrants. The hard work paid off when the investigation and leads resulted in the arrest (of the suspects)...on charges of felony breaking and entering," Biniecki said.

The suspects were identified as Cody J. VanBlaricum, 21, of Sandusky, and a 19-year-old Derrick N. Grifka of Snover.

Both were arraigned in Sanilac County District Court on charges of conspiracy to commit breaking and entering, 2 counts of breaking and entering with intent to commit larceny, conspiracy to receive and conceal weapons, and larceny of firearms.

Both men remain lodged in the Sanilac County Jail on \$250,000 bonds (10 percent).

"The solving of this case was due to solid police work by all my deputies involved in the case, but I feel it should be noted that Deputy Park's focus and determination was key in bringing these suspects to justice," he said.

Pair of rollovers blamed on weather

Sanilac County Sheriff's deputies say a light snow that led to icy road conditions contributed to a pair of roll-over traffic accidents last week. Both crashes involved single vehicles, and only one of the drivers suffered injuries.

According to Sgt. Mark Siemen, both accidents occurred Tuesday morning.

Siemen said 37-year-old Wendy Walker of Minden City was westbound on Bay City-Forestville Rd., west of M-53 in Sanilac County's Greenleaf Township, when she lost control of her 2001 Nissan Xterra.

"The vehicle slid off the road into the south ditch, rolled completely over and landed on all 4 wheels. Walker was not injured in this

crash," said Siemen, who noted Elkland Township fire fighters assisted deputies at the scene.

Earlier in the morning on the other side of the county, Marsha Jones, 43, of Marlette, was driving westbound on M-46 near Goetze Road, east of Carsonville, when she lost control of her 1996 Ford Explorer.

"The vehicle crossed the centerline and entered the south ditch, jumped a driveway and then rolled over and came to rest on all 4 tires," Siemen reported. Jones was transported by ambulance to McKenzie Memorial Hospital in Sandusky for treatment of minor injuries.

A Sanilac Ambulance crew and the Elkland Township Fire Department assisted deputies at the scene.

"Bath salts" are focus of probe into burglaries

since August.

"Just last weekend, 2 people were incarcerated in our jail and were under the influence of bath salts consumption," he added. "These individuals were involved in physical altercations, which from our understanding commonly occurs among users of these substances. One individual became severely depressed, making the statement that because of his addiction, he had spent birthday money (set aside) for his child. This week alone, we have been involved in 4 situations that involved individuals severely affected by consumption of bath salts. One individual who hadn't slept for days had to be transferred to a detoxification center."

Michigan Department of Community Health (MDCH) officials reported a surge of emergency room visits across the state related to the recreational use of bath salts beginning in the fall of 2010, with at least one suspected death. Most of the users were young adults in their 20s and 30s.

SERIOUS PROBLEM

The rising thefts and run-ins with users of bath salts has prompted Hanson to describe the drugs as a serious problem in the Thumb community.

"I am concerned about what an individual who is addicted to these so-called bath salts will do for their addiction," he said. "We have contacted Huron Medical Center and Huron Behavioral Health to learn that they have treated several individuals for severe physical and mental effects due to the ingestion of bath salts. Because these bath salts have the same effects as a person on a 'crack binge' or someone under the influence of methamphetamine, I am concerned that this problem...will continue to grow. Reports of teenagers experimenting with these salts have been coming in and parents need to be aware of this problem."

The sheriff's department has been working together with the Huron County Prosecutor's Office, Bad Axe police, Huron County Health Department and Huron Behavioral Health in an effort to combat use of the drugs.

"I have also been contacted by the Michigan Department of Community Health," Hanson said. "We have learned that this problem does not only exist in our county. One affected area that has been dealing with this longer than we have been is the Marquette area."

enrollment, but the formula was revised last year, making the fall enrollment count worth 90 percent.

Which has school officials across the region preparing for the worst and hoping for the best when it comes to anticipating revenue based on enrollment.

"We will continue to budget for a loss of students," said Hartel, who last fall projected a loss of 50 students. In the end, the actual decline was 38 kids.

"Over the past year, the county has

lost 383 students. We're not the only school losing students," Hartel commented, noting Kingston Community Schools was the only district to pick up students (20) last fall, while the rest saw their enrollments dwindle — Akron-Fairgrove (24), Caro (84), Mayville (42), Millington (62), Reese (19), USA (16), Vassar (91) and the Tuscola Intermediate School District (27).

A look at the enrollment history in the Cass City Public Schools shows the district has lost roughly 500 students since the 2001-02 school year. Hartel acknowledged that figure is

startling, but indicated it's difficult to pin down a single reason for the trend.

"It's jobs and Schools of Choice — a lot of different factors," he said. "Last year we didn't lose any kids from the fall to winter, and this year we lost 20. That seems to be the trend around here."

"It just a frustrating part of this job," added Hartel, who pointed out that the local school system continues to offer area families a high quality education, a solid curriculum and a full slate of extracurricular activities, including athletics.

TOWNSHIP OF NOVESTA FLOODPLAIN MANAGEMENT ORDINANCE ORDINANCE NO. 2012-1

An ordinance to designate an enforcing agency to discharge the responsibility of the Township of Novesta located in Tuscola County, Michigan, and to designate regulated flood hazard areas under the provisions of the State Construction Code Act.

THE TOWNSHIP OF NOVESTA ORDAINS:

Section 1: AGENCY DESIGNATED. Pursuant to the provisions of the State Construction Code, in accordance with Section 8b(6) of Act 230 of the Public Acts of 1972, as amended, the Building Official of the County of Tuscola is hereby designated as the enforcing agency to discharge the responsibility of the Township of Novesta under said Act 230. The County of Tuscola assumes responsibility for the administration and enforcement of said Act throughout the corporate limits of Novesta Township.

Section 2: CODE APPENDIX ENFORCEMENT. Pursuant to the provisions of the State Construction Code, in accordance with Section 8b(6) of Act 230 of the Public Acts of 1972, as amended, Appendix G of the Michigan Building Code shall be enforced by the enforcing agency within the Township of Novesta.

Section 3: DESIGNATION OF REGULATED FLOOD PRONE HAZARD AREAS. The Federal Emergency Management Agency (FEMA) Flood Insurance Study (FIS) entitled "Tuscola County, Michigan (All Jurisdictions)" and dated April 3, 2012, and the Flood Insurance Rate Maps panel numbers 26157C; 0253E, 0254E, 0258E, 0259E, 0261E, 0266E, 0267E, and 0278E dated April 3, 2012 are adopted by reference for the purposes of administration of the Michigan Construction Code, and declared to be a part of Section 1612.3 of the Michigan Building Code, and to provide the content of the "Flood Hazards" section of Table R301.2(1) of the Michigan Residential Code.

Section 4: REPEAL. All ordinances inconsistent with the provisions of this ordinance are hereby repealed.

Section 5: EFFECTIVE DATE. This ordinance shall be effective upon the date of publication specified below.

New life

Cass City agriscience students and teacher welcome a litter of piglets

Last week it seemed as though spring was in the air, even though it was the only first part of February. Temperatures in the 40s, birds singing and kids playing outside with no snow pants added to the illusion that spring was near.

The birth of baby animals and birds also sparks images of the end of winter, and last week new life arrived in the Ag Learning Lab at Cass City High School.

Thursday, Feb. 9, marked the first time livestock gave birth to offspring in the Ag Learning Lab. The first of 17 piglets was introduced to the Cass City community at 10:45 a.m. Ashlee Gibson, agriscience teacher at Cass City High School, assisted in the birth of the final 2 piglets at about 2:30 p.m.

Of the 17 piglets born, 16 survived and one was stillborn. The sow, affectionately named Mabel by the Cass City High School teaching staff, was 2 days past her due date.

Mabel isn't new to motherhood—this is her seventh litter. She has averaged 11 to 18 piglets in each of her 7 litters. The sow was purchased pregnant last month.

In addition to the new mother, the Ag Learning Lab houses another pregnant pig named Zelly. She is due at the beginning of April. There are also 3 pregnant goats scheduled to deliver kids in 2 weeks. A week after that, 3 sheep are due to give birth to lambs.

The new arrivals are bound to keep Ms. Gibson and her ag students busy for the next few months.

Students, under the guidance of Gibson, played a major role in the unique learning experience that took place last week. Students would visit the Ag Learning Lab at different times to check on the expecting pig. A web cam was installed in the hutch

so interested viewers could witness the birth. Interested individuals could also visit babycam.casscityschools.org and enter a password given out by Gibson to follow the miracle of life.

"It's a really good hands-on experience most kids don't get to experience. Whether it was through the web cam or first hand, it gives them an idea if they want to pursue careers as vets or other careers in the ag industry," Gibson said.

Megan Parrish, a senior at Cass City High School and ag student, received a true hands-on experience in that she helped deliver at least 10 of the piglets.

"I loved it! It was a great experience, and I'm ready for the next one," said Parrish, whose mother, Brenda Sherman, was able to view her daughter's involvement via the webcam. "I think it's a wonderful experience for all the kids. A lot of kids never have a chance to work with animals. What an awesome thing for our school system," Sherman said.

Ag students weren't the only members of the Cass City community attuned to the day's event. Students and staff across the high school campus were brimming with excitement throughout the day.

"What a very cool day today for all of the students. I am grateful for the cam out in the barn so we could all be a part of today," commented high school teacher Sean Zawilinski. "It seems that this was a topic for many today." The births themselves served as an exciting educational opportunity, she added. "The nice part was the cross curricular discussions."

The incredible learning experience connected with these piglets will continue until they reach approximately 50 pounds. At that time, they will be sold as feeder pigs. Individuals who might be interested in a pig when they are ready can con-



The Red Hawks will face perennial powerhouse New Lothrop tonight (Wednesday) in team regional action


in Marlette and travel to New Lothrop Saturday for individual regional play.

Tuesday, May 8, ballot, school Supt. Jim Wencel said. The Michigan Department of Treasury has already approved a preliminary draft of the proposal, with final approval expected yet this month, Wencel added, noting Owen-Gage's approach to securing the funding will enable the district to utilize the state of Michigan's credit rating.

Wencel explained the bond issue, if approved, will pay for a host of projects designed to upgrade the school building in Owendale. "Most of it is infrastructure stuff — new boilers, new roof, classroom furniture, equipment," he said.

Also planned are electrical service and lighting improvements along with an upgraded fire alarm system to bring the district up to code. A telephone system that's more than 20 years old will also be replaced.

Wencel said school officials plan to sink roughly \$150,000 into technology upgrades. "Our wiring is in pretty good shape and our routers are in pretty good shape. Most of it will go into 'end-of-the-line' technology — new computers, projection devices," he explained.

The improvements will include \$64,000 in site work, which will consist of paving a parking lot and service drive along with minor upgrades to athletic fields.

An estimated \$1.37 million will pay for renovation projects, including remodeling the gymnasium floor, new locker rooms, demolition of the concrete bleachers in the cafeteria. About \$385,000 of the total is the price tag for a new roof, while another \$130,000 will go for a new ceiling, and \$24,000 is expected to cover replacement of some flooring sections in the building.

In addition, new boilers will cost \$120,000, and the electrical upgrades are expected to run about \$180,000.

Wencel said another segment of the bond issue — roughly \$343,000 worth — will be spent on a new bus, a video security system, the new telephone system and furniture for 15 classrooms.

A citizens' committee will be formed soon to promote the bond issue, which will mean an increase in taxes for district residents.

The good news is Owen-Gage currently has no outstanding debt, according to Wencel, who said the bond issue would initially cost the owner of a \$40,000 home about \$120 annually, while the owner of a home valued at \$60,000 would pay \$180 a year to help fund the capital improvements.
