Lawmakers give schools \$120 more per kid

Thumb area school districts, along with many of their brethren throughout Michigan, stand to collect thousands more in state revenue under a new budget approved by the Republican-led House Thursday.

Unfortunately, the proposed increase in revenue for some K-12 schools falls far short of the cuts Lansing has handed down to local schools over the past few years.

The measure approved last week includes raising the minimum perpupil grant to \$6,966 per student, up from \$6,846. Thumb area districts are among those at the lowest funding level in Michigan. Schools already receiving more would see no per-pupil hike, but they could qualify for additional funding through technology and district performance grants or by adopting plans to hire private contractors to provide custodial and food services.

The proposed funding increase still leaves the lowest-paid school districts getting 5 percent less than the \$7,316 per pupil they received

in the 2010-11 school year, before Legislature reduced the amount by \$470. They made the cut so they could funnel \$1 billion of the school aid fund to community colleges and universities.

The state spending plan was expected to go to the Republican-led Senate this week Tuesday, sending the budget to Snyder's desk.

"It looks like money coming back to the schools. It all helps out," commented Cass City School Supt. Jeff Hartel, whose district stands to receive roughly \$140,500 more in state funding stemming from the \$120-per-student increase.


The estimate is based on a projected enrollment of 1,172 students next fall. For the purposes of budgeting, Hartel is hoping for the best but preparing for the worst, which is why he built a loss of 50 kids into the new spending plan — the Cass City Schools has lost a combined 500 students over the past 10 years, costing the district hundreds of thousands of dollars in revenue.

Hartel acknowledged any additional funding from Lansing is welcome.



Nearly 80 participate in annual tractor drive

It's not an uncommon occurrence to encounter a tractor or 2 on the roadways of the Thumb, especially in the spring and fall.

The region's rich agricultural heritage dates back many generations and it continues to influence the lives of most of the residents of Huron, Sanilac and Tuscola counties in some way, shape or form.

Residents who were traveling in the vicinity of the Lamotte Township Fire Hall Saturday were able to enjoy the 8th Annual Sanilac County Rainbow Tractor Drive.

The "Rainbow" portion of the event title relates to the various models and colors of tractors present for the drive. John Deere, Farmall, Oliver, Allis-Chalmers, Ford, McCormick and Minneapolis-Moline were the most common names recognized by even the most novice witnesses, but other tractor companies were also represented.

What began 8 years ago as a somewhat impromptu scenic trek, has turned into a highly organized and anticipated yearly event. Bob Darling and Gary Duff, both of Marlette, were this year's co-organizers.

In the past, the tractor drive has enjoyed high attendance. There have been entrants from Canada, Indiana and Illinois who have taken part. Two years ago provided the highest number of participants at 98, while last year's drive produced 87 tractors. Despite skies threatening to water the crops, 77 tractors pulled out of the Lamotte Township Fire Hall Saturday. As the day's activities rolled forward, a few late entries into the parade line pushed the number closer to 80.

The event kicked off with all drivers and riders registering at the fire hall by 8 a.m. Each driver was responsible for his/her own liability insurance, Please turn to page 12.

Officers' cooperation deserves our praise

Police departments across the country are sometimes the target of criticism for the way they handled this incident or that crime scene, while outstanding police work is often taken for grant-

We'd like to offer some area law enforcement agencies a bit of praise for their efforts in a recent case involving several break-ins in Tuscola County.

Sure, this isn't the sort of major criminal activity that hogs the spotlight on your television news broadcast each night. However, we'd like to think this case is a great example of how our local police agencies get the job done day in and day out.

In a nutshell, the Kingston Police Department and Tuscola County Sheriff's Department detectives had been investigating a series of late-night burglaries over the past 18 months. The suspects in the case are a couple who had lived in the Kingston area but then moved into a home in Snover in Sanilac County.

The burglaries continued, with property disappearing from unoccupied homes, vacation properties, etc.

Tuscola County detectives sought the assistance of the Sanilac County Drug Task Force in an effort to gather evidence via surveillance of the suspects. The tactic proved successful, with offi- is second to none cers from 4 agencies, including the Sanilac County Sheriff's Department, converging on the time to recognize the day couple's home.

*In the end, the suspects admitted to several bur*glaries, and police recovered a mountain of property — thousands of dollars worth of merchandise ranging from clothing, lawn furniture and small appliances, to a pair of log splitters, a furnace and a large industrial air compressor. In all, investigators said the suspects' combined take added up to 5 truckloads of stolen goods.

Now, the suspects will have their day in court and a host of grateful Tuscola County residents will be getting their belongings back.

The success of the operation can be attributed to plenty of cooperation by departments whose officers combined their experience and crimesolving skills to put an end to this little crime wave. Equally important, the arrests and seizure of property will hopefully send a strong message to would-be thieves throughout the region.

There was no petty bickering among these police agencies over turf, jurisdiction, etc. Their only priority was doing their job and doing it well.

That's worth keeping in mind the next time we go to the polls to consider a millage renewal for law enforcement operations.

The Michigan State Police (MSP) recently announced the results of preliminary reports that indicate 8 people lost their lives in 7 separate traffic crashes during the 2012 Memorial Day holiday weekend.

In comparison, 9 people died in traffic crashes during the 2011 Memorial Day holiday weekend.

Of the 8 fatalities, 3 were known to have used restraints, and alcohol was a known factor in 2 of the 7 crashes.

"These numbers are preliminary and only reflect those fatalities reported to the MSP as of noon today," said Captain Kari Kusmierz, commander of the MSP Training Division. "The preliminary numbers show a decrease in fatalities from this same holiday period last year. The MSP continues to urge motorists not to drink and drive, to always use proper restraints and to drive safely.'

The 2012 Memorial Day holiday weekend ran from 6 p.m., Friday, May 25, through midnight Monday, May 28.

Spur of the moment

Homemade turkey calls are a specialty

by Mason Doerr **Staff Writer**

The idea to craft a homemade turkey call was "spur" of the moment.

Jim Windy, of Cass City, has been making handmade turkey box calls with Rick Doerr since the spring of 2003. Over the last several years they have made over 130 that boast their trademark name, "Windy Calls"

"I got the idea when I was out in the woods deer hunting," Windy said. "I thought it would be nice to make something out of the outdoors."

The original plan was just to make one call to see if it would work, but after looking at the first call, which worked, they started coming up with new ideas on how to modify it and make it an overall better product.

"There are probably 7 or 8 different patterns that we mainly use. Others are one of a kind," Windy said. "Black walnut, cherry and ash are the main 3 woods used."

"The cherry (calls) are the easiest ones to work," Windy said. "We did make some out of birds-eye maple which was kind of unique.

Once the calls are finished they are given away, traded for new wood or sold to customers.

"We get a lot of repeat business," Windy said. "People come back and want them for gifts or for young new hunters in their families.

"Sometimes people send us pictures of the birds they ve gotten, Windy added. "Most of them are sold locally, but there are some out of state and I think one even went to Canada."

The calls are made at Windy's house and a wide variety of power tools are used in the making of these box calls. Some of the tools used include a table saw, miter saw, planer, drill press, palm sander and several others, including some homemade

'Sometimes you have to make your own jigs to help with the process," Windy said. "Not only for gluing them, but also for putting the finish on them.

Although these box calls are relatively small, the process of making them is complex and time consuming. On average, it takes roughly 5 to 6 hours to complete one. And that's not counting the time it takes for the glue to dry, or the time between applying each layer of finish.

Windy has also tried making different kinds of calls, including wing bone calls, which is another way of attracting turkeys.

In the end, the making of these calls is just something that is done as a hobby. Windy mentioned that if it became a job, making them wouldn't be fun anymore.

'Each call is numbered and we try to keep track of who buys what," Windy said. "It's just a hobby. It's just supposed to be fun."

Chocolate

American chocolate manufacturers use about 1.5 billion pounds of milk - only surpassed by the cheese and ice cream industries.

Lecithin is an emulsifier derived from soybeans used to reduce the viscosity of chocolate. It serves to lessen the amount of cocoa butter required in the manufacturing process.

There are about 5 to 10 milligrams of caffeine in one ounce of bittersweet chocolate, 5 milligrams in milk chocolate, and 10 milligrams in a six-ounce cup of cocoa. By contrast, there are 100 to 150 milligrams of caffeine in an eight-ounce cup of brewed coffee. You would have to eat more than a dozen Hershey bars, for example, to get the amount of caffeine in one cup of coffee.





to pay down some of the unfunded liability owed on retirees' health care costs.

However, there was no word regarding a controversial proposal in Lansing to overhaul Michigan's retirement system. Specifically, schools' mandatory payments to MPSERS, which now cost districts between 10 and 15 percent of their operating budgets, may be reduced.

Facing a \$45.2 billion unfunded liability in the state retirement system, GOP lawmakers have been pushing for a plan that would relieve rising retirement costs for schools districts and community colleges by imposing higher pension contributions on most employees hired before 2010.

The proposal under consideration, which cuts schools' contributions by 3 or 4 percent, would save the Cass City Schools an estimated \$150,000 to \$200,000.

Like their peers across the state, Hartel and the Cass City Board of Education have spent their fair share ment system.

of time trying to figure out how to further trim a lean budget without significantly impacting academic programs and offerings.

Locally, the board, which is scheduled to approve its new, 2012-13 budget later this month, has already adopted a plan cutting about \$1 million in spending, including more than \$400,000 in an agreement in which 5 veteran instructors agreed to leave the district in exchange for one-time payments of \$15,000 each. That move enabled school officials to table plans to layoff up to 8 instructors.

In addition, the school board closed Campbell Elementary School this year, saving nearly \$220,000; implemented a number of personnel changes; eliminated freshman sports and transportation for athletic events; and eliminated transportation for field trips.

Hartel has said school officials hope to reinstate some cuts should the Republicans follow through with promises to overhaul the state retire-







The best part of summer break for most is taking a vacation to somewhere



under legislation signed into law by Gov. Rick Snyder. With the signing Department of Human Services can begin moving forward with federal review and approval.

Many of the 800 foster care youths turning 18 each year lose the only reliable adult support they have ever known – some even become home-

'Young people in foster care need the same kind of support other 18year-olds do as they navigate the crucial years leading up to age 21," Snyder said. "The Fostering Connections legislation will give those who wish to receive it the extra assistance they need to become successful adults.

Extended benefits are made possible by the Fostering Connections to Success and Increasing Adoptions Act of 2008, which gave states the option of receiving matching federal funds for providing additional serv-

"Michigan is proud to be in the ture.mi.gov. forefront of this important reform effort," said Maura Corrigan, director of the Michigan Department of Human Services. "Offering an additional three years of support to young people who are on the cusp of adulthood will help ensure they successfully arrive at that destination."

Under the legislation, officially known as the Young Adult Voluntary Foster Care Act, Michigan will offer 18-, 19- and 20-year-olds the option of living in a licensed foster family home, a child care institution or a supervised independent living arrangement. In addition they will receive case management support, training in independent living skills, counseling services and medical assistance.

Young people aging out of enrolled in college or vocational 6-6-4 Michigan's foster care system at 18 training or be working at least 80 will soon have the option to receive hours a month, unless they have a life-directing support until age 21, medical condition that prevents it, to receive services.

The legislation addresses growing of the legislation, the Michigan evidence that foster care youth who receive extended supports are more likely to become successful adults. Statistics show that only half of Michigan youths aging out of the foster care system are likely to earn a high school diploma and, of those, only 10 percent will enroll in college less - when funding for their care or other training. What's more, foster care youths are at greater risk of early pregnancy, welfare dependence and arrest, national studies show.

"Few young people can make their way in the world unassisted at age 18," Corrigan said. "This legislation recognizes the reality of that and provides the kind of assistance that can keep foster care youths on the right track to independence.'

Senate Bills 435 through 440, sponsored by state Sens. Bruce Caswell, Judy Emmons, Mark Jansen, John Moolenaar, Mike Nofs and John Proos, respectively, are now Public Acts 225 through 230 of 2011. Detailed descriptions of the bill may be found online at www.legisla-

The bill signing came during the celebration of Michigan Adoption Day, an annual event started 9 years ago by Corrigan, then serving as a state Supreme Court justice. The event is co-sponsored by the Michigan Supreme Court, Michigan Department of Human Services, Michigan Adoption Resource Exchange and the Family Services Division of the State Court Administrative Office.

Michigan Adoption Day highlights issues facing children in foster care, including their need for permanent, loving homes. Families celebrated final adoptions at similar events across the state.
