Tendercare Cass City officials are gearing up to showcase a host of upgrades at the local facility, including a new therapy gym.

Area residents are invited to an open house slated for Thursday, Nov. 8, from 3 to 6 p.m. at Tendercare Cass City, located at 4782 Hospital Dr.

Officials earlier this fall reported the second phase of a major renovation project was proceeding on schedule.

This week's open house will feature tours of the new therapy gym along with improvements completed throughout the long-term nursing care facility, according to Cheryl Ollila, referral manager, Tendercare Cass City/Frankenmuth.

Specifically designed, staffed and exclusively dedicated to the care of aging individuals, Tendercare Cass City sets a new standard in care, Ollila said.

"Performing phase one of renovations (last fall), the center now features a new parking lot, siding, roof and gutters," she said, adding the more extensive phase 2 included the therapy gym, resident rooms, nurses' station and cosmetic updates to flooring and walls.

## Former Cass City man offers to match theatre donations with \$5,000

It's been decades since Steve Auvil stepped into the projection booth at the Cass Theatre, but the former Cass City resident hasn't forgotten the valuable lessons he learned while working for theatre owner Dick Hendrick.

Auvil also hasn't forgotten the Cass' place as an historic treasure of sorts in the village, calling it "more than a business, it is an institution.

"Countless Cass City area residents have attended movies at the Cass Theatre over the years since it opened late in 1935. The thought of driving down Main Street and seeing the Cass Theatre closed is unfathomable," he wrote in a "letter to the editor" in this week's issue of the Chronicle (See page 3).

Auvil's fond memories of the local theatre have prompted him to reach out to his hometown with an offer to help raise money that would enable Dick and Elaine Hendrick to upgrade their equipment and remain open for years to come.

Auvil's offer? To match local donations with up to \$5,000.

The dilemma the Hendricks face today stems from a film industry trend of going to an all-digital format, requiring installation of tens of thousands of dollars worth of new

We're not putting \$80,000 into it," Hendrick recently commented at the theatre, referring to the prospect of

installing the new digital equipment. "Everything in the booth, other than the surround sound stereo, would be junk because it would be an entirely different set-up," he said.

The change would mean distributing movies via computer rather than physically delivering copies of films. Although Hendrick already has a modern sound system and 3-D screen, the switch would still carry a hefty price tag of at least \$65,000.

## Man hurt in fire; loss set at \$17,000

A Cass City area man suffered second degree burns in a garage fire at his residence about 2 miles south of the village Friday after-

Elkland Township fire fighters were dispatched to the residence, located at 3301 N. Cemetery Rd.,

at about 2:26 p.m. Elkland Township Fire Chief Glenn Guilds said Richard Brown

was repairing a vehicle inside the garage when the blaze ignited. Brown, who told firemen there was a leak in the vehicle's gas tank, was transported to Hills and Dales General Hospital for treatment of burns to his leg.

Guilds said both the vehicle and garage were destroyed. He estimated the loss, including tools and equipment inside the structure, at \$17,000. The fire chief noted the homeowner, Darlene Ganley, is

According to the American School buses are the safest, most economic Bus Council, students are 50 times safer riding a school bus to and from school than driving themselves or riding with friends, and 20 times safer than riding with a parent or other adult. In addition, it's estimated every school bus keeps 36 cars off the roads around schools, reducing the likelihood of a crash and improving traffic flow.

> In 2011, Michigan school buses were involved in 902 crashes that resulted in 273 injuries, according to the Michigan State Police, Criminal Justice Information Center. The majority of those injured were motor vehicle drivers and passengers or pedestrians. While 3 people died in school bus-involved crashes, none of the fatalities were students riding on a school bus.

## SOS to close in observance of Veterans Day

Secretary of State Ruth Johnson reminds residents that all branch offices and the Office of the Great Seal will be closed on Monday, Nov. 12, in observance of Veterans Day.

The Department of State mails notices to motorists 45 days before their driver's license or license plates expire to give them ample time to renew. Licenses and plates that expire on a day when state offices are closed, such as a holiday or weekend, can be renewed the following day without penalty.

Most people renewing license plates, driver's licenses and ID cards can do business online at www.ExpressSOS.com or by mail. Easy to follow instructions can be found with the renewal notice. Additional services can be done online as well.

License plate tabs can also be renewed at Self-Service Stations, many of which are available around the clock. Visit the Branch Office Locator at www.michigan.gov/sos to find a Self-Service Station near you.

With the exception of holidays, offices are open Monday, Tuesday, Thursday and Friday from 9 a.m. to 5 p.m. Smaller offices may close for the lunch hour. On Wednesdays, most offices are open from 11 a.m. to 7 p.m., with those in city centers open 9 a.m. to 5 p.m. PLUS offices and SUPER!Centers are open from 9 a.m. to 7 p.m. on Wednesdays. SUPER!Centers also provide Saturday hours from 9 a.m. to noon.

## Tread lightly with rental ordinance

Cass City Village officials are considering a new ordinance related to rental properties that would, presumably, set some specific standards for the property

We'd like to urge local officials to proceed with caution, although it appears the council is doing just that, having tabled the issue to further study what such an aimed at manipulating my offspring into eating items ordinance should (and shouldn't) include.

Some of the landlords present indicated they're concerned about having to shoulder the cost of another set of housing regulations, and that the village may be trying to hold them to a higher standard than other homeowners in town.

Those are legitimate concerns, but to some extent, rental owners are already held to a higher standard by laws that govern liability when it comes to the condition of their properties. In other words, they can and often are held accountable when a tenant is injured or otherwise harmed due to negligence on the part of the landowner.

As for Elkland Township Fire Chief Glenn Guild's part in the discussion, Guilds has made it clear he isn't pushing for a new set of extensive rules that will cost an institution in town property owners an arm and a leg. The fire chief is, however, urging local government officials to take a serious look at safety issues for the sake of both residents and emergency response personnel.

We agree those are issues that deserve everyone's

Guild's concern stems, in part, from an apartment fire at a Main Street building last spring. There were 8 or 9 people living in the space of 2 apartments there, and *neither apartment was equipped with a smoke detector* or fire extinguisher.

Guilds is the first to say he believes the majority of rental property owners are doing a great job, but he also knows there's always going to be one or 2 that are more concerned with the almighty dollar than with the safety of their tenants.

Which has prompted him to make some common sense suggestions; require smoke detectors and fire extinguishers as well as separate entrances and exits for these buildings (exit ladders for upper floor apartments), and compile some sort of information database accessible to emergency response personnel that tells them where apartments are located and how many people are occupying each apartment.

"We didn't even know there were extra apartments up there," Guilds said of the fire his department responded to last spring. That's the worst-case scenario, when you don't know and you have to make a decision — do you send guys in (inside a burning building) when there's nobody there?

"The bottom line is safety for everybody, not only for tenants, but also for fire fighters."

Makes sense to us, especially with the economy forcing many families to make use of apartments and living in close quarters.

Better safe than sorry.

## Slices of Life



Food rules



When I walk into the kitchen first thing Monday morning and see the medicine cupboard ajar and an open box of cold tablets on the counter, I know we may be in for a long day and an even longer week. This morning was a three-fer.

Son number one complained of a sore throat. Son number two didn't want breakfast because his stomach didn't feel right. My husband was the culprit with the cold pills. He was achy and stuffed. That's no one's favorite way to start a week.

Since I'm too ornery to get sick, I watched from the sidelines, as only a wife and mom can. I thought about what I could do to help, and my mind headed in one direction. I grabbed a large stockpot and set out to prepare my special cure-all remedy: chicken soup.

I had to. Rules dictated my actions. At our house we have food rules. Tenets to live by. Precepts that precede our tasting and chewing. Many of them are unspoken – unconscious even – but they guide our culinary habits and experiences nonetheless. Rule 15 states homemade chicken soup is the weapon

of choice for colds and the flu. Ice cream, on the other hand, fixes broken hearts (Rule 37). Hot fudge sauce atop ice cream is deployed in the gravest of emergencies (Rule 52)

Not all our rules involve illness or heartbreak. Most days we aren't sick or crying. Thank goodness. Still, even in the status quo, food rules find their place in our

Many rules are based on psychological principals they otherwise would not consume. For instance, never ask your children what they want for dinner (Rule 88). If you do, their answer will include things like cheese balls and cotton candy. They will not suggest green beans, lean protein or any of the healthy choices currently in your refrigerator. Keep it simple. Keep it secret. Serve them up a platter of veggie-filled goodness and call it... chicken (Rule 119).

The Food and Drug Administration advises us to include a rainbow of foods in our diet – the more colorful the better. Kids love the idea of eating a rainbow. However, it is imperative parents are clear on the inher-

ent make-up of the color scheme. Skittles and M & M's do not qualify for rainbow status (Rule 198). Nor can a Reese's Peanut Butter Cup serve as a legitimate substitute for carrots – even though it comes in an orange wrapper (Rule 223). Be vigilant in your rule abidance. Do not let the children make unauthorized substitutions (Rule 256). Be prepared to hide the chocolate when necessary (Rule

Some of my favorite rules pertain to healthy eating and calorie control. They are rooted in common sense. For instance, hidden chocolate contains only hidden calories (Rule 271). Go ahead, indulge – but only when the kids aren't looking (Rule 292).

Here's another classic I adore: if you eat the ice cream right out of the container, it does not count toward your daily calorie intake because it isn't considered a snack unless you put it in a bowl (Rule 315)

This same rule applies to nibbles eaten while standing – versus sitting. Standing and eating cancel each other out because it takes more energy to stand (Rule 340). This is not based on any scientific evidence from the FDA, but on my own vast knowledge of the caloric universe. I've been eating for more years than I'll ever admit. My experience has taught me this: two bites of cake, eaten while standing, do not count as a snack. Three bites do, however, so you're smart to stop at two and leave the kitchen for a short while before returning for another bite or two but never three (Rule 389).

Food rules have been around for centuries and they aren't going anywhere anytime soon. They may ebb and flow and evolve with our culinary habits, but until someone invents a substitution for eating, food will be a constant in our lives. Forever.

Today my fodder of choice is chicken soup. The concept is generations in the making – feed a cold, starve a fever and all that jazz. Some experts believe I'm wasting my time. They say chicken soup does nothing to cure the common cold. The idea - they purport - is all in our

I think they've got it wrong. The love and feel-good medicinal properties that come from homemade soup don't originate in our heads. They come from the heart for the person stirring the stockpot as well as the one eating from it (Rule 1).

Okay newsstand readers, here are some election day reminders:

•Photographing ballots: The use of video cameras, still cameras and other recording devices are prohibited in the polls when they are open for voting. This includes still cameras and other recording features built into many cell phones. The ban applies to all voters, challengers, poll watchers and election workers. Exceptions are made for credentialed members of the news media though certain restrictions remain. Photos of ballots should not be posted on social media. Additionally, under Michigan election law, a ballot is rejected if deliberately exposed. A voter who deliberately exposes their ballot will not be allowed to vote in that election.

•Displaying election-related materials at the polls: Michigan has prohibited this practice for decades. This includes clothing and buttons as well as materials such as pamphlets, flyers and stickers. You may not display such items in the polling place or within 100 feet of an entrance to a polling place. If a voter goes to the polls with a T-shirt or button bearing campaign-related images or slogans, he or she will be asked to cover or remove it.

•Voter identification: You will be asked for photo ID when you enter the polls. If you do not have a photo ID or did not bring it with you, you will be asked to sign an affidavit attesting to your identity, and then you can vote. Your ballot will be counted alongside all others on

• Voting a straight party ticket: At the top of each political party's column on the ballot, there is an opportunity to vote "straight" party, which selects all candidates on that party's ticket with a single vote. If you vote straight party, there is no need to vote again for any individual candidate in the party column. However, if you do vote straight party and then vote for an individual candidate in that same party, it will not invalidate your vote for that candi-

•Split-ticket voting: You may "split" your ticket, which means you may vote for candidates of different parties, in the Nov. 6 general election. This differs from the August primary in which you must confine your votes to a single party column. Voters, however, must still be careful not to vote for more candidates than are allowed in specific races. Even if you vote a "straight" ticket, you may cross over and vote for candidates of a different party.






"My dad, Ray Auvil, taught me and showed me by example that when you take on a project, you don't do it in a halfhearted way and that you take pride in what you do and/or service you provide," Auvil commented Friday from his home in Macungie, Penn.

"During the couple years I worked for Dick Hendrick, he strongly reinforced that work ethic. Dick was, and I assume still is, a stickler about ensuring the theatre was clean and comfortable, the snack bar and quality of the snacks were top notch, and the quality of the sound and picture were first rate," he added. "He expected all of us — his family members, other employees and me — to do whatever it took to make attending a movie at the Cass Theatre an enjoyable experience.

"As the projectionist, I felt the pressure because if I didn't do my job well, all the tasty popcorn in the world wouldn't make up for sitting through 2 hours of a poorly projected image on the screen," Auvil recalled.

"Dick monitored the sound and picture quality from the back of the theatre as he went about his tasks, (and) there was a button there that he could push to signal me that there was something that needed to be addressed," he explained. "To this day I can remember the signals: one buzz, raise the volume; 2 buzzes, lower the volume; 3 buzzes, fix the

Auvil indicated he owes some of his success to his years growing up in Cass City.





## Small game

## From rabbits to wild turkeys, hunting opportunities abound

Sept. 1 with the opening of the early Canada goose season and continues until rabbit and hare season ends March 31. Department of Natural Resources wildlife biologists across the state say hunters should find conditions similar to last year — with a couple of notable improvements — in Michigan's wood lots, farm fields and wetlands.

#### Rabbits

Season: Cottontail rabbits and varying (or snowshoe) hare can be hunted from Sept. 15 - March 31, statewide. The daily bag limit is 5 in combination with a possession limit of 10.

Outlook: Roughly 60,000 hunters reported pursuing rabbits in 2010 (the most recently completed harvest survey), and about 15,000 hunted hares. Cottontail populations are good throughout their range over much of the state. Concentrate on thick cover, such as briar patches and brush piles, often near agricultural fields. Snowshoe hare populations, which are cyclical, are down somewhat from historic levels. Look for early-successional forests (such as aspen stands), and low-lying swamps with blow-downs and brush piles in the northern twothirds of the state.

#### **Squirrels**

Season: Sept. 15 - March 1. The daily bag limit is 5 per day with 10 in possession.

Outlook: Both fox and gray squirrels are at moderate to high levels across much of the state. Areas that had good acorn or nut production last year are a good bet as are wood lots adjoining corn fields. Post-deer-season hunting, in January and February, is increasingly popular. About 70,000 hunters pursue squirrels each year.

#### **Ruffed Grouse**

Season: Sept. 15 - Nov. 14 and Dec. 1 - Jan. 1, statewide. The bag limit is 5 per day/10 in possession in the northern two-thirds of the state, 3 per day/6 in possession in Zone 3 (southern Michigan).

Outlook: Grouse populations are cyclical, typically rising and falling over a 10-year period, and indications are that the state is coming off a peak, though spring drumming surveys indicate populations are still high and a warm, dry spring should help this year's reproduction.

Michigan boasts about 85.000 grouse hunters. Grouse are denizens of earlysuccessional forests — young to moderate-aged aspen stands (with trees of a

baseball bat) and tag alder thickets. Food sources are important, but berry and wild fruit production is down because of the dry summer this year.

Grouse are most numerous in the Upper Peninsula and northern Lower Peninsula, but hunters may find local populations in areas with good habitat in southern Michigan as well. Grouse and woodcock hunters are asked to assist the DNR in monitoring populations by reporting their results. Cooperator forms can be found on the website

www.michigan.gov/hunting (select Upland Game Birds and then Ruffed Grouse).

#### **Ducks**

Seasons: Sept. 22 - Nov. 16 and Nov. 22-25 in the North Zone (Upper Peninsula); Sept. 29 - Nov. 25 and Dec. 15-16 in the Middle Zone; and Oct. 6 - Nov. 30 and Dec. 29 - Jan. 1 in the South Zone.

The bag limit for ducks is 6 per day with no more than 4 mallards (no more than one hen), 3 wood ducks, 4 scaup (bluebills), 2 redheads, 2 pintails, one canvasback and one black duck. Five additional mergansers (no more than 2 may be hooded mergansers) may be taken. Possession limit is 2 days' daily bag limit.

Outlook: Hunting prospects for Michigan's 40,000 duck hunters are excellent as continental populations are at an all-time high and most species are above long-term averages. Locally, spring surveys indicated a 70 percent increase in mallard numbers, but biologists are tempering their enthusiasm because of drought conditions this summer. Good opportunities for puddle ducks, especially wood ducks, exist in beaver ponds and small inland floodings, but some of those areas could be dry this year. Diving ducks, which usually begin arriving in good numbers around mid-October, should be plentiful on the Great Lakes, with improved bluebill numbers allowing for a larger bag.

#### Canada Geese

The regular goose seasons are Sept. 22 - Dec. 22 in the North Zone; Sept. 29 - Dec. 29 in the Middle Zone; and Sept. 22-23, Oct. 6 - Nov. 30, and Dec. 29 - Jan. 1 in the South Zone, except in designated goose management units (GMUs). The daily bag limit is 2. In Saginaw County Tuscola/Huron GMUs, the season is Sept. 22-25 and Oct. 6 - Jan. 1 with a daily bag limit of 2.

The late goose season, in the South (1917).

Small game hunting season began diameter ranging from a cue stick to a Zone excluding the GMUs, is Jan. 12 -Feb. 10 with a daily bag limit of 5.

> Hunters may take 20 snow, blue or Ross geese daily and one white-fronted goose and one brant during the regular and late seasons.

Outlook: Resident Canada goose populations, which account for more than 70 percent of the state's total harvest, are above population goals, so hunters should find plenty of geese, and with 107 days of hunting, more opportunity than ever. Roughly 35,000 hunters pursue geese in Michigan.

## All residents urged to get pertussis and flu vaccines

The Michigan Department of we lead by example to protect not only Community Health (MDCH), along with our patients, but the entire health care the Michigan Osteopathic Association (MOA) and Michigan State Medical Society (MSMS), are urging all Michigan residents to get vaccinated against pertussis, also known as whooping cough, and influenza to protect themselves and vulnerable infants.

"Most parents today have never seen the devastating consequences that vaccine-preventable diseases can have on a family or community," said James K. Haveman, director of the MDCH. "Through vaccination, Michigan families are much better protected than they were in the past but vaccine-preventable diseases are still a very real threat and they continue to exist in the communities in which we live, work and play.

On May 17, Veronica McNally, mother of Francesca Marie, lost her 3-month-old daughter to pertussis, also known as whooping cough. McNally believes herself, Francesca, and her son had pertussis disease, which went unrecognized by numerous health care providers. McNally was not advised of the importance of receiving a tetanus-diphtheriaacellular pertussis (Tdap) vaccine for herself and those around Francesca to cocoon her daughter against this serious disease. Vaccination of those around infants is critical because infants cannot be fully immunized against this disease until 15-18 months of age. Additionally, her 2 older children were on a delayed immunization schedule.

"In deciding to delay my children's vaccination schedule, I thought I was doing what was in their best interest," McNally said. "I thought I was informed. I thought my vigilance in seeing a doctor when my children were sick was going to help protect them. I thought I was on top of my children's health. But I was naive."

Whooping cough is one of the most commonly occurring vaccine-preventable diseases in the U.S. and cases are on the rise

In Michigan, there has been a steady increase in pertussis throughout the past decade, with a peak of more than 1,500 reported cases in 2010. This year in Michigan, there already have been 597 reported pertussis cases as of Sept. 30.

Influenza is also a life-threatening disease especially for infants. During the 2010-11 flu season, there were 6 influenza-associated pediatric deaths in our state. Currently, flu activity nationwide is beginning to increase. Michigan already has seen 12 cases.

'Since health care personnel are the first line of defense in diagnosing, treating and preventing the spread of these infectious diseases, it makes sense that

workforce," stated Michigan State Medical Society President-elect Kenneth Elmassian, D.O. "Whether we commit to it as individual providers, or as health care institutions, we must take all appropriate measures to prevent the spread of infectious diseases in health care settings. This certainly includes vaccinating ourselves against seasonal and pandemic flu and pertussis." In Michigan, vaccination rates among


adults are very low, with almost 17 percent of adults ages 19-64 and only 66 percent of Michigan adolescents ages 11-12 having received the Tdap vaccine. Studies have shown that immunity to pertussis wanes after the childhood series has been given, therefore it's critical to vaccinate adolescents and adults to further boost their pertussis protection. Vaccination rates are also low for the flu vaccine, with only 31 percent of Michigan adults ages 18-64 vaccinated against the flu during the 2011-12 sea-

"Today's vaccines are created using modern technology, and involve many scientific disciplines. Our patients and their families should feel confident that the 'how to', and 'wherefores' of vaccine administration is greatly understood today," said Anthony Ognjan, D.O. FACP and member physician with the MOA. "The techniques involved for safe and effective vaccination delivery have been simplified for the average physician, specialty physicians and other health care providers, by diverse groups of scientists, physicians and clinical practitioners.

MDCH, MOA, and MSMS are urging Michigan families to talk to their health care provider about the vaccines they need for themselves and their family. Further, Michigan health care providers are encouraged to never miss an opportunity to vaccinate and to strongly recommend vaccines to patients of all ages. Even if you don't have a baby in your family or social circle, these diseases can be passed on anywhere that air is shared. Infants depend on all of us to be vaccinated to protect them.

"To all expectant mothers, I urge you: please ask your doctor about vaccination against pertussis and flu for you and all members of your family," said McNally. "Protect your infants."

## Baptism of Fire

## Rookie fire fighter getting her hands dirty in Cass City

The newest Elkland Township Fire Department recruit may not be the tallest or strongest among her fellow fire fighters, but her enthusiasm and passion for the job more than make up for her diminutive stature.

"I joined (the fire department) back in May. It's been about 6 months," said Dallas Leal, 20, a Pontiac native who moved to Cass City from New Mexico with her mom, Karen, and twin sister, Desirae, back in 2005.

Leal has been undergoing training through the Elkland Township Fire Department each month along with being enrolled in Fire Fighter I training. When she completes that phase she plans to continue on with the more advanced Fire Fighter II training. In all, she'll complete about 132 hours of formal training, including dealing with hazardous materials and emergency rescue driving, over the next 6 months.

Leal said she joined at the urging of a friend and former co-worker,

Matt Guinther, another volunteer fire fighter. "He would always come back with stories about the fire department, and he said, 'You should join'," she recalled

"I've always had a lot of respect for law enforcement (personnel) and fire fighters, because when everybody else is running out, they're running in," Leal said. "I've always wanted to be a part of that, and it's a way to give back to the community.

"The challenge is memorizing

too, so that's a little bit of a challenge," explained Leal, who stands just 5 feet 3 inches tall.

Although she hasn't completed her training, Leal is gaining confidence and knowledge at the scenes of fires, where she helps to move fire hoses, grabs tools and has helped to tear down part of a ceiling to search for "hot spots"

"They (fellow firemen) treat me really well — it's a good group to be with. They've just taken me under their wing. They're always trying to teach me something new," she said, noting Elkland Township Fire Chief Glenn Guilds has offered her some on-the-job training at fire locations. "He'll ask me what I see, and then he'll point out things I should be looking for," she said. "He's been

Guilds indicated he's pleased with Leal's progress.

"She has really come along. The biggest thing is (her) willingness to learn," Guilds said. "She'll be a fulltime fire fighter in the spring.

"She reminds me so much of my daughter that went into this full-time as a living," he added, referring to his daughter, Danielle (Guilds) Reiber, who served with the local fire department for 2 years and is now employed full-time with the Kalamazoo Police Department, where her service has included 2 years with the department's drug unit. She was recently promoted to the rank of sergeant and also serves as a fire fighter.





Kittle got his start in scouting as a youngster, joining the Tiger Cubs as a first grader. A senior at Cass City High School today, he's remained active in the program throughout the past 11 years and says earning the Eagle rank has been a goal for as long as he can remember.

## Beware the dangers of carbon monoxide

The Michigan Department of Community Health (MDCH) is reminding everyone to protect their families from the dangers of carbon monoxide poisoning.

"With the recent power outages in Michigan, as well as the winter months approaching, now is the ideal time to make sure that our homes are protected from carbon monoxide," said James K. Haveman, director of the MDCH. "Carbon monoxide poisoning is completely preventable, so we want to be sure that Michigan residents know what to look for and how to protect them-

Carbon monoxide is an odorless, colorless, and tasteless gas that kills more than 500 Americans each year and up to 50 a year in Michigan. It is produced by all forms of combustion. Warning signs include headache, nausea, vomiting, dizziness, drowsiness and confusion. If you suspect you have been exposed to carbon monoxide, immediately evacuate the area of contamination and seek medical attention.

Never use generators, grills, camp stoves, or other gasoline or charcoalburning devices inside your home, basement, garage or near a window because these appliances give off carbon monoxide. Running a car in an enclosed garage can create lethal levels of carbon monoxide in minutes.

Michigan's carbon monoxide poisoning tracking system counted 26 unintentional deaths and 986 non-fatal unintentional carbon monoxide poisonings in Michigan in 2010 alone. More than 60 percent occurred during the winter months and happened most frequently at home.
