Another suspect charged in probe

Thumb law enforcement agencies last week added another suspect to its list of individuals arrested in an extended investigation into heroin trafficking in the region.

Huron County Sheriff Kelly J. Hanson identified the latest suspect arrested as Rollie D. Smith Jr., 34, of Caseville. He was lodged in the Huron County Jail on 4 felony charges related to the alleged sale and distribution of the street drug.

Smith was been formally arraigned on the charges in Huron County District Court, where his bond was set at \$80,000. "He currently remains lodged in our jail," said Hanson, who noted police seized Smith's Chevrolet Monte Carlo. "He is the fourth person to be arrested in this investigation, with more arrests expected.'

Thumb law enforcement agencies executed a pair of search warrants earlier this month in Huron County's Caseville Township as part the ongoing investigation into the trafficking of heroin, which has been making a comeback in popularity in recent years in the state, especially in southeastern Michigan, according to Michigan Department of Health

July 4 holiday deadly in state

The week of July 4 proved much deadlier than the year before on Michigan highways, according to Michigan State Police (MSP) statistics compiled over this year's 5-day holiday.

State police officials Thursday announced the results of their preliminary reports, which revealed 11 people lost their lives in 10 separate traffic crashes during the 2013 holiday weekend. In comparison, 4 people died in traffic crashes during the 2012 Fourth of July holiday week-

"Of the 11 fatalities, only eight people had restraints available to them; four were known to have used restraints, three did not use restraints and one was unknown," said Capt. Kari Kusmierz, commander of the MSP Training Division. "Alcohol was a known factor in one of the crashes, not a factor in six of the crashes and unknown in four of the

Kusmierz noted this year's July 4 holiday covered a 5-day period from 6 p.m. Wednesday, July 3, through 11:59 p.m. Sunday, July 7 compared to last year's 2-day holi-

Prosecutor: woman died after being shot once

Investigators aren't saying what led to the July 4 death of a Reese woman - whose body was recovered after her husband was killed in a gunfight with police — but autopsy results have confirmed she died from a single gunshot wound.

That's according to Tuscola County Prosecutor Mark E. Reene, who said the woman, Donnieca Ann Garcia, 54, had been shot a period of hours prior to the arrival of law enforcement officers at her Van Geisen Road home in the Reese area.

Garcia's husband, James Edward

Garcia, 53, died of gunshot wounds he suffered after he opened fire on two $T\;u\;s\;c\;o\;l\;a$ C o u n t y Sheriff's

deputies and a Caro police officer, all of whom responded to the scene.

"One sheriff's deputy was shot by Mr. Garcia (while wearing) his protective vest and was treated and released from Covenant Hospital in Saginaw," Reene said. "All three officers returned fire after the initial shot by Mr. Garcia struck the sheriff's deputy.

"The investigation is continuing at the present time," Reene said. "Forensics work is continuing. Forensics work is being completed by the Michigan State Police Crime Laboratory, as well as additional interviews by the investigating offi-

The confrontation unfolded at about

"Two Tuscola County Sheriff's deputies responded (to the home after) a family member had called and said they had stopped at the house and confronted their father, who stated the mother was dead on the floor," said Tuscola County Undersheriff Glen Skrent. "The family member left the house and called 911.

"Deputies arrived along with a Caro City officer and set up a perimeter around the house," Skrent said. "A male subject came out of the house and started firing a weapon at officers. The officers returned fire and the subject was killed."

Donnieca Garcia was a Caro native and 1977 graduate of Caro High School. She married her husband in August 1982 and was employed as a bookkeeper with Anderson, Tuckey, Bernhardt & Doran, PC CPA in

Her funeral services were held Thursday at Christ Lutheran Church in Reese.

Drillers tapping into plentiful water supply

Despite the lack of new construction in the Cass City area, well drilling businesses are keeping busy installing replacement wells.

Frank Franzel, president of F. E. Franzel Well Drilling LLC has been drilling wells in the Tuscola County area ever since he was a young boy helping his father, who started the business in 1937.

The operation, run out of Mayville, recently installed a new well west of Cass City on Koepfgen Road.

"Around here, in this area, there is water everywhere. When you get over towards the lake it gets more touchy," Franzel said. "This old well was in the basement but the water

table has sunk down and we're kind of thinking it could relate to the digging in the gravel pits around here."

Last year, over 100 residents over by the Gagetown area found themselves having to replace their wells, which they blamed partly on the irrigation of farmers nearby. However, the recent recession of the water table in Cass City has some citizens wondering whether or not the gravel pits are causing the damage.

"Something is definitely going on down there," Franzel said. "We don't know if it affects the quality, but it definitely affects the quantity of the water."

"The casing went down 82 feet to the bedrock, 58 feet into the bedrock and the well will be 140 feet deep,' said Franzel, about the particular well he was drilling recently. "What we do is drill an open hole down to the bedrock until we can feel it, put the casing in, then we seal the outside of it. We seal it with a bentonite grout and then we go down with fresh water and drill an open hole right into the bedrock.



Jury still out on helmet law impact

Members of American Bikers Aiming Towards Education (ABATE) recently touted the positive economic benefits of Michigan's modified helmet law, which has given adults the option of not wearing a helmet since April 2012.

We have no doubt the organization is offering legitimate numbers and is sincere in its defense of riders' right to choose.

However, we also believe it's premature to celebrate the law's passage, considering some figures presented by other groups that indicate fears over rising insurance premiums stemming from an increase in serious motorcycle crashes are also justified.

A news release quoting representatives of both ABATE and the Michigan Licensed Beverage Association stated the elimination of Michigan's mandatory helmet law has had a positive impact in the

There has been more motorcycle traffic (tourism), with out-of-state participation in Michigan motorcycle events up by as much as 5 times during the summer of 2012, they said, noting those visitors are "stopping, staying and spending money at our restaurants, hotels and attractions.

Supporters of the law revision also cite an increase in motorcycle sales, boosting jobs and revenue in the form of both sales tax and state income tax.

They also point to what they say was the safest riding season for licensed motorcyclists in 10 years in 2012.

Statistics compiled by the Highway Loss Data Institute (HLDI), however, paint a somewhat different picture.

HLDI looked at insurance claims and payouts in 2011 and 2012, focusing on what's commonly considered the riding season, between May and September. After tracking the frequency of claims and the amounts paid on those claims, researchers found that numbers across the board had gone up.

Comparing Michigan's statistics with those of neighboring states, HDLI discovered the number of motorcycle accident claims in Michigan last year was roughly 10 percent above normal, and the average severity of those claims was up by some 36 percent. Bottom line? The amount paid out by Michigan insurers for motorcycle collisions rose significantly after the helmet law's repeal, even with a provision now in place that requires riders who opt to not wear a helmet to secure additional minimum insurance cover-

In 2011, 109 motorcyclists were killed in Michigan, with just 5 of those not wearing a helmet. Another 24 riders not helmeted were seriously injured.

Compare those numbers with 2012, when the number of bikers killed jumped to 129. Of that total, 55 weren't wearing helmets. A whopping 195 unhelmeted riders suffered serious injuries.

In all fairness, those figures could be skewed by the number of inexperienced and/or unlicensed motorcyclists on the road, the fact that weather was more motorcycle-friendly in 2012, and an increase in the number of riders taking to Michigan's roadways.

But, while more traffic could explain higher accident rates, it doesn't explain the increase in severity of Dear Editor, accidents.

In the end, we suspect it will take more time to truly get a handle on the long-term impact of allowing motorcyclists to not wear helmets.

*In the meantime, we continue to support the individ*ual's right to make that decision, provided their freedom to do so doesn't cause insurance rates to skyrocket for everyone.



FAIR HISTORY

The Tuscola County Fair's roots date back to the early 1880s.

The Tuscola County Fair Association, initially known as the Caro District Agriculture Society, was organized March 11, 1881, 33 was held in Detroit. In September exhibit.

Always a primary agricultural attraction, the county fair has displayed new farming equipment and methods, animals, produce and handicrafts on its current site.

The Tuscola County Fair pre-dates any of the football "bowl" games as well as the Indy 500. When the fair started, there was no Panama Canal, no radio, the Wright brothers had not flown, Ellis Island was not in operation, Geronimo was still on the war path, and 12 states had yet to be admitted to the Union.

Harness racing was a popular sport in a horse-powered society, and the clay track at the fairgrounds was Saturday's special attraction is a built in 1892 with 7,000 yards of horse show is also on tap starting at 3,000 yards of clay — all hauled

with horse wagon — at a cost of roughly \$1,000.

The first grandstand was completed in 1894 at a cost of \$2,000 and looked much like the stands of Kentucky's Churchill Downs, seating 1,500 people. This was followed by a stage, with a cement block basement for dressing rooms. Horse barns, sheep and hog pens were also constructed. In the early 1900s, the fair office and 2 restrooms were built. At about the same time, the hour. building now called Heritage Hall Caro High School was built on Frank Street.

The first electricity was provided by the Michigan Sugar Factory's power plant. The railroad tracks leading to the plant were also used in the early era of the fair to bring entertainment acts to the fair. One of those acts was Katherine Stinson, the fourth licensed female pilot in the United States. Only 21 at the time, she became known as the "Flying Schoolgirl", flying exhibitions all over the country. Her plane was brought in by train and then assembled in the infield of the track.

Over the years, many other world famous performers appeared at the Tuscola County Fair, including Gene Autry, The Cisco Kid, Minnie Pearl, Homer and Jethro, the Duke Ellington Band and the Glenn Miller

casing," He added. "Once we hit it (water), it comes up into the casing to the level that it's fed from."

The well Franzel was working on that afternoon was a 5 inch diameter made its way through the bedrock and the system has been flushed, an electric pump was lowered down into the plastic casing about 60 feet below the ground level.

"The new pumps push the water up instead of sucking it in. It's much easier to push than pull," Franzel said. "When we get all done with this (drilling), we're going to chlorinate it, disinfect it and let it sit over

Tomorrow they'll flush it out and that will clean out all the plumbing and everything," He added. "After that the health department is going to come in and do a water test on it."

Along with a well water test from the health department, there are many other guidelines that well drillers have to follow. According to Michigan law, wells have to be a minimum of 25 feet deep, along with other restrictions.

"You have to be 50 feet away from any part of the septic (system), that's the main criteria in this area," Franzel said. "This one (old well) had to be plugged and sealed according to health department regulations. That way you don't contaminate the new well or the neighbor's well."

"Tuscola (County) inspects every one," He added. "That's good, I like that."

Although many area residents are frustrated with the concept of having to have a new well drilled, these new wells far out-perform the old style

'With this system right here, you could have 1,000 gallons come out well. Once the carbide drill bit has of the faucet in an hour with just a standard 1/2 horsepower pump," Franzel said. "If you've got power, you've got water. There is no priming, no adjusting.'

> Due to the higher power of the new water pumps and tanks, precautions have been created to avoid any serious accidents that may occur.

> "They all have to have a relief valve on them now because these pumps are capable of producing so much pressure," Franzel said. "This pump is capable of producing 100 pounds of pressure.'

> We set them (relief valves) up to kick on at 40 (pounds of pressure) and off at 60 (pounds of pressure)," He added. "In case this switch ever stuck, this relief valve is going to blow it (water) down here (in the basement) before it blows it straight through the plumbing in the house.'

> Regardless of what is causing the increase of dry wells in the area, Franzel says the drilling of these replacement wells doesn't compare to when he was a younger man when the construction of new houses was booming.

> Back in my heyday we did over 100 a year," He said. "I bet you there aren't 100 wells, new or replacement, drilled in the whole county this year (total).'



Barb Peters, event coordinator, said the event went as planned and turned out to be a good time for local youngsters.


'We had 25 participants and we




