Despite similar bond proposals being struck down in the past, including one earlier this year that was rejected by a margin of 9 votes, 184 to 175, the board is hoping this proposal will be the one that passes.

Crash claims 4 Saturday in Huron Co.

Four people, including two teens, died in a 2-vehicle traffic crash Saturday night in Huron County's Oliver Township, the Huron County Sheriff's

The victims included a Pigeon area couple and one of their teenage sons. Huron County Sheriff Kelly J. Hanson said deputies were dispatched to the intersection of Stein and Maxwell roads at about 7:09 p.m.

"Preliminary investigation is indicating that a 2012 GMC pickup driven and solely occupied by Andrew R. Braun, age 22, of Ubly, and a 2011 Chevrolet crew cab pickup containing six occupants, impacted at that intersection," he added.

"Those occupying the Chevrolet pickup, of which it appears three were ejected from, were: Joshua C. Heck, age 40, Jessica A. Heck, 38, Jacob A. Langley, age 20, Jarrod R. Heck, age 15, Taylor J. Heck, age 13, all related and from the Pigeon area, and 13-year-old Brendon Smith from Caseville," Hanson said. "Unfortunately, fatal injuries claimed the lives of Joshua Heck, Jessica Heck, Taylor Heck and Brendon Smith."

The Sheriff noted that Braun, Jarrod Heck and Jacob Langley were all initially transported to Scheurer Hospital in Pigeon. "Due to their injuries, they were all eventually transported to out-of-county hospitals, with one going to a Saginaw area hospital and the other two going to a Flint area hospital," he

Hanson said autopsies were ordered, and the investigation is continuing. Assisting agencies at the scene included the Scheurer, Elkton, Central Huron and Sebewaing ambulance services, the Oliver Township Fire Department, the Elkton and Pigeon village police departments and the Michigan State Police.

A long-awaited ordinance overseeing rental properties in Cass City was abandoned Monday during the regular meeting of the village council, when trustees instead approved a rental inspection policy.

The need for some type of rental regulations surfaced when Elkland Township Fire Department Chief Glenn Guilds, after a downtown fire in 2012, alerted officials to the importance of safety inspections of rental properties in the community.

At the time, Guilds said the blaze at

6467 Main Street could have been a bad one, noting a second-floor rental unit in one of the buildings was home to 2 adults along with 6 children ages 9 months to 9 years, all of whom escaped unharmed after some electrical wires shorted out and ignited a blaze between the ceiling and roof of the structure.

While tragedy was averted in the April blaze, it set in motion the creation of a rental ordinance. However, last fall the village council tabled action on the plan for 90 days, followed by another 60-day extension in January, after receiving a signifi-

Let 'em grow

Plantinga: APR opponents continuing to twist the facts

New antler restrictions for whitetail deer may soon be enforced in Lower Michigan, including the Thumb, and while some groups are opposed to the idea, others are working diligently to make that happen.

The Chronicle ran a story on the issue in early June in which lifelong Cass City outdoorsman and columnist Tom Lounsbury explained his concerns regarding antler restric-

Paul Plantinga, director of the Thumb Area Branch of QDMA Management Deer Association), believes many of Lounsbury's facts and opinions are

"Back in 2002, I was, and still (am), involved with the organization that first proposed APRs (antler point restrictions) for Huron, Sanilac and Tuscola counties. The Thumb Area Branch of QDMA was the sponsoring organization of that proposal,' QDMA was incorrectly painted to be a group of 'trophy hunters' concerned with nothing more than 'antler score.' The primary group

opposed to the proposal was the United Sportsmen Alliance (USA) led by Tom Lounsbury of Cass City."

The USA, spearheaded by Lounsbury, raised roughly \$1,500, which paid for advertisements against an issue similar to the current one. The group gathered around 5,000 signatures in less than a month, which ultimately halted the proposed changes.

"According to one of the USA's senior members at the time, their only goal was to run the QDMA out of Michigan. In order to achieve that goal, the USA group flooded the local media with letters and editorials that...twisted facts surrounding the QDMA and the APRs," Plantinga said. "They ultimately succeeded in their goal of confusing hunters and landowners so much that, ultimately, the proposal was not implemented because the random surveys, 1,000 to hunters and 1,000 to landowners, failed to reach the required 66 percent approval number.

Dinner draws 400 members and guests

For her outstanding service organizing the annual "Dinner on the Farm" event providing members the opportunity to meet with Dist. 10 U.S. Rep. Candice Miller, Tuscola County's Janna Fritz has been named Michigan Farm Bureau's (MFB) Volunteer of the Month for July.

"Dinner on the Farm" brought together Farm Bureau members from Huron, Lapeer, Macomb, Sanilac, St. Clair and Tuscola counties for a personal legislative update from the congresswoman. This year's event saw record-breaking numbers of more than 400 members and guests in attendance June 24, due in large part to the organizational efforts of Fritz and others behind the scenes.

Fritz serves as the key communications liaison between the county farm bureaus and the congresswoman's office. She coordinates schedules, arranging the host farm and working with the county Farm Bureau leaders to disseminate information to members.

Fritz also manages fundraising activities to minimize the county farm bureaus' out-of-pocket expenses. This year she raised nearly \$6,000 in sponsorships, allowing county farm bureaus to focus their limited funds toward promotion, education and scholarships.

Fritz also schedules guest speakers, assists with script writing and coordinates the development of promotional materials for distribution to members and the broader communi-

Prison alternative is a second chance

It doesn't take a genius to look over a stack of criminal files in Tuscola County Circuit Court and come to the conclusion that a number of defendants are battling mental health and/or substance abuse issues.

It's also no big trick to assume that many of the offenders who end up getting jail time will still be faced with those issues when they're released, landing them back in trouble again before they know it.

That's why we support Tuscola County Circuit Court Judge Amy Grace Gierhart's efforts to take advantage of a program that offers some defendants an alternative to prison that could make the difference between a productive life in society and a more extensive criminal record.

Gierhart figures a number of offenders could embrace the former if given the opportunity to overcome stumbling blocks such as addiction.

That's where the Tri-County Community Adjudication Program, also known as TRI-CAP, comes in. TRI-CAP operates as an alternative to traditional prison or jail time, allowing offenders to be placed in a secure custodial environment while receiving an intensive level of counseling and other services at roughly half the cost to taxpayers as traditional prison about \$47.50 per day compared the estimated \$94.13 it costs to incarcerate someone for one day in a In the end, God Michigan prison.

fact, the program accepts only individuals whose criminal record demonstrates a pattern of non-violent offenses only.

Gierhart says the TRI-CAP option makes sense for a number of reasons.

"In the last few years, there has been an increasing recognition that the traditional cookie-cutter approach to corrections is ineffective, both in terms of cost and results," she said. "Sending someone to prison for the sake of sending them to prison is a waste of money when the individual can be better rehabilitated in another setting.

"TRI-CAP gives us a way to provide individuals whose biggest problem is a desperate need for treatment, whether substance abuse or otherwise, with the services they need to have a chance at being productive members of society," she added, noting offenders who participate in the TRI-CAP program can also receive vocational training and employment assistance.

Most folks deserve a potentially life-changing second chance, and Gierhart is giving some offenders just that by utilizing TRI-CAP.

If they blow it, they have no one to blame but themselves.

Please remember that a spot in line before noon on Aug. 3 does not guarantee a license. All wolf license purchases are first-come, first-served. Wolf licenses cost \$100 for Michigan residents and \$500 for nonresidents.

If you are looking to start a food truck business, be sure to touch base with the Michigan Economic Development Corporation (MEDC) as they have created 2 new programs to assist with the task.

MEDC has \$100,000 to help new or existing food truck business, Village Manager Peter Cristiano announced at Monday's village council gathering. Cristiano says the MEDC will provide a one-time grant of up to \$10,000. Needed is matching funds of at least 25-percent as well as a viable business plan.



Well, it finally happened; I know what it's like to sit in the back seat of a police cruiser, thanks to my wife, Deb.

No, this isn't going to be some sordid tale taken from an episode of the reality television show, "Cops". Instead, it's about Deb's latest longdistance shopping adventure.

Now, my wife is serious when it comes to doing her research, and she has an outstanding track record of buying great used vehicles that seem to last forever with very few mechanical issues. Over the years she's purchased them locally as well as from dealers around the nation via the

So, I wasn't surprised when she told me she had replaced our Journey, totaled in a traffic accident on I-75 recently, with a Chevy Impala she found in New York City.

But I perked up when she told me it was a former NYPD police cruiser, and that she picked it up for more than \$4,000 under the Blue Book price.

The car has fewer than 70,000 miles on it. More importantly, this bad boy is powered by Chevrolet's 3.9-litre V-6 engine. The 12-valve OHV motor has a compression ratio of 9.8 to 1 and an engine red line of 6,400 rpm, with a peak output of 240 horsepower at 5,800 rpm and 245ft.lb of torque at 2,800 rpm.

Okay, so I have no idea what that means, but I'm guessing that passing isn't going to be an issue.

The only real drawback is that portions of the police package have been removed — the interior flashing light and siren, for example.

I sort of wish they had left the cage installed. Could be pretty convenient when transporting rowdy grandchildren to various destinations.

A cage definitely would have come in handy when my daughters were younger and dating. You know, while transporting their suitors just to make sure they made it home safe and sound (and how convenient as a former police car, the unlocking mechanisms on the rear doors are disabled).

As a kid, I think it would have been great to have a cage separating the front and rear seating areas, especially on long family road trips. You have to keep in mind, that was a different era, and it wasn't unusual for loud, fighting siblings to find themselves dodging a face-seeking backhand from dear old (frustrated) dad.

Those were the days.

Well, even without the cage, this car is unique among the vehicles we've owned over the years.

Sure, it may not be the Bluesmobile — Jake and Elwood's 1974 Dodge Monaco Sedan black-and-white cruiser in the movie, The Blues Brothers, filmed in Chicago. But, as Elwood would say: "It's got a cop motor, a 440 cubic inch plant, it's got cop tires, cop suspension, cop shocks..."





"The LPDMI proposal also includes exceptions for the youth hunters during designated youth seasons, and apprentice hunters during any season. 

Fall sports schedules released at Cass City

Cass City Schools' 2013 fall sports schedule was released last week and included contests for five varsity teams and two junior high programs. Here's what I found interesting.

On the gridiron field, Coach Scott Cuthrell's Red Hawks open with four straight road games including a week two match-up against Greater Thumb West up-comers Elkton-Pigeon-Bay Port. After the early season clash with the Lakers, Cass City exits conference play in week three to visit Sandusky and ends the regular season hosting M-81 rival Caro – if the Tigers still have a team come Oct. 25.

On the volleyball courts, Coach Paula Potter takes charge after longtime Coach Beth Howard, who many credited with putting Red Hawk volleyball on the radar, stepped down following the 2012 season.

DNR will offer roughly same amount of tags for antlerless deer this fall

The Department of Natural Resources (DNR) will make roughly the same number of public-land antlerless deer licenses available to hunters this fall as last, after the Natural Resources Commission approved antlerless license quotas at its meeting recently in Lansing.

Private-land licenses, however, will decrease by about 25 percent, most significantly in southern Michigan.

The DNR will make 70,550 licenses available for public land, down slightly from last year's 70,750. A total of 483,400 private-land licenses will be available, down from 637,900 in the 2012 season.

In the northern Lower Peninsula, more antlerless licenses will be available for both public and private land. The DNR will make 35,900 public-land licenses available, up from 30,900 last year, and 119,100 private-land licenses, up from 115,500.

"Recent deer population trends in the northern Lower Peninsula have been increasing due to three previous mild winters." said DNR deer and elk program leader Brent Rudolph. "Although this winter had a number of severe storms, the overall impact appears to be mild with the majority of deer observed by staff appearing to be healthy and fit."

In the Upper Peninsula, 18,800 private-land licenses, down from 21,250 last year, will be available. The quota for public-land licenses has been cut from 5,900 to 4,500.

"An overall decrease in antlerless licenses was recommended in many deer management units (DMUs) in anticipation of increased adult deer mortality and low fawn recruitment due to the prolonged winter," said Rudolph.

In the southern Lower Peninsula, quotas for both public land and private land have been reduced. The DNR will make 30,150 licenses available for public land, down from 33,950 last year, and 345,500 private-land licenses, down from 519,650 in 2012.

"Deer populations in many areas are now near goals," Rudolph said. "This is particularly the case in some areas that have experienced repeated outbreaks of epizootic hemorrhagic disease (EHD) over the last several vears."

Hunters are reminded that many DMUs have changed as a result of changes to local deer populations. Check the 2013 Antlerless Deer Hunting Digest for details.



cant amount of backlash from local landlords.

During that time, Village Manager Peter Cristiano, former village employee Sam Moore, and a committee of rental property owners have been meeting to develop an outline for governing rental proper-

The council approved that policy Monday night.

included landlords and authors of the new rental strategy - Steve Wright, Deb McClorey, Nancy Braun, Tracy Moore and others - that the new plan is a self-inspection policy.

"The costs associated with an ordinance both for landlords and the village would be prohibitive," said Cristiano. "The village does not have the manpower associated with an ordinance. It would be the village's intent, with landlord participation

Cristiano told the gathering, which that, we review the policy periodically and make necessary adjustments."

Cristiano added, "The purpose of this policy is to provide for the registration and upkeep of rental properties located in the village...to prevent decay of rental properties, to prevent the decrease in property values, and to ensure the safe habitation of persons residing in rental unit."

COMMITTEE REPORTS

Also Monday, following a brief public hearing, Budget and Finance Committee member Israelson's motion to approve 4 Industrial Facilities Tax Exemptions for newly-located Garfield Avenue manufacturer MiTech Tooling was unanimously approved, 5-0, on a roll call vote.

On Thursday, a task force met at the municipal building and concluded that many diversified industries would be served and more than 30 employees hired as a result of the tax breaks, before giving its approval to the former Caro manufacturer's

MiTech Tooling officials Joe and Colleen Langenburg told the task force that the certifications will allow their company, which manufactures specialty carbide/tungsten indexable inserts for industrial companies, to expand, buy more equipat ment and hire additional staff.

Turning to the Public Services Committee, the council approved engineering contracts for wastewater treatment plant (WWTP) improvements and the transfer of 7 ½ acres of land in the industrial park. The 2 actions are related to the proposed dairy processing operation proposed by the Dairy Farmers of America

URS Corporation, at a cost not to exceed \$25,000, will provide a feasibility study for treating wastewater discharged from the WWTP based on projections related to the proposed dairy facility, while the sale of the 7 ½-acre parcel of land to the DFA for \$1 was recommended by the Cass City Economic Development Corporation (EDC) to allow DFA to continue the progress of developing the site for its operations.

"The Cass City Economic Development Corporation has recommended this sale for some time," Cristiano noted. He explained the delay involved getting approval from the Michigan EDC to proceed for the purpose of receiving credit for matching grant monies.

"We have put a value of \$75,000 on the land for purposes of grant funds, and it was recently approved."

OTHER BUSINESS

In other business during the monthly meeting, the council:

*Authorized the Spicer Group to prepare preliminary plans and estimates for Doerr Road improvements not to exceed \$15,000.

The \$15,000 will be paid by the state EDC. The projection is part of a \$500,000 Michigan Department of Transportation (MDOT) grant. A matching contribution of 20 percent, or \$100,000, will come from village

*Spicer Group was also awarded a contract, not to exceed \$19.500, to complete engineering and design plans for water and sewer lines in the industrial park, necessary to service the DFA plant.

*Purchased a 36-inch plotter for \$6,630. The wide format printer will allow the village to output large maps and drawings of the Cass City's infrastructure.

*Accepted the financial statement ending June 30, 2013, showing a cash balance of \$1,251,854.


