Deputies: Cass City victim in wrong lane

Investigators are continuing to put together the pieces of a fatal traffic crash Friday afternoon involving a local motorist whose car was traveling in the wrong lane, narrowly missing a collision with one semi truck before hitting another head-on.

Huron County Sheriff Kelly J. Hanson identified the victim as Dawn M. Champagne, 50, of Cass City.

The investigation unfolded Friday at about 3:50 p.m., when Huron Central Dispatch received a call reporting that a northbound car had sideswiped a southbound camper on Elkton Road, near Stein Road in Huron County's Oliver Township.

"The car's female driver apparently waited at the scene for a few minutes, then continued northbound. At 4:03 p.m., and while our deputies

were responding, Huron County Central Dispatch received another call about a northbound car impacting head-on with a southbound semi-truck and trailer on Elkton Road, north of Berne Road in Chandler Township," Hanson said.

According to the truck driver, James Siewert, 55, of Pigeon, he had to bring his 1996 Kenworth semi truck and trailer almost to a complete stop because a northbound car had entered his lane. The car continued on and collided with the truck.

Hanson said the car's driver, Champagne, had to be freed from her 2001 Pontiac Grand Prix by Oliver Township fire fighters using their Jaws of Life. Elkton Ambulance personnel transported Champagne to Scheurer Hospital in Pigeon, where she later died from her injuries.

"From preliminary investigation, our deputies have learned from witnesses that approximately one mile south of the final impact scene, (another) southbound semi truck earlier had to swerve into the northbound lane to avoid impacting with this vehicle," Hanson said.

An autopsy was ordered and the investigation will continue, accord-

ing to Hanson, who reported the latest crash marked Huron County's eighth fatal traffic accident this year.

2 INJURED

Sanilac County Sheriff's deputies reported a Harbor Beach woman and a one-year-old in her vehicle were injured in another collision Friday afternoon near the intersection of M-81 near M-53, about 4 miles east of Cass City.

Sgt. Nathan Smith reported his county's central dispatch received a

transfer call of Tuscola County 911, reporting the 2-vehicle crash in Sanilac County's Greenleaf Township.

According to Smith, the preliminary investigation revealed that Sarah Volmering, 24, of Harbor Beach, was traveling eastbound when she slowed down for a vehicle in front of her that was attempting to make a left turn into a private driveway.

"After slowing, Volmering was struck in the rear by a vehicle driven by 40-year-old Reggie Ignash of Cass City," Smith said. "Ignash

reported...that he did not realize that Volmering was stopping in the roadway."

Volmering was reported to be pregnant and her one-year-old niece was a passenger in her vehicle. They were transported by Cass City MMR personnel to Huron Medical Center for treatment of what deputies described as non-life threatening injuries. Ignash was not hurt.

The Cass City Police Department and Elkland Township fire fighters assisted deputies at the scene.

Cass City High earns top grade

Cass City High School has, once again, been named the top high school in Tuscola County.

Each year the Mackinac Center for Public Policy conducts an assessment and compiles information about each school in the state in conjunction with the Michigan Public High School Context and Performance (CAP) Database.

The information is a compilation of data averaged over a four-year span, 2008-2011.

The Mackinac Center also considers other factors, including the percent of students at each school that qualify for free/reduced lunch. It also breaks down the individual grades given to each school in Michigan Merit Exam (MME) subgroups.

Among the eight schools that were assessed in Tuscola County, Cass City High School was the only school to receive an "A" letter grade.

"It's important to know that we are meeting standards set for the state of Michigan," said Cass City High School Supt. Jeff Hartel. "There is certain criteria that is set and we feel that we do a good job of addressing those issues and making sure we're on track with our kids to get them

college ready."

Cass City High School was also ranked 29th in the state for its MME math scores.

"We have a number of very smart students in our district," Hartel said. "And the ones that we identify early as needing some extra assistance, we start working with them as early as second or third grade to hopefully get them caught up."

"We want our kids in Cass City to be successful, and I think our staff is on board with that," he added. "It comes down to the classroom teacher when you really look at test scores, and our administration helps out with support."

Something else to note is that every school in Tuscola County saw a reduction in their average enrollment over the four-year span. Cass City High School's average dropped from 468 students to 441, a difference of 27. The school also saw an increase in the average percent of students receiving free/reduced lunches, from 42.2 percent up to 43.7 percent.

Cass City High School's overall state ranking is 54th. Nearest to that ranking in Tuscola County was Caro, coming in at 131st. The assessment also placed Cass City in the top 91 percentile in the state.

Nearly 120 bidders turn out

Sales estimated at \$24,000 at YFC sale Saturday in village

It looked as if Bluewater Thumb Youth for Christ (YFC) officials had invited a lot of empty bleacher seats to Saturday's 16th annual YFC Benefit Auction as the sale got underway at 9 a.m.

But the thin crowd gradually grew, giving Campus Life officials what they had hoped for: a successful auction that grossed about \$1,500 more than last year.

"It was a little nerve wracking in the

morning," Campus Life Director Heather Jensen acknowledged. "But it didn't take long for the bleachers to fill up, so that's great."

"We did really well. We grossed \$24,000, and our (attendance) numbers were up — we had a different group of people," commented Jensen, who believes that a direct mailing along with increased Facebook activity helped to draw some new faces to the sale along with the faithful buyers who come year after year.

Jensen said the number of bidders

totaled just under 120 this year, with the gross proceeds coming in at roughly \$1,500 more than last summer.

The sale supports YFC Campus Life programs in Cass City, Caro, Reese, Akron-Fairgrove and Kingston, according to Jensen, who serves as director of the Campus Life programs at schools throughout much of Tuscola County with the exception of the Cass City-Kingston region, where Josh Byer is now in his second year as Campus Life

Rule sets his sights on career as storyteller and film maker

The best laid plans don't always come to pass, and sometimes that's a good thing.

Just ask Joe Rule, who enrolled in classes at Northern Michigan University (NMU) with the intention of preparing for a career focused on tweaking digital special effects in feature films, but left the school last spring, diploma in hand, with some different ideas.

"It (career plans) changed a lot as I went through the program," commented the former Cass City High School student, whose skills in digital media production and computer security landed him a spot in a Business Professionals of America (BPA) national competition back in 2008 while attending classes at the Tuscola Technology Center in Caro.

"I started out really wanting to work on movies," Rule recalled, noting he especially wanted to work for the



Starting Sept. 5, the Department of Natural Resources Weekly Fishing Report will be available via a toll-free telephone number. Anglers will now be able to hear the report without incurring any phone charges. The Weekly Fishing Report is available in 3 formats: online at www.michigan.gov/fishingreport, via email or over the phone. On Sept. 5 that number will become 1-855-777-0908.

When anglers call the new toll-free number, they will hear an overview of current fishing conditions in the state and then they will be prompted to select a section of Michigan they would like to hear a detailed report for (Southeast Lower Peninsula, Southwest Lower Peninsula, Northeast Lower Peninsula, Northwest Lower Peninsula or Upper Peninsula).

Of course, another way to find out current fishing conditions is to contact local charter captain Jeff Schwartz. He recently helped Jordan Mester, 9, catch his first king salmon, weighing 19 pounds, near Manistee in Lake Michigan. Call 989-872-4182 and that could be you holding a fish of a lifetime.

Here's more from the DNR: In one of the larger poaching cases in recent Michigan history, a Shiawassee County man has been sentenced under a plea agreement and will pay the State of Michigan \$75,000 in restitution and have his hunting privileges revoked for the remainder of this year and the next 3 years.

Brian Birchmeier, 51, of Owosso Township, was sentenced Aug. 12 in 66th District Court in Shiawassee County. He had been facing 125 misdemeanor charges related to poaching deer and turkey. In October 2012, DNR conservation officers found Birchmeier to be in illegal possession of parts of more than 100 animals, including deer and turkey.

Birchmeier originally was charged with 115 counts of taking or possessing a deer over the legal limit, one count of taking a deer without a license, 7 counts of taking a turkey without a permit and 2 counts of illegal baiting. Under the plea agreement, Birchmeier pled no contest on 3 counts of take and/or possess deer/bear/turkey and one count for licensing violations, allowing the court to revoke license privileges at its discretion.

DNR Conservation Officer Daniel Bigger was called to Birchmeier's home in early October 2012 on a tip from the Shiawassee County Sheriff's Department. Officer Bigger found numerous sets of antlers at Birchmeier's home, as well as illegal bait piles. Officer Bigger subsequently executed a search warrant at Birchmeier's home, seizing more than 170 antlers, as well as shoulder mounts, crossbows and turkey beards.

Based on a review of licenses purchased by Birchmeier, and an absence of hunting records prior to 1982, the number of deer parts alone that Birchmeier illegally possessed was estimated at well over 100.

Crash scene covers 200 yards

Huron County Sheriff's deputies say a Madison Heights man survived a traffic accident that covered some 200 yards Saturday morning in Huron County's Caseville Township.

The crash was reported at about 12:59 a.m. on M-25, west of Oak Lake Road.

When the deputies assigned to the

call arrived, he found a conscious, believed-to-be sole occupant lying outside a 2013 Dodge Durango, which was resting on its side on the north side of the road way, according to Huron County Sheriff Kelly J. Hanson.

Hanson identified the man as Jason P. Weber, 37, Madison Heights.

"Preliminary investigation of the nearly 200-yard-long scene is indi-

cating the vehicle was westbound, left the roadway and eventually went airborne (and) rolled at least once after it impacted with trees, scrubs and a mailbox," Hanson reported.

The victim was taken to Scheurer Hospital in Pigeon by Scheurer Ambulance Service for treatment of his injuries. Hanson said alcohol is believed to have been a factor in the accident.

He was also placed on 36 months probation and ordered to pay costs and fines totaling \$2,974 plus attorneys fees of \$500.



We are constantly amazed by some of the work completed by grade youngsters. The latest to come

our way was submitted by Mrs. Fred Maier. It was the work of Dale Strickland, 12-year-old son of Mr. and Mrs. Avery Strickland of Detroit. While staying with his grandmother, Mrs. Mary Strickland of Cass City, he composed a pamphlet entitled "Our Ocean of Air" that uses terms and expressions that would do credit to many high school youngsters. The entire pamphlet was typewritten.

100 YEARS AGO (1913)

In order that Perry Day may be properly celebrated in the schools of Michigan on September 10, it will be necessary for the teachers in the state to make preparation, so the department of public instruction has just issued a bulletin of exceptionally appropriate material and this will be sent to teachers upon request. A Perry Day celebration will be doubly significant as it is to commemorate the victory of Perry on Lake Erie, which meant more to Michigan than to any other state in the union, and to emphasize the fact that there has been enjoyed a century of peace between Great Britain and the United States. The bulletin contains valuable historical material and is attractively illustrated. Rule sets sights on career as storyteller, film maker

ital animation he entitled "Eat Your Vegetables", was named Best of Show by the School of Art and Design's faculty during the Senior Art Exhibit's closing reception, held at the university's DeVos Museum.

Rule's mother, Becky, noted 3 awards were presented in all, including Best of Graphics, which went to Cody Ross, another young man with Cass City connections — Ross is the nephew of Sharon Delamarter, and his grandfather owned the old Federated Store.

In addition to his university honors, Rule has entered a handful of film

festivals in the Mid-Michigan region, and earlier this month walked away from the Young Michigan Filmmakers Festival in Leland with Best Animation honors.

Rule's entry (also his senior project), which can be viewed on the Internet by logging onto the website, www.joerule.com, focuses on a little girl at the dinner table, facing the prospect of eating her broccoli, and follows her on a brief "harrowing" adventure.

"I started out with the idea of capturing this natural event through supernatural things. It evolved into exploring the perception of the world through a child's imagination," said

Rule, who is currently working for the family business, Consultations Unlimited in Cass City, which offers business and residential computer consulting and support.

The process of creating a story is complex and involves several steps.

"I begin with a basic concept, such as realizing the world through a child's imagination, and search for an interesting setting to fulfill that concept," Rule explained. I then place myself within the setting and repeatedly 'act out' the story, making different decisions and seeing where they take me. This is my favorite step. There is so much discovery and adventure in a short period of time. It is the only time I get to experience the story as an audience member would.

"I usually let the story 'incubate' for a while," he continued. "Idiosyncrasies in a freshly conceived story tend to surface after a couple days. My creation process begins by sketching characters and writing out the basic story. The next step is to draw storyboards. It's during this process that the final story problems surface and are fixed.

"I construct the character and environments as 3-dimensional models in the computer," Rule said. "Props are built. Specific colors and features are chosen. The environment

and the lighting are carefully tweaked to enhance a mood or setting. The character must be prepared for animation by building a skeletal system and recording facial movements.

"The final step in the visual construction is animation. I do a rough pass to block out the timing and cuts in a scene. The final pass introduces smooth, natural movement, facial expressions and other details."

As for the future, Rule, encouraged by his college professors, is looking at graduate schools to further his education and skills. He's already seriously considering applying to a school in California, where he'd like to pursue a Master of Fine Arts Degree in story telling and directing.

Regardless of the grad school he attends, Rule said he'll first have to prove himself to be a worthy candidate with an impressive portfolio. "They require that you show them that you have vision and creative ideas and are motivated," he explained.

Rule figures he'll be up to the challenge, thanks in part to the time invested at NMU.

"They taught me how to think creatively as opposed to just finding a job," Rule said. "I want to create my own films instead of just working on somebody else's projects."





2013 crops outstanding in Michigan

Farmers tending most of Michigan's big-acreage row crops are looking forward to what promises to be a prodigious 2013 harvest season.

Despite delayed planting and sub-normal temperatures, adequate rains are helping boost estimated yields toward potentially record-setting levels.

According to the USDA NASS Great Lakes Regional Office, Michigan's corn crop is poised for near-record production. Corn growers are looking at gleaning 158 bushels per acre, up 25 bushels from 2012. If realized, the current forecast corn yield for Michigan will exceed the previous record by five bushels per acre.

Soybean production is estimated at 85.1 million bushels, down slightly from last year, with yields forecast at 45 bushels per acre. Sugar beet growers estimate a yield of 25 tons per acre, down four tons from last year.

The state's hay yield is forecast at 2.61 tons per acre, up almost a ton from last year. That's good for livestock producers who've struggled to find adequate, affordable forage for their animals.

Possibly the best news is for producers of dry, edible beans, who are expecting crops to yield 1,900 pounds per acre, up 110 pounds from last year. The average yield nationwide is forecast at 1,795 pounds per acre.

The state's dry bean crop is developing on pace with its five-year average. Planting began in early June, and by late July, 60 percent of the crop was reported in good to excellent condition.

Dry bean production this year is estimated at 3.33 million hundred-weight, down slightly from 2012 as a result of farmers planting 20,000 fewer acres of beans compared to last year. (A 'hundredweight' is equivalent to 100 pounds.)

Michigan ranks second in the nation in total dry bean production, and is the top producer of black, cranberry and small red beans.



Intern's Notebook**Doerr: lessons learned during the summer at the Chronicle**by Mason Doerr

It was nice to come back to my roots again this summer and spend another few months working at the Cass City Chronicle. Although Mt. Pleasant is a great place, it's always an enjoyable experience to cut yourself off, even if only briefly, from the hustle and bustle of a larger city.


