Record breaker

15,000-plus crowd enjoys weekend bash at the Thumb Octagon Barn

Johnny Appleseed would have been proud.

The 19th annual Fall Family Days festival at the Thumb Octagon Barn drew thousands of people from locales ranging from nearby Gagetown to points throughout Michigan along with distant states such as Texas and New York. Canada was also well represented in the crowd.

There was plenty to see and more than enough to eat, as well as some special guests, including Johnny Appleseed himself, thanks to Ubly's David Jaroch. In addition, 2014 Michigan Apple Queen, Elizabeth Wittenbach, a Michigan State University student from Belding, stopped by Saturday to greet visitors.

This has been a groundbreaking year for us," Martin Kubacki told Sunday's crowd, estimated at some 6,000 people. "Yesterday (Saturday) we had over 1,000 more people than we've ever had in one day on the grounds."

It was also a record for exhibitors – 164, up by more than 40 over last year, plus more than 200 vendors.

Kubacki later said the combined weekend attendance was at least 15,000, with some 9,000 folks on hand Saturday to take in activities such as presentations by members of the Michigan Apple Association and Michigan Bee Keepers, who shared Family Days theme – from the blos-

Aside from tours of James and Cora Purdy's historical eight-sided barn and farmhouse, swarms of visitors were encouraged to walk the grounds to enjoy everything from live music and a variety of homemade treats, to patriotic presentations by area youngsters and teachers, all dressed in attire representing the 1920s and 30s, at the old Mast School, a one-room country school.

Dozens of antique and classic tractors and old steam equipment dotted the grounds as visitors toured the working sawmill, cider mill, blacksmith shop, sugar shack and grain

Among the special presenters during the weekend were former longtime Fall Family Days co-chairman Bob Hirn, who shared an interactive lumber industry program in the sawmill, and Gagetown area resident Margaret Sergeant, also a veteran Friends of the Thumb Octagon Barn, who gave historical presentations to small groups in the barn arena throughout the weekend festival. Cass City area beekeeper Dean Hutchinson was also on hand with honey separation presentations, while Carsonville's Greg Alexander educated the crowd on apple production and processing.

Although Kubacki has co-chaired the festival for 16 years, this was his first year heading up the event by himself. "It was more work than I thought," he said. "I was pretty the story of apples - this year's Fall nervous last week, but it came together.

Motorist, 91, dies in crash Friday in Tuscola County

Tuscola County Sheriff's Department investigators reported one death in a two-vehicle traffic crash Friday afternoon in Fremont Township.

Tuscola County Undersheriff Glen Skrent said the accident occurred at about 3:32 p.m. at the intersection of Saginaw and Mertz roads.

"Deputies report that a vehicle had been northbound on Mertz Road and failed to yield to a vehicle eastbound on Saginaw Road," Skrent said. "The driver of the northbound vehicle, a 91-year-old male, was pinned in his vehicle and the Jaws of life were needed to free him. He was transported to an area hospital where he passed away. The other driver, a 17-year-old male, was not injured."

Skrent, who did not release the names of the occupants, said an autopsy was to have been conducted Saturday.

Deputies were assisted at the scene by the Mayville Police Department, Mayville Ambulance, Mayville Fire Department and MMR Ambulance.

No grocery store? Talk it up, friends

We share the Cass City community's disappointment upon hearing that Erla Foods will be closing its doors this month, but we're also optimistic the village hasn't seen the last of a hometown grocery store in operation locally.

Current owner Venu Ganga gave the business his best shot and came up short, but not without doing everything in his power – we believe – to keep the store open. A final attempt to raise the bottom line by opening a buffet restaurant is a testament to his determination.

We would also like to thank Mr. Ganga for his willingness to invest in our community in the first place, and for making a concerted effort to ensure his employees and local business accounts are taken care of before closing this chapter in his career.

We also respect his decision to take the high road when he said the circumstances that have led to the store closure are not the fault of the community, especially having weathered some of what we feel was unfair and petty criticism in the past.

The question now is, how will Cass City attract another business owner willing to invest in this community?

Ganga doesn't believe an individual can make enough to keep a store the size of Erla's running without losing their shirt. We hope he's wrong about that, because we're not confident that a group of investors is going to be willing to buy and run the grocery as a cooperative, as he has suggested. The organizational challenges alone would be a nightmare.

Still, Ganga is right on the mark when he describes the difficulty of trying to compete against the big box giants and their wholesale buying power. He'll also tell you it's a no-win situation when customers walk through his door to take advantage of specials, but then head off to Caro or Bad Axe to pick up their bulk paper products, cleaning supplies, etc. He's also right when he cites the loss of dozens of families that have left the Thumb in search of greener employment pastures over the past several years.

On the other hand, Cass City remains a viable, strong community that boasts its own hospital along with a myriad of other healthcare facilities, a college campus, a respected K-12 public school system, a modern public library, a proactive village government, outstanding recreational facilities, a growing industrial base, and a wealth of community service groups.

In other words, Cass City is an inviting town with much to offer.

It's also worth mentioning that a grocery hasn't outlived its usefulness in small communities, especially those which, like Cass City, have a large segment of senior citizens who rely on the convenience of a local store from which to purchase produce, meat and other items.

Of course, selling the town's image and the need for a grocery store isn't going to be as simple as putting out the "for sale" sign, but every resident of the community can help by simply spreading the word – to family and friends near and far, via social media and in many other ways.

That suggestion may be simplistic, but you never know who might be listening or what a few positive words might accomplish.

Feeding Earl



I've been feeding a squirrel. Please note the singular grapes in his bowl. He nibbled on one. I tried a cherry tense. Squirrel. Not squirrels. People don't typically tomato. Earl buried it. I gave him a big treat of a strawfeed squirrels. They feed birds and try to keep the squirrels from getting at the bird food. That's how it goes,

I guess I'm not so much feeding him as attempting to train him to understand that when he sees a bright red bowl on the patio it contains scrumptious morsels. I use the same bowl, in the same spot, at the same time every day. When I walk outside with the bowl, I make a clicking sound to alert Earl with the message: "Food incoming." It's my own attempt at classical conditioning. Like Pavlov with his dogs except my dog is a salivating squirrel. I was a behavior analyst in another life. True story.

I provide just a tiny bit of food because I don't want Earl to be dependent on me. He still needs to hone and rely on his survival instincts. I'm no meals on wheels, more like a snack benefactor.

Besides, I don't want to feed all the squirrels in my yard. They'd probably tell their friends and pretty soon I'd have a squirrel overpopulation situation. Plus I don't have any desire to be known as the squirrel lady.

I chose Earl over the others because he is the cutest. He frolics in the yard – there's no other fitting description. He hops and digs and hops with a glee not typical of rodents. I get a kick out of the way he holds his food in his little front paws. (I realize all squirrels do this, but Earl is especially adorable.) And he is black, so I am able to distinguish him from his gray cousins. Earl is my boy.

Except, I don't know if he is a boy. You have to get really close to a squirrel to determine its sex. In other words, Earl could be a girl. But I'm not letting a detail like that get in the way of my science.

Don't be the one.

Hunting from a tree stand is a popular way for hunters to enjoy their season, but nearly every year a Michigan hunter is seriously injured or killed falling out of a tree

Conservation officers at the Michigan Department of Natural Resources (DNR) remind hunters of the top safety tips when it comes to tree stands

Before a hunt, know your equipment:

*Read and understand the manufacturer's instructions and warnings before using a tree stand and harness.

*Check the stand, straps and chains before you go out for signs of wear and tear or missing parts.

*Practice at ground level with your tree stand and harness with a friend or family member.

*Learn how to properly use your harness. The DNR recommends a full-body harness.

Waist belts or upper body-only harnesses can cause seri-

ous injuries or death in a fall. When scouting for a tree:

*Choose a healthy, straight tree that is the right size to hold you and your stand.

*Check the tree beforehand for insect nests or animal

*Avoid using climbing stands on smooth-barked trees, especially during icy or wet weather.

*Clear debris from the base of the tree to minimize injury from a fall and to ensure a sturdy base if using a ladder stand.

During your hunt:

*Tell a reliable person where you are hunting and when

you can be expected to return. *Wear a full-body harness and make sure it is connect-

ed to the tree at all times. If using a ladder stand or climbing sticks, attach the harness before securing the platform to the tree or stepping onto it. *Climb higher than your stand and always step down

onto your platform.

*Wear boots with non-slip soles.

*Never carry equipment when climbing – use a haul line to raise and lower equipment, unloaded firearm or bow. Do not attach the line near the trigger or trigger guard of your firearm.

*Have emergency equipment - a knife, cell phone, flashlight and/or whistle.

"DNR conservation officers responding to tree-stand falls see the same mistakes over and over – not using a harness or a haul line," said Sgt. Tom Wanless, supervisor of the DNR hunter education program. "Nationally, 82 percent of hunters who fall from a tree stand are wearing a harness, but it's not connected. And 86 percent of tree-stand falls take place during the climb up or down. Harnesses and haul lines save lives."



2013, this year's production is estimated to total 4.14 million hundredweight, or 210,322 tons — a 20 percent increase from last year.

their acres ahead of schedule, finishing in late June. Conditions have for Commodity, Farm and Industry been favorable for plant development, and by Aug. 1 three-quarters of the crop was rated good to excellent.

For dry beans, the path between adequate and excessive moisture is a

"We've got some dry beans that ones we planted later look pretty decent — they're starting to turn and get some color in them," said Nathan Clarke, who raises a variety of row crops in Midland and Isabella counties, including 650 acres of black beans and 150 acres of cranberry beans.

"The cool nights and high humidity we've been having is good weather for mold," Clarke added, "but I think we're getting past where it's likely to be a problem.

Navy, black and small red beans make up the lion's share of Michigan's bean acreage, but growers here also raise cranberry, kidney, pinto, great northern and other popular varieties. Michigan leads the nation in black, cranberry and small red bean production, and ranks second to North Dakota in overall bean production.

Corn growers expect yields averaging 161 bushels per acre, six bushels more than last year and about seven bushels fewer than the national average of 167.4 bushels. If realized, the national corn crop of 14 billion bushels would set a new national

Corn's long road to maturity and farmers' late start planting it this year - as much as a month behind schedule — has growers concerned about the onset of autumn.

The big question is when the frost Bean growers in Michigan planted comes," said Bob Boehm, manager of Michigan Farm Bureau's Center Relations. "We've seen a lot of variability in weather and soil conditions, but overall crops look good. In most places we've had adequate moisture, favorable weather during pollination, and no big pest con-

"The unknown is that first hard were hurt early on with water, but the freeze date," Boehm said. "If we can get well into October without that, we'll be good."

> Michigan soybean production is projected to best last year by 21 percent, totaling 100.76 million bushels. Unchanged from 2013, the yield forecast is 44 bushels per acre.

> U.S. soybean production is forecast at a record 3.82 billion bushels, up 16 percent from last year. The national average soybean yield projection — a record high of 45.4 bushels per acre — is coming from a total harvesting area of 84.1 million acres, also a record.

> In alfalfa hay — the primary forage for dairy cattle — increased planting acreage and improved yields of 3.3 tons per acre are adding up to a total production of 2.1 million tons statewide.

> Across the Thumb and Saginaw Valley, Michigan's sugar beet growers estimate a yield of 26.5 tons per acre, up .3 tons from last year.

> Only wheat fields are underperforming compared to last year, yielding 73 bushels per acre, down two bushels from 2013. Michigan's total winter wheat crop is expected to total 37.2 million bushels.

Price drops are pinching the state's grain farmers

Farmers who enjoyed well-publicized high prices last year are seeing the correction they all knew was coming, and they will influence more than just the farmers' bottom lines.

Prices received by Michigan farmers for key grain commodities in July and August were generally down, according to the latest report from the USDA National Agriculture Statistics Service's Michigan field office. Some notable Michigan prices included:

*August corn: \$3.60 per bushel (33 cents less than July; \$2.44 less than

*August soybeans: \$12.40 per bushel (60 cents less than July; \$2 less than

*August wheat: \$5.70 per bushel (five cents less than July; 73 cents less

*August milk, at \$24.20 per cwt. (50 cents more than July; \$3.80 more than

"The challenge from lower prices will potentially begin to impact 2015 returns and bring pressure to input costs and land rents," said Bob Boehm, manager of Michigan Farm Bureau's (MFB) Center for Commodity, Farm and Industry Relations. "The decline in commodity prices for corn, soybeans and wheat reflect much-improved outlooks of yield and production, rebuilding supplies. Demand from ethanol remains stable to potentially lower depending on the outcome of the Renewable Fuels Standard decision by

EPA—and livestock numbers have yet to rebound from historic lows.' On a global scale, Boehm noted Chinese grain and oilseed purchases have slowed, and the overall outlook for global crop production has improved.

"Livestock and dairy prices continue to stay in positive territory, especially when combined with lower feed costs," he said. "Overall, crop farmers should be looking at favorable returns from 2014 with record yields assuming the northern tier of states avoid an early frost — and a good portion of this year's crop has been priced ahead at more profitable levels.
