Think pink: ACS fundraiser on tap

The prospects of trying to top last vear's hugely successful "Pinktober" celebration in Cass City might intimidate some folks, but don't count Joey Kreeger among them.

In fact, Kreeger is brimming with month-long campaign to boost awareness about breast cancer and

Cancer Society (ACS).

During the third annual Pinktober celebration last October, Kreeger along with a team of other organizers orchestrated the local effort involving a variety of activities that raised more than \$10,000 and drew hundreds of area residents to the village's downtown for the "Pink or anticipation when it comes to the Treat in the Street Finale" celebra-

"Last year it just really finally raise money for the American kicked in," Kreeger recalled, refer-

ring to the community involvement lanterns. that made the 2013 project such a success. "It was amazing, so I think people are excited about it this year. It's like the whole community is getting together," she said.

Everybody was calling me this year, asking, 'How can I get involved?' Everybody wants to decorate their windows again and have everybody wear pink to the home-coming game," Kreeger said. "It's like everybody is excited to do something together."

Pinktober 2014 will kick off in conjunction with the Cass City home junior varsity football contest Thursday, Sept. 25. The half-time will feature lighting of sky lanterns purchased in honor of cancer victims and survivors, according to Kreeger, who noted residents can purchase lanterns for \$5 each at the Lions Pavilion, or pre-order them by contacting Shari Bock, food service director for the Cass City Public Schools, at (989) 872-2148. Last year, organizers sold 180 of the

"That's also the day we bring the pink toilet down," Kreeger added. The activity involves a pink toilet that is placed in front of local businesses and generates donations of at least \$20 every time a business owner pays the \$20 to have it moved. "It's a really good fundraiser – sometimes it gets moved two or three times in a day," she said.

In addition, Christine Anthony, owner of Captured By Christine Photography in Cass City, has launched her annual Pinktober Cutest Kids Contest. Cute kid photos will be posted around downtown, and residents are invited to "vote" for their favorite by donating money in an accompanying canister

The date for another popular event, the annual "5K Glow Ta Ta Trot", has been moved up this year to Saturday, Oct. 11. The 5K and 8K run and 5K walk were held in conjunction with the finale in 2013, but the numbers it drew left organizers a bit overwhelmed – there were nearly

180 participants compared to a previous high of 62 runners. The cost to enter is \$30.

Also planned is a pumpkin launch Saturday, Oct. 18, starting at 1 p.m. in the parking lot at Cass City Elementary School. Organizers will be providing the pumpkins for \$5 each, and the individual whose pumpkin is launched the farthest will receive a trophy.

Another Pinktober fundraiser – the second annual Elkland Township Cemetery Walk - is scheduled for Sunday, Sept. 28. All 150 tickets for the expanded event planned this year sold out within a week, and organizers anticipate donating all \$1,050 of the proceeds to the ACS.

The cemetery walk, which is videotaped, features several local actors portraying notable citizens from the Cass City community's past, each dressed in period costumes and presenting brief programs about "their lives" at their gravesites.

Missing Cheboygan man found safe in Huron Co. by Tom Montgomery Huron County Sheriff Department officials say the search for a missing Cheboygan man ended on a happy note last week in the Port Austin area.

Huron County Sheriff Kelly J. Hanson said Deputy Jake Dhyse reported locating the man after he was dispatched to a business – the Corner Beverage - to check on the well-being of an elderly man at about 2 p.m. last

"Business owner Kelly Szymanski became concerned after having contact with the man, who appeared to be in a confused state of mind," Hanson said. "Once Deputy Dhyse arrived, it was determined that the man, Frank R. McCarty, age 82, of Topinabee, Cheboygan County, had been missing since (Tuesday night) and apparently is in the early stages of dementia and

Alzheimer's. 'He also was the focus of a countywide search that had been initiated by the Cheboygan County Sheriff's Office. They, along with other agencies, as well as volunteers, had been searching the Cheboygan County area since he was reported missing," added Hanson, who did not say how the man made

Respiratory illness in kids on the rise, health officials report

Michigan Department of Community Health (MDCH) officials say they're receiving reports indicating an increase in severe respiratory illness in children ages 5 to 17 across the state.

MDCH is working with local health departments and hospitals to investigate those cases. At this time, Michigan has no confirmed cases of Enterovirus D68 (EV-D68) associated with the national outbreak, but state health officials are forwarding samples to the Centers for Disease Control and Prevention (CDC) for testing.

Remind your college student to get a shot

That chill in the air is a harbinger not only of fall in Michigan, but also the coming of flu season, which means it's time to think about taking a few minutes to get a flu vaccination.

And while the very young and the very old are among those most susceptible to serious and even life-threatening cases of influenza, we're joining with state health officials in recommending that parents remind their college students to protect themselves as well.

The Michigan Department of Community Health (MDCH) is partnering with colleges and universities, as well as community partners, across the state to increase flu vaccinations among young adults. Each year, several healthy, young adults in Michigan die from the flu.

Influenza vaccination is the single best way to prevent influenza infection.

According to data from the Michigan Care Improvement Registry (MCIR), only 10.1 percent of individuals aged 18-24 years were vaccinated against the flu during the 2013-14 flu season. College students have unique risk factors that make them more susceptible to getting sick, such as close contact in dormitories and classrooms.

In an effort to raise flu vaccination among this age group, MDCH is launching a new challenge this year among Michigan colleges and universities. School health centers have volunteered for a friendly competition amongst each other to see who can get the highest percent of their students vaccinated against flu this

"Regardless of your participation in the challenge, MDCH encourages all Michigan colleges and universities to support flu vaccination among your students," said Dr. Matthew Davis, chief medical executive with the MDCH. "Assess the needs of your students and strongly recommend flu vaccination throughout the entire season. Begin now before the flu hits your campus."

There are currently 13 schools enrolled in the 2014-15 Flu Vaccination Challenge from around the state. They include Albion College, Aquinas College, Central Michigan University, Eastern Michigan University, Grand Valley State University, Hope College, Kalamazoo College, Michigan State University, Northwestern Michigan College, Oakland University, Southwestern Michigan College, University of Michigan, and Wayne State University.

Competition aside, the flu doesn't have to be a serious health risk if you follow the Centers for Disease Control and Prevention (CDC) recommendations, which include a flu vaccine for everyone ages six months and older as the first and most important step in protection against this disease.

There's no reason not to get a vaccine and certainly no lack of opportunities - vaccines are available at doctors' offices, clinics, pharmacies, and a number of other locations.

Sure, for many healthy people the flu can be little more than a blip on their fall and winter radar. Just keep in mind that five to 20 percent of this nation's population is infected with the flu annually, with an average of 226,000 hospitalizations and more than 23,000 deaths.



Irony in the lot at Erla Foods

When was the last time you had to spend any amount of time searching for a parking space at Erla Foods? Probably the last time you couldn't find an empty space along Main Street in Cass City.

I went to Erla's after last week's paper hit the newsstands with plans to pick up a few things; eggs, some fruit, a roast, etc., and left with nothing, because the parking lot was packed like I've never seen before. So were the aisles, with shoppers pushing carts practically bulging with going-out-of-business bargains. I found eggs and fruit, but no meat, and decided an hour-long wait in line wasn't worth the trouble.

How ironic, I thought, as I maneuvered my way to exit the parking lot. Don't get me wrong; I'm not criticizing residents for taking advantage of the

deals. In fact, their presence will make it quicker and easier for the owners to tie up loose ends before closing the doors.

I guess the longtime family-owned grocery store's closing just didn't seem real until I saw all those people and all the empty shelves. How sad for the community, especially all of our senior citizens for whom a local grocery is more than simply a convenience, you know?

I've heard much of the local chatter in various conversations and on social media – "If the owners had just been more competitive with their prices...", "It only took them three years to bury the business...", "All they cared about was this or that...", blah, blah, blah. Sadly, much of these folks' information is, simply, wrong, because it's more entertaining to listen to the always-accurate grapevine than it is to check out the facts for yourself.

I've been a journalist for nearly 30 years now and I can tell you there's almost always more to a story than the press can publish.

Regardless, the critics will have plenty of time now to gripe on their way to Caro, Bad Axe or Sandusky the next time they need a bag of apples, a pound of ground round and a deli-fresh salad.

I suppose the reasons behind the loss of another business – and the community's only remaining grocery store — don't really matter now.

What does matter is how badly this town wants to continue having its own grocery, presuming another buyer decides to take the risk. Badly enough to shop locally a bit more? Badly enough to give the new owner(s) the benefit of the doubt as they try to make a go of it, rather than urging others to boycott the business because your brother, sister, Aunt Bertha, Grandpa Joe or whoever was laid off from that place "for no good reason at all?"

Being a small business owner in a small town is tough these days even without all the drama. Just ask the former owners of vacant store fronts anywhere. In the meantime, I suspect a number of Erla's customers, like me, won't hesitate to agree that the old saying really is true – you don't know (appreciate) what you have until it's gone.

5 YEARS AGO (2009)

You won't find many administrators whose educational backgrounds are as varied as Rocky Aldrich's experiences during his 28-year career. Aldrich has taught physical education/health, industrial education. math and driver's education. 


Cass City's Dagmar Brown completes yet another Labor Day walk across "Big Mac"


Deputies subsequently seized two rifles from the vehicle as well as the carcass of a deer.







Last year, the Federal Trade Commission received more than 100.000 complaints from Michigan residents about unwanted calls.

Call-blocking technologies including NoMoRobo, Call Control, and Telemarketing Guard, enable phone carriers to identify and block unwelcome sales calls at their customers' "Michigan consumers deserve request. In a letter signed by 31 other state and territorial attorneys general, Schuette filed official comments today with the FCC. The letter urges the commission to recognize callblocking filters as legally appropriate, if requested by customers.

In his letter to the FCC, Schuette asks for a formal opinion on whether an exception can be made to allow companies to block illegal telemarketing calls at the request of a con-




