State group honors Tuscola County sheriff with Crime Fighter Award

Fight Crime: Invest in Kids Michigan – a statewide crime prevention non-profit organization led by more than 500 of Michigan's best-known police chiefs, sheriffs, prosecutors and crime survivors - honored Tuscola County Sheriff Lee Teschendorf with Fight Crime's prestigious "Crime Fighter Award" during a recent training conference.

Clinton County Sheriff Wayne Kangas, the statewide co-chairman of Fight Crime: Invest in Kids Michigan, presented the award to Teschendorf, saying, "Preventing crime at the front end is in each community's best interest and in the best interest of our children. I am honored to convey Fight Crime's 2014 'Crime Fighter Award' to Tuscola County Sheriff Lee Teschendorf for his outstanding support and leadership on behalf of prevention."

"Sheriff Teschendorf's leadership on prevention included: meetings with State Rep. Terry Brown (D-Pigeon) on numerous occasions over the past five years while Rep. Brown chaired the K-12 Budget and sat as a member of the subcommittee, and co-hosting a meeting with Congresswoman Candice Miller (R-CD 10) and area law enforcement leaders to thank her for her support for early education and care and their important benefits to children and society," Kangas said.

"He also signed on to several letters to key lawmakers that led to the \$130 million increase in the state-funded preschool to ensure that all eligible Michigan children have access to high-quality preschool. This is important as the research shows that at-risk kids who have high-quality preschool are more socially, emotionally, and cognitively prepared when they enter kindergarten. In the long run as compared to similar kids who lacked the preschool experience, they graduate on schedule, go on to more vocational training or college, have higher-paying jobs, and own their own homes.

School officials scrambling to retain substitute drivers

Cass City School Supt. Jeff Hartel's general report on the state of student transportation in the local district turned into a brief discussion Monday night focused on ways to lure and retain substitute drivers, an issue schools are struggling with across the region.

"We are running short of drivers. Any suggestions (on ways to attract additional drivers), I am open to," Hartel said during the Cass City Board of Education's October regular meeting.

"We are in desperate need of substitute drivers. This is a problem all over the Thumb," added Hartel, Thumb compare with Cass City whose duties include serving as the Cass City Public Schools' transportation director. "I don't want to say we're at a 'critical stage', but we are getting there."

Hartel suggested that board members consider upping the pay scale for drivers and possibly offer some sort of insurance plan. He also agreed with a board suggestion that manages eight routes, according to offering a stipend to drivers who remain with the district throughout the school year might accomplish an year from 2000 to 2005, while the adequate supply of personnel.

Take another look at your medicines

Many parents may not know it, but the medicine cabinet in their own homes could spell serious trouble.

The risk for someone experimenting with prescription drugs – especially young people – has been around for many years, but Department of Community Health (MDCH) officials are hoping to raise awareness of the problem by launching a new website to increase public awareness of the risks and potential harm associated with misuse of prescription and over-the-counter drugs, and to provide everyday steps individuals can take to address the issue in their families and communities.

Do Your Part: Be the Solution is a multifaceted approach to addressing prescription drug misuse and abuse across Michigan.

We applaud the effort, especially in light of the growing popularity of heroin among young drug addicts who start out abusing prescriptions such as Oxycodin or Vicodin, but later resort to a cheaper although more dangerous high with the unpredictable street drug.

Everyone has a role to play in the solution as we address prescription drug misuse and abuse in Michigan, according to MDCH officials, who say their news website offers practical steps that everyone can take immediately to monitor the medications in their homes, understand the risks of sharing prescription medications, and properly dispose of medications when they are no longer needed.

Experts say the non-medical use or abuse of prescription drugs is the fastest growing drug problem in the United States, and prescription medication is the second most commonly abused category of drugs. Opiate overdoses, once almost always due to heroin use, are now increasingly due to the abuse of prescription painkillers. In 2012, 941 Michigan residents died due to unintentional drug poisoning.

According to the U.S. Department of Health and Human Services, every day an average of 2,000 teenagers nationwide use a prescription drug for the first time without a doctor's guidance. Oftentimes, teens are accessing these drugs in their own homes. It can be as easy as opening a cupboard, drawer or medicine cabinet.

In addition, the National Institute on Drug Abuse (NIDA) cites prescription opioid abuse as a common first step to heroin use. Recent research by NIDA indicated that almost half of the young heroin users who injected heroin reported they used opioid pain relievers before the started using heroin.

Do Your Part: Be the Solution addresses the issue of prescription drug misuse and abuse using a multi-pronged approach including educating communities and the general public, providing guidance and resources to the medical community and other professionals, and linking to information on proper disposal to reduce the impact on the environment.

Hopefully, you'll never look at your own medicine cabinet the same way again.

Slices of Life

I've got a list for that



I am an A-lister. And a B-lister. And a 1, 2, 3 lister.

And so on.

A. I make lists. B. I compose lists. C. I put lists together. D. I enlist lists.

My daily to-do directions tell me what to do. Sometimes I take my list from the morning and do a complete rewrite after lunch. I've been known to write, "Make list for Tuesday" on Monday's list. It's that bad. (Or good, depending on your opinion of lists.)

I've been a registered pro-lister since at least 1993 – for a number of reasons.

1. Lists tell me where to go and what to do. If I didn't have that, I might not get to the place where I am supposed to be. I might forget to do something meant to be an integral part of my day, like going to the dentist or (horrors) scrubbing a toilet. Instead I'd stay in bed and forget to eat breakfast. Lists keep me on track.

2. Lists provide opportunity. If an item is on your list, logic dictates it is a legitimate and prioritized activity. If you want to eat chocolate after lunch (or for lunch), include Hershey's on your list. Likewise with taking a nap, watching kitten videos on YouTube or scrolling through vast amounts of Facebook entries. It is your duty to complete the listings on your list; you might as well make a few of them enjoyable. You can thank me

3. Napping notwithstanding, lists help me sleep. Ever wake up in the middle of the night and become plagued by all the things you hope to accomplish in the coming day? Me neither. If I don't have a written list, the middle of the night mental one can keep me awake and alert for hours. I find keeping a pencil and paper by the bedside helps me sleep better. Or at the very least provides a groggily written, illegible directive to decipher over morning coffee.

4. Lists give a visual reminder of productivity. When you complete a task (this part is very important) you get to cross that item off your list. It's a fundamental human truth: there are few things in life as rewarding and satisfying as crossing an entry off your to-do list. Well, except for chocolate. Or maybe a combination of the two. Imagine savoring a bite of a bon bon while simultaneously crossing it off your list. Nirvana.

5. We now come to the importance of list content and increasing crossing opportunities. If I have three loads of laundry on a Tuesday, I could simply write "Laundry" on my list. That would be so wrong. I would spend hours hobnobbing with the dirty clothes before getting to cross the L-word off my list. When composing list content, it is prudent to maximize the crossing potential. An A-lister like myself knows how to expand list capacity so opportunities for crossations are multiplied.

For instance, one load of laundry equates to four entries on my list: 1. Wash 2. Dry 3. Fold 4. Put away. Three loads equals 12 crossportunities. It's smarter than new

You can imagine how similar amplification can be achieved with other household chores. Office and work tasks can likewise be outnumbered. Play it right and you'll spend more time crossing than working. There's a goal that's a bigger priority than any item on anyone's

6. One last piece of list advice for copious crossing opportunities: include items you've previously completed for the sole purpose of crossing them off. Ingenious, I know. You might think this sounds like cheating, but it isn't. You've done the chore. You deserve to take credit for your efforts on a list somewhere (and leave it out on the kitchen table for your family to see later).

7. I guess that sums it up. Lists can be helpful for

Ebola has been at the forefront on the news for weeks now, with both national and statewide health care systems reviewing their plans should they come into contact with a patient who presents symptoms of the deadly disease.

"Hills and Dales General Hospital is one of those hospitals. After the initial confirmed case of Ebola, the Infection Control team for Hills and Dales jumped into action to ensure we are prepared should the need arise," said Danielle Blaine, the hospital public relations director.

"All staff members have gone through new training, and we have developed new plans of action should we see a patient with symptoms," Blaine added.

remember that no Ebola cases have been seen in Michigan. The Ebola virus is currently in three West Africa countries of Guinea, Liberia fever (greater than 100.5°F) and and Sierra Leone. It is recommended that people should avoid non-essential travel to those countries," Blaine diarrhea, abdominal pain, or unex-

She also reminds area residents of the following vital facts:

- Ebola is not spread through casual contact, but through direct contact with the blood or body fluids (including but not limited to feces, saliva, sweat, urine, vomit, and semen) of a person who is already sick with Ebola.

"Community members should can enter another person's body through broken skin or for example, the eyes, nose, or mouth.

· Symptoms of Ebola include a additional symptoms, such as severe headache, muscle pain, vomiting, plained bleeding or bruising.

• Residents who have recently returned from West Africa and develop a fever should contact their healthcare provider immediately. If symptoms are present and the patient has traveled from an Ebola-affected country in the last three weeks, the patient should be properly isolated.

And I thought I was cynical...

And I thought I was cynical.

Shortly after completion of another successful pumpkin launch in conjunction with Cass City's month-long Pinktober – A Community with a Cause observance, organizers posted a Facebook message recognizing all those who took part in the event.

What seemed like a simple act of courtesy and appreciation was met by a response from a gentleman that ticked me off.

There are times when how you say something is much more telling than your message, but in this case, the guy struck a nerve on both counts, starting by asking how much of the money organizers received was actually going to fight

He obviously hadn't done his homework. Otherwise he would have known the pumpkin launch was simply a fun activity created in conjunction with the community's Pinktober festivities.

He then launched into a diatribe evidently sparked by opinions expressed on a website questioning the validity of pink-themed cancer awareness campaigns. I can't recall his exact words, but he implied that such promotions only serve to make pharmaceutical companies richer, and do virtually nothing to actually impact cancer research.

Local Pinktober organizers attempted to shift the focus of the conversation to the motivation behind Pinktober – increasing awareness and generating a few bucks to help the cause – but this guy was having none of it, basically accusing organizers of ignoring the "real facts" in his views.

That's when I stepped in a bit, suggesting this guy's real truth was based on the opinions spouted by a website (not sure if he missed this newsflash, but most folks have dismissed the idea that if information is posted on the Internet, it must be true).

Of course, the website he was referring to may be legitimate and is basing its statement on proven fact. Or maybe not.

I'm certainly not naive enough to dismiss the likelihood that some unscrupulous folks are making a dime on the whole "think pink" promotion. But what really bothered me was his assumptions that the almighty dollar was at the heart of Cass City's Pinktober observance.

Organizers attempted to set him straight by pointing out the local promotion "is mostly based on participation and support from the entire community. Our local businesses sponsor almost all the events and then they are held free to the community. We support everyone in our community as, unfortunately, cancer touches everyone's lives.'

Well said, although it may have fallen on deaf ears.

Just the same, I suggested that he was all wet when he implied that such observances are all about drawing attention to the communities that host them. Cass City had more than its share of reasons to be proud long before a handful of volunteers decided to organize Pinktober, although the annual fall observance has certainly become one of those reasons — not necessarily because friends and neighbors participate in activities that raise money for the American Cancer Society, but because the community is motivated by caring, compassion and a desire to take care of its own.





MILLAGE RENEWAL

Cass City School District voters will also be asked next week to secure a vital piece of the district's annual revenue package via the proposed renewal of an 18-mill non-homestead tax.

Cass City School Supt. Jeff Hartel has been making the rounds at local service clubs and other groups in an effort to explain the tax and the fact that it will not affect residents' tax bills. In fact, the 18-mill levy is a renewal for the next 10 years, 2015 through 2024, that will be assessed only on nonhomestead properties (industrial and commercial along with some agricultural property and second homes). Primary family residences are not affect-

The non-homestead millage is a requirement of Proposal A, the state's school funding structure requiring that the 18 mills on non-homestead property cannot be collected unless it comes before voters in an election.

"We're not asking for a new millage or bond," said Hartel, who pointed out the amount of funding at stake is significant – roughly \$770,000 annually. "If we don't get it, our district's bankrupt in two years," he added.



Imagination Library

Great Start Tuscola delivers 100,000th free book

A great example of the strength of community cooperation is being celebrated throughout Tuscola County.

The Great Start Tuscola Imagination Library (GSTIL) recently delivered its 100,000th free book to a child in the county.

The local effort was originally launched in conjunction with the national Dolly Parton's Imagination Library program, with the GSTIL delivering free books to children under the age of five who live anywhere in the Tuscola County Intermediate School District (TISD), according to Suze Walker, Great Start Collaborative director.

"Dolly Parton started the program in 1995 in her hometown of Sevierville, Tenn., but we learned of it locally in the fall of 2008," Walker noted. "Our first free books were delivered to children living within the TISD in January 2009."

Walker said although participation and support has grown steadily since, the program is still one of the "best kept secrets" in the area.

"Registered children ages from birth to five years old monthly receive a free book that is both gender neutral, and also age-appropriate," Walker explained. "There is no cost to the parents or guardian of the children, and there are no income guidelines that a family has to meet.

"If you live in TISD with children within that age range, you qualify. And if there are multiple children in a family in that age range, they each receive their own set of books."

Support from Tuscola County citizens and businesses have steadily grown, as news about the positive outreach has spread.

"People are realizing what a fantastic opportunity this is to help families in their own communities," Walker said. "When we started in January 2009, we had 611 registered children. Since the beginning of October this year, we've already had 2,015 children graduate out of the program (by turning five years old), and currently our average delivery is 1,700 books monthly.
