

State Farm leadership stays in the Thumb

Caro's Bednarski replaces Sanilac dairyman Wood as new MFB chief

District 6 director on the MFB Board of Directors since 2000 and a longstanding member of the board's executive committee, Bednarski succeeds outgoing president Wayne H. Wood, a dairy farmer from Sanilac County.

The MFB board also welcomed a pair of newcomers: Mark Daniels will represent the organization's Young Farmer Program, and Kellie Fox will represent its and Education Promotion Program.

Bednarski and his wife, Lisa, live near Caro and have three sons, Carl, Nathan and Michael. Their family farm raises corn, dry beans, sugar beets, soybeans and

For the first time in 14 years can keep it," Bednarski said, referring to Farm Bureau's member-driven, grass-roots policy development procedure. "If we lose that direction, we've lost our effectiveness."

Bednarski's organizational involvement includes six years as vice president of the Tuscola County Farm Bureau and seven years on its executive committee. He has served in several leadership positions at the county, state and national levels. including the membership, national affairs, promotion and education and policy development, in addition to service on several commodity advisory committees.

Outside Farm Bureau, Bednarski is a past 4-H youth sugar beet program leader, past vice chair of the Michigan Farm Produce Insurance Fund Board, a founding member of the Michigan Sugar Cooperative, and has served on the Michigan Sugar Board of Directors for five years.

Blaze guts **Cass City** area home

A quick response from the Elkland Township Fire Department was not enough to save a two-story wood frame home about two miles south of Cass City Friday morning.

The local fire department was dispatched to the Cole Miller and Madison Simpson residence, located just northeast of the intersection of Cemetery and Kelly roads at 3630 Cemetery Rd., at about 9:50 a.m. Fire fighters arrived about eight minutes later to find the home already fully engulfed in flames.

Motorist hits, kills flagman in Huron Co.

A flagman working at a road construction site in Huron County died Thursday after being struck by a pickup truck, Huron County Sheriff Kelly J. Hanson reported.

Deputies were dispatched to the scene - Sand Beach Road (M-142), west of Scott Road in Verona Township — at about 10:38 a.m.

Preliminary investigation is indicating that an eastbound GMC pickup driven by Dale C. Peyerk, age 58, of Bad Axe, struck a flagman and the flashing arrow sign trailer he was standing near, which was parked in the eastbound lane and connected to a construction company pickup," Hanson said. "The flagman then flew through the air over 75 feet and landed near a guardrail on the opposite side of the road.

"Lifesaving efforts were initiated by deputies and Central Huron Ambulance personnel, but unfortunately the victim, Nathan C. Hayden, age 21, of Kalkaska, later died at the Huron Medical Center in Bad Axe," the sheriff said

Hanson said Peyerk was apparently uninjured. "Our accident investigators remained at the scene, with the road closed for several hours. Further investigation will continue," he added. "We ask that anyone who may have witnessed this accident and hasn't already spoken to our deputies, to please contact our office during regular business hours at (989) 269-6500 or Huron Central Dispatch at (989) 269-6421 to leave a message."

Another feather in local district's cap

Anyone interested in seeing further proof that Cass City Public School officials are offering our youngsters a solid education need look no further than the 2014 Michigan Public High School Context and Performance (CAP) Report Card recently issued by the Mackinac Center for Public Policy.

This was the second edition of the report, which evaluated academic performance in standard public high schools in the state while also taking into account family income.

Specifically, four years' worth of Michigan Merit Exam (MME) and ACT test scores were adjusted based on the percentage of students in a high school who qualified for a free lunch. A high school's "Cap Score" indicates how far above or below projections a high school performed, given its student population's socioeconomic status, with 100 set as the standard.

So, how did the Cass City Public Schools measure up?

According to this latest "report card", Among 659 Michigan public high schools, Cass City Junior-Senior High School ranked 36th, with an overall CAP score of 111.02 and a grade of "A". The district's performance topped that in nearly 94.5 percent of the other districts examined in the study.

Among other area schools, Kingston High School was ranked 102nd with a CAP score of 106.06 and a grade of B; Owen-Gage High School was ranked 329th with a CAP score of 100.37 and a grade of C; and Ubly Community High School was ranked 316th with a CAP score of 100.65 and a grade of C.

"We were the first research group in the state to attempt this type of analysis on such a large scale," said Audrey Spalding, education policy director for the Mackinac Center for Public Policy – a non-partisan research and educational institute dedicated to improving the quality of life for all Michigan residents by promoting sound solutions to state and local policy *questions* — *and author of the study.*

"We now have two, four-year periods of data with overlapping years, and it's even more obvious that socioeconomic factors have a significant impact on standardized test results," Spalding added.

Equally important, the information contained in the study can now be used by parents as well as school officials and policymakers.

"This report card is a different tool parents can use to make informed decisions when comparing schools; it provides school officials with a better understanding of how their school compares to others statewide; and it will help policy makers truly identify high-performing schools," Spalding said.

"Assessing school performance by using raw test scores alone ignores the tremendous impact a child's circumstances can have on his or her educational performance."

We couldn't agree more, and we also couldn't be prouder of local school officials' efforts, both in the past and currently, to provide a quality education for all students, in spite of financial and other pressures that challenge public schools on a daily basis.

Sure, no "report card" can provide a complete picture of how well a school system is doing its job, but these numbers are proof that Cass City School officials are offering the community much more than lip service.



Sanilac robbery suspect in custody

The suspect in a recent armed robbery in Sanilac County pushed his luck too far when he allegedly robbed a gas station in southwestern Macomb County last week.

Sanilac County Sheriff Garry Biniecki reported Center Line police officers arrested a 26-year-old Croswell area man Tuesday. The man, whose name had not been released as of press time, is also believed to be responsible for the Sanilac County robbery, which targeted the Sunrise Marathon Station in Worth Township three days earlier on Saturday, Nov. 29.

In that case, a 19-year-old store clerk called 911 at about 6:30 p.m. after a male suspect confronted her, produced a semi-automatic pistol and demanded money, which the clerk handed over from the register. The suspect then fled the scene on foot.

"Sanilac County detectives were notified that Center Line police had a suspect in custody matching the (DNR) Law Enforcement Division.

description of the Worth Township Marathon robbery," Biniecki announced last Wednesday. "The suspect was apprehended by Center Line police Dec. 2 in the afternoon after pulling a similar armed robbery at a gas station in their area.'

The suspect was transported to the Macomb County Jail, where Sanilac County detectives interviewed him regarding the Marathon robbery case. "The suspect, who was wearing a red hooded sweatshirt, dark colored blue jeans and a facemask at the time of the armed robbery, confessed to committing the crime," Biniecki said. "(He) remains in custody at the Macomb County Jail, without bond, on multiple charges, with a hold placed by Sanilac County.'

Officers from the Lexington, Croswell and Port Sanilac police departments all assisted in the Sanilac robbery investigation, as did the Sanilac County Drug Task Force, troopers from the Michigan State Police post in Caro and the Michigan Department of Natural Resources

Reporter's notebook Are we far too PC for our own good? by Tom Montgomery

There's been no shortage of talk about the fatal shooting of Michael Brown by a white Ferguson, Mo., police officer, but I wonder how many folks aren't willing to say a word for fear they will become the target of verbal abuse or worse?

A friend of mine may have hit the nail on the head when she told me, "Thanks to the political correct (PC) movement, you cannot talk about, for example, race without being labeled a racist. The PC movement has been so influential that it has succeeded in prohibiting people from speaking clearly about anything that matters without paying a dear price for speaking up."

That's too bad, because we've become so lazy as a society that we paint everything (and everyone) with one big wide brush, as in most white cops target black citizens.

As a journalist, I can't help but wonder why the Michael Brown shooting became the monstrous story it did. Don't get me wrong – it's an important story, but no more important than any other fatal shooting involving a police officer (black, white, or any other race) and any other victim (black, white, or any other race).

Maybe less so, considering the victim in this case appeared to have raised a number of red flags for any police officer (start with being belligerent and apparently lacking any respect for the law). Does that justify being shot? Of course not. What I'm suggesting is that Brown's behavior played a vital role in putting his own life at risk by acting like a thug in the presence of a law enforcement officer who could not have known what was inside Brown's head at the time.

I'm also not saying that law enforcement is without members who have no business serving the public as police officers. The same could be said for any profession — businessmen, attorneys, public servants.

On the other hand, police officers sometimes get the raw end of the deal in conversations involving individuals who feel members of their family are being frequently profiled based on their name alone, the color of their skin or where they live. I'm not naive enough to believe that doesn't happen, but often those individuals are simply trying to justify behavior that cannot be justified.

Here's a newsflash: the police are supposed to profile people who break the law, so stop breaking the law and see what happens. Duh.


I guess one of my concerns is that all of this political correctness will only encourage residents to believe that all (or most) police officers are blood-thirsty, uncaring, racist thugs. Sure, some of them are jerks, but I've also met my share of idiot newspaper reporters (and have been called the same).

Over the years my job has enabled me to witness police officers do some very human things for people they've never met. I've seen them hug bleeding accident victims awaiting an ambulance, risk their lives in an effort to protect others, and go out of their way to ensure a family shocked by the death of one of their own has the resources it needs to

I've seen them as people – dads, moms, sons, daughters, brothers, sisters – caring for their own families and contributing to their communi-

Maybe talking about that little piece of reality isn't politically correct, but maybe if more people did, some folks would put away those wide paint brushes long enough to forego some sensational bandwagon in favor of gaining a better understanding of their fellow man.

Millages would benefit vets, EDC

Even working part-time, three days a week, Amend has helped to secure some \$15 million a year in various benefits for servicemen and women and their spouses, ranging from service-related injury claims to pensions and education benefits.

But Amend knows he can't possibly begin to adequately service the county's veterans now because he often must travel to serve clients, which means that while he is on the road, no one is in the office to answer questions brought in by veterans, some of whom are hesitant to ask for assistance in the first place and will attempt to do so only once.

"This (millage) would give us two people to work this office instead of one," Amend said, adding one staff member could be traveling to meet veterans and assist them in applying for benefits, while the other would be in the office five days a week, available to answer questions and assist veterans seeking help.

The additional tax revenue would also enable the office to purchase a second van to transport more veterans to VA-approved medical facilities in locations such as Bad Axe and Saginaw as well as Detroit, Ann Arbor and Battle Creek.

In addition to providing more stability in terms of revenue, the proposed EDC millage would pay for an expansion of staffing – from 1 ½ to 3 ½ positions – and augment the EDC's revolving and other loan programs, according to Hoagland. time, free up \$50,000 the county annually provides to the EDC agency's annual budget — for other purposes.

"The last time we had a millage (that eased funding demands on the county's general fund budget) was in 1988 with the first road patrol and senior citizens millages," said Hoagland, who noted Tuscola County already has among the lowest allocated millage rates in the

"Like everything else, it takes more resources to do (everything), but these are pretty modest millage amounts. We've done well with what we've had to work with," Hoagland added.

Tuscola County EDC director Steve Erickson said the special levy would enable his office to better serve residents while providing a dependable funding source. "If approved it would fully fund the Tuscola County EDC as well as provide a grant matching fund of \$150,000 for local municipalities," he said.

"When we began in 1982, the Tuscola County EDC was formed and supported by our local farmers and businesses. We provided the funding they needed to grow in our county," Erickson said. "In the early 1990s the Tuscola County EDC was expanded to help grow our manufacturing base within the county. Today, we have grown from a board of 12 to 23 volunteer community members from throughout Tuscola County who represent all aspects of economic development as well as health care and education.

"In order to assist and grow our equipment lease program. This program allows small businesses to purties in the county and, at the same chase vital equipment through the

Tuscola County EDC, so that their business can grow and thrive in our making up roughly half of the county," Erickson explained. "This program has created and retained much needed jobs...and provided \$150,000 of funding to our county businesses.

> "Another facet of financial assistance for businesses in Tuscola County is our Revolving Loan Program," he noted. "This program offers businesses gap financing to assist them in growing their business. This program has also retained and created jobs.

"(We're) actively involved in meeting the need of growing our energy infrastructure to meet the current and future demands of our agriculture and manufacturers within our county. The EDC is dedicated to working with our manufacturers to receive state grants that help them to expand their operations or purchase new equipment," he said. "Through our grant writing service we have helped to raise over \$5 million for county, (and) our new service of creating master, downtown development authority, and park and recreation master plans allows municipalities to plan for and develop their communities, downtowns, and park and recreational opportunities.

Erickson added, "(We're) seeking a millage to combine all of our funding from one source. Currently, changes within the tax structure coupled with decreases in property values and loss revenue from the personal property tax have caused most municipalities to struggle financially. If approved, this mileage would relieve them of their financial support to the Tuscola County EDC. It would also provide them with an opportunity to receive grant matching dollars for federal and state

Judge Gierhart attends training focused on use of high-tech evidence

Texting and social media sites can be a quick and convenient way of communicating with friends, family and co-workers, but they're also increasingly making their way into courtrooms across the country in the form of poten-

A desire to effectively deal with those types of legal issues recently prompted Tuscola County Circuit Court Judge Amy Grace Gierhart to return to "school"

"New forms of communication technology continue to force judges to make difficult decisions about what constitutes admissible evidence," commented Adam Pavlik, Tuscola County deputy court administrator. "What does the law require to verify that alleged text messages are authentic? How do we know if a printout of a Facebook post is legitimate?

With those questions coming up more and more during legal proceedings, Pavlik noted, Gierhart opted to attend a conference Nov. 10-14 on the state of the art in these technologies at the National Computer Forensics Institute in Hoover, Ala. The training was paid for with a grant from the U.S. Department of Justice.

"There is no question that parties in court want to rely on this kind of information more and more in making their case," Gierhart said. "When I found out about the tremendous opportunity to learn about such a topical subject with a grant paid for by the federal government, I jumped at the opportuni-

The five-day program, "Computer Forensics for Judges", combined handson exercises with lectures to familiarize judges with both the technology and the manner in which legal concepts apply to the technology. The training covered material ranging from recovering information, such as text messages, Internet posts and email, for use as evidence in court.

'I can't overemphasize how fantastic and useful this experience was," Gierhart said. "I'm already applying some of the lessons I learned in the

"Judges are expected to do two weeks of continuing education every three years, and I am always looking for ways to get that in at the least expense to Tuscola County taxpayers," she added. "Being able to get such valuable training at the Federal government's expense is a win-win-win for the public, the county and the courts.

In 2004, the Michigan Legislature and then-Gov. Jennifer Granholm amended the law to include emergency vehicles such as tow trucks and courtesy vehicles operated by the Michigan Department of Transportation (MDOT), placing them on the same level as police cars and ambulances.

"Drivers charged with (a) violation could be guilty of a misdemeanor punishable by a fine of not more than \$500 or imprisonment of no more than 90 days, or both," Hanson noted. "However," he pointed out, "if a driver causes injury to a police officer, fire fighter or other emergency response personnel, the penalty raises to a felony violation with a fine of not more than \$1,000 or imprisonment for not more than two years, or both. If a driver causes death to a police officer, firefighter or other emergency response personnel, they now face a felony charge with a fine not more than \$7,500 or by imprisonment of not more than 15 years or both."

"Move over" for safety on state's roads: It's the law On roads with two or more lanes of travel in the same

direction:

*When approaching a stationary emergency vehicle with its emergency lights activated, carefully move over into an open lane. *If that is not possible due to traffic, weather or road conditions, slow down and pass with caution, allowing the emergency vehicle as much space as possible.

On roads with one lane of travel in each direction:

*When approaching a stationary emergency vehicle with its emergency lights activated, carefully move over into an open adjacent lane.

*If this is not possible due to traffic, weather or road conditions, slow down and pass with caution, allowing the emergency vehicle as much space as possible.

Q: If I am on a two-lane road and see a police car on the shoulder and a car is traveling in the opposite direction, what am I supposed

A: If it is not safe for you to move over into an adjacent lane, then you must slow down and pass with caution, giving the emergency vehicle as much room as possible.

Q: Do I have to move over for a tow truck?

A: Yes, road service vehicles, including tow trucks, are considered to be emergency vehicles under the law.

Q: If I see an emergency vehicle on the side of the road and it does-

have its emergency lights activated, do I have to move over?

A: No, you do not have to move over if the emergency vehicle doesn't have its emergency lights activated. However, you should always pass with caution, giving the emergency vehicle as much space as possible.






