# Village settles **URS** dispute

The village of Cass City will borrow \$450,000 to help settle a dispute with URS Corporation, Southfield, to cover all monies owed on engineering work on proposed upgrades to the Cass City Wastewater Treatment Plant (WWTP), related to construction of the Dairy Farmers of America (DFA) milk plant located in the industrial park adjacent to Doerr

Disagreement on the billed costs, scope of the project and contract limits were all issues, according to village attorney Jason Bitzer, who has had a series of discussions with opposing council in an effort to resolve the clash totaling \$742,739.





# We'll say it again: get your flu shot!

At the risk of sounding like a broken record, we're going to again encourage our readers to consider putting "Get a flu shot" on their list of things to do as soon as possible.

Michigan Department of Community Health (MDCH) officials say influenza activity in the state is increasing, especially in Michigan's southeast region, prompting them to urge residents not to wait to get their flu vaccine this year.

"Vaccination is the single best way to prevent against getting the flu," said Nick Lyon, director of the MDCH.

"Vaccine-preventable diseases like the flu are a very real threat in our communities," adds Dr. Matthew Davis, chief medical executive with the MDCH. "It takes about two weeks after vaccination to be protected against the flu, and I encourage all residents to get vaccinated now so they are protected before flu becomes widespread in Michigan."

The flu can be serious, and complications are usually more common in young children, older adults, pregnant women, and people with chronic health conditions. Last flu season, influenza particularly affected healthy young and middle-aged adults. This is why MDCH urges everyone age six months and older, regardless of health status, to protect themselves against the flu.

Each flu season is unpredictable.

The 2013-14 season began relatively early, was moderately severe, and was predominantly an H1N1 season. So far in 2014-15, flu activity is increasing and health officials say they are primarily seeing H3N2 along with some influenza B viruses.

Nationally, about half of H3N2 viruses characterized have "drifted" and do not match the vaccine strain. Because of this, there may be decreased vaccine effectiveness observed this flu season. However, the vaccine can provide some protection against Ubly drifted viruses, and is still strongly recommended.

Last flu season, 42.9 percent of Michigan residents were vaccinated against the flu, which remains below the national coverage of 46.2 percent. Data from the Michigan Care Improvement Registry show only 10.1 percent of adults age 18-24 were vaccinated for flu in 2013-14.

Spending Christmas and New Years with the flu is no way to celebrate the holidays. So why not take a few minutes and take care of that immunization. Keep in mind, by protecting yourself, you're also protecting friends, loved ones and co-workers you come into contact with on a regular basis.

If you're not sure how to start, contact your personal physician or stop in at the many pharmacies that offer flu shots.

Of course our kids love us in return. But they love us like kids are supposed to love parents. We love them in a different way. As only a parent can. It's how things are. How they were meant to be.

Most days, most times, most moments, I am so grateful I've been given the gift, the privilege, the honor of

### **DNR** math on wolves is just not adding up

The DNR better hire someone who knows how to add and subtract. Why? Because the biologist that was assigned to Isle Royale was told that 80 wolves was a perfect balance for the 5,700 moose over there, but then they let them breed to roughly 300 and that brought the moose population down to under 1,000.

The DNR claims the wolves caught a disease and died off to roughly 28. I wonder if someone in that department with one ounce of brains knew they were in trouble and gave them a self-inflicted disease or lead poi-

In Michigan's Upper Peninsula, the DNR claims there are 658 wolves, and they claim there are five wolves to a pack. If you have five wolves to a pack or 30 wolves to a pack, there will only be one breeding female to a pack. So take 658 wolves with five wolves – that equals 131 breeding females. A female can have four to seven pups, but let's take four pups to each female and that equals 524 pups. I'd like to know, at that rate of pups, why we only have 658 wolves.

I have a question for that biologist that works for the DNR. In 2005, you claim there were 405 wolves, which equals 81 females with five wolves to a pack. Each female having four pups would equal 324 pups. Then in 2006, you claim there were 431 wolves. If that is true, I would like to know what happened to the rest of the 298 pups, because from 2005 to 2006, you say wolves only increased by 26. I know some would die from natural causes, but not 298 of them. So does anyone really know how many there are? Please don't tell me they had abortion.

This much I do know: four to five years from now there won't be any deer to hunt at the rate these wolves are increasing. The millions of dollars we spent bringing moose in from Canada will be dinner for those wolves. The original wolves in Montana weigh 80 to 90 pounds, and the ones that they introduced from Canada weigh 180 to 190 pounds. I'd like these biologists that are tracking the predators to put tracking collars on the high level management to see if they can hold down a real job, because they surely don't know how to do the ones they have.

But then there are those times, those instants, those seconds, when the weight and the pain of it all seems awfully great – to love someone so much it hurts. Caring for another person like a parent cares for a child leaves you vulnerable in a way you never imagined. It's scary sometimes, living with that vulnerability day in, day out. Not for weeks or months, but for a lifetime.

It's something no one admits. Something no one tells you. Something you don't often even dare tell yourself because your weakness and susceptibility could make you seem selfish or ungrateful for the gift you've been given. Thinking about it - acknowledging it - makes it more real and more raw.

When they come to us as tiny babies – so vulnerable and dependent - their world becomes ours and their needs become almost more important than our own. When they hurt, we hurt. When they smile, we smile. When they sleep through the night, we breathe a sigh of relief. We worry and fret because there is no shortage of things that could go wrong.

Their vulnerability creates ours.

A new parent might believe the situation is temporary or at the very least will change as her children grow and become more independent. And it's true; the situation does change. In some ways it multiplies.

Kids grow up and the distance between you – both physically and psychologically – increases. You're no longer needed to kiss away boo boos or help a toddler get back to sleep after a bad dream. It isn't as simple or as easy as that anymore. And while you might not be with them every minute or every day, you never quite lose sight of their state of being and whether they are happy or hurting, succeeding or struggling, at peace or at war and everything in between.

Two decades ago, we brought a pink bundle home with us from the hospital and watched her chest rise and fall in the relaxed cadence of a baby's sleep. Back then we looked forward to the milestone of having her sleep through the night.

This morning my husband and I shared a tender parenting moment when we realized she had.

Oak wilt outbreaks are increasing in Michigan and the Department of Natural Resources (DNR) has conducted treatment at several state parks to halt the spread of the

Oak wilt is an introduced disease that causes rapid death of infected trees. The fungus is easily transported by beetles from infected wood to nearby wounded trees.

Trees cannot be cured of oak wilt, and once a tree is infected the disease can rapidly spread to neighboring trees through underground root graft connections. The loss of large numbers of oak trees in parks can be dramatic, both for the park visitor experience and the ecology of the natural habitat.

"The likely cause of the oak wilt outbreak at Michigan state parks is the movement of infected firewood into campgrounds," said DNR natural resources steward Heidi Frei. "Campers and other park visitors can help prevent the spread of the oak wilt fungus by not moving firewood between campgrounds.'

Treatments in 2014 included using a vibratory plow fitted with a special blade (designed and fabricated at the DNR's Forest Fire Experiment Station in Roscommon) that severs grafted tree roots, isolating healthy trees from infected trees. Treatment also included the application of fungistats, which inhibit the growth and reproduction of fungi, and which have been used in areas declared critical dune habitat.



\*Dramatic increases in your intelligence and higher brain functioning because: bacon.


\*Easier wake-ups - your mornings will be like being shot out of a bacony cannon.

# School pleased with rank in study

was ranked 19th among district-run (non-charter) high schools based on a four-year average of Context and Performance (CAP) scores, which are based on both average student performance on the ACT composite scores and average Michigan Merit Exam (MME) subject scores in math, reading, writing and social

The second-edition report was unique in that the authors also took into account students' family income by adjusting test scores based on the number of students who qualified for a free lunch.

"It's very impressive," school Supt. Jeff Hartel said of the local district's ranking during a rescheduled monthly meeting of the Cass City Board of Education Monday. Hartel lauded teachers, administrators and other staff members for their work, saying they deserve the credit for the local students' achievement.

According to officials at the Mackinac Center for Public Policy, a non-partisan research and education institute, the study was groundbreak-

"We were the first research group in the state to attempt this type of analysis on such a large scale," Audrey Spalding, education policy director for the center, said in a news release announcing the results.

"We now have two, four-year periods of data with overlapping years, and it's even more obvious that socioeconomic factors have a significant impact on standardized test Spalding added. "Assessing school performance by using raw test data scores alone ignores the tremendous impact a child's circumstances can have on his or her educational performance.

#### ALTERNATIVE ED?

Turning to other matters, juniorsenior high school Principal Chad Daniels asked the board to consider establishing a potentially effective but expensive - program to deal with students whose serious behavioral issues frequently land them in expul-

sion hearings. "We're running into a growing problem," Daniels said, adding that the current process of bringing students to the board for possible expulsion due to disciplinary problems sometimes ends in a student being given additional chances to return to school. "But it's not fixing anything, and it's...bringing the other kids

Daniels said one way to prevent troubled kids from impacting the education of other students, and at the same time give youth with disciplinary problems every chance possible to succeed, would be to establish an alternative education pro-

The concept isn't new – the Cass City Public Schools has previously operated such a program off-campus (at the local Baker College campus). However, the cost is significant, requiring the services of a skilled educator who has a special education endorsement and is able to work well with these students. A para-professional would also be needed to run

to 15 kids.

The program could be located in the former Campbell Elementary School building, according to Daniels, who said participating students could be offered the opportunity to work their way back into the junior-senior high building with long-term acceptable behavior. If problems persist, they would be brought to the board and recommended for expulsion, he

#### IN OTHER BUSINESS

In other business Monday, the board:

\*Briefly discussed Hartel's suggestion that school officials consider setting aside a portion of the district's surplus fund balance for future capital improvements and various upgrades, including parking lot and heating system repairs, and replacement of aging computer technology equipment.

Hartel noted school officials were able to put \$240,000 into the district's fund balance at the end of the 2013-14 fiscal year, "which was about \$150,000 more than we anticipated." With a fund balance at nearly \$1.2 million, or an amount equal to 12.67 percent of the general fund balance, Hartel added, "If you wanted to put some money aside for some of these (repairs/upgrades), now is the time to do it.

"We've never had the luxury to do that before. It's not like we're rolling in money - don't get me wrong. We just need to brainstorm it," he said. "We do not have to do anything this minute."

Hartel indicated the unexpected revenue was due, in part, to measures such as reducing the number of school bus routes from nine to eight. Another factor was the loss of fewer students than anticipated.

Hartel, board members and school Finance Director Mary Cunningham discussed possibly "assigning" a certain amount of money towards capital improvement projects, but no formal action was taken.

the program, which would be limited Emily Phillips, who fills a vacancy left by the recent resignation of Trustee Jeff Loomis. During a special session prior to Monday's regular board meeting, the board interviewed both Phillips and Joey Kreeger for the position.

\*Heard a report from Kathy LaPonsie, RN, school nurse, regarding the "dental bus" service brought in occasionally to offer basic dental services to students. The board authorized LaPonsie to contract with the company she recommended based on its flat rate of \$40 for all services provided to youngsters who have no insurance coverage.

\*Heard a report from school Technology Director Severance, who reported on the general status of the district's technology program and confirmed needed upgrades are on the horizon.

At any given time, Cass City's wireless system is accommodating up to 500 devices (desktop computers, laptops, iPads, etc.), according to Severance, who said the schools' servers are now six years old. In addition, he said, just 15 percent of the districts computers are new enough to qualify for warranty coverage (less than three years old), while 25 percent are four years old, 25 percent are five years old, and the remaining 35 percent are six years old or older. "That old. That's very old," he told the board.

# Village officials settle URS dispute

regular meeting of the Cass City Village Council in 2014 that officials have reached an agreement to pay \$658,000 to URS. This represents a reduction of \$84,739.

"The Village will borrow \$450,000 in a 10-year note payable from the revenues of the wastewater treatment plant (WWTP). The balance of the money — \$208,000 — will come from the fund balance of the WWTP.

Chemical Bank will supply the loan at an annual fixed rate of 4.99 percent. Clerk/Treasurer Nan Walsh explained that a rate of three percent was originally discussed for a tax exempt note; however, council has been advised that the note is taxable, resulting in a higher interest rate.

URS officials have given the village until Dec. 29, 2014, to make payment totaling \$658,000. Failure to do so will result in the full outstanding amount of roughly \$743,000 becoming due, along with interest and legal fees.

#### **BUDGET**

Following a short public hearing, the council approved the village's 2015 operating budget. As required by law, the expenditures are balanced against anticipated revenues. The spending plan for next year totals \$3,425,832.

expected to decrease three percent in 2015, but the impact of pending legislation leaves this figure uncertain.

The new spending plan calls for a 2.5-percent increase in water and sewer rates due to the number of vacant houses in the community that utilize only minimum water and sewer services.

Cristiano also noted that no cost-ofliving pay increases are planned for village employees, and the current health insurance plan will remain in place with the deductibles introduced in 2011. The 2015 costs for health insurance are 5.5 percent higher than the current year.

Also in 2015, the police department will replace a vehicle, while capital improvements at the WWTP include the replacement of the ferric pump and grit system, and in the Motor Vehicle and Equipment Fund, a new leaf vacuum, paint buggy, and additional hydraulics for the grader are scheduled for purchase.

In the Parks and Recreation Department, the day camp building, swimming pool, and other facilities have been restructured to expend fewer dollars. Additionally, by better marketing, village officials anticipate greater use in 2015, says Cristiano.

"The theme that runs through this proposed budget is one of maximizing available resources, both physical and human, to continue an exceptional quality of life for resident of Cass City," he added. "The programs and capital improvements scheduled in 2015 are a continuation ingrained in Cass City history. The 2015 budget meets the goals of village staff, council and residents."

#### OTHER BUSINESS

In other business Monday, the council:

\*Approved payment of \$36,840 to Spence Brothers, Saginaw, for improvements at the WWTP. In 2013, the village contracted with the Saginaw firm to be a construction manager at risk for the expansion to the WWTP. At that time, village official expected a cost between \$8 and \$10 million for services rendered. However, as Spence Brothers bid the project out, the estimates came in much higher than expected - more than \$15 million – and the project was abandoned. Still, the village was responsible for time spent on the project, plus incurred expenses.

They did mobilize some equipment in order to fast track the project. The fee for time spent and mobilization ran about \$36,000. The money to pay this bill will come from the WWTP Enterprise Fund," Cristiano said.

\*Approved payment of \$31,576 to World Water Works, Oklahoma City, Okla., for engineering at the WWTP. Due to fast tracking of the WWTP expansion to meet the Dairy Farmers of America's timeline, the village contracted with the equipment vendor to get started on long-lead items crucial to completion of the project.

\*Approved payment to Miller, Cristiano said revenues levels are of a program of excellence that is Canfield, Paddock, and Stone, Lansing, in the sum of \$40,933 for drafting the development agreement between the village and the DFA.

who shared the podium with her uncle, Meredith Auten, honored as Citizen of the Year that same year.

Spearheading the revised junior citizen selection process has been Kate Van Auken, director of Rawson Memorial District Library and a past Cass City Citizen of the Year herself. Van Auken said she suggested some changes after discussing the process with former Cass City Chamber of Commerce Director Dee Mulligan and businessman Jim Luth, who has been in charge of the junior citizen program for several years.

"I guess things came to a head when, a few years ago, we were interviewing the five or six candidates and one of the questions we ask is, "If you were not selected as junior citizen, who would you select?" Van Auken recalled. "Typically, the kids say another person who is nominated, but that was not the case. Three of the students suggested two other students who were not nominated. One student was suggested by two of the candidates and they did not make the cut, so to speak. This made me really think that things should be changed."

In the past, the high school teachers nominated students and the list of prospective candidates would be gradually whittled down to a half-dozen or so finalists, who were then given a packet of information to fill out as part of the selection process.

"The high school teachers still get to do their selection, but this year I sent out about 60 letters to churches, 4-H clubs, local businesses and businesses that have co-op students," Van Auken noted. "I have received back five nominations from the community. I am very pleased that people took the time to respond.

Once we get the teachers' nominations, we will send out the application to all who were nominated and decide who will be interviewed based on academics, community service, work experience, sports, activities, honors/awards, and two questions: 'Why are you a good candidate for junior citizen' and 'What is your greatest accomplishment'?" she said.

Van Auken believes expanding the nomination process will result in a more thorough selection approach for what is, after all, a chamber of commerce

'This is a chamber award and should reflect students who are good citizens," she said. "This is for local students, home schooled or public schooled, that have the values, citizenship, and community service that we want to recognize.

"Now that money is involved through the scholarship, I felt that the selection process should be changed," Van Auken added, referring to the addition of the scholarship component in 2011.

"Back when we first moved here and (my husband) Joe and I would go to the dinner, I was always surprised there was no scholarship money attached to the junior citizen award. As I got more involved in the community and with the chamber directors. I realized that the chamber did not have the funds to support this and that is why it was not done," she said. "After I became involved with the selection of the citizen of the year in 2009 (past honorees are asked to participate in the selection of future recipients), I asked — did they ever consider it, was it ever even discussed — those kinds of things.

The next hurdle is to get the scholarship self-supporting.

"Dee and I along with (chamber board member) Karen Easterling have worked to try to get \$1,000 to \$1,500 added to the fund each year by donating \$1 from each ticket sold to the dinner as well as having a silent auction," Van Auken explained. "In November I sent out a donation letter to past citizens of the year and some local business people, encouraging them to help get this fund to \$20,000.

"We are at about \$15,000 now, but we give away \$500 each year and earn about \$250 each year (in investment income)," she said.

"I would feel better if interest rates were higher, but to get to \$20,000 would be a great milestone to me," Van Auken added. "Honestly, I feel so grateful that we have had the donations we have had to help us get to where we are today. Without Dee and the silent auction, we wouldn't be close to \$15,000 like we are."

# Measles cases have state health officials concerned

Following the recent confirmation the disease from widely spreading in Asia, Africa and the Pacific. of two measles cases in the Traverse the U.S., we need to succeed in our City area, the Michigan Department efforts to keep immunization rates of Community Health (MDCH) is reminding all residents to protect themselves against the disease by making certain they are up-to-date on their vaccines.

Michigan is now among 23 states that have reported cases of measles in 2014. The Michigan cases were unvaccinated and were exposed to measles during travel in the Philippines. Additional cases are under investigation.

"Although the once common disease is now a rarity in the United States, measles can spread when it reaches a community where groups of people are unvaccinated," said Dr. Matthew Davis, chief medical executive with the MDCH. "The progress made here in the U.S. may be threatened by the high incidence of measles elsewhere in the world. To protect against outbreaks and stop including some countries in Europe, persons traveling internationally.


From 2001 through 2012, the average number of measles cases reported nationally per year was 60. According to the Centers for Disease Control and Prevention (CDC), there have been more than 600 cases reported this year in the U.S., and the vast majority of cases have been among persons who had no history of vaccination against measles.

The Philippines is experiencing a very large and ongoing measles outbreak, with more than 50,000 measles cases and more than 100 measles-related deaths reported this year. Many of the cases in the U.S. this year have been traced to travel in or contact with the Philippines. Measles also continues to be common in many other parts of the world

Measles is a vaccine-preventable disease that can result in hospitalization, pneumonia, encephalitis, and death. Measles illness involves a high fever, conjunctivitis (red, inflamed eyelid membranes), cough, runny nose, photophobia, and a generalized red, raised body rash starting on the head and face and progressing to the rest of the body.

Because measles is highly communicable, successful prevention and control requires high levels of immunity in all communities.

The measles vaccine is highly effective and very safe. The first of two routine childhood measles vaccine doses is given at 12 months of age. For international travel, infants as young as 6 months should be vaccinated against measles. The vaccination, or documentation of immunity to measles, is recommended for all


