Cold case cracked

Hidden stockpile of stolen smokes, liquor leads deputies back to suspect in Owendale break-in

The discovery of a hidden stockpile of stolen cigarettes and liquor inside a residence last week led Huron County Sheriff's deputies to a suspect they believe broke into an Owendale business more than a year ago.

Huron County Sheriff Kelly J. Hanson reported the investigation was revived when Sgt. Ryan Neumann responded to a Sixth Street residence in Owendale to investigate a large quantity of found property.

Apparently the owner of the residence found 797 packs of assorted cigarettes concealed inside of an old large television set. The homeowner also found 22 bottles of assorted liquor in different quantities, concealed in a hidden compartment," Hanson said. "The residence has had several different occupants living in it over the last couple of years.

"Evidence was then gathered and the property, (worth) store's front door glass broken out. nearly \$5,000, was taken for safekeeping," Hanson added. "Detective Daryl Ford and Deputy Ryan Swartz the business at about 3 a.m. with two duffle bags and began looking into the matter. It was eventually determined that the property had been stolen from Stack's Market in Owendale back (in) August 2013.'

Green: reforms make Michigan a true "shall issue" state for CPLs

State Senator Mike Green's long-fought effort to make Michigan a true 'shall issue" concealed pistol license (CPL) state ended in victory last week when Gov. Rick Snyder signed legislation that will do away with county gun boards and cut the red tape and cost involved in obtaining a permit.

Senate Bills 34 and 35, sponsored by Green (R-Mayville), reform how CPLs are issued. The legislation streamlines the process across all counties, dissolving county gun boards and transferring all application and licensing duties to county clerks and the Michigan State Police, which is now responsible for conducting background investigations previously overseen by

"These bills streamline how we issue concealed pistol licenses, creating a uniform system that will better support the rights of firearm owners in Michigan," Snyder said. "I appreciate that the Legislature revamped this legislation, removing any unintended consequences that could have put domestic abuse victims in danger."

"I applaud the governor for working with the Legislature to address concerns surrounding my previous CPL proposal," Green said. "As passed by both chambers and now signed by Gov. Rick Snyder, Senate Bill 34 represents the most fundamental overhaul of Michigan's concealed pistol license system on behalf of law-abiding citizen gun owners since 'shall issue' was adopted in 1999. This uniform statewide process finally completes those

important reforms." Green's bills will eliminate lengthy application periods – waits that often exceeded the 60-day limit under the old law — by creating a uniform, centralized system when applying for a concealed pistol license.

The legislation places jurisdiction with the county clerks, decreasing the entities involved in the CPL process from five to two. "This allows for a more efficient and timely process for applicants seeking their CPL, an issue that was previously dependent upon the county of residence," said Green, who noted county clerks will now be required to respond to any application within 45 days after fingerprints are taken.

"While the law contains a \$10 increase in the statutory CPL fee, the bill will actually decrease an applicant's cost below what they're currently paying, according to Green, who explained his bill accomplishes this by wrapping current additional fees for photos and other items into the statutory fee and by substantially reducing the travel time and costs required to obtain a

The reforms also require MSP to establish an online permit renewal system by October 2018.

The change makes Michigan the 47th state to update its concealed pistol licensing process in this similar manner.

"I am very pleased the governor is willing to stick up for the Second Amendment rights of Michigan's citizens," Green said. "This is a major victory for Michigan; no longer will the residents of this state be subject to arbitrary local policies that directly infringe on their constitutional rights. I am proud that the governor and my colleagues in the Legislature were able to bring Michigan in line with other true 'shall issue' states."

Snyder vetoed similar legislation last session, despite supporting most of the included reforms, due to a provision that could have increased the risk of violence and intimidation faced by domestic abuse victims who seek court

Green's bills, which will take effect Dec. 1, 2015 and are now Public Acts 3 and 4 of 2015, made no changes to CPL eligibility standards, the "pistol free" zones or exemptions to those zones.



Time to focus on others' abilities, not disabilities

We're joining local and state officials this week in observing March as Developmental Disabilities Awareness Month.

The observance, proclaimed by Michigan Gov. Rick Snyder, Lt. Gov. Brian Calley, the Michigan Department of Community Health (MDCH), and the Michigan Developmental Disabilities Council (DDC), was established to celebrate the different abilities some 180,000 adults and children in Michigan have.

"Developmental Disabilities Awareness Month is a chance for Michiganders to help create and be part of a more inclusive community," Calley said. "I often say people have different abilities, not disabilities. This is a perfect time to look at things from a new perspective."

This year's theme, "Side-by-Side: Celebrating Togetherness", encourages residents to participate in the awareness month by meeting, talking with, and engaging people with developmental disabilities to promote an inclusive community.

"Michigan has recently made great strides in promoting positive change in our communities through the Michigan Health and Wellness Commission and Employment First initiatives," said Nick Lyon, director of the MDCH. "The work does not stop there, however, and Developmental Disabilities Awareness Month is a great opportunity to continue that work."

Self-advocacy groups, such as Michigan's Regional Inclusive Community Coalitions (RICCs), are hosting events throughout the month of March to celebrate togetherness and to emphasize opportunities to support people with developmental disabilities. Residents can get involved in the month-long awareness effort by contacting their local RICC.

"Reaching out to their local RICC is a great way for the public to get involved in their community and include people with disabilities in their everyday lives," said Vendella M. Collins, executive director of the DDC. "I encourage everyone to take the important first step of getting involved."

A developmental disability is a severe, chronic disability attributable to mental or physical impairment, or combination of such impairments, which manifests before the person is age 22 and is likely to continue indefinitely. It results in substantial functional limitations in three or more major life activities including: self-care, receptive and expressive language, learning, mobility, self-direction, capacity for independent living and economic self-sufficiency.

Some examples of a development disability include autism, cerebral palsy, Down syndrome, intellectual disabilities and epilepsy.

Last year, Michigan took action to reduce stigma around intellectual and developmental disabilities by enacting R Word legislation which removed the terms "mental retardation" and "mentally retarded" from the statute and replaced them with inclusive, people first language.

It was a positive step, one that we hope will be followed by others as we all strive to see past our residents' disabilities and focus on their abilities.

Slices of Life

A blank page can be daunting. Especially first thing on a Monday morning, which is how I usually start my

As a columnist, it's my job to fill the page with something – or nothing. Yeah, nothing. You read that right.

I've said it before, but it bears repeating. Readers tell me they enjoy this column because I write about nothing, and they can relate to that. Most of us have a familiarity with nothing. We all have personal experience with the lack of something - which in essence is nothing – depending on your thesaurus.

Because I write for newspapers, sometimes people confuse me with a journalist. Journalists write about important and critical matters, like crime, volcanic eruptions and the color of dresses. They are expected to be neutral and stick to the facts. Accuracy about the who, what, where, when and why of a story is critical. Journalists who get this wrong - or worse yet make things up – do not stay journalists for long. Journalists write about something – and it's a something that is real

Columnists enjoy creative liberties. We tell stories. We voice opinions. We're even allowed to write about nothing and – on the best days – it becomes something. Every week, I hash out a few paragraphs. Coming off my inkjet printer, they take up a page or two. Week by week it isn't much. Close to nothing, really.

But then each year at about this time, I print out copies of all the columns from the previous year and place them in a three-ring binder. When printed in their entirety, they amass about 100 pages and embody a quantity that feels a lot more like something than noth-

I thought the nothing-something analogy lent itself to numerous lessons that could benefit my kids, who've been known to procrastinate on large projects, so I approached one son with my freshly printed stack of words. I held up two pages

"This is what I write each week," I said. "It doesn't seem like much, does it?"

He nodded in agreement. Next I held up the full stack. "But when I write a little each week, and print them all at the end of the year, they make this large pile. I wouldn't be able to write all these pages in a week, but when I break it down over a year this big job gets

I was on a roll and decided to keep going. I separated about 20 sheets from the bunch. "If I got behind by this much, it would be hard to catch up. It's important to stay on schedule." I was sure the life lessons were flow-

ing like hot lava or maybe a professional athlete's long hair - smooth and fluid - straight from me to my kid.

My husband, who'd been sitting next to me, must have been feeling the flow himself because at this point he spoke up. "So when mom prints all those articles at the end of the year, what does that mean?" he asked.

We sat on the edge of our seats, anticipating the answer. Our son looked up from his phone. A blank stare can be

daunting. But I wasn't ready to end the lesson just yet. "You know," I prompted. "I write a column each week and at the end of the year I have a whole stack to print out. What's something we can learn from that?'

Time for the board to seek other opinions?

Local governments must often rely on the expertise of those around them for the best timely advice. Working with limited resources, it is often a friend or neighbor or another member of the board who fulfills this need. In Huron County, the board of commissioners has found it necessary to hire a full-time corporate council to facilitate getting the best advice possible.

In the past this responsibility was entrusted to the prosecutor's office, which is comprised of a number of attorneys with diverse backgrounds. With either system the board is seeking a legal opinion on which to base county policy. We only know what we know; the rest we must trust to someone else.

Recently it was reported that the Huron County Corporate Council advised one member of the board of commissioners to resign his position on the county planning commission due to a perceived conflict of interest. Within days, corporate council reversed that opinion and advised the board of commissioners that it was not a conflict of interest for a different member of the board of commissioners to fill the same seat.

It appears that what is a conflict for one member is not for another member. Which opinion was correct?

If this is the type of conflicting opinions being given to our board of commissioners, I have to wonder what other decisions were made by our commissioners on our behalf from similar opinions. Can we rely only on the advice of counsel in helping to set policy for our county? Have similar opinions lead us to now seek a moratorium on new wind turbine construction? How many other policies have been established that relied on opinions that could be reversed so quickly based on the person who asks the question?

As a former Huron County Planning Commission member and former Huron County commissioner I wonder if it is time to seek opinions from additional sources.

Happy birthday to a village institution

I'm not a newspaper publisher, but I played one in a cemetery once.

For those who missed the second annual Elkland Township Cemetery Walk last fall, I'm referring to my debut (and probably my only) acting role as local newspaper Publisher the late-Frederick Klump, whose entrepreneurial skills and passion for the Fourth Estate led the German Immigrant to found the Tri-County Chronicle – a precursor to the Cass City Chronicle - back in 1899.

That's all a long-winded way of taking note that a special birthday is

The Cass City Chronicle, an institution in Cass City that continues to serve the community as an independent, weekly newspaper, will turn 109 next week.

If you're unfamiliar with the history, here's a quick synopsis:

Klump, an Evangelical Association minister and State Court of Arbitration and Mediation official, owned the Tri-County Chronicle for just five years before selling the business to his partner, Herbert Lenzner, who also bought out Cass City's other newspaper at the time - the Enterprise – and consolidated the papers under the new name, the Cass City Chronicle.

Lenzner published his first edition April 20, 1906.


He later sold the Chronicle to longtime Publisher John Haire, whose tenure at the corner of Oak and Main spanned nearly 60 years before his death at the age of 87 in 2009. Today, John's son, Clarke, is continuing his father's legacy as publisher of the Chronicle.

Newspapering in the Thumb has withstood obstacles of all kinds over the decades, from fires and floods to the powerful force of technology

Sure, the business has taken its share of financial hits over the years, as evidenced by the number of papers long gone, but make no mistake the Fourth Estate is still alive and kicking in the Thumb. And, we're still drawing young, fresh faces to a career that still requires passion every bit as much as accuracy.

Say what you want about newspapers having outlived their usefulness, with instant news at your fingertips via the Internet. However, there's a reason folks whose communities still have a newspaper continue to pick up a copy each week; they know they're going to find local stories that other media outlets aren't likely to bother with, yet are no less important because they involve events and people in their own hometowns.

I'm proud to have played a role at the Chronicle for more than 28 years now, and I'm thankful for all of the men and women before me whose hard work, foresight and dedication have enabled those of us still here today to carry on a legacy of service to our community.







For the past year, Good Shepherd Lutheran Church has been supporting his chaplaincy work in Cleveland, Ohio, where he ministers to police and fire fighters.

"I can be called at any time of the day or night, 365 days a year, to offer counsel, ministry, consolation, guidance and prayers for members of the safety forces," Kavouras said. "It may be a member who is injured in the line of duty, or it may be a critical incident of such ghastly nature that it overwhelms a person's normal ability to cope. On occasion the safety forces members will ask me to offer prayers to victims and witnesses of crimes, and other terrible


"In all these cases I impart the one thing that can make a difference, and set a person on the right healing path: the life-giving Word of God,' he added. "I make much use of the Scriptures, and the prayers and hymns of the church. These have a mighty effect on people in dire circumstances."

Over the past few years, Kavouras has been called to crime scenes where children have been shot, to homes burned to the ground, and even to the site where the three Cleveland girls who were kidnapped 10 years ago emerged from their captor's home.

"It is hard to describe what we ask these safety forces members to do for us," he said. "This ministry is a way of showing our support and saying thank you. In truth, many police and fire fighters have no one to look

"They know humanity too well. But they do look to the clergy for guidance, and for satisfying answers to questions that no one else can give."

In 2014 alone, the organization awarded nine college scholarships to seniors from around the county, bringing the total of scholarships awarded to more than 50 in the 11 years since the chapter was chartered.
