Her resume also includes a bachelor's degree in finance from Saginaw Valley State University and a master's degree in budget to pay for textbook purchases business administration from Central Michigan University.

"She comes with solid references. She's dedicated to the district," Hartel said, adding, "She's first class all the way."

Cunningham agreed with Hartel's assessment, saying, "I think she'll provide the longevity that you need in this role."

Turning to finances, Cunningham indicated the district stands to complete the 2014-15 fiscal year with a balanced budget, in spite of the loss of some \$20,000 in revenue due to enrollment dips over the past year.

The only significant changes in expenses, she noted, stem from the board's decision last month to spend a portion of the projected \$100,000 to \$125,000 surplus in this year's and capital improvements.

The planned expenditures include an estimated \$60,000 to \$70,000 for new (replacement) textbooks in grades K-5. Another \$23,000 will be earmarked for repairs to the district's parking lots, and Hartel has sought bids for a new bus garage roof. School officials also anticipate completing a project that will address

Memorial Day observances on tap locally to honor the fallen

Cass City area residents will honor the nation's fallen heroes this month just as they have for many decades: with Memorial Day observances designed to demonstrate the community's respect, gratitude and desire to honor those who made the ultimate sacrifice for freedom.

The traditional Elkland Township Memorial Service will begin at 10 a.m. Monday with a parade starting at the corner of Main and Seeger streets in Cass City.

Line-up for the procession will begin at 9:30 a.m., according to Joe Merchant, commander, VFW Post 3644, who noted local VFW members will be placing a wreath at the downtown veterans' memorial before proceeding to the Elkland Township Cemetery.

Of course, those planning to attend can look forward to viewing the VFW Post's impressive "Avenue of Flags" numbering roughly 200 flags posted along the main drive at the cemetery.

The flag display is an integral part of the day's observance, serving as a powerful reminder of what the holiday is all about - honoring the memory of men and women whose service to their country paved the way for the freedom their fellow citizens enjoy to this day, Merchant said.

This year's service at the cemetery will again be led by master of ceremonies Mark Zmierski, senior chief, U.S. Navy retired. The Rev. Mark Karwowski, pastor of the Living Word Worship Center in Cass City, will be the guest speaker and will also lead the invocation and benediction. Also featured will be the Cass City Junior-Senior High School Band. VFW members will be placing another memorial wreath, and the post's firing squad will present its traditional salute.

The Cass City Historical and Genealogical Society is again encouraging area volunteers to assist with placing American flags on the graves of servicemen and women at the cemetery, located just east of the village. The work, involving placement of some 600 flags in all, is scheduled to get underway today (Wednesday) at 9 a.m.

A group of home schooled students and parents along with members of the local VFW post have already indicated they will be helping out, but more volunteers are always welcome, according to organizer Katie Jackson. "We need about 32 people to handle this," Jackson said, adding the project typically takes about 2 ½ hours to complete.

Cristiano: village in stable condition

Although real and personal property values – consisting mainly of residential housing – slid by nearly two percent in taxable value for Cass City residents from a year ago, village officials say those same home owners won't see a hike in their next tax bills to help make up the deficit.

In fact, the village of Cass City is in a stable condition, reports Village Manager Peter Cristiano, as increases in Renaissance Zone tax values and Industrial Facility Tax (IFT) Exemption values totaled over \$55,000. The increase in IFT values from 2014 to 2015 - \$1,866,700 - will easily cover the tax revenue shortfall.

Accordingly, the Cass City Village Council set the 2015 tax levy at 18.1387 mills during its regular monthly meeting Monday, keeping the rate unchanged for the past several years. It will cost the owner of a home located in the village, with a market value of \$100,000, about \$725 annually in

Despite the expected loss of \$12,305 in 2015 tax revenues from a decrease in personal property values, Cristiano expects an overall gain of nearly Please turn to page 7.

Heart smart

Cass City School buildings among 122 in state to earn new designation for being cardiac emergency prepared

No one wants to think of a seemingly healthy youngster suddenly collapsing due to a cardiac emergency, but it happens, and it can happen in school.

Parents of children who are students in the Cass City Public Schools can rest assured, however, that local school officials are prepared to act in such emergencies, when seconds can make the difference between life and

Michigan High School Athletic chief medical executive of MDHHS. Association (MHSAA); Michigan Alliance for Prevention of Sudden Cardiac Death of the Young (MAP-SCDY) last week awarded 122 schools in Michigan the MI HEARTSafe School designation, which recognizes schools that are prepared to respond to cardiac emer-

Among the recipients were Cass City Junior-Senior High School and Cass City Elementary School.

"Sudden cardiac death claims the The Michigan departments of lives of more than 300 Michigan Health and Human Services children and young adults between (MDHHS), and Education (MDE); the ages of one and 39 years of age

American Heart Association (AHA); each year," said Dr. Eden Wells, "Implementation of CPR and an automated external defibrillator (AED) within three to five minutes is crucial for increasing the chance of survival. Cardiac arrest is often unexpected and frightening, and I'm pleased to see so many of our schools taking preventative measures to address this health issue."

Doctors use the term "sudden cardiac death" to describe a young, apparently healthy person who dies suddenly from a cardiac arrest. Often, a sudden cardiac event is the first apparent sign in a young person.

Memorial Day much more than a day off

Families throughout the Thumb are no doubt planning picnics, barbecues and other family gatherings for Saturday and Sunday, a tradition that fits naturally with the arrival of a long weekend.

But many of those families will do so with empty chairs at their tables, painful reminders of the dear price of freedom paid by so many brave men and women who lost their lives while serving our nation in the military.

Memorial Day, originally called Decoration Day, is a day of remembrance for those who have died in service to the United States of America. More than two dozen cities and towns claim to be the birthplace of the observance, although Waterloo, N.Y., was officially declared the birthplace of Memorial Day by President Lyndon B. Johnson in May 1966.

Regardless of the exact date or location of its origins, one thing is clear – Memorial Day was borne out of the Civil War and a desire to honor

our dead. It was officially proclaimed on 5 May 1868 by General John Logan, national commander of the Grand Army of the Republic, in his General Order No. 11.

"The 30th of May, 1868, is designated for the purpose of strewing with flowers, or otherwise decorating the graves of comrades who died in defense of their country during the late rebellion, and whose bodies now lie in almost every city, village and hamlet churchyard in the land," he proclaimed.

The date of Decoration Day, as he called it, was chosen because it wasn't the anniversary of any particular battle.

On that first Decoration Day, General James Garfield made a speech at Arlington National Cemetery, and some 5,000 participants decorated the graves of the 20,000 *Union and Confederate soldiers buried there.*

The first state to officially recognize the holiday was New York in 1873. By 1890 it was recognized by all of the northern states. The South refused to acknowledge the day, honoring their dead on separate days until after World War I, when the holiday changed from honoring just those who died fighting in the Civil War to honoring Americans who died fighting in any way.

History lessons aside, Memorial Day was established as a somber day of remembrance for Americans to take the time to visit cemeteries and place flags or flowers on the graves of this nation's war dead. It is a day to remember ancestors, family members and other loved ones who made the ultimate sacrifice.

But now, too many people "celebrate" the day without more than a casual thought to the purpose and meaning of

How should we honor the 1.8 million who gave their lives for America since 1775? How should we thank them for their service? We believe the answer is simple: we can all take the time to observe a few moments of silence, keep their memories alive and sincerely appreciate what they gave up that we might continue to live in a free nation.

That's an obligation most of us can fulfill by simply attending a local Memorial Day observance in our communities, such as those organized annually in Elkland, Novesta and Grant townships, as well as others in the Cass City area.

Memorial Day is a federal holiday that comes with a day off for most of us. Why not spend at least a portion of that day remembering and considering just how thankful we are for each of these heroes?

It's the very least we, as Americans, can do.

The Michigan Department of Natural Resources (DNR) is busy with the 2015 fish-stocking season. This spring, people are likely to find DNR fishstocking trucks releasing their prized cargo at hundreds of lakes and streams throughout the state.

Fish stocking is a valuable tool used by fisheries managers to restore, enhance and create new fishing opportunities in Michigan's inland lakes and streams and in the Great Lakes. The DNR Fisheries Division accomplishes this task by rearing fish at its six fish production facilities located throughout the state; cooperatively managing up to 50 rearing ponds and 12 Great Lakes net pen locations; and maintaining a fleet of 17 specialized fish-stocking vehicles.

Over the course of a typical year, the DNR will stock roughly 20 million to 25 million fish weighing nearly 400 tons, including eight species of trout and salmon, and four cool-water species such as walleye and muskellunge.

Michigan anglers have access to four Great Lakes, 3,000 miles of Great Lakes shoreline, more than 11,000 inland lakes and tens of thousands of miles of rivers and streams. That puts residents and visitors no more than 10 minutes away from great angling opportunities and world-class fisheries.

Canfield lauds next effort to fix state's crumbling roads

State Rep. Edward "Ned" Canfield (R-Sebewaing) last ciently. week took part in the unveiling of a House Republican transportation plan designed to fix Michigan's roads and bridges by creating long-term and sustainable funding.

Canfield is sponsoring a bill in the plan that focuses on dedicate more than an additional \$1 billion annually for transportation within four years.

"Hard-working Michigan taxpayers have waited long enough for a solution," Canfield said. "I applaud my Republican colleagues for coming up with a plan that reprioritizes existing dollars instead of taking more from

According to Canfield, key elements of the House transportation plan include:

*Dedicating general fund dollars to fix roads by phasing in spending — beginning with the 2015-16 budget.

*Creating tax fairness by generating \$45 million annually for roads on electric-, hybrid- and diesel-powered vehicle registration, and an additional \$117 million yearly by eliminating the Earned Income Tax Credit.

*Reprioritizing restricted funds by thoroughly reviewing how taxpayer money is used, generating \$185 million a year for roads and bridges.

*Ensuring quality work by securing warranties and know their tax dollars are being spent wisely and effi- portation.

House Bill 4611, sponsored by Canfield, would change bidding requirements to allow the Michigan Department of Transportation (MDOT) to borrow money from local road agencies. Under the bill, the contract of a local road using existing dollars and reprioritizing other funding to agency's construction project exceeding \$100,000 in cost would be awarded by competitive bidding.

This bill ensures that tax dollars are being spent effectively," Canfield said. "It is important that the roads are not only repaired, but repaired well."

HB 4611 has been referred to the newly-created House Committee on Roads and Economic Development.

The unveiling of the House Republican transportation proposal comes on the heels of a statewide vote earlier this month in which Michigan resident overwhelming rejected a costly and complicated Proposal 1. Some 80 percent of residents who cast ballots voted "no".

Gov. Rick Snider had touted the proposal as an effective, bipartisan plan to address the state's deteriorating infrastructure by providing a long-term funding source. The multi-faceted proposal also included more funding for education, local governments and recreational opportunities, and would have given low-income families a

However, the price tag was hefty - raising taxes by competitive bids on infrastructure projects so citizens nearly \$2 billion, including \$1.3 billion a year for trans-







Village of Gagetown- Amendment to Ordinance #117

An ordinance to prohibit the storage of junk or junked motor vehicle parts with the Village of Gagetown having previously been adopted on December 4, 2000, is hereby amended as to the follow-

Section 5: If any person violates this ordinance, the Clerk shall send notice by either personally delivering a copy of the notice or by sending a copy via registered mail to (1) the owner of the junked motor vehicle, the junked vehicle parts, or the junk at his or her last known address: and (2) the owner of the premises on which the junk, vehicles, or parts are lying at the last known address. The notice shall contain a description of the violation of the ordinance and a statement that if the violation continues for fourteen (14) days from the date of the notice that criminal sanctions will be sought against the person in violation of the ordinance. If the owner of the motor vehicle, junked vehicle parts, or the junk cannot be determined after a reasonable search, notice shall be given by publication once a week for two weeks in a newspaper of general circulation in the Village of Gagetown.

Section 6: If a violation of the ordinance is not remedied within fourteen (14) days from the date that notice from the Clerk is mailed or after notice by publication for two (2) weeks where necessary: A. The person violating the ordinance shall be guilty of a misdemeanor and shall be punished by a fine of not more than Five Hundred (\$500.00) Dollars, and each day that a violation continues after the fourteen (14) day notice period has expired constitutes a separate offense; and B. The person violating the ordinance shall be responsible for all necessary costs to enforce the ordinance, including attorneys fees. C. The Village may impound the junked motor vehicle, the junked vehicle parts, or the junk and it may sell them for salvage or destroy them.

Except as amended herein, the Village of Gagetown Ordinance #117, adopted on December 4, 2000,

is hereby reaffirmed and ratified. This amendment being adopted the 4th day of May, 2015.

Village of Gagetown – Off-Road Vehicle Ordinance #119

An ordinance adopted by the Village of Gagetown on the 4th day of May, 2015, for the purpose of authorizing and regulating the operation of off-road vehicles on the streets in the Village of Gagetown and for the purpose of providing penalties for the violation thereof; The Village of Gagetown hereby ordains:

Section 1: As used in this ordinance, the following definitions shall apply: A. "Village" means the Village of Gagetown. B. "Driver's License" means an operator's or chauffeur's license or permit issued to an individual by the Secretary of State under Chapter III of the Michigan Vehicle Code, 1949 PA 300, MCL 257.301 to 257.329, for that individual to operate a vehicle, whether or not conditions are attached to the license or permit. C. "Operate" means to ride in or on, and to be in actual physical control of the operation of an off-road vehicle. D. "Operator" means a person who operates or is in actual physical control of the operation of an off-road vehicle. E. "Off-Road Vehicle" means a motor driven off-road recreation vehicle capable of cross country travel without the benefit of a road or trail, on or immediately over land, snow, ice, marsh, swampland, or other natural terrain. Off-road vehicles include, but are not limited to, a multi-wheeled drive vehicle, an ATV, a motorcycle or related two wheel, three wheel, or four wheel vehicle, an amphibious machine, a ground effect air cushion vehicle, or other means of transportation deriving motive power from a source other than muscle or wind. Off-road vehicle does not include a registered snowmobile, a farm vehicle being used for farming, a vehicle used for military, fire, emergency or law enforcement purposes, a vehicle owned and operated by a utility company or an oil and gas company when performing maintenance on its facilities or on property over which it has an easement, a construction or logging vehicle used in performance of its common function, or a registered aircraft. F. "Road" means a country primary road or country local road as described in Section 5 of 1951 PA 1951, MCL 247.655. G. "Road Commission" means the Board of County Road Commissioners for the County of Tuscola. H. "Safety Certificate" means a certificate issued pursuant to 1994 PA 451 as amended, MCL 324.81129, or comparable off-road vehicle safety certificate issued under the authority of another state or province of Canada. I. "Street" means a city or village major street or village local street as described in Section 9 of 1951 PA 51, MCL 247.659. J. "Visual Supervision" means the direct observation of the operator with the unaided or normally corrected eye, where the observer is able to come to the immediate aid of the operator.

Section 2: An off-road vehicle may be operated on the far right of the maintained portion of a road or street within the Village with these exceptions: A. In the event that either the Road Commission has closed or in the event the Village has adopted an ordinance or resolution which closed certain roads to off-road vehicle pursuant to MCL 324.81131(4), operation otherwise permitted under this ordinance shall not be considered authorized with respect to such closed road(s). B. The ordinance is not intended to authorize the operation of an off-road vehicle on a road, street, or highway which is under jurisdiction of a government entity other than the Village.
Section 3: An off-road vehicle may not be operated on the road surface, roadway, shoulder, or right-

of-way of any state or federal highway in the County.

Section 4: Except as set forth herein or otherwise provided by law, an off-road vehicle meeting all of the following conditions may be operated on a street in the Village: A. At a speed of no more than twenty-five (25) miles per hour or a lower posted off-road vehicle speed limit. B. By a person not less than sixteen (16) years of age, as long as any such person under the age of eighteen (18) is in possession of a valid driver's license or is under the direct visual supervision of a parent or guardian and has an off-road vehicle safety certificate in his or her immediate possession. C. With the flow of traffic. D. In a manner which does not interfere with traffic on the road or street. E. Traveling single file except when overtaking and passing another off-road vehicle. F. When visibility is not substantially reduced due to weather conditions. G. While displaying a lighted headlight and lighted taillight at all hours. H. While the operator and each passenger is wearing a crash helmet and protective eyewear approved by the United States Department of Transportation unless the vehicle is equipped with a roof that meets or exceeds standards for a crash helmet and operator and each passenger is wearing a properly adjusted and fastened seat belt. I. With a throttle so designed that when the pressure used to advance the throttle is removed, the engine speed will immediately and automatically return to idle. J. While the off-road vehicle is equipped with a spark arrester type United States Forest Service approved muffler in good working order and in constant operation. K. Pursuant to noise emission standards defined by

Section 5: A child less than eighteen (18) years of age shall not operate an off-road vehicle on a street in the Village unless the child is in possession of a valid driver's license or under the direct visual supervision of a parent or guardian and the child has in his or her immediate possession a Michigan issued off-road vehicle certificate or a comparable off-road vehicle safety certificate issued under the authority of another state or a province of Canada.

Section 6: Unless a person possesses a valid driver's license, a person shall not operate an off-road vehicle on a street in the Village if the off-road vehicle is registered as a motor vehicle and is either

more than sixty (60) inches wide or has three wheels.

Section 7: The Village is immune from tort liability for injuries or damages sustained by any person arising in any way out the operation of use of an off-road vehicle on maintained or un-maintained streets, shoulders, and rights of way over which the Village has jurisdiction.

Section 8: In a court action in this state, if competent evidence demonstrates that a vehicle that is per-

mitted to operate on a street pursuant to the code was in a collision with an off-road vehicle required to be operated on the far right of the maintained portion of a road or street pursuant to this ordinance, the operator of the off-road vehicle shall be considered prima facie negligent.

Section 9: Any person who violates this ordinance is guilty of a municipal civil infraction and may be ordered to pay a civil fine of not more than Five Hundred (\$500.00) Dollars.

Section 10: In addition to the penalties under Section 9 of this ordinance, a court may order a person who causes damage to the environment, a street, or other property as a result of the operation of an off-road vehicle shall pay full restitution for that damage above and beyond the penalties paid for civil

Section 11: The Village Treasurer shall deposit all fines and damages collected under this ordinance into a fund to be designated as the off-road vehicle fund. The Village shall appropriate revenue in the off-road vehicle fund as specified in MCL 324.81131(14).

Section 12: An off-road vehicle may only be operated on streets between the hours of 5 a.m. and 10

Section 13: Should a portion of this ordinance be found invalid for any reason, such holding shall not be construed as affecting the validity of the remaining portions of this ordinance.

Section 14: This ordinance becomes effective after publication and expiration of the time prescribed

An ordinance adopted by the Village of Gagetown on the 4th day of May, 2015, for the purpose of authorizing and regulating the operation of golf carts on the streets in the Village of Gagetown and for the purpose of providing penalties for the violation thereof; The Village of Gagetown Hereby Ordains:

Section 1: As used in the ordinance, the following definitions shall apply: A. "Village" means the Village of Gagetown. B. "Driver's License" means an operator's or chauffeur's license or permit issued to an individual by the Secretary of State under Chapter III of the Michigan Vehicle Code, 1949 PA 300, MCL 257.301 to 257.329, for that individual to operate a vehicle, whether or not conditions are attached to the license or permit. C. "Operate" means to ride in or on, and to be in actual physical control of the operation of a golf cart. D. "Operator" means a person who operates or is in actual physical control of the operation of a golf cart. E. "Golf Cart" means a motor that has not less than three wheels in contact with the ground and has unladen weight of less than 1,800 pounds and is designed to be and is operated at not more than twenty-five (25) miles per hour and that is designed not to carry more than four (4) persons, including the driver. F. "Street" means a city or village major street or village local street as described in Section 9 of 1951 PA 1951, MCL 247.659.

Section 2: A golf cart may be operated on the far right of the maintained portion of a street within the Village with the following requirements: A. The golf cart shall not be operated in excess of the speed of fifteen (15) miles per hour and shall not be operated on a street with a speed limit of more than thirty (30) miles per hour. B. The operator must use hand signals to indicate turning left or right and an intent to stop the golf cart while operating on a street. C. The golf cart may only be operated on a street between one-half hour after sunrise and one-half hour before sunset.

Section 3: During the operation of a golf cart on a Village street, the operator must be at least sixteen (16) years of age and have a valid driver's license.

Section 4: Except as prescribed herein, a golf cart shall not be operated on a street within the Village. Section 5: The Village is immune from tort liability for injuries or damages sustained by any person arising in any way out of the operation of use of a golf cart on maintained or un-maintained streets,

shoulders, and rights of way over which the Village has jurisdiction. Section 6: Any person who violates this ordinance is guilty of a municipal civil infraction and may be

ordered to pay a civil fine of not more than One Hundred (\$100.00) Dollars. Section 7: In addition to the penalties under Section 6 of this ordinance, a court may order a person who causes damage to the environment, a street, or other property as a result of the operation of a golf cart to pay full restitution for that damage above and beyond the penalties paid for civil fines.

Section 8: Should a portion of this ordinance be found invalid for any reason, such holding shall not be construed as affecting the validity of the remaining portions of this ordinance. Section 9: This ordinance becomes effective after publication and expiration of the time prescribed by

"With the combination of all types of taxable property, the gains in real property and IFT values offset the losses in personal property taxes, leaving a gain in village taxable values of \$1,421,731, resulting in an increase of \$11,935 in tax revenue," Cristiano said.

IN OTHER BUSINESS

Also during Monday's brief 25-minute meeting, the council:

*Heard from Dr. Nick Nahernak. He asked for the village's help in removing a four-foot fiber optic pole from his property at the corner of Church and Main streets that was installed several years ago and remains an eye sore, according to the local dentist. Nahernak vowed to cover all expenses for the

*Learned that 10,858,000 gallons of water were pumped from the village wells in April. This compares with 7,316,000 gallons pumped in April 2014. The amount of water pumped is higher this year because the Dairy Farmers of America plant is currently using village water to clean their trucks and equipment.

*Learned that repairs to the surge tank at the Helen Stevens Memorial Pool have been completed. The surge tank is a major part of the Cass City pool's filtering system. To conserve dollars, the DPW did the work of taking out the block walls to get access to the tank and then replaced them when the job was complete. Without the work done by the DPW, Cristiano says the repair costs would have more than doubled.

*Approved the fireworks display permit for Mark Schramke for the July Freedom Festival. The permit calls for 736 shells measuring 2.5 inches to six inches and five 1.3-gram cakes.

*Learned the chamber of commerce, once again, is sponsoring Cass City's Beautification Project. Flowerpots, trash cans, and pool sponsorships are all part of plan. To get involved, call Judy Keller at (989) 872-8311.

*Accepted and filed the financial statements ending April 30, 2015, with a cash balance of \$1,023,465.

athletic field drainage problems.

Hartel said Monday that he has received five bids for the roof project and two bids for the parking lot work. Those bids will be opened Friday, May 29, starting at 3 p.m., he added.

The planned capital improvement spending, which board members have been discussing for several weeks, won't significantly dent Cass City's fund balance, which totals some \$1.3 million, an amount equal to about 13 percent of the district's general fund budget.

As for the coming year, Cunningham noted the Michigan Senate has proposed a per-pupil funding increase of \$127, but it appears more likely that Gov. Rick Snyder's version — \$75 more per student – will be the reality for the 2015-16 budget. At the same, the governor is proposal funding cuts for items such as "best practices", resulting in a net increase of roughly \$58 more per student.

"We should hear (what's going to happen) by June 1," added Cunningham, who recommended that school officials continue to approach the new budget conservatively by planning on the projected loss of 20 students, and spending 1 ½ to 2 percent more across the board in the coming year.

IN OTHER BUSINESS

In other business, the board:

*Approved an annual resolution stating the Cass City Public Schools will continue to be a Michigan School of Choice, accepting students from neighboring districts in grades K-10, with transfer juniors and seniors accepted

*Endorsed the Tuscola Intermediate School District's (TISD) proposed 2015-16 general fund budget, set at \$4.782 million, compared to \$4.93 million this year. Revenues for 2015-16 are estimated at \$4.783 million, with a projected year-ending fund balance of about \$920,000.


The TISD has an overall budget of more than \$30 million, including close to \$20,000 for special education (funded in part by a tax of 2.45 mills), and \$5.6 million for career and technical education, funded in part by 1.649 In a related matter, the board appointed Janie Meeker to cast Cass City's

ballot in the next TISD board election. The lone candidate seeking reelection is James Welke of Mayville, one of the longest-serving ISD board members in the state, having already marked 35 years of service.

*Approved Hartel's recommendation to participate in town-wide garage sales this summer by offering for sale items no longer in use at the former Campbell Elementary School building.

*Heard from Kayla DeLong, who sought – and received — the board's verbal support for Cass City third graders to continue participating in Tuscola County Farm Bureau's Project R.E.D. (Rural Education Day), to be held Sept. 24 this year at the Tuscola County Fairgrounds. She noted Cass City FFA members volunteer during the project, which involves introducing voungsters to agriculture by inviting them to visit educational stations featuring topics such as honeybees, small animals, crops, soil conservation and farm safety.

DeLong pointed out that Dave and Kris Milligan sponsor transportation for local students to attend. As a result, Project R.E.D. doesn't count toward the Cass City third grade's allowed field trips for the year.



Local schools are "heart smart

It's sometimes caused by inherited conditions that affect the heart's structure

Implementation of cardiopulmonary resuscitation (CPR) and an automated external defibrillator (AED) within the first few minutes is key to surviving a cardiac arrest. The American Heart Association (AHA) recommends the 'Chain of Survival' that includes five important steps: early recognition of a cardiac arrest and calling 9-1-1; rapid bystander response with hands-only CPR; use of an AED; advanced life support; and, post cardiac care.

Between 1999 and 2009 in Michigan, there were 3,134 young individuals between the ages of one and 39 years of age who died of sudden cardiac death. Of those, 246 were between five and 19 years of age.

Now in its second year, the MI HEARTSafe Schools designation represents Michigan's commitment to reducing the number of sudden cardiac deaths among youth. Last year was the first year of the program, and 40 schools – both Cass City Public School buildings among them — were designated in

"MDE is proud to support MI HEARTSafe schools," said State Superintendent Mike Flanagan. "Ensuring schools are prepared for sudden cardiac emergencies through planning, training, and AEDs is an important part of having safer learning environments for students, staff and the com-

Public Act 12 of 2014 requires all schools (grades kindergarten to 12) to have a cardiac emergency response plan in place. This designation recognizes 122 schools that have taken steps above and beyond to prepare to respond in the event of a cardiac emergency, and is awarded for a period of three years.

"The Michigan High School Athletic Association is proud to partner with the state of Michigan to promote the MI HEARTSafe Schools program," said Jack Roberts, director of the Michigan High School Athletic Association. "It's important we all do our part to help schools prepare for unexpected emergencies to keep children in our communities safe.

In order for a school to receive a MI HEARTSafe designation, it must perform at least one cardiac emergency response drill per year; have a written medical emergency response plan and team; have current CPR/AED certification of at least 10 percent of staff; have accessible, properly maintained and inspected AEDs with signs identifying their location; and ensure preparticipation sports screening of all student athletes using the current physical and history form endorsed by the Michigan High School Athletic Association.
