Investigators seize \$250,000 in goods stolen during spree

What started out as an investigation into an apparently related series of thefts in Huron and Sanilac counties led sheriff's deputies to a stash of nearly \$250,000 worth of stolen goods last week in St. Clair County.

And investigators say they believe the larcenies were part of an organized crime ring targeting a region that includes the Thumb.

"From tips generated through news and social media regarding our earlier press releases, two deputies from the Huron County Sheriff's Office and one from the Sanilac County Sheriff's Office started off early (last Wednesday) following leads," Huron County Sheriff Kelly J. Hanson reported in a news release issued Thursday.

"These leads took them to Oakland County and then Macomb County and eventually into St. Clair County," Hanson said. "Finally, during the evening hours, they began to locate property in St. Clair County. Throughout the course of the night, it is estimated nearly \$250,000 worth of stolen property was recovered by the deputies with the assistance of the St. Clair County Sheriff's Office. This property appears to have been taken in an organized crime spree, which includes St. Clair, Sanilac, Tuscola and Huron County. Other areas of southeast Michigan may also have been victimized."

Hanson noted the recovered property included tools, trailers, tractors and other miscellaneous items.

The Huron County Sheriff's Department's Argo (amphibious 8-wheel ATV) was dispatched to aide in the recovery of items located in a swampy area. That property included an Arctic Cat ATV stolen from a farm on West Sanilac Road, near M-53, in Sanilac County's Lamotte Township.

"Our broadcasted (surveillance photo of a) person of interest is currently being held on unrelated parole absconding charges through the Michigan Department of Corrections," Hanson said. "As this investigation continues to unfold, others are expected to be charged in this criminal enterprise.

The joint investigation is continuing and involves the Huron, Sanilac, Tuscola and St. Clair county sheriff's departments, with assistance from the Shelby Township Police Department and Utica Police Department.

"Anyone with information about these crimes is asked to contact your local dispatch center or any agency involved in the investigation," Hanson said.

Background

The investigation began June 23 when Huron County deputies were dispatched to Sobczak Construction in Huron County's Verona Township to investigate the larceny of a 14-foot enclosed 2000 Interstate tandem axle construction trailer valued at \$3,000. Deputies say the trailer was then taken a nearby warehouse/storage yard owned by B.W. Crisman Co., Bad Axe. where the thief or thieves took a pair of 55-gallon barrels of scrap copper valued at \$2,000 to \$3,000.

Caro woman awaiting sentencing following embezzlement conviction

A Tuscola County Advertiser employee charged with embezzling some \$100,000 is awaiting a sentencing date following her recent plea of no contest to the charge in Tuscola County Circuit Court.

A pre-sentence investigation was ordered for the defendant, Staci L. Pomeroy, 38, of Caro, and her bond was continued at \$25,000 by the court, which took Pomeroy's plea under advisement.

Embezzlement of \$100,000 is a felony punishable by up to 20 years in prison and/or a fine of up to \$50,000 or three times the amount embezzled, whichever is greater.

Pomeroy allegedly took the money Jan. 1, 2012, according to court records, which state she was employed at the newspaper, owned by the Edwards Group and/or Edwards Publications at the time.

She originally faced three charges, including two counts of embezzling \$20,000 to \$50,000.

Snover motorists hurt in separate crashes

Sanilac County Sheriff's deputies say two Snover motorists were injured in separate traffic crashes last

According to reports, Seth Steinkopf, 18, Snover, was hurt in a two-vehicle collision Friday morning at the intersection of M-46 and Ubly Road in Elmer Township.

"At approximately 10:56 a.m., Sanilac County Central Dispatch received a 911 call reporting the injury accident. The initial investigation revealed (Steinkopf) was traveling eastbound on M-46 in his 2013 Ford Focus when he rear-ended a 2001 Dodge Ram pulling an enclosed trailer," Sgt. Nathan Smith said. "The Dodge Ram was driven by 25-year-old Jonathon Nelson of Macomb, who was stopped on M-46 at Ubly Road attempting to make a

The heart of a farmer



In my heart, I am a farmer – at least during the summer months when I'm outside tending my garden.

I love growing things. I enjoy the feel of moist black dirt between my fingers. I get a sense of satisfaction when my seedlings sprout. I even take pleasure in the achy, sweaty feeling I get after a day spent outside moving dirt and pulling weeds - doing good work. Real, honest work in the garden with Mother Nature as my boss and my husband as my supervisor. (Not really, but I let him think so.)

But even though I truly dig gardening, I am not a farmer. Nor is my husband a farmer. I'm a writer who is sometimes a farmer at heart. Transoccupational would be the trendy term for it.

My husband and I are a pretty good team in the garden. I pull weeds. He hauls dirt. We express satisfaction with the height of the tomato plants and anticipate the first pea pods and squash blossoms. We marvel at the ever-vigorous growth of the indestructible, immortal

Over the years we've learned growing things involves a never-ending learning curve. (There's a parenting analogy in there for anyone who wants to harvest it.)

We've also learned that gardening success comes not only from what you plant, but where. Plants are social beings and garden relationships are key to a robust crop. You don't have to be a farmer to reap the benefits of companion planting. Strong smelling herbs like basil, dill and green onions protect tomatoes from insects and slugs. Beets like bush beans (but not pole beans). Corn likes cucumber. Nasturtium is an edible flower that deters bugs and aphids. Ditto that for marigolds. You can also eat pansies. They look pretty in a salad.

Some plants experience irreconcilable differences and do not make good neighbors. Cabbage and cauliflower prefer to stay away from one another. Beans don't like garlic or onions. Lettuce and celery may both be green and crispy, but they don't like growing in proximity to each other. Garden plants possess more (or less) social skills than I ever would have imagined.

Another interesting aspect of gardening is sex – most specifically (and literally) the birds and the bees. What I'm referring to is pollination, which in plant circles means S-E-X. Both birds and bees can pollinate, but bees are better known for this skill.

Garden plants produce flowers. Some plants develop male and female flowers, others are hermaphrodites; their flowers are twofers – male and female at the same time. For plants to produce fruit (most things in the garden, even tomatoes and cucumbers, are technically fruit) pollen from the male part of the plant must make its way to the female ovaries. Here's where the birds and bees come in.


I don't want to get all R-rated, but as bees collect nectar from flowers, pollen clings to their tiny bee feet. As they flit about the garden, the pollen is distributed to a female flower (or portion thereof) and the deed is done – pollination! Flower sex at its finest and it's all made possible by busy bees (or in some cases butterflies, bats or even the wind). They flutter from bloom to bloom in search of nectar seemingly oblivious to the flora life cycle they are helping to perpetuate.

Summer's in full bloom in my yard and my husband and I are busy bees ourselves with weeding and watering and - hopefully soon – harvesting.

We aren't farmers, but you don't have to be an official farmer to enjoy growing things. We started with kids and moved up to tomatoes and beans – if you consider that an advancement, which it probably isn't. I guess that's okay with us. It is summer. We are outside. And we are having fun pretending to be farmers together.

Feels pretty good to me.

I've done my share of river angling over the years. But last week's journey to fish the hex hatch on the Au Sable was a first in my 45+ years of wetting a line.

Local fly fishing enthusiasts Bill Potter and Dan Dickinson got me back on the fabled Blue Ribbon stream when we put-in at the Connor Flats access site near Grayling looking for big brown trout.

Now, I've cast a line on that stretch of the river on more than one occasion as a youth with a dad, but I have never gone fishing in the middle of the night as we did Tuesday

Did you know that there were 10,984,000 gallons of water pumped from the Village of Cass City wells in May 2015 for an average of 354,000 gallons of water pumped per day?

This compares with 8,349,000 gallons of water pumped in May 2014. The amount of water pumped is higher this year because the local Dairy Farmers of America (DFA) milk plant is using Village water to clean their trucks and equipment. Eventually the DFA will be using water extracted from processing milk at the Doerr Road facility to do most of their cleaning.

The accident occurred in Colfax Township on West Richardson Road, west of Lackie Road, with deputies responding to the scene at about 3:30

"(The) investigation is revealing that a 1999 GMC pickup and a 2003 Chrysler car were both westbound and attempting to race on the gravel road at a high rate of speed," Hanson reported. "The car, which was driven by 21-year-old Mary M. Mattingly of Bad Axe, lost control and made contact with the pickup, which was being driven by 21-yearold Nicholas C. Redman of Elkton.

"When that occurred," Hanson said, "the pickup lost control and rolled over, ejecting the passenger - 18year-old Stephen N. King of Burton - who had been sitting on the passenger side door's window ledge, with most of his body outside of the pickup. Both (occupants) were taken to Scheurer Hospital in Pigeon for treatment.

"As for the car, it impacted with a tree, ripping its motor out of it before coming to rest," the sheriff added. "Surprisingly, no Jaws (of Life) were needed to free the victims. The driver was taken to Scheurer Hospital and later transferred to a Bay City area hospital with non-life threatening injuries. Her passengers, a 16year-old female from Bad Axe and a 12-year-old boy from Bad Axe, were taken to the Huron Medical Center in Bad Axe'

The 12-year-old was later flown out to a Flint area hospital with non-life threatening injuries, according to Hanson, who noted the investigation is continuing.

Cronkite earned that title by presenting facts in a very human way, but also in a manner that left his audience with the responsibility of forming their own opinions. And he did so while covering some seriously heavy-duty headlines – combat in Vietnam, Watergate and the Iran Hostage Crisis, for example.

I shudder to think of how Fox News would have handled those sto-

The work in agriculture for the year was new and of necessity not as complete as could be made. Warren's Elements of Agriculture was completed and practical experiments carried out in grafting, budding, seed germination and analysis, seed corn testing and judging, osmosis, and milk testing. The Latin and German of the school have been very successful in the year just closed and we are sure there can be no criticism as to the quality of the instruction. The work of the science department has been the completion of the regular prescribed courses of study in physics (40 weeks), chemistry (40 weeks) and botany, Zoology, physiography and physiology, each 20 weeks. The study and text book work has been supplemented by laboratory work, all experiments explaining the work have been performed and in botany an herbarium of 35 specimens was required. The math department covers algebra, geometry, higher arithmetic and book keeping.

Owendale gearing up to host bash this weekend

an article in the online Cass City Chronicle archives through the Rawson Memorial District Library website.

The story, published in July 1983, announced plans for the first-ever "Main Street Owendale" festival, sponsored by the Owendale Community Club.

Brinkman posted the article on her "You Know You Are from Owendale, MI, When..." page on Facebook, then went to work on pursuing a community celebration this year.

"It's our 110th birthday, and there hasn't been a festival in Owendale since the early 1980s," Brinkman said, adding the committee started sending out requests for sponsorship last spring to help cover expenses. "There isn't really a lot of cost; less than \$2,000, probably."

Brinkman indicated the response to those requests has been great, making it possible to plan a number of activities over the coming weekend.

Friday's bratwurst roast will kick off at 5 p.m. and continue through 7 p.m., with area classic car enthusiasts invited to cruise into town and show off their classic vehicles from 5 to 9 p.m.

Saturday's events include a 3K fun walk/run at 8 a.m. (start and finish at the village park), a craft sale/farmers market from 9 a.m. to 3 p.m. in the high school gym, and a Lions Club donut and coffee gathering from 9 to 10:30 a.m. in the high school cafeteria.

A grand parade is scheduled to get underway at 11 a.m., following by a tribute to veterans at noon, and a firemen's Jaws of Life demonstration and LifeNet Helicopter landing from 1 to 2 p.m. The Bill Denbrock Big Band will be featured in the village park from 1:30 to 2:30 p.m. There will be kids' activities, crafts, inflatables, wagon rides, sidewalk art and a magic show from 2 to 4 p.m. on the west lawn of the high school. In the park, the Eastern Michigan Music Makers are scheduled to perform

from 2:30 to 3:30 p.m., Paula (Good) Ralph will be performing dulcimer music starting at 3:30 p.m., and an ice cream social sponsored by the Owendale United Methodist Church will run from 4:30 to 5:30 p.m. The community choir will present a patriotic tribute from 6 to 7 p.m., also at the park, and the weekend will close after "A Night at the Races" at the nearby Silver Bullet Speedway starting at 7 p.m.

Committee members' enthusiasm over hosting a town-wide celebration has spread, according to Brinkman, who said local residents have been cleaning up and fixing up, as well as decorating their homes with banners and flags. 'The pride and excitement behind it has been fun to watch," she said

Brinkman acknowledged that organizing even a small-scale festival involves plenty of work, but she and her fellow committee members figure it will be worth every meeting they've attended and every phone call and sponsorship letter they mailed.

"It's just the way everyone pitches in. Each part is small, but altogether it'll end up being a nice two-day festival," she said. "We're looking forward

Barcia offered Owendale tribute during area's 125th anniversary

Then-U.S. Rep. James A. Barcia paid tribute to the village of Owendale and Brookfield Township during the area's 125th anniversary back in 1993.

The following was part of Barcia's speech, which focused on the history of the community:

Mr. Speaker, I rise today to pay tribute to the village of Owendale during its 125th Brookfield Township anniversary festival. In the year of its beginning, 1868, the village of Owendale did not exist. Most of the area was known as the Columbia Swamp. Owendale is a small village in Huron County the Columbia Swamp. Owendale is a small village in Huron County in the midst of a rich agricultural region. The Chippewa Indians were the original settlers of the area, much of which was swamp land.

Andrew Hosea Burton entered his homestead claim on Nov. 25, 1865, in Brookfield Township. He assumed an active role in the organization of the township and was permitted to name it Brookfield in memory of his native place in New York.

In 1882, Mr. John G. Owen of Saginaw purchased about 1,000 acres of timber land in the Columbia Swamp. Upon completion of the Pontiac, Oxford and Northern Railroad in 1883, Mr. Owen erected a saw mill. This mill was said to be one of the finest and largest sawmills in Michigan. In 1887, Owe had the lands of the present site of Owendale surveyed by Quincy A. Thomas, a civil engineer and surveyor. The parks, alleys, and streets were dedicated, by Owen, to the public for their perpetual use.

By November 1901, Owendale became the terminus of the stub end of the Michigan Central Railway. Charles Montague of Caro was instrumental in getting this railroad to Owendale to haul sugar beets to the factory established in Caro. At that time there were not many inhabitants in the village, although the businessmen were trying to give the place a boom

The success of these businessmen led to the incorporation of Owendale as a village in 1905.

About 1914 a cooperative shipping association was formed, with W.F. Kretzschmer as manager and William C. Pobanz as secretary and treasurer. Kretzschmer would line up cattle from the farmers to ship by train to Detroit, receiving a certain commission on the cattle sold. About 1918, the Shebeon Creek was dredged out to drain the lands through the former Columbia Swamp. A dipper dredge, with a portable gasoline engine, was used. This land, when satisfactorily drained, became part of the richest farm land in the

In 1921, Harold Ricker built a theater, situated in the block which had previously burned. His sister, Erma Ricker, played the organ to accompany the silent movies. Several other changes were made to the village in the 1920's. Electric light equipment for the streets was purchased, with street lights to be turned out at 10 pm Tuesday, Thursday, Friday and Sunday nights. Art Ricker erected a gas station on the corner of Main and Fourth in 1924. This was incorporated as Art and Duff Oil Co. when Lawrence Dufty later bought part of the business. They later added a trucking firm, trucking cattle to

The vast amount of mechanization by the 1930's brought even more changes to the area. With the use of tractors, farmers were now able to raise, and likewise sell, more corps. The Michigan Bean Co. became the second largest receiver of navy beans in the nation. Sugar beets were now hauled to the sugar plants by truck, or tractor and wagon. The Great Depression of the 1930's caused many problems in the rural area, with many farmers losing their farms. By the late 1930's as the economy began to emerge from the Depression, farmers began buying more tractors.

During the 1940's, combines were beginning to be seen on some farms. These first combines were pulled by tractors. Some had gasoline motors, which supplied the power to operate, while power take-off supplied the power to run others. During World War II, there were not many changes in the methods of farming, but farm prices were at an all-time high, and the community prospered.

In the fall of 1946, Automotive Industries established a factory in the building which had formerly been occupied by G.V. Black General Store. Much remodeling took place throughout the years, and some new buildings were erected. The manufacturing of armrests was the principle function from the time the factory began, until they were outmoded by rotational molding in 1958. In the mid 1960's they began manufacturing sun visors, starting out making them for one company and, eventually, for four companies. The factory averaged about 100 employees, with about 50 percent being residents of the immediate vicinity and the rest commuting from the outlying towns.

Today, with the large drainage ditches and tile, Owendale boasts as being Michigan's leading agricultural township, with all 36 square miles under cultivation with the exception of a few small patches of woodland.

Hunting Access Program offered by Department of Natural Resources

Landowners looking to make the omy. The majority of the HAP most of their property can support local hunting traditions and the economy, improve their land, and get paid to do it through the Michigan Department of Natural Resources' (DNR) Hunting Access Program.

The DNR encourages landowners to consider enrolling their lands in the program, which provides privateland hunting opportunities in southern Michigan and the eastern Upper Peninsula. Landowners with at least 40 acres are eligible to enroll.

Michigan's Hunting Access Program (HAP) was created in 1977 to increase public hunting opportunities in southern Michigan, where 97 percent of the land base is privately owned.

Landowners enrolled in the program receive an annual payment, up to \$25 an acre, for allowing hunters to access their lands. HAP, one of the oldest dedicated private-lands public-access programs in the nation, provides access to quality hunting lands close to urban properties.

Using funds from the new hunting license package and a new U.S. Department of Agriculture grant, the DNR - in collaboration with Michigan Department of Agriculture and Rural Development and local conservation districts - plans to continue expanding the program over the next three years.

"Providing access to hunting lands that are close to home is critical for supporting Michigan's strong hunting heritage," said Mike Parker, a DNR wildlife biologist. "Our commitment to providing access has more than tripled the number of farms enrolled in HAP the past three years. We now have over 140 farms and nearly 16,000 acres available for public hunting.

"HAP is also good for the economy," Parker added. "Hunters taking trips to HAP lands contribute \$1.7 million annually to Michigan's econ-

Landowners have the ability to choose which types of hunting are allowed on their lands. Hunting options include:

- *All hunting
- *Youth and apprentice hunting only *Small game hunting only
- *Deer hunting only
- *Sharptail grouse hunting only

Landowners may choose more than one option, such as deer and turkey hunting only. Maximum payments will be given for all hunting or youth and apprentice hunting options.

In order to manage the number of hunters using HAP lands at any one time, hunters are required to register to hunt each time they visit the property. The landowner can select either a mandatory registration at their home or a hunter self-registration box, which the DNR will provide and install.

The maximum number of hunters allowed on the property is determined by the total acreage, as well as the habitat type. Leases are for a two-year period, with annual payments made each spring.

To ensure landowner and hunter satisfaction, HAP offers landowner liability protection. Public Act 451 of 1994 addresses the concerns some landowners have over sharing access to their land. In addition, HAP lands are patrolled by conservation officers, with an increased focus on patrolling during the busy fall hunting season.
