School officials okay sale of Campbell building to Thumb Area Psychological Services

The Cass City Board of Education unanimously approved the sale of the former Campbell Elementary School building during a 30-minute special meeting Thursday night.

The new owner is Thumb Area Psychological Services, which has been leasing a portion of the building for the past two years and provides a wide range of counseling, group and tutoring services for all ages. The business is also the only one of its kind in the region that offers cutting edge Applied Behavior Analysis (ABA) interventions for children with autism.

The board vote Thursday was 6-0. Trustee Stacey Bliss was unable to attend the special meeting, but previously stated she would abstain on the issue due to a conflict of interest, as she is employed part-time by Thumb Area Psychological Services.

The sale of the building is still pending an inspection along with a review and approval of the purchase agreement by the school district's legal coun-

Thumb Area Psychological Services' original bid totaled \$45,000. The other offer for the building \$50,000 — came from Silverwood area resident Sean Astley, who indicated he hoped to transform the former school into a state licensed home for the elderly.

Both parties upped their bids since they were first announced during a regular monthly meeting of the Cass City Board of Education meeting early last week, with Thumb Area Psychological Services offering \$50,001 and Astley, \$51,000.

During the public comment section of the meeting, two area residents voiced support for sale of the building to Thumb Area Psychological Services, saying their own past experiences with youngsters in need of specialized services would have been much less of a challenge if local psychological service resources had been available.

Also voicing support was Debra Edler, director of nursing/director of resident care at Heritage Hill, an assisted living facility in Caro. Edler noted Thumb Area Psychological Services has provided a variety of invaluable professional services focused on geriatric issues at Heritage Hill in support of both residents and their families.

Driver in fatal crash enters plea of guilty

The driver in a 2014 fatal traffic crash that claimed the lives of two Thumb teens last week pleaded guilty to a pair of felony charges in Sanilac County Circuit Court.

The defendant, Laken Williams, 21, of Lexington, entered pleas of guilty to two counts of reckless driving causing death in the accident, which left 18-year-old Dakota Moore of Applegate and 17-year-old Danielle

Torrez of Croswell dead. Reckless driving causing death is punishable by up to 15 years in prison and/or a fine of \$2,500 to \$10,000. Two other charges in the case – falsely reporting a felony and lying to a peace officer – were dis-

Sanilac County Sheriff's deputies, who arrested Williams last January, reported the accident occurred shortly after 11 p.m. Oct. 28, 2014, on Roach Road, west of Croswell Road in Sanilac County's Lexington Township.

Sheriff's department investigators said speed was a factor in the crash, with Williams losing control of the Biniecki said.

vehicle, which ran off the north side of the road and overturned several times, ejecting both victims.

Williams initially claimed to be a passenger in the vehicle.

Sentencing in the case is scheduled for Feb. 3 at 9 a.m. in Sanilac County Circuit Court before Judge Donald A. Teeple.

The Sanilac County Prosecutor's Office lauded what it described as the "excellent handling" of the investigation by the sheriff's department under the direction of Deputy Jim Sanchez and Deputy Kevin

Sheriff Garry Biniecki noted his department was assisted by the Croswell Police Department, Michigan State Police, Michigan State Police Crime Lab, St. Clair County Deputy Russ Nowiski, the Croswell Fire Department, Croswell EMS and Dr. Virani, Oakland County Medical Examiner.

"I am very proud of my staff and all those involved in the investigation, and now, with the guilty pleas being entered in circuit court, the families can finally find the closure they have deserved for some time now,"

Officers identify victim in fatal house fire in Vassar

Tuscola County Sheriff's deputies have identified the victim in a fatal house fire last week.

Undersheriff Glen Skrent said the early Tuesday morning blaze in Tuscola County's Vassar Township claimed the life of 54-year-old Jason Whittaker, although he noted positive identification won't be confirmed until DNA test-

ing is complete. "The cause of death is listed as smoke inhalation," said Skrent, who earlier reported that the Vassar and Mayville fire departments were dispatched to residence on Sheridan Road, near Saginaw Road, at about 2:15 a.m. Tuesday after a passerby called 911.

"Deputies also responded and the house was engulfed when emergency responders arrived," he added. "Vassar Fire Department located a body in

A state fire marshal was called in to investigate, according to Skrent, who said the house at 5747 Sheridan Rd. was reportedly in the process of being

restored when the fire broke out. The blaze remains under investigation.



Campbell sale is win-win for town

The Cass City Board of Education's decision to sell the former Campbell Elementary School Thursday to Thumb Area Psychological Services represents a win-win for both the company and the Cass City area.

The reasons go far beyond elimination of a taxpayer burden and school district liability, including a \$20,000 tab annually spent on utilities to help keep the former school in decent shape.

The sale, approved during a special board meeting Thursday night, should provide a sense of permanency for a growing company that provides specialized counseling services to clients of all ages, including support for youngsters on the autism spectrum whose families would otherwise have to travel long distances to obtain what many parents will tell you is a vital ingredient in enabling their children to reach their full potential.

The sale is a certain display of support – on the school district's part in particular and of the community in general of what Thumb Area Psychological Services is accomplishing here. In return, the business is certain to bring more visitors to Cass City, which means more investment in the local economy.

That sort of arrangement might seem like a no-brainer, but all too often individuals with personal agendas get in the way of sealing a deal that will benefit a community as a whole. We're glad that wasn't the case Thursday.

Of course, the biggest winners, as we see it, are the families who will remain in the area – not to mention those who may consider making Cass City or a neighboring town their home – because of the specialized services available for their children right here in their own backyard.

Area residents Sue Stuever Battel and her husband, Bob, may have best described the benefits in a letter presented to school officials describing their own experiences with Thumb Area Psychological Services.

"We adopted two children through foster care...who are severely affected by autism and other special needs. The Turning Point program at Thumb Area Psychological Services is literally turning their lives around," they said.

"As you know, Cass City needs young families to thrive. We have two different friends from college who had to move either across the state or out of Michigan to access autism therapies for their children. Having access to Thumb Area Psychological Services right here in Cass City is not only a boon to existing families, but families looking to relocate. While our children have intense needs, the organization also offers services for typical children and families," the Battels

"Cass City benefits when its talented professionals can find work in our community," they added. "Several behavior technicians work with our sons on a day-to-day basis. The organization also employs social workers, counselors, a psychologist, support staff and many others – nearly all of whom had to leave Cass City to work before Thumb Area Psychological Services opened its doors.

"As the program grows, even more families outside Cass City will be traveling here to use it, and of course filling their cars with gas, shopping and eating while they're here."

As we said, the sale of Campbell is a win-win for all, and we'd like to applaud the Cass City Board of Education for its wisdom in making it happen.

Oh Christmas Tree



alike. People take to the malls to hunt for bargains, but they also take to the grocery store parking lot to hunt for freshly slaughtered Fraser firs. It's open season on evergreen trees and unlike forest critters with legs and camouflage capabilities, the trees have nowhere to hide. I've witnessed the tree victimization practice for decades and typically participate in the violence myself.

Parking lots offer the perfect tree for the taking but some over-achieving families seek to intensify the hunt by carrying through with the actual execution themselves. A quick kill would be bad enough, but prolonging the agony is another part of the merriment. After chopping down the innocent tree, dad drags it out of the woods and mounts it on the top of the family minivan with twine and bungee cords. The family heads for home, traveling 60 miles per hour on the Interstate while the bitter wind whips through the tree's branches, threatening to pull them apart limb from limb. Inside the warm and cozy vehicle the family sings "Oh Christmas Tree" and "Joy to the World." The irony of this is not lost on the Scotch pine riding atop the van.

Once home, the tree is propped in a vertical fashion in the living room where the family bedecks and bedazzles its branches in gaudy fashion with bows and garlands. In an ultimate act of humiliation, a star or other such adornment is ceremoniously placed on the treetop of our simple woodland giant and a mad celebration ensues - for everyone but the tree.

At this point, the overt abuse ends, but the suffering continues as the tree is left to die a slow and tortuous death, the immediacy of which is postponed by daily doses of water administered in quantities just large enough to keep it alive – but



It's the time of year dreaded by spruce and pine when the family descends upon the living room suddenly one morning and tears the colorful wrapping from the packages. Not one gift is left for the tree and in a final act of torture, the family drinks eggnog and forgets to give the evergreen any water that day.

The tree, sapped of any energy and overcome with despair, begins dropping its needles. In response, the family (usually dad or mom) drags the tree out to the backyard where it sits until February or March when, in a blaze of glory, it is burned in a bonfire while the children roast marshmallows over its

Tis the season of joy – unless you are an evergreen. Then, it's a season of torment and terrible treatment of trees. You probably never thought of it that way. But I bet you would – if you were a tree.

There's bacon under there? Underwear?

I didn't anticipate writing about Justin Esch and Dave Lefkow again, but if you're still looking for a gift item for that really difficult person to buy for, they might just have what you're looking for.

But you're going to have to look under there to find it.

Okay, I'll be brief: Esch and Lefkow recently announced the latest addition to their unique J&D Foods product line – the world's first underwear that looks and smells like bacon.

"Marrying the ultimate in comfort and cured meat, J&D's Bacon Scented Underwear represents the gold standard of meat-scented luxury undergarments," the pair state in their latest announcement. "Each pair is hand crafted in the USA (and features) state-of-the-art moisture-wicking, scent-emission technology stolen from NASA."

Esch and Lefkow claim these unique undies – available for just \$19.99 in both men's and women's styles — will last through multiple wash cycles and wearings, and continue to smell like bacon for up to six months or longer.

Of course, they don't recommend this product for mail carriers, zookeepers, veterinarians, dog catchers and walkers, and circus performers (especially lion tamers). They also warn customers not to fall asleep wearing a pair if they have a large dog with sharp teeth. Probably wouldn't be all that wise to wear them while hiking in areas frequented by bears.

Last year, Esch and Lefkow unveiled another first: the world's first pillowcase that looks and smells like bacon.

Hey, these products are not all that far-fetched, given our passion in this country for what amounts to a meat product prepared from pig and usually cured with large amounts of salt.

Of course, bacon can be eaten smoked, boiled, fried, baked or grilled, and is used to flavor all sorts of dishes. And Americans do just that, eating an average of 18 pounds of bacon each year (that's about 5.6 million pounds — give or take a strip — for the entire country, or the equivalent of 7.68 Empire State buildings).

"Bacontrepreneurs" Esch and Lefkow formed their unique bacon partnership in Seattle, Wash., after winning \$5,000 on "America's Funniest Home Videos".

The pair started out by creating Bacon Salt and later added other products such as Baconnaise, a product television personality Jon Steward described as being "for people who want to get a heart attack but are too lazy to actually make bacon." Esch and Lefkow went on to sell 6,000 jars of their Bacon Salt in just five days to customers in 25 states and 15 countries, via a website they created in a garage.

That innovation led to Bacon popcorn, bacon ranch dressing and bacon croutons. Then came the novelty products: bacon lip balm, bacon-flavored "Mmmmvelopes", bacon shaving cream, etc., all available for purchase on the website, www.JDFoods.net.

And now you can have your own pair of bacon scented undies, too. Gee, Esch and Lefkow may be right: "The support of briefs, the freedom of boxers and the smell of breakfast cooking in your pants. You really can have it all."



School accepts offer for Campbell building

Nicole Kohaif, who along with Deb Thomas and Kathy Mroz formed the partnership that owns Thumb Services, Psychological addressed the board.

Aside from being the only provider of specialized clinical services for autistic children in the Thumb region, Kohaif said Thumb Area Psychological Services has been and will continue to be invested in the community.

The business has already invested \$15,000 in physical improvements at Campbell, in addition to leasing a portion of the building for two years, she said, adding the staff is currently serving 250 clients in the community and employs nearly two dozen salaried professionals, and has been involved in student experience projects involving the local high school and internship programs utilizing university students from across the state and beyond.

Kohaif and her partners noted their purchase offer includes a provision to provide a classroom for use by community organizations, free of charge, for a period of five years. Kohaif also said Thumb Area Psychological Services fully intends to retain lease agreements already in place at Campbell, including one with a call center business that also currently utilizes a portion of the former school and specializes in snowmobile parts distribution.

Astley also addressed the board prior to Thursday's vote, noting he grew up in the Kingston area and has and discussion over its future. been employed as human resources

and Hospice in Lapeer for the past eight years. Astley said his vision for Campbell is to establish an independent licensed home for up to 40 elderly clients. The facility would employ at least 25 full-time workers and would build relationships within the community, including with the local school system through projects encouraging interaction between students and residents of the home, he said. "I think there's a lot of opportunities here," Astley added.

Astley indicated he admires the work now underway by Thumb Area Psychological Services and would not displace the business if he owned the former school. In fact, he said he would like to discuss a shared business arrangement involving the available space.

Kohaif stated she and her partners are also open to meeting with Astley and exploring various options, although they have not yet had any formal meetings.

The school board tabled action on the original bids last week in order to revise the property description to include an adjacent grassy area and 25,000 square feet of parking lot space. School officials cited a reduction in the district's liability related to the property as the reason.

School officials earlier this year dropped their asking price for the building from about \$120,000 to \$79,000.

Cass City School officials voted to list the structure for sale in April 2014 after several months of debate

The decision came after the board closing the school four years ago.

director of Hometown Home Health had hoped to let voters decide the issue at the polls, but subsequently learned it isn't a legal option. At the time, it had been more than two years since school officials closed Campbell in a consolidation effort designed to cut expenses following a multi-year trend of declining enrollment that has cost the Cass City Public Schools hundreds of students. In early 2013, the board began talks with representatives of a group of Thumb dentists who had proposed utilizing the building to house a nonprofit regional dental clinic to serve Medicaid patients.

The dentists agreed to a three-year lease and offered to buy the building outright, but negotiations stalled when the board approved, on a split vote, a motion to not sell the former

Board members opposed to selling expressed concern for the possible need for more space in the future, especially in light of construction of the new Dairy Farmers of America (DFA) plant in town. But other board members suggested it's highly unlikely enrollment would increase significantly due to the plant construction. They also noted the district has some existing space that could be used to accommodate additional students.

However, since then, the district has not seen a notable increase in enrollment due to the DFA plant. In fact, student numbers have continued to decrease. School officials have spent roughly \$20,000 annually in utility expenses at Campbell since

The report will include details on current wheat production, current and potential milling capacity in Michigan, preferred wheat varieties in various end-user sectors, and possible areas for future development of Michigan's wheat industry.

The Lansing Economic Area Partnership (LEAP), the economic development agency responsible for serving the Lansing metropolitan area, partnered with the Michigan Wheat Program and MSU Product Center to put the grant application together. LEAP has prioritized agricultural processing and is looking to better connect the local wheat supply chain by expanding wheat processing and value-added operations in mid-Michigan. The Lansing area has recently launched several businesses that produce artisan beer and spirits and their associated malts and grains, and wants to leverage other specialty wheat opportunities to complement the growing cluster.

"This important study will help us define the wheat market and identify processing opportunities in the Lansing area and around the state." said Bob Trezise, President and CEO of LEAP. "LEAP's Agriculture and Food Business Workgroup was excited to provide the initial concept, and looks forward to working with the Michigan Wheat Program while using the report's findings to maximize value-added growth down the




