## Cyber hackers target Caro hospital

Although hacking has been in the national news, hacking can be found in rural communities, prompting Tuscola County officials to take a proactive approach to the

Hacking is becoming a persistent problem everywhere.

Even though Caro Community Hospital and its clinics became victims of a "ransomware attack" earlier this month, so far it doesn't appear that patient data was compromised. The attack disabled the hospital's phones and ability to access patient data.

A ransomware attack is when an unidentified, unauthorized entity gains access to data that is supposed to be secure, encrypts the captured information, and ransoms the code to the owner of the data in exchange for money to allow the data to be un-encrypted for use.

Hospital officials are working with the FBI's cyber-security on the

In Cass City, Hills and Dales General Hospital officials were notified about the neighboring hospital's security breach.

"Our IT (information technology) department sent out a notice about what happened in Caro. Our IT keeps up on the latest technology and have several firewalls in place," said Samone Ivan, who is the assistant to the CEO.

"The IT provides us with training on what to look out for in hacks. And, our phone system is independent from our computers," Ivan

Before the Caro Community Hospital's hack became public, Tuscola County Commissioners approved spending \$110,000 on software and hardware for network security. The money will come from the county's equipment fund.

Software was only part of what Tuscola County IT Director Eean Lee wanted. He requested adding a full-time employee to audit the security of the network system, training staff on how to avoid hacks and scams, and developing a plan to handle breaches.

The total cost for the proposed new staff member and software is estimated at about \$182,000, with an annual licensing fee for the software and employee salary of about \$88,000.

Although commissioners only approved the software upgrade, they did agree to allow Lee to interview for a part-time IT security position to monitor workstation updates, contingent upon board approval

## Markel is among coaches' "hall of fame" inductees

The doors to the Michigan High School Coaches' Association Hall of Fame will swing open once more this fall, and for the first time ever, a Cass City coach will be part of the new class inducted by the organization, founded back in 1954 on the campus of Central Michigan University.

Don Markel, who has spent the lion's share of his 40-year career in education in the Cass City Public Schools — currently serving as an assistant principal, athletic director and veteran wrestling coach — is among 16 coaches slated to be honored by hall of fame officials Sept. 17.

The Cass City Board of Education applauded Markel's selection during a regular monthly meeting Monday night.

Markel made the decision to go education long before he stepped foot on the campus of Central Michigan University, and he figured coaching would be a big part of that career.

It was a natural choice.

Originally from Marine City, located south of Port Huron, he was a standout

## New leadership

### Roedel retires from medical care passes the torch to Kretzschmer

After 17 years as the Tuscola County Medical Care Center (TCMCC) CEO, Margot Roedel, R.N., is retiring July 31, and Brenda Kretzschmer of Owendale will become the facility's new

"I'm 75 years old, and I'm ready to retire and enjoy myself," said Roedel. "I know when Brenda takes over the facility it will be in good hands. She is my 'heir apparent'. We have been working closely together for her to take over."

Since she started in 2000, Roedel has spearheaded several major construction and renovation projects to make TCMCC a state-of-the-art medical care facility.

One of the first projects she tackled was bringing the original building up to code both inside and out. That project was completed in 2005 along with a three-story addition, complete with a landscape makeover that created a nature center for residents.

Roedel had other plans for expansion, but because the facility was landlocked, there was no way to proceed until 2011 when Davenport University, located next door, closed.

The TCMCC Board approved plans to purchase the 16-acre college complex property, including the building, and subsequently relocated the medical care operation's business and administrative offices.

With the additional acreage, Roedel realized her vision of creating an assisted-living complex. The Baldwin and the Cortland houses opened in 2015, and there is still enough area available for further housing develop-

When the assisted-living complex was being built, two parcels of land adjacent to the medical care complex became available and were purchased by

TCMCC. Roedel's long-range vision for that area was to create a proposed respite-care facility for the disabled. That additional land is available for development when needed.

## Sheriff: scam artists are posing as DTE workers

The Sanilac County Sheriff's Department is urging area business owners and residents alike to be aware of a reoccurring scam that has again popped up in the region.

"The scam works like this: DTE Energy imposters are contacting businesses and residents, informing them that they have late payments and that their service will be disconnected unless they receive a payment over the telephone," explained Detective Sgt. Nathan Smith.

"Imposters have also in the past requested persons to pay via Western Union or by purchasing pre-pay credit cards or Apple I-Tunes cards, etc.,"

Anyone who receives such as call is encouraged to take the following steps:

\*Ask for identification.

\*Pull out your most recent DTE Energy bill and ask the caller to provide you with the amount due and the account number they are referencing the call to.

## Overcoming overdose trend a big challenge

The number of total drug overdose deaths in Michigan increased by 18 percent in 2016, and the majority of overdoses were related to opioids, according to new provisional data announced by officials at the Michigan Department of Health and Human Services (MDHHS).

In a move we should all applaud, MDHHS has responded by launching a media campaign to raise awareness about the dangers of opioid misuse, the treatment options available, and to educate the public about proper storage and disposal of prescription drugs.

"The addiction epidemic continues to take lives and hurt families in every corner of our state and our country," said Lt. Gov. Brian Calley. "While many initiatives are underway to address this crisis, it's clear that we have to work harder to reverse this tragic trend. Working together on treatment and prevention efforts will ultimately lead to more second chances and fewer funerals."

States nationwide have experienced a dramatic increase in the number of opioid-related overdoses in recent years.

In Michigan, the number of heroin-related overdose deaths per 100,000 residents increased from 1.1 in 2007 to 7.5 in 2015. Of the 2,335 overdose deaths in 2016, 1,689 were opioid-related, up from 1,275 opioid-related deaths in 2015.

"The initiatives underway for treatment and the public awareness campaign are key to reaching more residents across the state and providing them with the information necessary to find the available prevention, treatment and emergency services that can save a life," said Dr. Debra Pinals, MDHHS chief psychiatrist.

"The provisional data show that remaining vigilant in our fight against the opioid epidemic is an everyday matter of life or death for many Michigan residents," she

The public awareness campaign is part of Michigan's extensive efforts to address opioid addiction and overdoses. In May, Michigan issued a standing order to preauthorize the distribution of naloxone by pharmacists to eligible individuals. Naloxone is a fast-acting, potentially life-saving medication that reverses opioid overdose.

Since it was issued, more than 700 (25 percent) of Michigan pharmacies have registered to dispense naloxone under the standing order.

Both the naloxone standing order and public awareness campaign were significant recommendations of Governor Rick Snyder's Prescription Drug and Opioid Abuse Task Force. A Commission was also launched at the end of 2016 to pick up where the task force left off and drive the agenda to combat the opioid crisis.

In addition, in April Michigan received more than \$16 million in Opioid State Targeted Response (STR) funds from the Substance Abuse and Mental Health Services Administration. The Opioid STR grant is being used to promote prevention and increase access to treatment by funding a variety of state initiatives, including the Michigan Prescription Drug Monitoring Program.

This is an uphill battle, to be sure, but one worth every ounce of effort because it could be all that stands between recovery and a casket.

As Cass City residents gear up for village-wide garage sales this weekend, they can either take comfort or be concerned that Big Brother has rules about garage sales.

Earlier this month, the state's top law dog, Michigan Attorney General Bill Schuette, released a new consumer education newsletter concerning hosting and going to garage sales.

It would seem it is a simple process to go through and sort belongings to decide what to keep and what to put in a garage sale, or for garage sale goers to shop for bargains. But it isn't. According to Schuette, some legal issues - even federal ones - could come into play for those hosting a simple garage sale.

The federal Consumer Product Safety Improvement Act of 2008 (CPSIA) regulates the safety of items even those sold in garage sales, says Schuette, who explained CPSIA regulations apply not only to manufacturers and primary sellers, but also to resellers, which includes yard sale merchants.

So, folks who organize garage sales are legally responsible under the law for any recalled products they sell. And, the seller is obligated to check if the items they have for sale face a recall, especially items like cribs, highchairs, playpens, car seats and toys.

There is a list of recalled items on the U. S. Consumer Protection Safety Commission website.




We'd like to offer our congratulations to Cass City Athletic Director and veteran wrestling Coach Don Markel, who is scheduled to be inducted into the Michigan High School Coaches' Association Hall of Fame this fall (see story, page one).

Here are a couple of tidbits Editor Tom Montgomery picked up (but didn't use) during his interview with Markel:

While the longtime Red Hawk coach was a solid athlete as a youth and even in his college days at CMU (although he describes himself as an average wrestler when he competed for the Chips), he noted he learned early on that he simply wasn't cut out for some sports. "I played basketball in junior high. I was terrible," he said.

Cass City's longest serving coach has mentored 52 different varsity teams during his years in Cass City. Can you guess who the runner-up is in this category? The answer is Scott Cuthrell, who has led 29 different varsity teams, including 14 varsity football

Markel will be the first Cass City coach to be inducted into the coaches' association hall of fame, but the roster of past honorees includes another familiar name - Paul Smarks, for whom Cass City High School's coveted Paul Smarks Award was named. Smarks did, in fact, coach for the Red Hawks for three years – about 90 years ago – but was inducted into the hall during his tenure as a coach in Warren.

Also, the state's unemployment rate in June was sixtenths of a percentage point below the national rate. The U.S. jobless rate edged up by one-tenth of a percentage point to 4.4 percent in June.

Furthermore, since June 2016, total employment rose in Michigan by 95,000, or 2.1 percent, while the number of unemployed fell by 46,000 or 19.7 percent, both of which compared favorably to the U.S.

Gov. Rick Snyder said Michigan's 3.8 percent unemployment rate is the state's lowest in 17 years.

"Not only is statewide unemployment once again below the national average – it's Michigan's lowest rate recorded since August 2000. This is another exciting step on the path toward our future as Michigan's reinvention continues," Snyder added. going to keep that momentum going now as we continue to build and educate our workforce and create more and better jobs."

You may not know Michelle Leeson, Keith Mitchell or Lou LaPonsie, but I'd wager most folks would count themselves lucky if they could come close to reaching any of these area residents' ages and still be as

For years, Leeson was the friendly face behind the desk in the front office at the former Campbell Elementary School, but retirement hasn't slowed her down. Hopefully, it's also catching.


I don't think there's a secret recipe that guarantees a long, satisfying life for anyone. But I suspect balance in just about every aspect of our lives is one key.

## **Fighting** the bite

## Mosquito population thriving this year in Tuscola County

The mosquito population has more than doubled in northern Tuscola County, thanks to a wet spring and summer.

To help handle the additional work, Tuscola County Mosquito Abatement Director Kimberly Green asked retired former biologist Richard Colopy to come back as a seasonal biologist at a rate of \$20.95 per hour to assist with laboratory work due to the mosquito outbreak caused by recent significant rainfall.

"Richard is helping out in the lab in counting and comparing mosquitos," said Biologist Gavin Greer. "We are finding 2,500 mosquitos in some traps along the (Saginaw) bay area. Generally, the trap average is about 1,000 mosquitos.

"Recently, there has been six to seven inches of rain in the northern part of the county and there is more forecast," he added.

Traps with 2,500 mosquitos have been recorded in Akron and Columbia townships.

The mosquito abatement department has 10 New Jersey Light traps and three Gravid traps to conduct mosquito population

"The New Jersey Light traps use light to draw in mosquitos. It needs a power source," he said. "The Gravid traps use organic

Mosquito trapping is important. The number collected helps indicate the mosquito population and is a potential indicator of disease

Tuscola County has a millage to operate its mosquito control program. In addition to roadside spraying, the tax allows for individual residential properties to be sprayed when scheduled.

"We are averaging 100 calls a day for yards to be sprayed," said Greer. "So far, we are keeping up. We are doing 80 to 85 residential sprays a day."

The department has 15 employees who conduct suppression spraying at night.

in each township at night doing suppression spraying," Greer said.

Trying to keep mosquito numbers down is important because the Culex mosquito carries West Nile Virus, which has been found in crows in Midland and Saginaw counties. So far, the virus has not been documented in Tuscola

Although Tuscola County has seen its share of rain, the county has not been hit as hard as Midland and Saginaw counties have with rain and flooding.

"As long as we don't get a lot more rain, we are holding our own for the most part against mosquitos," said Greer.

Tuscola is one of four counties that have a suppression program – the others are Midland, Saginaw and Bay. Tuscola levies .6316 of a mill and has had a suppression program since 1997.

Residents can also do their part in reducing the mosquito population by eliminating breeding grounds for mosquitoes, such as standing water near the home in pools and buckets, and by keeping screens in good repair.

Wearing long sleeves, closed shoes, and slacks help to protect against mosquito bites, along with not going outside during peak mosquito times in the early morning and evening.

When applying insect repellents on children, follow the guidelines recommended by the American Academy of Pediatrics Committee on Environmental Health by applying repellent on your hands and then rub it on the child. Do not use repellents with DEET on infants less than two months old. Avoid spraying children's eyes and mouths, and use the repellent sparingly around their ears.

Also, never apply repellent to children's hands or their skin under clothing. Do not allow young children to apply insect repellent to themselves, and once a child is indoors, wash the treated skin with soap and water.

Before applying repellent, read all label directions; not all repellents are intended to be applied to the skin. Repellents with low concentrations (10% or below) are effective and may be preferred in "With that large of a crew, we are most situations. Start with a lowconcentration product.

## It's a waiting game for next step in construction of state's new hospital

In mid-June, state officials announced that Michigan's new psychiatric hospital, planned to replace the Caro Center, will be built in Tuscola County. But little else has been decided regarding the project.

Gov. Rick Snyder's proposed 2018-19 budget, which goes into effect Oct. 1, earmarks \$115 million for the project, but state officials initially had not settled on a location for the facility.

Faced with the possibility of \$54 million revenue loss in the county, Tuscola County officials launched an informational and support campaign for the new state hospital to be built on state land in Caro. Their efforts were successful — the new 200-bed hospital will be constructed outside of Caro on state-owned land at 2000 Chambers Rd. in Indianfields Township. The new facility is expected to create 100 new jobs. Now, it's a matter of waiting for a construction date.

"The start of construction has not been decided yet," said Angela Minicuci, a spokesperson for the Michigan Department of Health and Human Services in Lansing. "There is no time frame yet. The budget was just recently approved.

The new facility will replace the 104-year-old Caro Center hospital. There are currently 18 buildings on the Caro Center's grounds that are not being used.

"There has not been a decision on what will be done with Caro Center when the new hospital opens, or with the other unused buildings," said Minicuci. "I expect there to be a site tour done (in the coming months)."

Now that the location of the hospital has been determined, the State Budget Office of the Michigan Department of Technology and Management will be handling the details, she explained.

"The design phase for the hospital is just beginning. It typically takes about a year to complete to see shovels in the ground," said Kirk Weiss, the Michigan Department of Technology and Management spokesperson. "It is understood there is an urgent need for completion because of the condition of the center.'

Keeping the hospital in Tuscola County is a boon for the Thumb area. Data shows more than 80 percent of the center's patients come from bordering counties, and about a third of the facility's employees live in a Caro ZIP code, with more than 70 percent of workers living within 30 miles of the Caro Center.



athlete as a youth, playing football, wrestling and running track and cross country during his four-year high school career in Marine City. He earned his high school's outstanding male athlete award before collecting his diploma in 1973

"I actually, from the get-go, planned on going into teaching. I just liked working with people," said Markel, 61, who majored in history at Central. He minored in physical education with an emphasis on coaching during his years in Mount Pleasant. Markel also wrestled for the Chippewas, earning a varsity position in his junior year.

After graduating in 1977, he spent a couple of years working as a long-term substitute teacher, including one year at his alma mater. He then taught for one year in Freesoil, near Ludington.

Markel accepted a math and social studies teaching position in Cass City in the fall of 1980. His 37-year tenure here has since included 29 years in the classroom, teaching subjects ranging from business math and history to health and social studies. In 2006, he was named an assistant principal and athletic director.

Along the way, Markel amassed an impressive coaching resume spanning 40 years, including 37 years coaching varsity sports in Cass City. He led the Red Hawk football team to a league title during his nine years at the helm, and also coached track for 10 years.

But Markel is best known for his skills and mentoring ability as a wrestling coach, a job he took over from former Cass City administrator and coach Russ Biefer about 32 years ago.

Markel's wrestling teams have since captured 10 league championships, eight district crowns and one regional title.

Along the way, Markel earned a few spots in the local sports history books, including the distinction of being the longest-serving coach in Cass City High School history — 32 years as head wrestling coach — a title previously owned by former girls' softball Coach Dave Hoard, who served in that role for 18 years.

Markel is also Cass City's longest-serving athletic director (10 years).

The names and faces and titles have changed over the years, but Markel indicated his motivation for returning every year in his role as coach has not.

"The impact you have upon the kids and seeing the kids grow," he said, adding he's seen how a passion for athletics has probably kept a number of student athletes in school and focused on academics as well as their performance as team members. "And then you take a look around and you see the success some of these kids have had in their personal lives (since)..."

Sure, athletics offer a fair share of excitement and – hopefully – glory, but Markel always makes a point of emphasizing to his teams that there's a price tag for success in the form of effort, dedication and a willingness to sometimes sacrifice for the good of the team.

Apart from those attributes, he says, participation in sports builds

character and teaches self-discipline and teamwork.

But being an effective coach isn't just about attitude and effort.

"I think developing that personal relationship with your athletes — that's the biggest challenge, and that's different with every kid. Some kids, you can get in their face, and they'll respond to that," he added, noting other athletes respond better to different approaches.

In either case, he said, the goal is the same; to encourage the students to believe in the coach and in what he or she is trying to accomplish

Coaching involves a fair amount of behind-the-scenes interaction, such as keeping tabs on students' academic performance and touching base with them when grades start to slip, according to Markel, who pointed out high school coaches are dealing with teenage athletes who are still maturing emotionally and sometimes need a word of encouragement when they're struggling.

they're struggling.

For Markel, the behind-thescenes tasks include plenty of recruiting for a sport that isn't as
high profile as football or basketball. He also meticulously scripts
each practice in an effort to accomplish as much as possible.

It's all in a day's work for Markel, who is quick to say his wife, Stacee – a high school special education teacher in Cass City since 1992 – has always supported his interest and work in student athletics.

"As a coach, my goal is to prepare my kids physically and mentally to the best of my ability," he said. "It's just like anything else; you have to have a passion for what you're doing. I've very much enjoyed having that personal impact on the kids and (developing) those personal connections."






