Tuscola County voters to decide tax hikes for road patrol, senior services

Tuscola County officials are hoping residents will be willing to shell out a few more dollars to fund the sheriff's department road patrol and senior citizen services over the next few years when they

go to the polls during next week's special election.

Voters will decide requests for additional funding in both categories during the Tuesday, Aug. 8 vote.

According to veteran Tuscola County Controller/Administrator

Mike Hoagland, citizens will be asked to approve an increase of .43 of a mill – from the current .9 of a mill to 1.33 mills — for the road patrol.

The current millage generates roughly \$1.564 million and costs the owner of an \$80,000 home about \$36 annually. The increase in millage would generate another \$747,000 and add \$17 to residents' tax bills for a total of \$53 per year, he said.

Residents protest village manager pick in Cass City

Several angry village residents voiced concerns Monday night during the regular monthly meeting of the Cass City Village Council.

Most of the standing-room-only crowd was on hand to protest the selection of Ted Andrzejewski as a new permanent village manager to replace interim Village Manager Lou LaPonsie.

In a 4-1 vote last month, Andrzejewski was selected from a group of four finalists to replace LaPonsie following reference and background checks conducted by the Michigan Municipal League (MML). However, many in the overflowing audience questioned the council's decision after negative reports about Andrzejewski surfaced.

"Ted was placed on administrative leave at his old job," said trustee Tom Herron, who referenced a story broadcast by News10NBC and published on the station's website, WHEC.com, that reported Andrze-

Juveniles turning over a new leaf, giving back in new court initiative

Tuscola County court officials are putting youths on probation to work in hopes of encouraging them to use their time and talents in a positive way and give back to their community.

Those are among the goals of a new initiative announced by the Tuscola County Circuit Court-Family Division-Juvenile Probation Department, which has secured grant funding through the Tuscola County Community Foundation to develop an arts and science program for the courts' juvenile offenders

venile offenders.

"This program, which is a partnership between the court, Caro Community Schools and MSU Extension, allows juveniles to spend ten hours a week in the classroom, engaging in hands-on arts and science activities, which relate to (a) community park that they are in the process of building," explained Caryn Michalak,

circuit court administrator.

Michalak explained the initiative was launched in June, several months after court officials began exploring a possible expansion of programming for juveniles on probation.

"Summer programming was seen as a need, and (family court) Judge (Nancy) Thane was recommending an arts program," she said. "The court wanted every youth in summer programming to ensure that they were involved in activities that would increase their life skills and educational abilities.

"When staff discussed what options were available for programming and resources, the county owned the property that is being implemented into a park, and the grant was presented," added Michalak, who noted the Janks Fund approved a \$6,000 grant for the project, with the Future Youth Involvement (FYI) Fund kicking in \$3,920. Both funds are administered by the Tuscola County

Community Foundation.

"The balance of the funding at this point is being supported through the county and state funding. Through this funding, the county is able to support this program with a 50-percent reimbursement from the state," Michalak said.

The community park, located on the corner of Bush and Court streets, currently has twelve raised garden beds filled with tomato, pepper, onion and other vegetable plants.

"The park is continuing (to progress) in design and construction, with the initial help of students from the Tuscola Intermediate School District Technology Center who built the raised beds," Michalak said. "The worksite program of the Tuscola County Jail aided in the delivery and painting of the shed at the park."

High-risk youth, under the jurisdiction of the county's family court, have learned how to maintain the gardens and will be building walking paths as well as additional items that need to be completed to ensure the park's success for the residents of Tuscola County, according to Michalak

2 funding proposals on tap in the Ubly Schools

Voters in the Ubly School District will be asked to approve a pair of ballot proposals designed to fund upgrades and construction projects

"One request is for a bond proposal and the other to create a sinking fund," explained school Supt. Joe Candela. "The bond proposal is for 1.7 mills that would generate about \$8.3 million. The sinking fund request is for two mills for 10 years."

Passing the bond proposal would allow the district to build seven new classrooms, furnish and equip the additions, do remodeling along with furnishing and refurnishing, equipment upgrades, add and install instructional technology, and improve playgrounds and athletic facilities.

"We want to build 12 new elementary classrooms and close off the seven classrooms in the upstairs section of the 1936 school, which is the original school," said Candela. "Those rooms need a lot of work,

jewski was placed on leave with pay from his position in the city of Canandaigua, N.Y., June 9. In the story, Mayor Ellen Polimeni cited "personal issues" as the reason for

That red flag alone was enough for resident Gary Jones to scold the council.

"Administrative leave? Something isn't right there. Why would you even consider him for villager manager?" he asked the council, adding, "He'll make your job miserable. He has too many dark clouds over his head."

Long-time village residents Ed Knight and Don Ball agreed.

"If two different communities let him go, I can't believe you still think he is the right choice," said Knight. Ball added, "We don't want to see him as village manager. Ted is not our candidate."


On the other side of the coin, trustees Marilyn Biefer, Jenny Zawilinski and Mick Kirn, all who originally backed Andrzejewski for village manager, mentioned his ethics and infrastructure knowledge as reasons for supporting the one-time former city manager from Menominee before Village President Carl Palmateer instructed both sides, "It's time to move on."

However, in a related matter, the council approved a motion to hold

a special meeting – Tuesday, Aug. 15 at 7 p.m. — to fill a pair of vacant council seats. Expected to be interviewed are trustee candidates Heather Severance, Eric Reed, Dan Delamater, Nancy (Braun) Hrabcak and Nancy Barrios. If, as expected, the council returns to a full seven-member panel, they should be able to decide on Andrzejewski's fate in Cass City.

"I want to know all the facts. Let's see what Jason (Village Attorney Jason Bitzer) has to say," Kirn said concerning Andrzejewski.

"One day I'm 'yes' and the next day I'm 'no'," commented Biefer on Andrzejewski selection as village manager. "It's a big decision and we need a full council to represent the community. I'm not in a rush to get this done."



Understanding school funding key to debate

We don't always see eye to eye with the folks at the Mackinac Center for Public Policy — especially in the areas of privatizing education and the impact of additional revenue on public schools' ability to educate students – however, we believe the organization was on the money with a recent article promoting a better understanding of how pub*lic schools are funded.*

Mackinac Center for Public Policy officials describe their organization as a nonpartisan research and educational institute dedicated to improving the quality of life for all Michigan residents by promoting sound solutions to state and local policy questions.

In this case, center officials recently released a new resource entitled "How School Funding Works in Michigan" which, while not exciting reading, seeks to educate citizens on topics they must understand if they are to make informed decisions about funding issues in their home districts.

The 16-page report offers easy-to-understand explanations of six major topics related to school funding in Michigan, according to Author Ben DeGrow, director of education policy at the center, who says the guide "will be a useful tool for policymakers, parents, media and educators.

Residents can access the full report on the web at www.mackinac.org/S2017-04.

"Michigan schools receive funding from a variety of sources based on numerous formulas, so our goal was to create a plain-English guide to help stakeholders easily understand the facts," DeGrow said. "The debate over the level of school funding may never end, but this new report gives people the facts they need to have meaningful discussions."

The foundation allowance, categorical grants, funding for intermediate school districts, financing of special education services, school facilities financing and federal revenues are each discussed. While funding levels change annually, most of the key elements remain the same, so this can be a helpful tool for years to come.

"Since school funding is, at best, difficult to understand, the goal of this publication is to simplify things so we can get to the heart of what matters," DeGrow said. "Now that we know how much money Michigan schools receive and from what sources, we can focus on ensuring we are spending those dollars in the best way possible."

The report does not attempt to assess the efficacy of certain funding or spending, but rather sticks to an easy-tounderstand description of how all the pieces of school funding fit together. It is offered as a public resource that can be used by anyone interested in gaining a deeper understanding of school funding in Michigan.

Whether you're asking yourself why a district asks for a special millage for building repairs when "the school already gets state funding", or you wonder how school officials estimate their anticipated funding when drafting a new budget, or you just simply want to better understand how your tax dollars are funneled back to educate local students, this report is a good, basic resource to better understand a variety of topics.

It's worth a look.

While zombies munched their way through their victims, my goosebumps grew as I realized "I'm going to die" if there is a zombie apocalypse. My new house didn't have enough doors to put over the windows, and the doors certainly were not as thick as the ones in the farmhouse.

I owned only one gun with a handful of ammunition, and only enough food for about a week.

Romero's work spawned a zombie genre with programs about them on nearly every television channel, (good job, George). There is even a tongue-in-cheek commercial about insurance that will cover a zombie apocalypse but not certain household repairs.



I finally made it to the Real Seafood Company in Bay City this past weekend, something that has been on my wish list since the fine dining eatery opened in May of 2015.

The waterfront restaurant is located in the brand new Uptown Center and offers a contemporary atmosphere with scenic views from every table, both indoors and out, of the Saginaw River.

On Saturday, the Haires ate outside and were able to enjoy watching boat traffic cruise up and down the river on a perfect Michigan summer night. But let's get to the nitty-gritty, how was the food?

We had two appetizers: crab cakes and oysters. The crab offering was excellent, but the oysters too small for any real tasting.

County workers discover crash, assist injured teen

Tuscola County Sheriff's deputies credited a county mosquito abatement crew with discovering a traffic accident that sent a motorist and her vehicle into a water-filled ditch Thursday in Ellington Township.

Deputy Steve Roland was dispatched to Deckerville Road, west of Dodge Road, to investigation the crash, according to Undersheriff Bob

"The driver, a 16-year-old Caro woman, was traveling westbound on Deckerville Road and lost control and entered a ditch. She sustained minor injuries and was later transported to Caro Community Hospital by MMR," Baxter reported.

"Deputy Roland spoke with two employees from Tuscola County Mosquito Abatement and learned the two were traveling on Deckerville Road (when) they noted the markings on the roadway and shoulder and felt that there may have been a recent traffic crash," he said

"The two stopped and found the young female driver trapped in the vehicle in a ditch, which had several inches of water. They assisted her in getting out of the vehicle and remained at the scene with her until emergency services arrived on scene.

"It should be noted that the vehicle was barely visible from the roadway and may not have been noted by other motorists," Baxter said.

Clever scammer bilks resident out of \$4,000

Tuscola County Sheriff's deputies say a clever scam artist bilked an elderly Almer Township widow out of \$4,000 last week.

"In short, she received a call from a subject indicating that her grandson was in jail in Switzerland," Undersheriff Robert Baxter reported on the department's Facebook page over the weekend, noting the woman's grandson was, in fact, visiting Switzerland at the time.

The subject that called her, placed a younger subject on the phone who identified himself as the complainant's grandson. The younger subject sounded like her grandson and she only talked to him momentarily,"

"The complainant ended up withdrawing \$3,000 as requested and purchased gift cards at Walmart in Caro. The complainant then scratched off the pin identification number on the back of the card.

She later provided this information to the subject posing to bail her grandson out of jail," he continued. "Two days later, an additional request was made to withdraw \$1,000. The complainant withdrew the money and again purchased the gift cards, providing the PIN identification to the subject posing in the same fashion.

"The complainant felt that these individuals were well versed in this fraudulent activity," Baxter said. "They were able to answer all of her questions. They told her that her grandson was extremely nervous and shaken. This would explain any reservations that the complainant may have had. She also said that the subject calling indicated that there was an attorney involved, who was also involved in the transactions."

The phone numbers provided by the suspect(s) appear to be trac phones, according to the undersheriff, who noted the complainant had no idea how someone would know that she had a grandson and he was in Switzerland, or any correlation between the two.

"The complaint is still under investigation. Walmart is attempting to track cards with PINs on history of purchases," Baxter said.

Cass City School officials cancel an entrepreneurship program for this summer

Lack of participation has cancelled a special program on entrepreneurship development planned by Cass City School District officials later

'We didn't have enough sign up for it to make it worthwhile for the expense," Cass City School Supt. Jeff Hartel said of the August program, noting it was open to high school students in the Thumb area. "We refunded the money back to those who had signed up."

The two-day event that was to be offered was the seminar entitled "Students Charting the Right Career Path so They and Their Community Will Prosper." Among the presenters scheduled to participate was Dr. Mike Mulligan, a well-known career management consultant.

Although the seminar won't be taking place now, Hartel hasn't given up on the program designed to encourage students to think about their academic strengths, interests and talents along with the work environment they're interested in pursuing — and how that could be channeled into developing their own business.

"We are hoping to offer a similar program to juniors and seniors when classes start in the fall," Hartel explained. "The plan is to have it as a day-long class as part of the curriculum. It's a good program."

Some of the goals for the program include exposing students to various occupations in their community, and helping them understand their academic strengths, interests, talent, personality and skills.

Several appear in court on charges last week

The following people appeared in Tuscola County Circuit Court last week on various criminal charges:

*Justin K. Bowles, 28, Waterford, was sentenced to 57 months to 15 years in prison following his plea of guilty to home invasion, second degree, July 24-25, 2011, in Denmark Township.

He was also ordered to pay court costs and fines totaling \$258. Restitution in the case is to be determined.

*Brandon E. Smallwood, 33, Otter Lake, entered pleas of no contest to charges of armed robbery, first degree home invasion and unlawful imprisonment Jan. 24 in Vassar Township.

A pre-sentence investigation was ordered in the case, bond was revoked and the defendant was remanded to the custody of the sheriff's department. Sentencing is to be scheduled.

*Lindsey M. Irish, 24, Mayville, was sentenced to six to 40 years in prison following her pleas of guilty to first degree home invasion and delivery/manufacture of marijuana, subsequent offense, Jan. 24 in Vassar Township. She was also convicted of being an habitual offender (two prior felony

In addition to prison time, she was ordered to pay costs and fines totaling \$326. Restitution in the case is to be determined.

*Patrick J. Payne, 40, Caro, received a one-year delayed sentence following his plea of guilty to violating the Sex Offenders Registration Act by failing to update his address March 21, 2016, in Indianfields Township. He was also convicted of being an habitual offender (one prior felony conviction).

Payne was ordered to pay costs and fines totaling \$508.

*Christopher B. Senior, 34, Millington, was sentenced to 18 months to 20 years in prison following his plea of no contest to operating a motor vehicle while under the influence of liquor, third offense, Jan. 14 in Vassar Township. He was also convicted of being an habitual offender (three or more prior felony convictions). In addition to prison time, he was ordered to pay costs and fines totaling \$758.

*Jarred W. Long, 27, Caro, received a one-year delayed sentence following his plea of no contest to a charge of assault with a dangerous weapon (felonious assault) Feb. 8 in Caro.

He was ordered to pay costs and fines totaling \$1,258.

*Joanna L. Welch, 28, Caro, was sentenced to 270 days in the county jail and 36 months probation following her plea of guilty to delivery/manufacture of a controlled substance (hydrocodone) Aug. 31 in Mayville.

In addition to jail time, she was ordered to pay costs and fines totaning \$508.

*Joshua S. Praay, 32, Saginaw, pleaded guilty to two counts of retail fraud, first degree, involving merchandise valued \$1,000 or more. The charges stem from incidents April 25 and June 3 in Caro, according to court records.

Pre-sentence investigations were ordered in the cases, bond was continued at a combined \$20,000

and the defendant was remanded to the custody of the sheriff's department. Sentencing is to be scheduled.

*Roy J. Klinesmith, 54, Elkton, was sentenced to 300 days in jail, with work release, following his pleas of no contest to charges of operating a motor vehicle while under the influence of liquor, third offense, and possession of cocaine, heroin or another narcotic (less than 25 grams) Sept. 23 in Gilford Township. He was also convicted of being an habitual offender (three or more prior felony convictions).

In addition to jail time, he was placed on 60 months probation and ordered to pay costs and fines totaling \$1,576 plus attorneys fees of \$500.

*Jessica L. Cox, 27, Vassar, pleaded guilty to one count of child abuse, second degree, stemming from an incident between Jan. 1, 2016, and June 10, 2016, in Vassar Township.

A pre-sentence investigation was ordered and bond was continued at \$5,000. Sentencing is to be

*Martin A. Perlaki, 64, Cass City, was sentenced to 167 days in jail and 18 months probation following his plea of guilty to violating the Sex Offenders Registration Act by failing to register within the month of January in Ellington Township. He was also convicted of being an habitual offender (one prior felony conviction).

But I digress.



Who knows, maybe I'll even have two portions.







Cass City School officials announced the hiring of Osentoski and Gehring in conjunction with a new "team teaching" approach to the junior-senior high school's agriculture/FFA programs.

Osentoski will teach agriculture and science courses and serve as FFA advisor, while Gehring will teach agriculture classes and manage the Cass City Ag Learning Lab.

The two hires filled vacancies left by the resignations of teachers Craig Weaver and Russell Weyer.

Osentoski has taught in the Capac School District for the past 16 years, while Gehring is a recent Michigan State University graduate from the Harbor Beach area.

the program are non-violent offenders who are able to receive community-based services," she said. "They are supervised by court staff, and their ages have ranged from 13 to 18. There are 14 youth involved in the summer program through the court."

"The initiative of the art and science program is to encourage our youth to use their talents in positive ways. We want the community to embrace this change of direction for our juveniles and to encourage their viewing of the... garden," said Thane.

Aside from the park, the court also maintains an in-house educational program for high school students who are lagging behind on their credits for graduation. Those students are also participating with the park.

"As an incentive for engaging in both programs, youth are able to work off their court fines and learn about much needed life skills," Michalak said. "Furthermore, youth that successfully complete the program will earn a trip to Michigan Adventure."

Once the park is completed, Michalak said, the juveniles will continued to manage it, working in the gardens and handling other chores.

Court officials hope to expand the initiative in the future.

"This program serves as positive engagement with the youth, bridges gaps in the community and allows the youth to have ownership in the community where they live," Michalak said. "It beautifies the county and is a continuing effort that is long-lasting."

Tuscola voters set to decide funding for patrol, seniors

If approved, the millage would be levied starting this year (providing increased funding starting in 2018) and would remain in effect for eight

The senior citizens millage, meanwhile, currently consists of a tax of .2 of a mill, generating \$348,000 annually and costing the owner of an \$80,000 home about \$8 per year. Human Development Commission (HDC) officials are requesting an increase of .12 of a mill – also for the next eight years - which would raise an extra \$208,000 and cost taxpayers an additional \$5 per year, Hoagland explained.

Road patrol

Sheriff Glen Skrent says the increased road patrol funding would enable his department to ensure adequate staffing levels to continue providing Tuscola County's only 24-hour-a-day countywide law enforcement presence year-round. The funding would also upgrade the department's ability to respond more quickly to investigations involving missing persons and bomb threats, he noted.

Skrent is proposing hiring four additional deputies as well as establishing a K-9 unit.

The need for more money is attributable to the local economy, with fewer citizens residing in Tuscola County and home values dropping, resulting in less property tax revenues, according to the sheriff.

"If we have no millage money coming in, the entire road patrol would be laid off, as it was in 1988. There is no general fund money to fall back on," Skrent pointed out. "If it were not for the windmill revenue, we would not be able to function even right now as a 24-hour road patrol. However, windmill revenue declines every year automatically."

Even if voters renewed only the .9 of a mill, Skrent said, "I can't guarantee the road patrol would be able to be 24 hours a day through the life of the millage. We are at minimum staffing now, and losing any more positions would mean no 24-hour coverage.

Skrent said the number of calls his officers respond to annually has remained in the 5,000 range, but the number of calls involving serious crime and medical emergencies has increased.

In addition, "There are many times in our current schedule where we only have one car on the road," he added, noting Tuscola County encompasses more than 816 square miles, frequently making it difficult to arrive on the scene of an accident, crime or other incident as quickly

Funding for additional manpower will address several concerns, Skrent

"We have had incidents where it was necessary to search for missing children and Alzheimer's patients, and a dog from another jurisdiction was very far away. Time is critical in those situations," he explained. "I believe our first and foremost duty is to protect the public. Having the dog available to clear a school quickly (during) a bomb threat, and having the K9 officer visit children in schools would be a great tool to have.

"Last year deputies assisted local police jurisdictions over 500 times, and I feel it's a safety issue for them, as well, if the deputies are not there to back them up," he continued.

"Keeping up with technology is very expensive; body cameras, body armor, health and liability insurance all cost a lot of money and, as you know, costs keep going up," Skrent continued. "Deputies have taken cuts in their benefits. Pensions have been eliminated in lieu of defined contributions. We apply for as many grants as possible.'

Senior citizens millage

According to Hoagland, HDC officials have also outlined specific uses for the extra funding they've requested.

Their proposal calls for spending \$156,000 more on the home-delivered meal program, \$11,000 for senior transportation services, and \$33,000 for adult day care services.

"The proposal would add an additional day of home-delivered meals, which would eliminate the current waiting list for meals and allow service to all those currently in need," Hoagland said.

"The additional amount requested for transportation would provide transportation for non-emergency medical, such as out-of-town testing and chemotherapy," he added. "Adult day care services - at the HDC day care facility – would be strengthened by adding an additional day of operation."

They played from 1:15 until after 8 p.m. on Sunday without a break, winning four in a row," he said.

Heat management tips

As summer turns toward the beginning of fall sports practices next week, the Michigan High School Athletic Association is providing a familiar but vital reminder that student-athletes need to prepare for activity in the hot weather that traditionally accompanies the beginning of August and the first training sessions of the school year.

Each year, the MHSAA provides information to its member schools to help them prepare for hot weather practice and game conditions during the late summer and early fall. Football practice can begin at MHSAA schools August 7, followed by first practices for all other fall sports August 9.

The topic of heat-related injuries receives a lot of attention at this time of year, especially when deaths at the professional, collegiate and interscholastic levels of sport occur, and especially since they are preventable in most cases with the proper presentions

with the proper precautions. "We emphasize preparation for hot weather at the start of each fall, but this cannot be repeated enough: If we take precautions and plan as we should, heat illness is almost always preventable," said John E. "Jack" Roberts, executive director of the MHSAA. "We encourage student-athletes to come to their first practice prepared for hot conditions. But coaches also are trained to assume not all student-athletes will be ready, and to be vigilant in making sure all participants are hydrating

properly."

A number of member schools continue to follow the MHSAA's Model Policy for Managing Heat & Humidity, which while not mandated for member schools was adopted as a rule for MHSAA postseason competition in 2013. The plan directs schools to begin monitoring the heat index at the activity site once the air temperature reaches 80 degrees and provides recommendations when the heat index reaches certain points, including ceasing activities when it rises above 104 degrees.

The model heat & humidity policy is outlined in a number of places, including the publication Heat Ways, which is available for download from the MHSAA Website on the "Health & Safety" page at

www.mhsaa.com/Schools/Health-Safety-Resources.

To also assist in acclimatization, football practice rule changes adopted in 2014 allow for only helmets to be worn during the first two days, only shoulder pads to be added on the third and fourth days, and full pads to not be worn until the fifth day of team practice. The policy in detail can be found on the Football page of the MHSAA Website

"With the team entry fees and the home run derby and concessions, we probably took in between 7,000 and 7,500 dollars. It's a little early for final numbers," he said Monday morning.



rules meetings for coaches and officials. The online presentations discuss the need for good hydration in sports, regardless of the activity or time of year, and informs both how to recognize the early signs of heat illness and the immediate steps to take to respond to those symptoms. The MHSAA requires all head varsity, varsity assistant and subvarsity coaches at the high school level to complete the rules and risk minimization meeting requirement.

The first days of formal practices in hot weather should be more for heat acclimatization than the conditioning of athletes, Roberts reminded, and practices in such conditions need planning to become longer and more strenuous over a gradual progression of time. He noted that schools also must consider moving practices to different locations or different times of day, or change practice plans to include different activities depending on the conditions.

Roberts also noted that studentathletes should make sure to hydrate all day long – beginning before practice, continuing during and also after practice is done. Water and properly-formulated sports drinks are the best choices for hydration, while energy drinks, high-carbohydrate fruit juices (greater than eight percent carb content), carbonated and caffeinated beverages are among those that should be avoided.



and are not handicap accessible on the second floor.

"Long-range plans are to be able to add pre-kindergarten classes with those classrooms that we don't offer now."

Also, the bond money would fund a new drop-off and pick-up loop near the new elementary wing, and allow for main entrance renovations as well as heating and cooling upgrades.

The maximum number of years a bond may be outstanding, exclusive of any refunding, is 20 years. The request for the sinking fund would allow the district to save up money for items such as the purchase of property, construction or repair of school buildings, school security improvements and tech-

"If approved, it would generate about \$490,000. It would be earmarked for those issues so the money would not have to be taken out of the general fund," Candela explained. "It would help us to be able to update our gym. We need a new floor and bleachers, roofs, technology and security improvements."

If the two ballot issues are approved, they would cost the owner of a home with a \$75,000 market

value about \$64 a year for the bond and \$75 for the sinking fund

about \$67,000 the first year.

The two-mill tax equals \$2 per \$1,000 of taxable value. So, if the millage is approved, it would cost the owner of an \$80,000 home roughly \$80 a year based on its taxable value.

"It is a new millage, and if approved, can only be spent on road improvements," Kramer pointed out. "It is really important for residents to understand that money can only be spent on roads and nothing else." The township currently levies two mills for roads, but more money is

needed to do the necessary improvements.

"Some of the roads residents asked to be improved (are) White Creek Road, the Mayville Road, and Marlette Road," he said. "White Creek Road needs to be repaved. Some of the other work is stone patching and doing graveling.

"Those at the annual meeting really stressed they wanted roads im-

It costs about \$120,000 to pave one mile of road with a three-inch base. Putting down a mile of stone costs about \$36,000, and it's estimated it will cost between \$18,000 and \$20,000 for gravel.

Kramer noted the Tuscola County Road Commission offers a \$25,000 incentive towards road work for qualifying roads, but he isn't sure the money can be used for the White Creek Road project. Koylton Township has about 50 miles of roads.





"A search warrant of the Bad Axe man's North Van Dyke address in Sheridan Township was served the following day, which resulted in the confiscation of 83 non-compliant medical marijuana plants," Hanson said. "However, several other compliant medical marijuana plants were left behind."

During the course of the arrests, deputies confiscated a Cadillac Escalade, recording equipment and cash.

"The investigation has been ongoing since and will continue, with further charges likely being requested. Assisting us with this investigation was the Bad Axe City Police," Hanson noted.

Tuscola Co. men sentenced

HURON COUNTY — Huron County Circuit Judge Gerald Prill recently sentenced two Tuscola County men in separated cases.

Scott A. Heckroth, 46, of Caro, pleaded guilty to one count of larceny in a building. He was also convicted of being an habitual offender (two prior felony convictions).




