Lack of insurance puts an end to Pinktober

Pinktober is no more.

The decision to abandon the popular celebration of supporting breast cancer awareness and research has nothing to do with a lack of interest - either among organizers or the hundreds of people it drew to various events in Cass

In fact, concerns over liability are at the heart of the matter. Specifically, the Cass City Chamber of Commerce's insurance carrier informed chamber officials that it will no longer insure Pinktober

Although the chamber hasn't served as sponsor of the celebration or been involved in the organization of activities associated with the observance, it has provided insurance coverage for the event over the past several years.

"As far as I know, they're not going to have anything," Cass City Chamber of Commerce Administrator Judy Keller said of what has become a familiar fall tradition in Cass City - the only community in the region to host such a celebration. "Our insurance company said we can no longer carry the insurance...because (Pinktober) is not a chambersponsored event.

'We have to do an audit every year, and they (insurance company) came back to us last year and said they can't cover it anymore," Keller added. "It's not a chamber decision. It came from the insurance company. We didn't have a choice.

"I don't know – if another group that has insurance could take it on, then they could" host Pinktober.

Keller said the chamber spends more than \$1,000 a year for insurance coverage related to its own events, including the Cass City Freedom Festival and Christmas in the Village. Taking on Pinktober and its various activities would cost more, she noted.

Keller could not estimate how much more, but indicated it's not a question the chamber intends to explore.

"If one of the other (organizations) wants to pick it up, that's fine, but the chamber isn't willing or able to pick it up," she said. "The chamber needs to focus on business."

The way Joey Kreeger figures it, Pinktober has been an effective tool in serving local businesses as well as promoting awareness of breast cancer and raising literally thousands of dollars donated to various causes, including the American Cancer Society.


"When was the last time you saw 700 people walking on our sidewalks?" Kreeger asked, referring to the estimated attendance during last year's Pink-or-Treat activity, during which youngsters and their families are invited to "trick-ortreat" downtown, courtesy of the business community, volunteers and others.

"In my opinion, the Pink-or-Treat should be a chamber event," said Kreeger who spearheaded the celebration about eight years ago.

Kreeger went on to recruit a small but dedicated group of volunteers who each organized different activities, and Pinktober blossomed into a month-long observance that has included fundraising events, contests and breast-cancer awareness promotions.

Those activities included a Pretty in Pink Girls Night Out, Pinktober Talent Show, Pink-or-Treat in the streets, the Glow 5K Run/Walk, a cutest kids contest, and Volley for

ATV crash claims life

Gagetown resident Scott R. Woidan was scheduled to exchange vows with his fiancé, Christine Tate, also of Gagetown, this month. Instead, Woidan's family buried him last week after the ATV he was operating collided with a deer.

The bizarre accident occurred during the evening hours of Aug. 13, about a mile south of Gagetown in Tuscola County's Elmwood Town-

Troopers from the Michigan State Police post in Caro were initially dispatched at about 10 p.m. to investigate a reported missing person.

During the course of the investigation, officials "pinged" Woidan's cell phone – a process in which the approximate location of a cell phone can be located by utilizing multiple cell towers - which led officers to an area near Hobart and Cedar Run roads. Troopers located Woidan, 30, who was deceased at the scene, along with the deer.

Michigan Department of Natural Resources (DNR), Tuscola County Sheriff's deputies, MSP Technical Services, Cass City MMR, Bartnik's Towing and the Tuscola County medical examiner all assisted troopers at the scene.

Woidan, formerly of Cass City, was a 2006 Cass City High School graduate. A complete obituary is published in this week's edition of the

Adam R. Village officials fill vacant council seats

Once again, the village of Cass City has seven representatives on its council.

Two trustees were appointed to the council by four of the five council members during a special meeting early last week. Selected were Nancy Barrios, who formerly served on the council, and newcomer Robert Piaskowski. They fill vacancies left by the resignations of trustees Steve Erickson in May and Mark Karwowski in June 26.

Barrios, who served on the council from October 2011 until 2016 when she launched an unsuccessful bid for a seat on the Tuscola County Board of Commissioners, was appointed on a vote of three to one, with Trustee Tom Herron casting a no vote.

The council unanimously approved Piaskowski's nomination. Both new trustees took the oath of office during the special session.

Others who vied for the trustee positions were Dan Delamater, Nancy

Hrabcak and Eugene Wilson II. Those who conducted the interviews and approved the appointments to the council were village President Carl Palmateer and trustees Marilyn Biefer, Tom Herron and Jenny Zawilinski. Trustee Mick Kirn was

not able to attend. The next regularly scheduled council meeting will be 7 p.m. Monday, Aug. 28, at the Cass City Municipal Building.

Damage minimal in Owendale plant fire

Although fire struck the BAMP Marketing and Consulting Inc. building in Owendale last week, it will be business as usual at the dry-edible bean processing facility, located on Vita Plus property at 3580 Fourth St.

Fire ignited in the storage facility's conveyor system Aug. 14 at about 12:30 p.m.

"The fire damage was very minimal. It was contained to the shoot that was being repaired," said Mike Eisengruber, who owns BAMP Marketing and Consulting Inc. "I want growers to know that we will be ready to handle the dry bean harvest."

Investigators determined a weld-

ing accident started the fire. A local company was welding a shoot on the conveyor system of the storage facility when the rubber liner inside caught fire.

Tornado touches down near Kingston

Clean-up from the aftermath of last week's storm is continuing in Sanilac County.

A tornado warning was issued late Thursday afternoon for southern Tuscola County and northern Sanilac County. Trained weather spotters took photos of funnel clouds, and on Friday the National Weather Service (NWS) confirmed a tornado did touch down.

"It was an EF-0 tornado (minor). The path was about 100-yards wide and about three miles long. Most of the damage was minor, with trees (and) wires (down), shingles blown off, and a camping trailer was dam-

Chamber should take another look at event

You may or may not have heard that Cass City's "Pinktober; A Community with a Cause" event has been axed this year due to a lack of liability insurance which has been provided by the village's chamber of commerce in past years.

Chamber officials say it was an insurance company decision – not a chamber decision – to no longer cover Pinktober because the event isn't technically a chamber event.

Chamber officials have also indicated they don't intend to make Pinktober a chamber-sponsored event, saying they want to focus more on supporting local businesses.

We believe the chamber board should take another look at this issue for several reasons.

Start with the fact that businesses in a small town need customers to survive, and while drawing crowds to the village in the name of Pinktober won't guarantee sales, it will guarantee exposure to local merchants' goods and services.

Isn't that an effective way to support local businesses? Pinktober has also provided a windfall of sorts for the chamber, in that a small group of very dedicated volunteers has done all the work – the organizing, making the necessary phone calls, and handling all of the fundraising required to make Pinktober one of the most successful, sustained activities in this community for the past seven

years or so.

And let's not forget what Pinktober is all about – supporting breast cancer research – to the tune of thousands of dollars each year – along with celebrating the lives of breast cancer survivors and honoring the memories of those who lost their battle to this dreaded disease.

It seems to us that demonstrating support for this sort of effort could shine only a positive light on our local businesses, although many of them already deserve a pat on the back for quietly joining others in making financial donations toward the cause.

It's no secret Pinktober has been a huge success, including the popular Pink-or-Treat event that drew 700 or so people to the downtown area last year. That's a testament to the organizers, all of the participating businesses, and to the willingness of a community to get behind an important cause.

It could also serve as a testament to the Cass City Chamber of Commerce, if the board and administrator get on board with doing what it takes to keep this annual fall celebration going this year and for years to come.

It would be interesting to hear our business owners' take on the predicament facing Pinktober organizers.

Hopefully, they will contact chamber board members and voice their opinions one way or another. If you agree that the chamber should stick with other avenues to support the local business community, fine. If you believe chamber officials should get behind Pinktober, let them know.

After all, it's your dues that enable the chamber of commerce to exist.

I tried being a blond for a while because I was sup-


I tried being a blond for a while because I was supposed to have more fun, according to the commercials. That didn't happen.

On the following day, someone allegedly representing FedEx came to the door and left a note saying it was a mistake and wanted the computer back.

The residents contacted Best Buy where the laptop was purchased and discovered someone had accessed their personnel information and ordered the computer with the resident's credit card and address. The suspects then had the laptop sent to the residence so they could pick it up, pretending to be with FedEx.

Sheriff officials advise if this scenario happens to you, call 911 to report it. The scam, according to online research, has been happening in other areas also.





Rogue drone hampers FlightCare landing at scene of fatal accident

Troopers from the Michigan State Police post in Caro say a drone delayed the landing of a medical helicopter at the scene of a fatal traffic accident Thursday in Tuscola County's Indianfields Township, and the operator could now face charges.

Troopers were dispatched to the scene of the crash – M-81 near Prospect Avenue – at about 4:50

Rain was falling at the time of the accident, according to reports, which state the driver of a passenger vehicle was traveling west on M-81 and, due to speed and poor tire condition, the driver lost control on the wet roadway and entered the path of an eastbound pickup truck.

Troopers identified the driver of the passenger vehicle as Michael

T. Millerov, 49, of Grand Blanc. He was extricated from his vehicle using the Jaws of Life, and then transported to an area hospital by FlightCare Helicopter.

Millerov died a short time later as a result of the injuries he suffered in the crash. Troopers reported it appears he was not wearing his seat belt at the time of the crash. His passenger, a 19year-old Akron man, suffered minor injuries and was treated at a local hospital and then released.

The driver of the pickup, a 26year-old Clarkston resident, was not hurt, nor was his two-year-old passenger, who was properly restrained in a child restraint seat. The child was transported to an area hospital for evaluation and later released.

Troopers were assisted at the scene by Mobile Medical Response (MMR), the Caro Fire Department and deputies from the Tuscola County Sheriff's Office.

During the investigation, troopers noted, an unmanned aircraft (drone) was discovered to be flying over the crash scene as Flight-Care was making its final approach to land at the accident scene. The helicopter crew was forced to abort its landing, which was then delayed while officers located the operator and secured the drone.

Troopers remind those operating drones to avoid flying in the area of traffic crashes, as many times helicopters are used to transport injured subjects from crash scenes.

Troopers said they will be preparing a report regarding the incident to be reviewed by the Tuscola County Prosecuting Attorney's Office and the Federal Aviation Administration (FAA).

One of Maxson's co-defendants, Tyler J. Meffer, 23, Cass City, pleaded guilty to delivery/manufacture of cocaine, heroin or another narcotic (less than 50 grams), which is punishable by up to 20 years in prison and/or a \$25,000 fine, and possession of cocaine, heroin or another narcotic (less than 25 grams), a fouryear felony also punishable by a fine of up to \$25,000.

A third count – delivery of a controlled substance – causing death - was dismissed. That offense carries a maximum penalty of life in prison or any term of years.

A pre-sentence investigation was also ordered for Meffer and his bond was continued at \$50,000. Sentencing is to be scheduled.

The third defendant, Edward Dontae Forte, 37, of Saginaw, is awaiting his next appearance in court. Forte is charged with one count of delivery of a controlled substance - causing death, and one count of delivery/manufacture of heroin (less than 50 grams).

Deputies found Dennis deceased at about 12:20 a.m. April 20 at a home on Dodge Road in Elmwood Township. Investigators reported Dennis died of drug intoxication, but noted "the manner of death is indeterminable.

Based on evidence collected by deputies at the scene, heroin was suspected to be the cause of the overdose, according to Tuscola County Undersheriff Bob Baxter.

Overdoses involving opioids have reached epidemic levels, prompting health departments to distribute Naloxone/Narcan, a drug used to reverse the effects of opioid overdoses. Tuscola County Behavioral Health System (TCBHS) is among the agencies that are making Narcan kits and instruction in how to use them available to the public free of charge.

An increasing number of overdoses in the Thumb has law enforcement officials prosecutors concerned along with health officials, especially with reports of drug investigations involving the potent synthetic opioid fentanyl, and the even more powerful drug carfentanil surfacing earlier this year in Huron and Sanilac counties, respectively. Both drugs are known to be used to "cut" or mix with heroin before being sold on the

"It's frightening right now. It's absolutely frightening, what's happening – and trying to get a handle on it," said Tuscola County Prosecutor Mark E. Reene

"I'm not sure that we've faced a greater crisis, in recent memory, than this," he added. "It's (illicit drugs) taking lives in record num-

In an effort to coordinate Michigan's efforts to combat the ongoing opioid epidemic, Gov. Rick Snyder last week signed Executive Directive 2017-2, establishing the Council on Opioid and Prescription Drug Enforcement

The council, which was recommended by the Michigan Prescription Drug and Opioid Abuse Task Force, will address, develop and maintain relationships among local, state and federal agencies charged with enforcing the laws and regulations.

"We must ensure all partners are working together effectively if we are going to combat this epidemic and protect all Michiganders," Snyder said. "This council will open up the lines of communication and allow for a better use of resources while working to reduce opioid abuse and prevent addiction from occurring in the first place."

Lt. Gov. Brian Calley will lead the council, in conjunction with the directors of the Michigan Department of Licensing and Regulatory Affairs and the Michigan State Police.

The council will coordinate with the Michigan Attorney General's Office, U.S. Drug Enforcement Administration, the Prosecuting Attorneys Association of Michigan, and other relevant agencies involved in the enforcement of laws and regulations related to opioids for their input and participation on this council.

"The opioid epidemic is destroying lives and families every day," Calley said. "It is an emergency and we need to go above and beyond to combat it. I'm proud to lead this council and improve coordination among everyone involved so that we can save more lives and prevent addiction from occurring.

Michigan has seen a dramatic increase in opioid-related deaths. From 1999-2015, more than 4,400 people have died from an opioid overdose, with more than 50 percent of those deaths occurring since 2010.



"I want bean growers to know that we will be ready to handle their harvest with business as usual," said Eisengruber. "If they have any questions, just call."



a Cure (hosted by the Cass City Junior-Senior High School volley-ball team). In addition, a number of local businesses annually decorated their windows in a contest seeking the best breast cancer awareness message, and area kids – 150 last year – took part in their own poster contest, with their work displayed in the windows of empty businesses downtown.

The events proved not only popular, but also effective. For example, last year's Pretty in Pink Girls Night Out alone generated nearly \$10,000

A portion of the money raised each year was earmarked for the Love for Lexi Paying It Forward Fund, which was established in 2012 following the death of Alexis "Lexi" Jade Smith, the daughter of Heidi Hartwick of Cass City and Randy Smith. The youngster was diagnosed with an inoperable brain tumor earlier that same year.

The tragic loss prompted a small group of parents and others to establish a fund that would not only honor Lexi's memory, but also assist other local families caring for a child diagnosed with cancer. The Cass City Lions Club also stepped in to help the group by handling the money donated to the group. Donations are now held in a fund through the Tuscola County Community Foundation.

"The community was amazing" in supporting Pinktober events, said Kreeger.

Unfortunately, she added, while the organizers/volunteers have always done their own fundraising, they never formed any sort of formal organization in order to carry liability insurance – and none of the individuals involved can afford to take that responsibility on themselves.



Turning to the Cass City men's team, CarLee Stimpfel and Zane Wright will lead a group of 10 re-




"We lost only senior Chase Winter from last year's roster and have three freshmen and one sophomore joining the team," Zdrojewski said.

aged," said Meteorologist Alex Manion.

The tornado touched down near M-53 and M-46. At one residence, a camping trailer was picked up by the wind and smashed upside down on a neighboring yard.

"The tornado touched down 2.6 miles southeast of Kingston and 4.2 miles east of Kingston," noted

"All of the damage that was shown on televised news reports was in Sanilac County, just outside of our county," said Tuscola County Emergency Management Director Steve Anderson. "In our county, the only damage was in the Millington area at the high school with a downed tree.'

Most of the property damage in Sanilac County was along Marton Road, and the camper trailer that was damaged was located off Harrison Road, Manion said.

The National Oceanic and Atmospheric Administration's (NOAA) Fujita Tornado Damage Scale classifies tornadoes into the following categories: EF-0 (weak - winds of 65 to 85 mph), F-1 (weak — 86 to 110 mph), EF-2

(strong — 111 to 135 mph), EF-3 (strong — 136 to 165 mph), EF-4 (violent — 166 to 200 mph), and EF5 (violent - more than 200 mph).

Some Millington residents are still recovering from a tornado that caused extensive damage in July 2015. That same year, a tornado touched down Aug. 2 in the village of Owendale, causing damage to a couple of businesses in the downtown area and to the high school.





Early beet harvest is approaching

With the sugar beet harvest

month, there is a flurry of activity at Michigan Sugar factories in the Thumb.

The finishing touches are being put on upgrades and seasonal hiring for the 2017 sugar processing campaign is underway.

"Michigan Sugar Company is making progress on numerous capital projects being installed throughout the cooperative. Upgrades are being made to all facets of our business, including additional ventilation equipment, a new pulp press, a new first carbonation tank, new packaging equipment, a juice softening system and much more," said Ray VanDriessche, Michigan Sugar Company's director of community and government relations.

"We appreciate the support we receive from our board, shareholders and many other partners as we continually reinvest in our facilities."

Among the upgrades in the works are additional ventilation being installed at the piling grounds in the Ruth area, a new pulp press and first carbonation tank is being installed in the Sebewaing factory, and a juice softening system and new packaging equipment are going into the Croswell factory.


The company's capital investment for 2016 and 2017 is estimated at \$25 million.

Because sugar beets like hot days, cool nights and moisture, the wet summer hasn't had the same impact on beets that it's had on some of the other crops.

"In general, a minor percentage of the overall acreage was lost or damaged by the heavy rains, but obviously some growers were impacted more severely in those areas that received the heaviest amount of rain," said VanDriess-

"We did not test for sugar when we pulled our first sample. The current estimated tonnage is 29 tons per acre. This estimate will adjust accordingly as we pull additional samples."

According to VanDriessche, the early harvest is expected to begin the last week in August.
