Ben's clears hurdle in plans for new grocery

Cass City Village Planning Commission okays preliminary site plan for construction of bank branch inside new store.

Plans to incorporate a Frankenmuth Credit Union branch within the new Ben's Supercenter store slated to be constructed on the former Erla's Food Center property in Cass City cleared one hurdle during a special Cass City Planning Commission meeting Thursday night.

After about 30 minutes of discussion, the planning commission unanimously approved a preliminary site plan for construction of the bank branch inside what is expected to be named "Ben's Fresh Neighborhood Market".

The approval is contingent on developer Jim Zyrowski securing a zoning variance allowing a bank drive-through feature to be constructed within less than the 60foot setback requirement in the village zoning ordinance.

David Marr, project manager with TSSF Architects Inc., Saginaw, explained the bank branch would be located in the southeast corner of the store and would feature a drive-through banking option utilizing a narrow strip of land previously used for parking.

There is adequate space for two lanes of traffic (one for the drivethrough and the other for bank customers to pass those in the drive-through lane), according to Marr, who noted the grade of the land would be lessened and a full curb and gutter installed on the south border along Church Street.

Among the concerns voiced by planning board members was adequate space for two lanes of traffic in the drive-through area, and whether the close proximity of exits serving the bank and store would cause traffic issues. Marr assured officials that the available space is adequate, and he suggested that specific entrance and exit lanes should be established in the store's main parking lot.

Zyrowski, president of the Marlette-based Ben's Supercenter Inc., announced last spring that he was ready to move forward with plans to gut and renovate the former Erla's building and open a full-service grocery store.

Zyrowski, whose announcement came more than a year after purchasing the Erla's building in the fall of 2015, previously expressed interest in building a new store on property located across from the Shell station on the former Croft Clara property along Main Street. Negotiations followed with representatives of Frankenmuth Credit Union, which owns the property, but an agreement never material-

"The cost ended up being too high for that project," Zyrowski said at the time. "Our intention now is to go back into the existing Erla's building and completely revamp it – completely reface it inside and out – and restore what the Erla's family started years ago.

A representative of Frankenmuth Credit Union who was on hand for Thursday's planning commission meeting said the credit union was planning to build its new branch

on the former Croft Clara property, but opted instead to become part of Zyrowski's new store because of the community interest in Please turn to page 16.

Area schools collect more funding

Michigan lawmakers recently approved additional school funding following years of stagnate or moderate per-pupil funding.

According to state Rep. Dr. Edward J. Canfield (R-Sebewaing), schools will see an increase in perstudent funding of between \$60 and \$120, and high schools will get an extra \$25 more per student

Funding has been a struggle for some districts since 1994 when Proposal A revamped school funding from a property tax levy to a per-pupil foundation allowance funded by an increase in state sales tax.

This year's funding hike means the Cass City Public Schools will receive \$233,532.

Cass City School Supt. Jeff Hartel says he knew about the funding change several months ago, so the increase was built into the local district's 2017-18 budget, which was drafted in June and went into effect July 1.

"It's good news. Enrollment has been decreasing, but some district's say the increase isn't enough because it is offset by the expense of complying with unfunded mandates," said Hartel. "The increase certainly helps, but we still have to watch spending." Hartel noted about 10 years ago

Fall Family Days

Thousands expected for 22nd annual celebration

It's been more than two decades since the first Fall Family Days celebration took place at the Thumb Octagon Barn near Gagetown.

That inaugural festival came about thanks to a group of hard working volunteers who hosted some 300 visitors while working towards a common goal; to repair and renovate the historical eight-sided barn that former Gagetown banker James Purdy contracted to have built in the

Folks planning to attend the 22nd annual Fall Family Days at what is now called the Thumb Octagon Barn Agricultural Museum, can look forward to seeing nothing short of a complete transformation of the old Purdy family farm, including that unique barn and nearby farmhouse, all part of what is now known as the Thumb Octagon Barn and Agricultural Museum.

They should also be prepared for plenty of company, as Fall Family Days officials say they would like nothing better than to see attendance top the average 15,000 people who have attended the two-day celebration in recent years.

This year's festival is slated for Saturday and Sunday, Sept. 9 and 10.

The Thumb Octagon Barn and Agricultural Museum is located 1 ½ miles east of Gagetown and one mile north in Tuscola County, just south of the Huron County border at 6948 Ritchie Rd. Daily gate admission is \$5 (six years and older), and all activities/events will be open both days from 8 a.m. to 5 p.m. No pets are allowed.

Free tractor driven wagon shuttles are provided to transport people to and from the parking areas to the site; handicapped shuttles are also available.

The theme for 2017 is Grain Elevators, and there will be tent presentations on that theme throughout the weekend.

The Friday night fish fry tradition will continue this year from 4 to 7 p.m. Sept. 8 in the Munro Building, with Greg Talaski of Kinde preparing the fish. The menu also includes baked beans, potatoes, vegetable, cole slaw and dessert. The cost is \$10 for adults and \$5 for kids ages six to 12 (free for children under five).

Saturday's events will include opening ceremonies at 8:30 a.m. Food and refreshments will be available in the Munro Building from 10 a.m. to 6 p.m., and there will be traditional country music from 11 a.m. to 5 p.m., followed by more music in the barn from 7 to 9 p.m.

On Sunday, a Gospel hymn sing will get underway at 10 a.m., and there will be more traditional country music from 11 a.m. to 5 p.m.

Daniel Wood





Remind your college student to get a shot

Cooler temperatures are a harbinger of not only fall in Michigan, but also the coming of flu season, which means it's time to start thinking about taking a few minutes to get a flu vaccination.

And while the very young and the very old are among those most susceptible to serious and even life-threatening cases of influenza, we're joining with state health officials in recommending that parents remind their college students to protect themselves as well.

The Michigan Department of Health and Human Services (MDHHS)is again partnering with colleges and universities across the state to increase flu vaccinations among young adults. Each year, several healthy, young adults in Michigan die from the flu.

Influenza vaccination is the single best way to prevent influenza infection.

According to data from the Michigan Care Improvement Registry (MCIR), adults ages 18 to 24 years have the lowest flu vaccination coverage rate.

Centers for Disease Control and Prevention (CDC) data last fall showed that, as of early November, only about two out of five people in the United States had reported receiving a flu vaccine.

At the time, officials reported the vaccine offered substantial benefit during the 2015-16 season by preventing an estimated five million flu illnesses and 71,000 flu hospitalizations.

College students have unique risk factors that make them more susceptible to getting sick, such as close contact in dormitories and classrooms.

In an effort to raise flu vaccination among this age group, MDCH launched the inaugural College Flu Vaccination Challenge in 2015 among Michigan colleges and universities. School health centers are again volunteering this year for a friendly competition among each other to see who can get the highest percent of their students vac-

The 2016-17 flu challenge winners were Calvin College (small school), Wayne State University (medium) and the *University of Michigan (large).*

This year's challenge runs from August 2017 through March 2018. The winning schools - small, medium and large – will be determined based on student self-reported vaccinations and each school's undergraduate population.

Competition aside, the flu doesn't have to be a serious health risk if you follow the Centers for Disease Control and Prevention (CDC) recommendations, which include a flu vaccine for everyone ages six months and older as the first and most important step in protection against this disease.

There's no reason not to get a vaccine and certainly no lack of opportunities – vaccines are available at doctors' offices, clinics, pharmacies, and a number of other locations.

Sure, for many healthy people the flu can be little more than a blip on their fall and winter radar. Just keep in mind that five to 20 percent of this nation's population is infected with the flu annually, with an average of 226,000 hospitalizations and more than 23,000 deaths.

Then, he was gone. His tricycle sets tipped on its side under the pine tree.


His swing sets unused. His little feet are just indented memories in the sand-



Goose hunting season is underway until Sept. 30, and the new rules on dark goose and light goose aggregate bag limits apply.

Hunters can harvest five dark geese per day in September, only one of which can be a brant. All five dark geese harvested can be Canada geese. After Sept. 30, hunters still can harvest five dark geese per day; however, only three of those can be Canada geese, and only one can be a brant.

Three Canadian geese can be harvested daily after Sept. 30, and the remainder of the aggregate daily bag limit can be filled with two white-fronted geese or a white-fronted goose and a brant. An aggregate bag limit is also in place for light geese, including snow, blue and Ross's geese. Hunters may harvest 20 light geese per day during goose seasons.

Sheriff introduces new deputy

Although the tax money voters approved for the Tuscola County Sheriff's Department Road Patrol won't be available until next year, Sheriff Glen Skrent has already started the process of improving his department's coverage of county roadways.

Skrent last week announced the hiring of new Deputy Trent Bellamy as part of his plan to beef up the road patrol.

Bellamy is a longtime resident of Tuscola County and attended Delta College before working for the Detroit Police Department since January, Skrent

County voters last month approved replacing the current sheriff's road patrol millage levy of .9 of a mill with a new, increased levy of 1.33 mills for eight years in a vote of 5,280 to 3,166.

The expanded road patrol millage will enable the sheriff's department to add four additional road patrol officers as well as a fifth officer with a canine partner. The funding will allow for two patrol units to be on the road per shift instead of just one to cover the county's 816 square miles.

Because of retirements, out of service disabilities, and job openings, there was some money left in this year's budget to hire the first of those deputies.

Pennsylvania man sentenced on charges from Sanilac traffic stop

One of the two people from Pennsylvania who were arrested last spring in Sanilac County on drug charges has been sentenced. Joshua Boston, 29, Bridgeville, Penn., was ordered to serve 180 days in the county jail, with credit for 106 days already served, following his conviction on charges of possession of a controlled substance (less than 25 grams), and

fleeing a police officer. He was sentenced to 93 days in jail for operating a motor vehicle while impaired. The sentences are to run concurrently and may be served in a residential treatment

The charges stem from what started out as a routine traffic stop April 26 and ended with what law enforcement officials described as a significant drug bust.

Windy Baker, 34, of Washington, Penn., was with Boston in the vehicle and was also arrested.

According to court records, the pair were returning home from visiting relatives in Huron County when Troopers from the Michigan State Police post in Caro attempted to stop their vehicle for speeding in Lamotte Township.

When the vehicle initially failed to stop, a short pursuit followed. After the vehicle came to a stop, troopers searched it and found 270 bundles of heroin and 20 grams of

Baker was charged with possession of a controlled substance (less than 25 grams). When she did not appear for her court date, a bench warrant was issued for her

Here's an idea: Marriage first?

Maybe it's because I'm old fashioned, or maybe it's just because I'm old, but I cringed a little at a recent press release from the Michigan Department of Health and Human Services (MDHHS), urging families to give their children the "dadvantage" by establishing paternity at birth.

"When a baby is born, establishing legal fatherhood – called paternity - can give the child a better sense of identity and ensure financial and emotional support from both parents so that the child's needs are met," says Erin Frisch, director of MDHHS's Office of Child Support.

The release goes on to say that children who have a legal father also have a right to their parents' benefits, such as health insurance and Social Security, and can stay healthier through knowledge about the family's complete medical history.

The Office of Child Support recently kicked off its "Give your child the dadvantage" campaign to educate parents about the importance of establishing paternity and the value of discussing paternity before the

Actually, the paternity process at the hospital upon birth of a baby is simple. To establish paternity, both parents should have photo identification and read and sign the affidavit the hospital gives them when the child is born. It's free, and both parents should sign.

Okay, I get it. Countless young men who want to spend time with children born out of wedlock have figured that out, too, after facing all sorts of legal and ex-girlfriend issues because the government doesn't legally consider them to be a parent.

But it's kind of sad that so many young people are dismissing marriage, not to mention failing to actually consider the consequences of their actions before, well, acting.

Gee, back in the day we established paternity the old-fashioned way; by getting married before starting our families. Weird, I know, but it made it easier to establish the identity of the father, who was then expected to put some effort into being a decent parent and provider alongside his better half.

But that was then, you say? Maybe, but the rules of biology haven't changed; guys who aren't interested in tying the knot, establishing paternity, or being a parent will still take a little time to learn about the complexities of birth control, if they have half a brain.

Of course, I suppose there may be legitimate reasons why young couples these days are having kids left and right without benefit of a marriage certificate, but I can't think of many. Probably the lamest thing I've ever heard is, "We don't need a piece of paper to prove our love."

Hogwash. Just my opinion, but it's the lifelong commitment represented by that piece of paper that scares many people away. Somehow that idea just doesn't fit in with the disposable society in which we live.

That's a shame, because the attitudes of today's parents will impact the attitudes of their children, just as their parents' attitudes about marriage impacted their outlook on this neglected institution.

Maybe some would-be brides and grooms just can't wrap their heads around the prospect of really spending the rest of their lives with that one person. I mean, how do people do that? Don't they get bored, irritated and even angry with their spouses sometimes?

The answer is "yes". But this is reality, kids. As one Facebook meme put it: "Being married can be fun sometimes. Problem is, you're married all the time.

Seriously, though, guys, if you want to give your child a "dadvantage", give some serious thought to your level of commitment to both your mate and to being a father before you start making babies.

Public hearings scheduled

Up for debate are two parcels - 035-034-000-5800-00 and 035-034-000-5700-00 - near the corner of Maple and Elizabeth Streets and part of a 21 acre parcel that includes the Waste Water Treatment Plant (WWTP) on Doerr Road.

In a letter to the Village of Cass City, Bay City Forestville resident Joey Kreeger expressed an interest in purchasing the two village lots for a total of \$3,000.00.

"This lot[s] adjoins my son Zachary Deitering's property at 4144 Maple St. [in] Cass City. My purpose would be to purchase these lots and have them added to my son's tax ID," she wrote, adding, "[These lots are] often overgrown and unkempt. If the village sells it it will be added to the tax roll and we will maintain it."

Village Treasurer Nanette Walsh explained approximately \$55.00 (\$3,000 increased value x 18.137 mills) would be added to the tax rolls if the sale is approved.

Turning to the wooded land that includes roughly 1,250 feet of Cass River frontage, long-time residents Rich and Gayl Patera have offered \$8,500 per acre for the village property located east of their Doerr Road

In response to the Patera request, WWTP Superintendent Dennis Mc-Cabe wrote a memo to Village Manager Lou LaPonsie, stating "Currently the WWTP has approximately 12.7 acres of wooded land west of the WWTP grounds. This wooded acreage was set aside for future expansion of the WWTP. At this time no plans are being worked on for expansion into the west end of the property. I would recommend that the village allow Rich to buy a piece of the property in the size of 200 feet x 850 feet."

If the sale of 3 ½ acres is approved, McCabe says, 8.8 acres of land would remain as village property for future expansion.

However, Cass City Village Council trustee Nancy Barrios – a strong advocate for expanding on the uses of the Cass River – wondered if the land might better serve the public in another manner.

Barrios, a Cass River Greenway volunteer, voiced support at the latest village council meeting for a possible canoe launch at the site.

That drew criticism from village resident Linda Herron. She expressed

creating a road to the river would be too costly.

Once again, Walsh clarified the sale (3 ½ acres at \$8,500/per) would produce an increase value of about \$29,000 or \$540 annually to the village tax rolls.

West Nile virus confirmed for first time in '17

The Michigan Department of Health and Human Services (MDHHS) last week confirmed the state's first human cases of West Nile virus

Four cases of WNV have been confirmed; two residents of Montcalm County, and one each from Oakland and Macomb Counties. Their illness onsets range from August 6 to Aug. 11, and all have been hospitalized with neurologic disease.

"This is an important reminder to stay vigilant and protect against mosquito bites throughout the summer and into the fall," said Dr. Eden Wells, chief medical executive at the MDHHS. "All residents should take steps to prevent bites, such as use repellent and take extra care during peak mosquito-biting hours between dusk and dawn."

Surveillance for mosquito-borne diseases is being conducted by the MDHHS and Departments of Natural Resources (MDNR) and Agriculture and Rural Development (MDARD). In 2017, WNV activity appears to be widespread statewide in Michigan. In addition to the four human cases, five Michigan blood donors have had WNV detected in their blood.

To-date, 148 birds have tested positive for WNV from 44 of Michigan's 83 counties. In addition, 86 WNV positive mosquito pools have been detected in seven Michigan counties.

MDARD has reported eight horses that have tested positive for WNV (Clinton, Jackson, Livingston, Missaukee, Mecosta, Midland, Ottawa, and Wexford Counties). Also one horse has tested positive for Eastern Equine encephalitis virus (Wexford County). Vaccination is the best way to protect horses from both WNV and EEE. Horse owners should work with their veterinarian to make sure their horse is properly vacci-

Finding infected birds, mosquitoes and horses in a community is an indication of risk for human infection.

Most people who become infected with WNV will not develop any symptoms of illness. However, some become sick three to 15 days after exposure. About one in five infected persons will have mild illness with fever, and about one in 150 infected people will become severely ill.

Mild illness may include headache, body aches, joint pain, vomiting, diarrhea, or rash. Severe symptoms of WNV are associated with encephalitis or meningitis, and may include: stiff neck, stupor, disorientation, coma, tremors, muscle weakness, convulsions and paralysis. People 50 and older are more susceptible to severe WNV disease symp-

Residents can stay healthy by using simple, effective strategies to protect themselves and their families. The following steps are recommended to avoid WNV and other mosquito-borne diseases:

*Maintain window and door screening to help keep mosquitoes out-

*Empty water from mosquito breeding sites around the home, such as buckets, unused kiddie pools, old tires or similar sites where mosquitoes

*Use nets and/or fans over outdoor eating areas.

*Apply insect repellents that contain the active ingredient DEET, or other EPA approved product to exposed skin or clothing, and always following the manufacturer's directions for use.

*Wear light colored, long-sleeved shirts and long pants when outdoors. Apply insect repellent to clothing to help prevent bites.

This collection is for toxic, poisonous, flammable and caustic materials; latex paint and oil-based paints; pool chemicals, pesticides, herbicides and mercury.

Tuscola County recycling officials recommend that residents properly dispose of household hazardous wastes, which are defined as being toxic, flammable, caustic or chemically reactive. Key words found on such containers are danger, poison, warning and caution.

Such items should not be poured down drains, onto the ground or thrown into the trash. Some examples of these materials include oil based paints, stains, home repair products, cleaners, contaminated oil, pesticides and herbicides.

If you have any of these items that you will no longer use, or think they are unsafe to use, this is the way to responsibly dispose of them, according to recycling coordinator Mike Miller, who noted water-based paints will also be collected during the event.

There is no fee to participate for Tuscola County residents.



They should: wear long pants and long sleeves, apply a repellent that contains DEET, and eliminate sources of standing water.

cially, but through adjustments and careful spending, there is now a fund balance of about \$1,634,212.

When drafting this school year's budget, district officials calculated a loss of about 25 students for a total enrollment of 975 students.

"We won't know for sure what our enrollment will be until classes are underway," Hartel noted.

Under the new per-student funding levels, the district will receive \$7,631 instead of \$7,511, as well as another \$25 per high school stu-

Yet, despite the adjustment, funding for some schools will be differ-

"Some of the schools in bigger areas receive more. In Bloomfield Hills, they get about \$9,000 per student because the cost of living is higher there," explained Hartel, who said it's his understanding they will get about a \$60 increase.

The Kingston Community School District, meanwhile, will receive about \$77,000 in additional funding.

"We estimated being down 10 students for an enrollment of about 589, and set the budget for that," said Kingston school Supt. Matt Drake. "We won't know for sure what our enrollment will be until the October count. We hope to be back up to an enrollment of 600 students."

It's estimated Kingston Schools has an enrollment of about 297 students in seventh through twelfth grades, and 292 students at the elementary.

With the funding increase, the Owendale-Gagetown School District will receive \$44,729 more this year, and the Ubly Community Schools will receive about \$193,040 more.

Two years ago, the Knights decided to include Revive Ministries, and the two food pantries shared \$3,500 in proceeds thanks to the generosity of sponsors and event participants. Last year, the organizations benefitted from \$3,900 raised during the event, which saw about 66 area residents participate.

"The first year we had 69 (runners/walkers), and the second year we dropped down to about 49 because we had terrible weather – rain and windy," Churchill recalled. "It didn't chase the runners away, but it chased away the walkers."

"All ages are welcome," Churchill said. "I think our youngest was like four for the kids' run/walk, and one of the (adult) walkers was approaching 80."

Churchill noted this year's route is the same as last year.

"It starts at the St. Pancratius parking lot, to Cemetery Road, to River Road, to the walking trail bridge, and then it comes back north to Garfield (Avenue) east all the way to Woodland (Avenue), north up Houghton Street, then back to the west to Oak Street, then back to St. Pancratius," Churchill said.

He added the fundraiser primarily draws running/walking enthusiasts from the central Thumb area. "We get runners from Cass City, Gagetown and Caro, but I also have some people coming from Harbor Beach, Mayville, Reese."


Churchill said support for the event also comes from a variety of places. He explained he sends out about 200 letters to prospective sponsors – businesses as well as individuals — in May/June.

Teams from the Greater Thumb Conference dominated Thursday's Brown City Invitational.

Cass City was the easy winner with 77 points, while Ubly edged Unionville-Sebewaing Area Schools (USA) 100-104 to round out the top three spots in the team standings.

Cass City uses final half comeback to derail Ubly

In an early season statement game Thursday, Cass City spoke the loudest.

The Red Hawks (2-0) remained perfect on the year with a hard fought 30-16 Greater Thumb Conference (GTC) crossover victory over guest Ubly (1-1), delivering a clear message throughout the Thumb in the process – Cass City is a team to be reckoned with in the GTC.

The Cass City margin appeared in jeopardy moments later, when Ubly used a 50-yard pass play from quarterback Maikrzek to Casey Sweeney that spotted the ball on the Red Hawk two-yard line.

Instead, facing fourth and goal, Hank Janik pounced on an Ubly fumble that returned the momentum back to Cass City entering the final 12 minutes.

There, another 60-yard run by Perry set up a touchdown run by Luke Stern that capped an 98-yard drive and extended the gap to 30-16, with just over five minutes remaining in regulation.

Still, Ubly had two possessions after Stern's 4th down marker, but both were foiled by Hamilton interceptions.

"This was a signature win for Cass City. There was great effort from all the players," said Cass City Coach Scott Cuthrell.

Hamilton and Perry each rushed for over 100 yards to lead the winners. Hamilton gained 187 yards on 21 carries, while Perry chipped in 104 yards on 10 totes. Stern collected 60 rushing yards on 13 attempts. Cass City did not complete a pass on the night.




Hard hitting Hank Janik is Schneeberger's selection for their Athlete of the Week award.

While he recorded a teamhigh 11 stops in the non-conference win, it was Janik's huge fumble recovery that may have saved the day for Cass City.



Ben's clears hurdle with village planners

seeing a grocery open again in Cass City – and because securing approval for a bank branch is an integral part of Zyrowski's proposed development.

Zyrowski said the Ben's location in Cass City will feature fresh produce and meats along with a deli and bakery.

When the project is complete, he said, the store will actually yield one-third more space than when Erla's was open because the area previously devoted to meat processing will now be used for the grocery/deli/bakery sections of the new store.

Ben's Supercenter is family owned and operated. Founded in 1965, the company currently has three locations; Ben's Supercenter in Brown City, Ben's Supercenter in Marlette and Ben's Contractor Center/Ben's Great Outdoors, also in Marlette.

It's been three years since Cass City's only grocery store closed its

Former Erla's Foods owner Venu Ganga closed Erla's in September 2014 after owning and operating the business for about 2 ½ years. The decision left the village without a grocery and nearly four dozen area residents without jobs.

Ganga purchased Erla's Foods Inc. in February 2011, marking the end of a 57-year business tradition established by the Erla family. Ganga attempted to reinvent Erla's by creating three separate enterprises within one company – Erla Foods, Redhawk Steaks and Erla's Distributing LLC.

He made the decision to close after trying to increase customer traffic – and sales – by investing in an in-store buffet restaurant during the summer of 2014, but the venture failed to produce the results Ganga had hoped for, and the restaurant was shut down after less than two months of operation.

In addition to Zyrowski's plans, Cass City was the focus of a grocery store development planned for months by Texas businessman Mark Molter, whose proposal entailed building on lots on the south side of Main Street occupied by the former Fairway store and antique mall, and Rotary Park.

The project was later delayed by a Michigan Economic Development Corporation (MEDC) decision requiring Molter to incorporate the antique mall building into his new store, due to the historical value of the antique mall structure. Since then, village officials have indicated Molter is no longer pursuing the project.

Be careful!

Thumb schools back in session

Whether they're ready or not, Tuscola County students are headed back to the classroom. And the Tuscola County Sheriff's Department wants them to make it there in one piece.

Of the 301 school-age children killed from 2006 through 2015 in school transportation-related crashes in the United States, 102 were pedestrians and eight were bicyclists, according to the most recent available data from the National Highway Traffic Safety Administration.

"With more than eight public schools in the county, drivers and pedestrians alike need to put their phones away and pay attention to their surroundings," said Tuscola County Sheriff Glen Skrent.

Deputies will be monitoring school zones, added Skrent, who offered some additional tips to help ensure a safe trip back to school:

*If you drive your children to school, be sure to use the appropriate parent drop-off/pick-up area.

*Drive defensively. Always anticipate the possibility that a small child may dart in front of your vehicle. Be prepared to stop at all times.

*Slow down and watch out for school zones and children walking or biking to school or congregating near bus stops. Also, be alert for student drivers.

*Remember that buses will be making frequent stops. It's not only dangerous to students, but it's against the law to pass a school bus while it's stopped on the roadway picking up or dropping off students.

*When turning at an intersection, be sure to yield to pedestrians and cyclists.

* If you're a student riding the bus, stay out of the street while waiting for the bus and allow the bus to come to a complete stop before approaching the bus from the curb. Make sure you remain in clear view of the bus driver, never walk behind the bus, and look both ways before getting on the bus and after getting off. After getting off the bus, look both ways and then move immediately onto the sidewalk and out of
