Vandals deface the petroglyphs

Vandals have struck at the Sanilac County Petroglyphs Historic State Park, scratching random images into the historical sandstone formation featuring native American carvings that archeologists say were created hundreds of years ago.

Michigan Department of Natural Resources (DNR) announced officials the vandalism Friday.

"We are all deeply saddened by this disre-spectful act," said Sandra Clark, director of the Michigan History Center, which interprets the petroglyphs for the public at this state park near Cass in Sanilac City. County's Greenleaf Township. "The petroglyphs were created by people who lived in what is now Michigan centuries ago.

"They are part of all of our history, and they have a deep spiritual meaning for many Anishinabek who live in the Great Lakes Region today."

The Saginaw Indian Chippewa Tribe of Michigan, which considers the petroglyphs sacred, partners with the state

Anonymous donors offering to cover insurance for local Pinktober events

Cass City's Pinktober celebration is back on, although this year's observance in support for breast cancer awareness and research has been scaled down in size and length.

The decision to abandon the popular event – announced last month – stemmed from concerns over liability. Specifically, the Cass City Chamber of Commerce's insurance carrier informed chamber officials that it will no longer insure Pinktober events.

Although the chamber hasn't served as sponsor of the celebration or been involved in the organization of activities associated with the observance, it has provided insurance coverage for the event over the past several years.

"Our insurance company said we can no longer carry the insurance... because it's not a chamber-sponsored event," chamber Administrator Judy Keller said at the time of what has become a familiar month-long fall tradition in Cass City – the only community in the region to host such a celebration.

"We have to do an audit every year, and they (insurance company) came back to us last year and said they can't cover it anymore," Keller added. "It's not a chamber decision. It came from the insurance company. We didn't have a choice.'

After news of the cancelation spread in the community, a small group of local businessmen anonymously offered to cover the cost of insurance for this year's events, according to organizer Joey Kreeger, who

Local car dealership to close




Small town businesses throughout the Thumb continue to struggle to keep their doors open as populations dwindle and downtown markets

Parents behind in child support could lose their hunting license

Parents who aren't taking care of their child support obligations through the Tuscola County Friend of the Court Office could wind up losing their hunting priv-

That's according to Tuscola County Friend of the Court Sandy Erskine, whose office regularly conducts a review of open files in an effort to ensure that children get the financial support they de-

Making that happen is an ongoing challenge in some cases, according to Erskine, who sometimes targets suspension of hunting and other sporting licenses held by individuals who aren't regularly paying their child support.

"Michigan law gives the Friend of the Court office a variety of tools which it can use to encourage individuals to comply with their child support orders," Erskine said, adding her office typically begins reviewing cases in early October to determine if suspensions of certain individuals' hunting/sporting licenses is appropriate. "We are starting to review cases a little sooner this year we anticipate starting around late September."

Parents at risk for having their licenses suspended are those who have missed at least two months of child support, those who have been inconsistent payers, and those who have not yet entered into some sort of payment arrangement with the friend of the court office.

"The review (focuses) on consistency of payments and any known hardships that the payer is facing," explained Erskine, who noted the goal is not to automatically suspend the hunting license of everyone who is behind on their child support.

Although our office does not want to seek hunting license suspensions, sometimes we are left with no choice if an individual has a child support obligation, is not making payment, and has not

reached out to us to work out some sort of payment arrangement," she said.

"We certainly understand that some individuals are currently

dealing with circumstances beyond their control, like health issues, inability to find work, and

extreme financial hardship," Ersk-Please turn to page 7.

Counties score win in battle over wind taxes

Two counties, including Tuscola, have scored a minor win in the war

over how wind turbines are taxed. For several years, the five counties with wind farms have been at odds

over the state's abrupt change in the taxing method and depreciation schedule of wind turbines. Because of that, the counties of Tuscola, Huron, Sanilac, Gratiot and Mason formed the Michigan Renewable Energy Collaborative, (MREC) to challenge the changes.

"We were scheduled to go to court Sept. 18 with NextEra Energy Resources, when we received notice NextEra asked the Michigan Tax Tribunal to dismiss their tax appeal on their Tuscola Bay 1 Wind Park," said Huron County Economic Development Director Carl Osentoski, who is the spokesperson for MREC.

Card skimmers still present big problem

Credit card skimmers are still being found in Michigan more than two years after the Michigan Department of Agriculture and Rural Development (MDARD) found the state's first skimmer in the Grand Rapids area in 2015.

"Looking for, and removing, skimmers at the 4,691 gas stations located across Michigan, is now part of the standard inspection process. We are committed to doing our part to protect consumers from fraud," said Jamie Clover Adams, MDARD director.

But the problem remains pervasive enough in the state to prompt the Michigan Senate earlier this summer to overwhelmingly approve a bill requiring installation of new safety measures at the state's more than 100,000 fuel

Credit card skimmers, which can't be seen from outside the pump, can be installed in seconds. Criminals use keys to open the pumps quickly, insert the skimmers, and then leave. The skimmers copy the consumer's card information for criminals to make fraudulent purchases.

Local, state and federal regulators, MDARD's Weights and Measures Division inspectors, various law enforcement agencies, and gas station owners continue to be on the lookout as part of the ongoing efforts to crack down on consumer credit card information being hacked by skimmers.

"Some steps station owners can take, and have taken, to protect their patrons from cyber-criminals are changing locks, using tamper-proof security tape, and security cameras. MDARD is also encouraging station owners to increase the frequency of their regular dispenser inspections," Clover Adams said.

Consumers are being encouraged to monitor their banks and credit card accounts. If a consumer sees a charge they didn't make or looks erroneous, they should immediately contact their banking institution.

While skimmers are nothing new, technology has made them smaller and harder to find. However, experts say consumers can help to protect themselves by:

*Making sure the gas pump panel is closed and doesn't show signs of tampering. Many stations now put security seals over the cabinet panel. This is part of a voluntary program by the industry to thwart gas pump tampering. If the pump panel is opened, the label will read "void," which means the machine has been tampered with.

*Taking a good look at the card reader itself. Does it look different than other readers at the station?

*Gently wiggling the card reader before you put in your card. If it moves, report it to the attendant, then use a different pump.

If you use a debit card at the pump, run it as a credit card instead of entering a PIN. That way, the PIN is safe and the money isn't deducted immediately from your account. If that's not an option, cover your hand when entering your PIN. Scammers sometimes use tiny pinhole cameras, situated above the keypad area, to record PIN entries.

Of course, if you're really concerned about skimmers, you can pay inside rather than at the pump. Another option is to use a gas pump near the front of the store. Thieves may target gas pumps that are harder for the attendant to see.

Texas has a long, long road to recovery, but the kindness of strangers has helped and will continue to



Michigan has achieved a significant milestone in the state's efforts to keep babies safe with the 200th surrender of a newborn under the state's Safe Deliv-

Under the law, a biological parent may legally surrender an infant no more than 72 hours old to an emergency service provider. An emergency service provider is a uniformed or otherwise identified employee or contractor of a hospital, fire department or police station who is inside the building and on duty, or a paramedic or emergency medical technician who responds to a 911 call.

The law has been in effect since 2001.

"These are 200 newborn babies who have been given a chance at life thanks to this important law, said Nick Lyon, director of the Michigan Department of Health and Human Services. "Safe Delivery provides parents who may be in a desperate situation a safe, legal and anonymous option of surrendering an infant who will be placed in a loving, adoptive

MDHHS wants all Michiganders to be aware of the law. Unfortunately, there are still situations in which parents abandon their babies in unsafe locations. A communications toolkit and other resource materials are available at www.michigan.gov/safedelivery to help more people understand the law and how they can help promote awareness in their community.

Reporter's notebook

Ride free and die?

Even at the ripe young age of 55, I still have enough thrill seeker in me to never turn down the opportunity to ride the scariest roller coaster I can find.

But I'd never hop on a motorcycle and go roaring down Deckerville Road (or any other road for that matter) without a good helmet protecting what's left of my brain.

Yeah, I'm one of those folks who simply can't fathom the movement that successfully convinced Michigan lawmakers to make it legal to ride without a helmet back in 2012. It's also a fact that I don't own a motorcycle and wouldn't know how to operate one if I did.

But I have eyes, and last week they witnessed a near-tragic accident involving a pickup truck and two folks enjoying an early fall afternoon ride on a Harley. The driver of the pickup had stopped on Dodge Road and started turning onto Deckerville Road – apparently unaware of the westbound motorcycle traveling in front of me. Luckily, the gentleman on the front of that Harley veered off to the left, avoiding what almost certainly would have been a collision involving serious injuries.

Of course that's a guess, but neither he nor his rider was wearing a

Officials at ABATE of Michigan, the nonprofit cycling rights group that pushed for the repeal of Michigan's helmet law, say helmets are a freedom issue and an individual rights issue. I get that.

But it's difficult to ignore Michigan State Police data that shows, for example, that 138 people were killed in motorcycle crashes in 2015 – higher than any year dating back to 1985. From 2000 to 2011, an average of just under 112 motorcyclists were killed a year. From 2012 – when the helmet repeal took effect – through 2015, that number averaged nearly 126 people.

A number of hospital and medical journal studies have since reported what one might guess: that death rates from motorcycle accidents are higher among operators/riders who don't wear protection, and those who survive are frequently more severely injured.

ABATE officials have reported – accurately – that unlicensed motor-cycle riders comprise a disproportionate share of riders who crash.

But does that really matter? I mean, you can be the most experienced motorcycle operator in the universe, with years of experience and the reflexes of a cat, but there's no way to anticipate every bonehead move another driver may make in front of you (or behind, or next to you, etc.), especially if they're paying more attention to their lunch or an incoming text than they are to the road.


Sure, wearing a helmet offers no guarantee that a rider will survive a traffic crash. However, I can't imagine there's any doubt that a helmet increases your chances of survival, or maybe even escaping with only minor injuries.

Personally, if someone doesn't want to wear a helmet while they're cruising through town or on the freeway, I have no problem with that, provided a law that removes a proven safety measure doesn't end up infringing on my freedom by costing me more in insurance premiums.

Even though the repealed law requires motorcyclists who forego protection to carry \$20,000 in medical insurance, I'm not convinced that's the case, largely because it doesn't take long to rack up \$20,000 in medical bills even if you're talking about a minor procedure.

Oh well, call me a chicken. That's okay. I'd rather be a live chicken than die riding a motorcycle without a helmet because, well, I can.

Vandals deface petroglyphs

in interpreting the petroglyphs, which are called ezhibiigaadek asin ("written on stone") in the Anishinabemowin language.

"The Sanilac Petroglyphs are one of the most important connections we have to our past within the region," said Tribal Chief Frank Cloutier of the Saginaw Chippewa Indian Tribe of Michigan. "The stories that are handed down from generation to generation thread our past to the present. We need to preserve diba jimooyung ('telling our stories')."

"Pictures, stories and our language are all we have that identifies our Anishinabek people," he added. "Without proper protections of these ancient treasures, we run the risk of losing precious sacred information,' Cloutier added. "My community needs these treasures protected and

The petroglyphs were discovered after the devastating fire in 1881 that swept through the state, burning more than a million acres of central and eastern Michigan, including all of the Thumb, and claiming more than 280 lives across the region. The petroglyphs were carved into a sandstone formation - measuring 40 feet in length by 15 feet wide that remained hidden by dense forests until the flames exposed it.

Historians believe the original carvings were created 300 to 1,000 years ago. They depict birds, animals and a figure that appears to hold a bow and arrow.

The petroglyphs – Michigan's only known prehistoric carvings — are part of a 240-acre park at 8251 Germania Rd. The Michigan Archaeological Society purchased the property and deeded it to the state in 1971. Today, the park is open to the public from Memorial Day through Labor Day, with an estimated 4,000 people visiting annually.

To help preserve what remains of the carvings, a pavilion and guardrails were set up to protect the sandstone formation and to keep people from damaging the site.

"We urge the public to be our added eyes and ears in the field to assist Michigan's state parks and recreation system in protecting these and other cultural treasures from such senseless acts of vandalism," said Ron Olson, chief of DNR Parks and Recreation Division. "Please alert park rangers and staff if you witness any suspicious activity that may threaten this area "

The DNR and the Saginaw Chippewa Indian Tribe of Michigan ask that anyone with information concerning the individuals who defaced the Sanilac Petroglyphs call or text the DNR Report All Poaching (RAP) hotline at 800-292-7800. Individuals may qualify for a reward, provided by the Michigan History Center, if they submit information that leads to the arrest and conviction of the vandals.

A state representative on hand for a recent Cass City Village Council meeting announced he plans to seek veteran state Senator Mike Green's 31st District seat in Lansing.

State Rep. Gary Glenn of the 98th District announced to an audience of about 35 people in attendance at the meeting that he plans to run for Green's post when it becomes available.

"This is Mike's last term as senator," said Green's aide, James McLoskey. "Mike is in line to become the Michigan Director of the USDA Rural Development office in Lansing. We are not sure when the federal government appointment will be announced, but it could be within the next month or

so.'

Glenn's 98th District includes portions of Bay and Midland counties. Within Bay County, he represents the cities of Auburn and Pinconning and Linwood, and the townships of Beaver, Fraser, Garfield, Gibson, Mount Forest, Pinconning, and Williams. In Midland County, the district in-

cludes the city of Midland, the village of Sanford, and the townships of Midland,

land, Homer, Gary Glenn

Jerome, Larkin, Lee and Lincoln. Green's district covers Bay, Lapeer and Tuscola counties. He previously served as a state representative and as a Tuscola County commissioner.

When Green is appointed to the USDA Rural Development office, it will be up to the governor to schedule a special election to fill the senate vacancy left by the appointment, according to McLoskey.

The winner of the election will serve for the balance of the term of office in the senate.

In his position as a state representative, Glenn is chair of the House Energy Committee (his second term of being on the panel). He also was named to a second term on the Military and Veterans Affairs Committee. Glenn also serves on the Communications and Technology, and Insurance committees.

School serves up free meals

several years.

Bock, who coordinates the preparation of free meals for local students throughout the school year, then undertakes the same job to serve up thousands of meals for Thumb area youngsters after school lets out, reported she and her crew prepared nearly 1,900 breakfasts and more than 5,766 lunches at three different meal sites between June and August.

The program started June 21, with nutritious meals served Monday through Friday at Cass City Elementary School.

Cass City School officials again partnered with other districts to provide free meals for children in the surrounding area, according to Bock, who said breakfasts and lunches were served at Small Wonders Day Care, 1381 Cleaver Rd., Caro, as well as in the community room at Grandview Estates, 154 E. Deckerville Rd., also in Caro.

In all, the Cass City Public Schools prepared more than 9,300 meals in the summer for area children last summer, up from 8,000 meals during the summer of 2015.

This year's total was around 7,650 meals. However, the program started about two weeks later than usual because of a late school dismissal date, and the program had one less meal site, Bock pointed out.

"Overall, our program was very well received. Both sites in Caro did really well. We were pleased with those," she said, noting one of those sites saw 50 to 60 youths in attendance each day, while participation at the other site averaged 25 to 30 youths daily.

"At the Cass City site, we (fed) generally 70 to 100 each day," Bock added. "I think it's a great program – there are kids that ride their bikes up there every day to eat.

Bock and one or two other food service personnel prepare all the food in Cass City. The U.S. Department of Agriculture reimburses the district for the meals, some of which are then transported to the satellite summer meal sites.

The continued steady participation in the free summer meal program doesn't come as a surprise to Bock, who reported roughly 56 percent of students at Cass City Elementary School qualified for free or reduced-price meals during the last school year, while the percentage at the high school dropped a few points – about 45 percent of those students qualified for reduced-price or free meals.

"I don't know if that's because more families were working or because more families just weren't applying. We had a lot of applications last year, by the end of the school year," she said. Bock added applications for the new school year are starting to flow in, (and) they're coming in pretty steady so far. We'll see what this year brings, but I'm hoping more people are working."

Bock takes advantage of every opportunity to encourage parents to apply for free or reduced-price meals, including those who find themselves suddenly facing reduced incomes due to job loss or other situations. Parents can file an application on-line by visiting the Cass City Public Schools website, or by calling (989) 872-5729.

Fundraising efforts pay off with drone purchase for sheriff's department

The latest addition to the Tuscola County Sheriff's Department's arsenal of investigative tools combines flight with high-tech visual equipment, giving deputies a bird's-eye view of traffic crashes, fires and

The department recently purchased a drone that provides an aerial view not available before. The equipment can also be used to assist in missing person searches.

"The price of the drone was \$4,000. Several fundraisers were held to cover the cost. One of the events was a cookout at Northstar Bank in Caro that raised over \$1,500," said Undersheriff Robert Baxter. "Donations from Team One Credit Union, Poet Biorefinery, and several private donations helped with the cost."

The sheriff's department used the proceeds to purchase an Inspire II model drone. The high-quality unit can operate for 25 minutes in between battery charges, its maximum speed is 58 mph, and it has infrared

With that speed, the drone can cover a lot of area in a short amount of time, which is helpful when searching for a missing child or a vulnerable adult, Baxter pointed out. He noted the drone can also be used to take photographs of accident scenes, natural disasters, and other inci-

There is more to operating a drone that just turning it on and moving the controls, according to Baxter.

Because this equipment isn't a toy, its operator(s) must be licensed. Towards that end, Steve Anderson, director of Tuscola County Emergency Management, and Sgt. Josh Herman have both become licensed drone operators.

So far, officers have used the drone to take aerial photos of scenes involving malicious destruction of property, accidents and house fires.

Counties score victory in battle over wind turbine tax revenue

taxed rather than the true cash value of the turbines.

The Tuscola Bay 1 Wind Farm, which became operational in 2012, consists of 68 Turbines located in Tuscola County's Gilford Township and seven turbines in Blumfield Township in Saginaw

"While we are pleased with this outcome, it only covers that one NextEra wind farm and not their second wind farm in our county," said Tuscola County Controller Mike Hoagland.

"It has no impact on the wind farms in Huron County and in Sanilac County. The issue of taxes and depreciation on the wind farms in those counties are still before the tribunal," Osentoski

The appeal that was dismissed on Tuscola Wind 1 was for tax years 2014 through 2017.

However, the dismissal is not a financial windfall for Tuscola County. Ever since the state changed the tax and depreciation method of wind turbines, Tuscola officials have escrowed a portion of the tax money collected to be on the safe side in case the tribunal found in favor of the energy

Hoagland estimates the county escrowed about \$970,000 for the general fund, and about \$576,000 from the eight special millages the county levies.

"I caution that all of that approximate \$1,546,000 is not free and clear to use. That includes escrowed money from NextEra's second wind project that is still before the tribunal," Hoagland said. "And, we do not have all of the details from the tribunal of what the dismissal actually means.

"That money is in the bank, but we are not banking on being able to use all of it until everything is worked out. That will still take some time."

In addition, NextEra also has the Tuscola Wind II that is located in the townships of Gilford, Akron, Fairgrove and Juniata.

The dismissal has no impact on the second wind farm that became operational in 2013, said Hoagland, who explained the heart of the issue is that in 2011 the State Tax Commission (STC) changed the depreciation schedule for wind turbines. That change resulted in lower taxable values for wind projects, which in turn meant less tax revenue.

Officials from the five counties with wind farms protested the abrupt change, implemented with no input from local municipalities. Since the tax change was implemented, the MERC has been trying to get the state to institute a fair tax process that reflects the taxable value and life of a turbine.

Under the tax commission's 2011 ruling, wind turbines went from a 100 percent assessment in year — with a scheduled depreciation to 30 percent value in 15 years — to an 80 percent initial assessment, with a depreciation to 30 percent value in six years.

The change meant thousands of dollars in reduced revenue to the counties and the other taxing agencies within those entities.

Because of that and STC refusal


ties formed MREC with the common goal of correcting the taxation inequity. The organization also hired the law firm of Clark Hill to handle legal matters and make the argument for the original or another fair and reasonable method of wind energy taxation.

"At NextEra Energy Resources, we want the communities where we do business to benefit from our projects. We also want them to know what they can expect to collect in tax revenue and have certainty in their budgeting processes," said NextEra Energy Resources spokesman Steven Stengel. "While there are many issues we would like the state to clarify with regard to assessing the taxable value of wind farms, our case with the Michigan Tax Tribunal has simply dragged on too

"In the interest of maintaining strong relationships with the communities we serve, we have chosen to withdraw our case with the tribunal (on that one issue)."

Had NextEra's appeal been successful, it would have lowered the overall value of the 75 turbines in Tuscola and Saginaw counties.

"We would like to acknowledge the professional nature in which the attorneys and management at NextEra handled their part of the appeal process," said Osentoski. "NextEra indicated to us that their request to dismiss was in the interest in maintaining a strong posirelationship

Hawks remain perfect despite sluggish start

To nearly no one's surprise, the Cass City Red Hawks remained unblemished Friday with a nonconference road win at Brown

And although Coach Scott Cuthrell's team was able to improve to 3-0 with a 54-30 victory, a disturbing trend has developed in the process.





His building at 6617 Main Street had been the location for the town's Christmas for Kids drive annually.

"We will remain present in Cass City. Dan lives in Cass City and his wife (Director of Bands Laura Curtis) teaches here. We are not upset with Cass City in any way. This is more of a consolidation," Curtis said, noting all employees of the Cass City franchise have jobs waiting for

Curtis purchased the Cass City car establishment in 1998 and then invested thousands of dollars to demolish a pair of buildings in 2003 to improve the downtown development.

To make room for a used car lot along Main Street, Curtis purchased the former Videomation building in 2000 and the East and West Restaurant building in 2003 that helped to clean up the block near the corner of Main and Sherman streets.

The local car dealership's improvements also included exterior and interior renovations, landscaping and installation of lighting for the new lot space.
