Elkland twp. a safe place to live, police report shows

Elkland township is one of the safest places to live in Tuscola county, according to a study recently completed by the Michigan State Police from the Caro Post.

Statistics compiled by Post **Community Services Officer** Donald Reed show Elkland township rates 20th in terms of reported crime out of the county's 23 townships. Only Juniata, Gilford and Columbia townships rate safer, Reed said.

The findings came following a study of crimes reported bers to each crime and rate the problem accordingly. to State Police throughout the

county and interviews with school and township officials. The study is part of a new community services program initiated by the State Police Jan. 1.

Elmwood township ranked 12th in Reed's survey. He said police have been battling a "moderately severe" breaking and entering and larceny problem in the township during the past year.

Novesta township ranks 15th and Ellington township ranks 18th.

The findings are based on statistics gathered over the past year and use complaint

reports filed with the Caro State Police post only, Reed said. He vouched for their accuracy however, saying if other police crime reports were added in, the end result would probably be much the same.

PURPOSE

Reed said the reason these statistics are gathered is to help the State Police coordinate patrols better and place manpower in high-crime areas. He said the emphasis of his work is in crime

prevention.

'Our department is the first in the state to have a full-time crime prevention unit," he said, adding that federal funding was used to set the program into motion.

"From our studies, we can tell immediately where the most serious crime is happening and can concentrate our patrols there," Reed said.

The survey will be updated monthly, Reed said, to keep a running tab on the crime problem in the county. Reed concentrates much of his work with area schools. If

administrators indicate a serious problem, then Reed arranges a presentation to students on crime prevention, geared to their level and using visual aids.

Reed said his services are also available at no cost to interested civic clubs or organizations.

In commenting on area crime statistics, Reed said population is well-divided by age in Elkland township, which helps reduce the crime problem. He said 34 percent of township residents are

under 16, 34 per cent are

under 45 and the rest, 32 per cent, are 45 or over.

Another factor contributing to the township's safe rating, Reed said, is the fact that unemployment is relatively low, compared to areas closer to Saginaw, Bay City or Flint.

"We found in talking with school officials that in over 30 per cent of the households that have students in school, both parents are working," he said.

He said among recurring complaint reports from the Cass City area are dog complaints and littering.

The other day he reported to his dad, Dave Ackerman of Cass City, that he thought an "Editor's Corner" dealing with retirement was simply outstanding.


