

Hawks Romp Over Unionville For Fourth Straight Win

The Cass City Red Hawks romped an easy, 66-37, victory over Unionville Thursday evening at the Cass City High School gymnasium before a surprisingly large crowd for a mid-week holiday game.

Owendale, who had lost only to Sebewaing in previous games, was outclassed from the start and midway through the first quarter, it was evident that the only question remaining was just how big was the final score going to be.

Tom Schwaderer, Bob Wallace and Tim Burdon played heads-up ball and was ably supported by the rest of the squad, all of whom saw action in the one-sided fray.

Using a fast break and clever passing attack, the Hawks jumped into a 13-2 lead with four minutes left in the first quarter. Schwaderer was hitting on his drive-in shots for the basket and Graydon Agar, Wallace and Burdon added one-handed pushes from around the foul circle to build up the margin.

By the end of the first quarter, Cass City had moved in front, 19-5, and the rout was on.

With the regulars playing tight defensive ball, and hitting with regularity, Unionville dropped farther behind in the second period. Schwaderer was the big gun in the attack, as he picked up six points on three field goals. At the end of the half, Cass City was on the long end of a 34-12 count.

Coach Art Paddy used his reserves through most of the second half as Dick Wallace, John Ellis and Don Tuckey saw plenty of action in the final two periods.

The third period was the best of the evening for Unionville as they outscored Cass City, 17-14, to make the gap between the two clubs three points less. But in the final quarter, the Hawks came bouncing back behind Bob Wallace's three buckets to romp for 18 points, while Unionville was netting eight.

The three buckets made Wallace the high-scorer for the evening with 16 points. Schwaderer was next with 12 and Burdon netted 11 for the evening.

The Hawk reserve squad also chalked up an easy win when they doubled the score on Unionville, 48-24. Scoring was fairly evenly divided, with Russ Foy picking up 10 points to lead the reserve scorers. He was closely followed by Bill Martus and Pete Martin with seven and Mason Cook with six points.

Tonight Cass City steps back into Upper Thumb competition with Bad Axe. The game will be played in the Huron City.

This year approximately 60,000 two-cent stamps were issued. In the one-cent bracket, 18,000 were issued in 1951, and 30,000 three-cent stamps were issued this year, as compared with 20,000 in 1950.

Parcel post, which varies little from year to year, remained about the same this season. Despite the similarity in the amount of business in December 1950 and 1951, the post office was busier this year than they were in 1950.

The reason, said Mrs. Bigelow, was that this year persons waited until the final two weeks to do their mailing. In 1950, many persons took care of their Christmas mail early.

Stevens' Nursing Home Tries To Create New Family Life

Ever stop to think about what happens inside a nursing home? What problems, decisions, duties, and work that is needed in a typical day in a well regulated, fully equipped home, such as the Stevens' Nursing Home in Cass City?

Last week your Chronicle reporter decided to try and find out just what does happen and whether the popular conception of nursing homes was real or just a figment of the imagination of ill advised people.

To get a complete picture, we spent two hours with Mrs. Helen Stevens, R. N., who runs the nursing home here. We saw the complete facilities of the institution—from the laundry department, through the modern kitchen, into the wards and even into the bedroom of the Stevens' where there is a modern intercom system that connects Mrs. Stevens, who is a registered nurse, with every patient in the house. The system is also connected with the basement and lawn so there is a central supervision with all the staff and all the patients, wherever they may be.

Naturally, modern equipment is essential, but for a properly run home, equipment is only the beginning in the care of the acute or chronically ill who stay at the home.

Both Mrs. Stevens and Mr. Stevens regard atmosphere as one of the most vital factors in the care of patients in the home. "It is our job," Stevens said, "to create a new family life for persons who come to stay here."

To achieve this atmosphere takes a good deal of skill, training and perseverance. A cardinal rule of the home is to be pleasant at all times and the five young, cheerful nurses follow this axiom to the letter.

The Stevens and the staff read, joke, write letters and arrange for many outside organizations to entertain the patients.

The home is equipped to handle most medical care with the exception of surgery and the delivery of babies. At the present time, one patient is being spoon fed, others have special diets and special medication under the supervision of Mrs. Stevens. There has been as many as five or six patients that require spoon feeding at the home.

There are times when running a nursing home is a very trying job. For instance, we heard, via wire recorder, a conversation between a mentally ill patient and Mr. Stevens. At around 12 midnight, it was necessary to put a patient in the isolation room to calm down.

This was done by a conversation with the patient which lasted for approximately one-half hour.

However, at the end of the session, the patient was calmed and the home has not had a similar problem with this patient since.

Also, on the brighter side of the picture, is the possibility that the patient may be cured at the home. "We have had worse ones," Mrs. Stevens said, "and they have been cured while staying here. The patient is starved for affection and that is one of the reasons for the condition today."

Rev. Libby Answers Ten Questions in Annual Address

"We have some big questions to decide in 1952," said Rev. Frederick J. Libby in his annual holiday address at the Presbyterian Church in Cass City.

Rev. Libby then went on to list 10 questions that he considered vital to citizens of this country and of the world.

In congress, universal military training will be up for vote. Rev. Libby claims that it is not needed now and that it may be defeated in the House. In other questions, Rev. Libby went on record as being against an alliance with Britain, because it could do no good and may cost the United States in money and possibly embroil us in war.

Korea is now an insoluble situation, Rev. Libby claims. "It would have been better to have stopped at the 38th parallel," he remarked when discussing the situation.

The United States should stay out of Iran and do something about Japan. After five years of teaching peace, we do an about face and tell Japan to rearm. We encourage Japan to produce industrial goods, her only method of surviving, and then erect tariffs that remove her market for the goods, according to Rev. Libby.

Germany is a betwixt and between nation. If war comes, Germany will be the battlefield, Libby said, and the Germans have no desire to rearm or become the center of a struggle between Russia and the United States.

The only answer to the question is disarmament, Rev. Libby said. If we can negotiate with Russia to this effect, we will be taking the only permanent step toward a lasting peace. Neither the United States nor Russia can afford a continual state of armament. The present course of both nations is leading toward war.

Another peace step would be to make the United Nations universal. "Take in the other 19 nations for an effective group," Libby stressed, when discussing the situation.

According to Rev. Libby, our fight with Russia is economic and ideological, not military. The question is, Rev. Libby pointed out, whether the most good for the people comes from Communism or private ownership of property.

The last question was possibly the most important to the listeners. Will there be war in 1952? Rev. Libby said that he did not believe the countries were ready for war this year.

COUNTY EXTENSION OFFICE
Extension bulletin 257, and referred to as "Farmers 1951 Income Tax" is now available to Tuscola County farmers by calling or writing the County Extension office.

A committee representing certified seed growers, cash crop farmers and elevator managers met January 3 to review the crops program to be carried on in the county by the Extension office

during 1952. About 57% of the total farm income in the county in 1949 was from the sale of field crops.

A well-kept farm account book beginning on January 1 will make the income tax return job a lot easier a year from now, and a good set of records help a farmer analyze his farm business after the totals are added up.

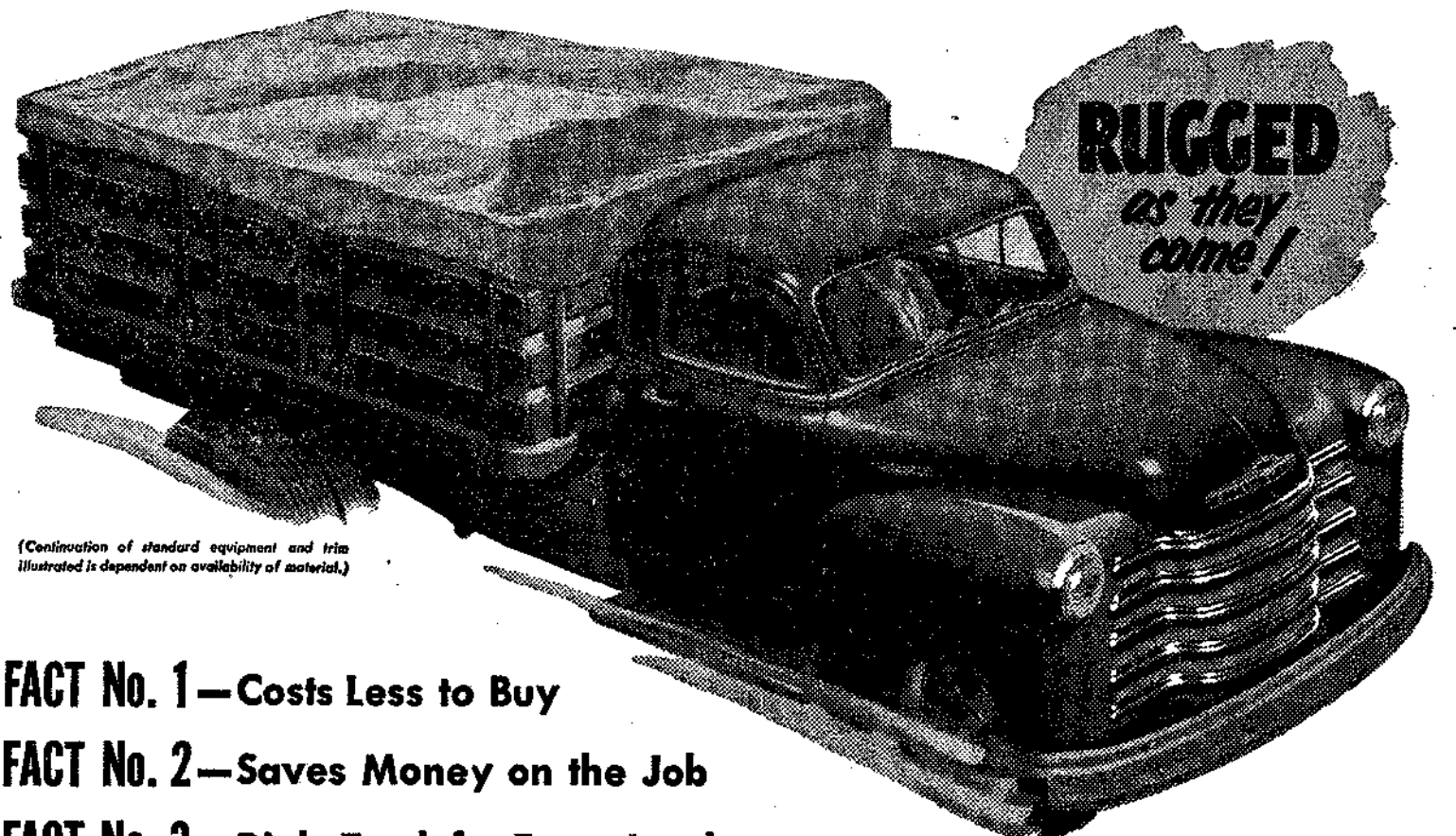

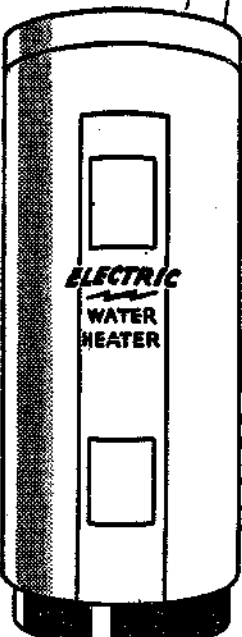

MICHIGAN MIRROR NEWS BRIEFS

Most noteworthy of 1951 was the howling of the wolf at the Capitol doors. His footprints track through most every state department.

Michigan is not likely to forget the year soon. The Legislature boosted taxes 46 million dollars and the federal government swooped in to grab 400 millions more in income and excise taxes.

But despite the bigger bite in revenue, the state treasury deficit rose 40 million dollars on June 30 and is expected to reach 60 million next year.

And more taxes to come—state government's finances appear insoluble without another major nick from the taxpayer's wallet.

The Legislature, due back in Lansing Jan. 9, should be prepared to face a spine-jarring budget from the governor. In a "pre-session" message, Williams said the state faces an additional cost of \$21,700,000 from the general fund alone for financial aids to local governments during the 1952-53 fiscal year. Of the increase, \$18,400,000 is for education and \$2,800,000 for additional welfare costs.

A suggestion from the budget office to discontinue the Michigan Veterans Vocational School at Pine Lake drew protests from the state office of vocational rehabilitation which claimed such a move would be "illogical and wasteful." At the same time, an additional appropriation was requested by the OVI.

Michigan manufacturers took raw materials and added \$7,392,255,000 to their value by manufacture last year. Michigan ranked fifth in the nation as a manufacturing state, third among the east-

northcentral states area.

During 1951 the state highway department contracted for \$41,000,000 worth of state and county road projects and expects a \$45,000,000 construction program in 1952.

The state treasury has suspended investment of public funds in long term securities pending a crystallization of bond markets. State Treasurer D. Hale Brake says more than \$100,000,000 worth of assets will bear "the closest watch if the state is to obtain its maximum earnings."

Dr. John A. Hannah, president of Michigan State College, says MSC enrollment could reach 35,000 by 1968 if present birth and college entrance trends continue. Present enrollment is some 16,000 students.

The conservation department warns ice fishermen that using the top or the bottom of lakes for public waste baskets is punishable as a misdemeanor.

The Pentagon has announced it is setting up four Reserve Officers Training schools in Michigan. They will be located at Lansing, Grand Rapids, Flint and Battle Creek. Purpose: Allow reservists to continue training and offer specialist courses.

Membership in Michigan's Ground Observer Corps, listed at 4,300 last August when responsibility for the corps was transferred from the state police to the office of civil defense, now stands at 7,000.

Governor Williams has appealed to Charles E. Wilson, defense mobilizer, against a rumored drastic cut in automobile production. Senator Blair Moody previously has said Wilson is studying a plan to cut car manufacturing to 800,000 units for the second quarter of 1952.

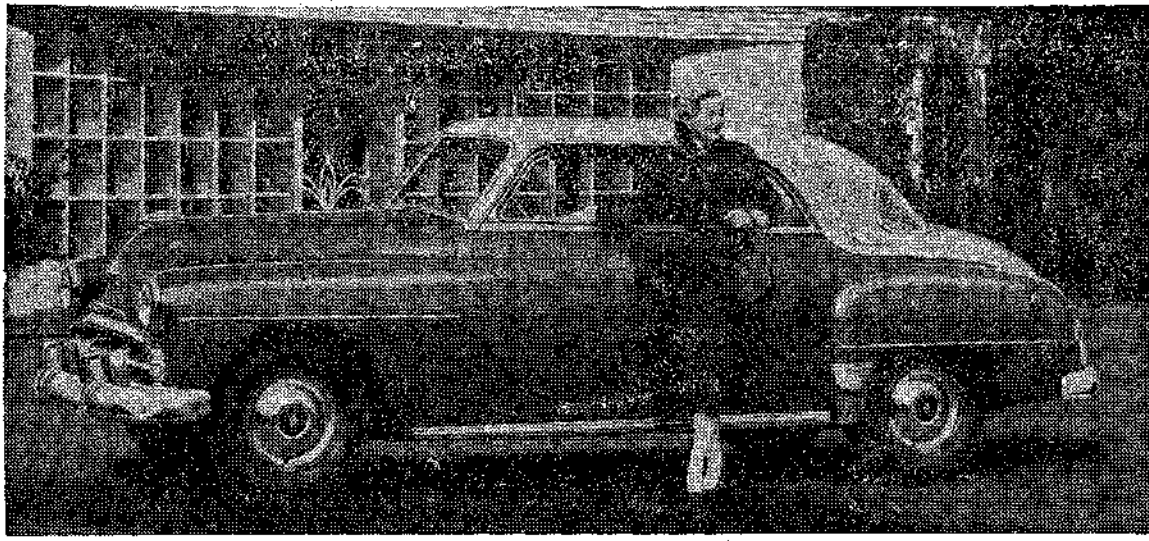

Slate Dealer Meeting For Insect Control

Insecticides and chemicals that will be in demand for farm weed control are the subjects scheduled for discussion at a meeting of Tuscola County elevator operators and implement and drug dealers on January 7, said county agricultural agent, Alfred P. Ballweg, early this week.

The county agent announced that MSC extension entomologist, Ray L. Jones, and Professor E. R. Churchill, of the College's farm crops department, are expected to discuss the kinds of materials most likely to be called for by farmers during the coming crop year.

"New formulas and new methods of application are constantly being developed, and it is important that retailers who supply weed and insect control materials keep up to date so they can stock the merchandise that gives the most effective results," Ballweg said.

He stated further that all merchants who stock and sell either insecticides or weed control chemicals are invited to attend and hear Jones and Churchill. The specialists will discuss the various control materials, using illustrations, and will save some time to answer questions.

The meeting will be held in the supervisors' room in the courthouse at Caro, at 8 p. m., Monday, January 7.

Tests Show Sawdust Good Cattle Bedding

Dairymen who have access to a supply of shavings or sawdust will find that they make an excellent bedding material for the herd, according to word from Michigan State College's Upper Peninsula Experiment Station at Chatham.

In Northern Michigan supplies of shavings are naturally easy to get. However, dairymen in many other sections of the state may be able to locate a good supply at a nearby sawmill.

Shavings used as bedding or sawdust under straw make a warm, absorbent bed for the dairy herd.

The U. P. agricultural specialists say that some farmers think that sawdust or shavings will have a harmful effect on the soil when the manure is later applied to fields. This, they point out, is not true.

Arthur Wolcott, soils and crops researcher at the U. P. Station, says that under controlled conditions, mixing sawdust with soil, only one or two per cent of nitrogen need be added to counteract the effect of sawdust.

If the dairyman used two tons of sawdust per cow during the winter and the cow produced five tons of manure (which contains 10 pounds of nitrogen per ton), this would provide one and one-quarter per cent nitrogen. This would be adequate under controlled conditions to counteract any possible ill effects to the soil caused by the sawdust.

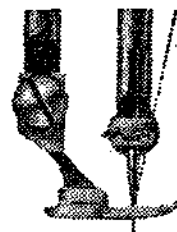
