Vic Guernsey, Little League president, announced that plans to expand the Minor League part of the program prompted the

School TV Postponed

A proposed educational television series for Cass City elementary students, received a minor setback Monday night when school board members learned that it would not be advisable to

start the program this year. At the October board meeting, the administration was given the go-ahead to investigate the possibilities of educational TV at

Cass City. The approval came after a report by a Central Michigan University official on the series during which he offered the program at an "experimental rate" of \$500 for the remainder of the school year.

At Monday's session, Superintendent Willis Campbell read a report from Mrs. Marie Murray, elementary principal, which stated that following a survey of elementary teachers, it was felt the program should be put off until next year.

Chief reason for the delay, according to Mrs. Murray, is the SRA reading series, currently under way in some of the elementary grades. The series, designed to increase reading ability and comprehension, requires extra study and work by the teachers. Arthur Holmberg, principal, backed Mrs. Murray's report. "I'm inclined to agree," he stated.

"The ideal way would be for teachers to take part in the summer TV workshops. We're just not ready." The delay will cost the school



Next to brakes, the most important safety components of the modern car are undoubtedly the shock absorbers that keep the wheels gripping the pavement and prevent side sway. Yet shock absorbers are often the most neglected of all moving parts requiring intermittent service.

Perhaps because they are out of sight and the driver gets gradually used to the steady decline in their shock absorbing power, shock absorbers are often in astopishing poor condition on cars otherwise well maintained.



country roads, shocks are worn out at 10,000 miles. At 20,000 it is a pretty safe bet that they should be rebuilt or replaced if they are going to give you the comfort and protection they were intended to render.

## **Michigan Mirror Unique Program Enables 23 Pupils to Attend University**

By Elmer E. White Michigan Press Association

## "Money-Falks"

An admirable effort to provide quality education to persons who most likely could not get it on their own is under way at Michigan State University.

With little fanfare. University officials found 23 young men this fall who had the scholarship ability but no monetary means to attend college. All 23, from five Michigan

high schools, are now studying and working at the East Lansing institution. \*\*\*

The rather unique program which got these 23 into MSU is known as "Operation Ethyl." University officials said this name was selected to denote "an educational additive."

State Health Commissioner Albert E. Heustis warns. Several recent incidents, one of which resulted in a death, pointed

up the danger in a child using an automobile for a plaything. "Children should never be left alone in an automobile under any conditions," Heustis said. "A car with automatic windows particularly is a booby-trap."

The power of automatic windows exerts up to 50 pounds pressure. This is enough to strangle a child easily, Heustis said.

"In the standard models, the windows work only when the ignition key is on, so removing the keys eliminates the danger," he said. "In most station wagons with automatic tailgate windows, however, the ignition key is not required. The windows can become a blunt guillotine for a

Heustis views the solution to this rapidly increasing problem as a matter of engineering.
