

Job Applicant Urges Support in Intermediate District

A slightly-built but outspoken applicant for the post of special education director for Tuscola county surprised Intermediate School District board members at a meeting Wednesday night, Aug. 12, by chiding both the board and diagnosticians for the manner in which a recent interdepartmental flare-up was handled.

Remarks by Richard Maxey, 34, Washtenaw County special education official, Ann Arbor, vindicated the position of Intermediate School District Supt. William A. Scott in the recent controversy which resulted in the resignation of three county special education diagnosticians.

One letter of resignation, that of William Stewart, lashed out at the supervision of the Intermediate School District in relation to its handling of the special program in the county.

Ralph Brown, diagnostician, and Dick Reva, pioneer speech therapist in the county, also resigned.

Stewart charged that "severe administrative problems" were responsible for "erratic quality of services, a poor public image, misunderstanding and dissatisfaction in the local schools and lack of staff confidence in the ability and integrity of the administration."

He also cited a lack of response to suggestions by the diagnosticians to the board.

Maxey's comments to the board came after his interview for the special education directorship. He first condemned the diagnosticians for taking their problem to the public via releases to the press and radio.

"The school district has to operate in a chain of com-

mand," he charged, "and problems should be taken to immediate superiors and then passed on."

He also commented on the irresponsibility of the diagnosticians in handling their work. "A diagnostician who works with children who are misunderstood by nearly everyone has to be a very special person . . . one who needs no direction and acts accordingly."

"If recommendations are not taken care of at once, they (diagnosticians) shouldn't be surprised. Special education is a very stubborn field and change takes time."

Maxey's next blast was aimed at the board. He asserted that if he were Scott, "I would have expected the board to back my decisions. The board should have stood up for his decisions."

A letter from the diagnosticians listing the 12 points against the administration was read and filed.

Maxey, during his interview for the directorship, told the board that he would not be available for the post until the 1965-66 school year because he was under contract to Washtenaw county.

A member of the board defended the actions of the diagnosticians in an interview Wednesday morning by stating that the three men had not gone over Scott's head until after they had resigned.

He also contended that Maxey was not completely informed on the issue.

"The trouble is there," he remarked, "and we won't get rid of it by ignoring it."

Village Driver Hits, Kills Caro Bicyclist

For the second time within less than a week, a county child died in a bicycle-car accident when a car driven by Thomas Kostanko, 19, Cass City, struck and killed 10-year-old Kenneth Kitchen Sunday near Caro. He was the son of Mr. and Mrs. Hugh Kitchen, East Caro Road.

Sheriff Hugh Marr reported that he was to talk with Prosecutor James Epskamp sometime

Thursday (today) to determine if any charges would be brought in the accident.

The boy rode his bike into the path of Kostanko's car after coming out of the Lucien Tiedgen driveway at 2205 West Dixon Road at about 5:10 p.m. Sunday.

He was dead on arrival at Caro Community Hospital of a broken neck, according to Coroner J. Benson Collon.

Kostanko told sheriff's deputies that he was going west on Dixon Road at about 65 miles an hour and saw the boy on the bicycle coming out of the driveway.

\$750,000 Sought In Frutchey Fall

A \$750,000 damage suit against Frutchey Bean Co. was filed Monday in Saginaw Circuit Court by a Saginaw man injured in a fall down the elevator shaft of the Cass City Frutchey Bean Company elevator on July 20.

The suit was filed by Chester Jamrog, 36. Jamrog was working for MacArthur Roofing and Sheet Metal Co. which was doing some roofing work on the new elevator.

He was approximately halfway up the elevator with two five-gallon cans of tar in the one-man, platform elevator when the cable snapped and the lift fell approximately 70 feet to the bottom of the shaft.

Jamrog asks the damages for his injuries, medical and hospital expenses and loss of wages. He was hospitalized with compound fractures of both ankles, broken ribs, back and internal injuries and shock.

Cass City Public Schools will open Wednesday, Sept. 9, for a half day session, school authorities announced this week.

All students except kindergartners will report on the opening day. The kindergarten class will not start until Friday, Sept. 11.

Missing Line Spoils 18,000 Primary Ballots

An unprinted line on the non-partisan judicial ballot for the primary election will turn out to be an expensive omission for county taxpayers.

Henderson Graham, candidate for re-election as judge of probate, ordered that the term "Judge of Probate" be placed under his name on the ballots Friday after he discovered that the imprint was missing from the 18,000 non-partisan ballots.

Graham's decision, rightfully his, according to election laws, will necessitate reprinting of the entire 18,000 ballots. Because there are three candidates for the office, the ballots are printed in three runs and shuffled so the names will be rotated.

Due to the rotation of names, it is impossible to add the missing line.

Council Okays Program

The Cass City Village Council has voted to accept the planning commission's recommendation concerning the improvement of West and Leach streets in Cass City. The action was taken Wednesday morning.

The recommendations, described in last week's Chronicle, end several months of strife over how the improvements were to progress.

Painting of the Evangelical United Brethren Church in Cass City, part of a continuing church plant improvement project was completed early last week, according to Rev. R. E. Betts, pastor.

Work on the \$1,700 project was done by Rev. Richard Spencer, Nazarene minister, on contract. The job included calking and painting. Color schemes were white with a Cape Cod red foundation trim.

Betts reported that several hundred dollars of interior work was done during the winter by parishioners. Over \$2,000 was spent last summer on work on the parsonage.

Immediate improvement plans call for reroofing of the parsonage some time this summer. On long range planning, a study committee has been appointed to look into the needs for expansion of the educational wing in the future.

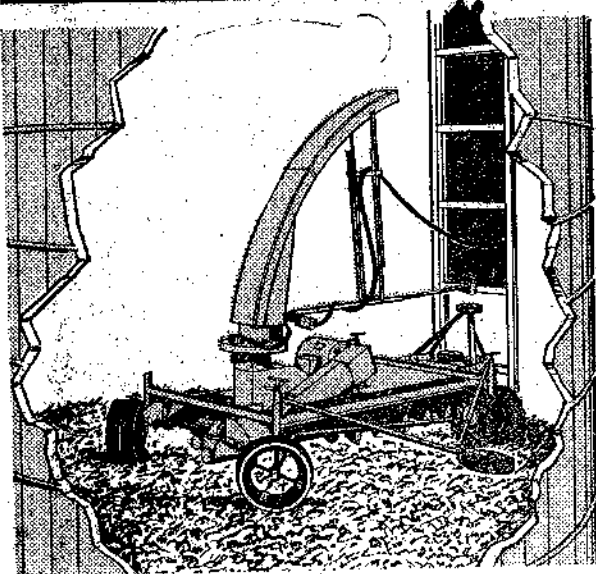

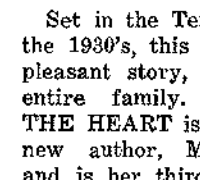

BOOK REVIEW

Here's A Good Story Without A Moral

By the Rev. Robert J. Searls



Set in the Texas panhandle in the 1930's, this book is a warm, pleasant story, suitable for the entire family. SEASONS OF THE HEART is by a sensitive new author, Margaret Abrams, and is her third book.

Her written words are calm and soft, at least that is a first impression, but after you've skimmed along through the opening chapters, you discover that you have involved yourself in the plot, thoroughly. This is ostensibly the story of Mrs. Malone and her family, made up of Bertie (her son) and Mary Beth (her granddaughter). Key supporting roles are 'Dad', an old Negro who has attached himself to the family according to the stereotype of the old southern retainer, and Mrs. Cox, described on the book's jacket as "A ruined Valkyrie of a woman with delusions of past grandeur."

Bertie has held down a good executive position before the depression dealt him (and, of course, countless others) a body blow. Now he is resigned to the attitude that says he has no future in the business world. He is waiting for a key promotion, in the meantime living with his mother, a little afraid of life after seeing his own family break up and end in divorce. Mary Beth is the daughter of Mrs. Malone's daughter, Gladys, who moved away following her divorce, promising to return for Mary Beth as soon as she could afford to take on the responsibility.

Gladys gets married to Tony, a brash and ill-mannered man. Stopping by on their way to their honeymoon and returning on the way back, they offer to take Mary Beth home with them. She gives it thought for a few days, then makes up her mind to live, at least to the end of the school year, with her grandmother.

Old Dad had lived in shacktown (no city was without one during the depression) but with the approach of winter gained Mrs. Malone's permission to make his home in her chicken coop -- his shack having burned down. The wily former slave begs and borrows the furnishings needed for his house, except for a toilet, which Mrs. Malone leaves to Bertie to secure. He gets a garish lavender one and it immediately becomes Dad's status symbol. In his nineties, old Dad marries a young teenager to give her a home.

Mrs. Cox, a woman without a place to go, is given the general housework and cooking to do. She makes many claims to grandeur; wearing her worn fur neck-piece to remind everyone that she knew better days. Immediately she becomes the devoted enemy to the old Negro. She lives in shacktown, where under her bed are dozens of pairs of shoes, all stolen.

Mrs. Malone supports the household by canning and selling to grocery stores, orange marmalade, adding other jobs as she is able.

Bertie and Dad are arrested for theft, though the crime is actually performed by Mrs. Cox. When they are set free Mrs. Malone having turned in Mrs.

Cox), Bertie packs a suitcase and takes the train for other climes, in the hope of getting a job. (A new man had been brought in by his boss, to take the promotion Bertie had counted on for so long.)

And, that's it! There is no wrapping up loose ends, or some great moral that is supposed to have been proved by the novel. You are left with the feeling that the author is planning to continue the story tomorrow, right where she concluded this one. She could do worse.

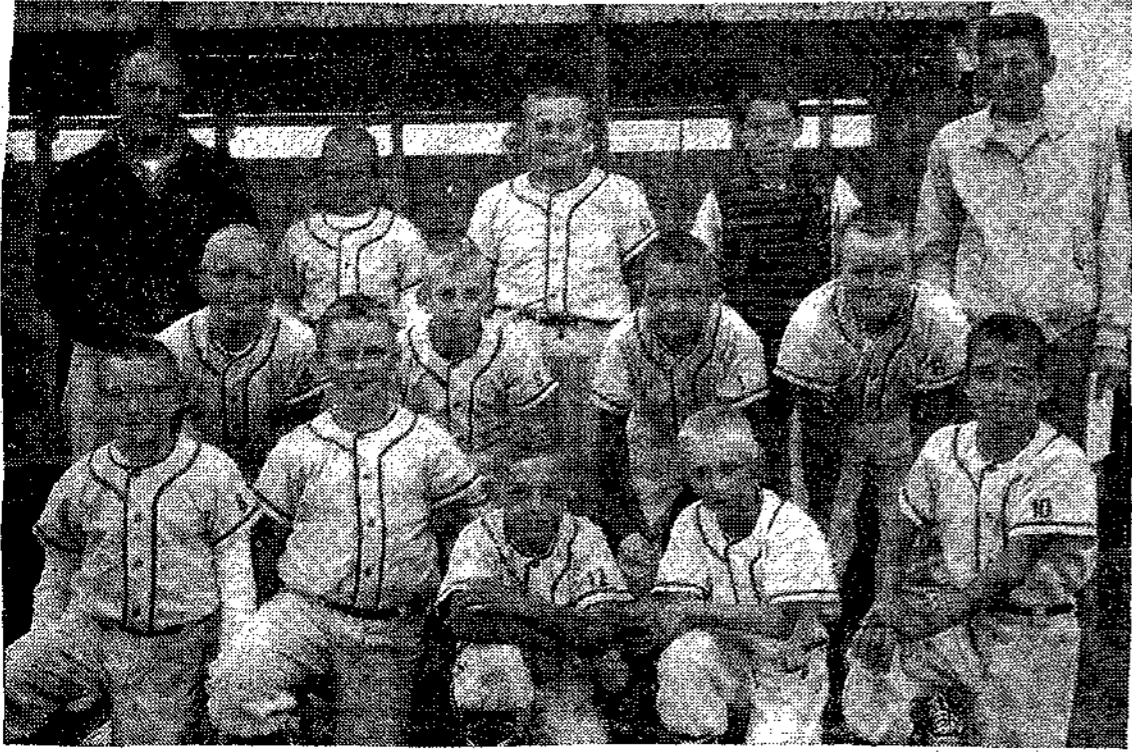

School Starts Anti-Poverty Campaign with Special Course

A "new and different" educational project is under way within the shadow of Michigan's State Capitol.

Students attending classes in old St. Mary's School are all majoring in the same subject - jobs. "The world doesn't owe us a living - all we ask is that it give us a chance to earn one ourselves."

With this creed, 150 students, most of them previously unemployable are undergoing a one-year training program at the Michigan Catholic Conference Job Training Center. Religious background is not considered when enrolling students, and many faiths are represented.

The unique anti-poverty program, designed to make them employable, is being paid for by three federal agencies and is sponsored by the Michigan Catholic Conference which represents the Catholic Bishops of Michigan. However, few of the students and staff are Catholics. Students attend classes daily from 8 a.m. to 3 p.m. in old St. Mary's School. The program calls for 30 weeks of basic education and 20 weeks of vocational instruction. Students receive training allowances ranging from \$20 to \$48 weekly depending on their family status.

Average age of all students is 34. Married students have an "average" of four children; one has 12. Their formal education level is grade six. One in four students had less than three years of formal education.

The average earning of each trainee last year was below \$700. Francis J. Coomes, Executive Director of the Michigan Catho-

lic Conference, said the program has received "outstanding support" from all major faiths in the Lansing area and other community organizations like the Lansing Community Services Council.

"Central Methodist, for instance, is operating a Nursery School for prekindergarten children of the trainees," Coomes said. "And transportation for the preschoolers is being supplied by the Lansing Chapter of the American Red Cross."

Coomes said most of the students are making "good progress." "We're pleased with results of the program so far but the real test will be whether they can get jobs afterward," he said.

"If they can get jobs that will pay twice as much as they were receiving on welfare, then the training will pay for itself," Coomes said.

If Experience Counts

Farm displays and other agricultural matters at Michigan's State Fair are in the hands of six experienced farmers. The Fair opens Aug. 28 and closes the evening of Labor Day, Sept. 7.

The six farmers who are in charge of exhibits include two who come from Centennial Farms, which means they have been operated by members of the same family for more than 100 years. One of these is Stanley M. Powell of Ionia. Powell is very active in the Farm Bureau and raises both prize milking short-horn cattle and prize sheep.

The other Centennial Farmer is Delmont Chapman, South Rockwood. He has served on the State Fair Authority several times and in the State Legislature. He is the third generation to operate the farm and now raises prize sheep. His youngsters are also

active in sheep raising.

Former Director of Agriculture Charles Figy, a Morenci farmer, is chairman of the State Fair Authority. Youngest member of the group is Robert Zeebe, 32. Chosen Outstanding Young Farmer of the Year in 1963 by the Junior Chamber of Commerce, Zeebe operates a 480 dairy farm with his father near Bath.

Robert J. Noon, Jackson, has been on the Fair Authority for more than a dozen years. He raises swine, sheep and Shetland ponies.

Lyle Glover operates a 247-acre dairy farm near Fowlerville where he was born in 1907.

This is the Annual Financial Report as filed by our auditors showing the condition of our schools at the end of the school year, June 30, 1964. We ended the year in the red and will probably continue to do so in future years, unless more monies are provided for operation.

Our bonded debt picture is good with reserves well in advance of required amounts. At the present time we are levying 2 3/4 mills for debt.

Our buildings and grounds are in excellent shape. Because of crowded conditions, we should be making plans to bond for a new high school to accommodate the tenth, eleventh and twelfth grades. This would leave our present high school building to house sixth, seventh, eighth and ninth grades.

One rural school, Greenleaf No. 5 (Wickware) has been annexed to the Cass City School District this year. Greenleaf No. 2, (Greenleaf School) will vote on whether to annex. This leaves the Stone School, Greenleaf No. 3, and they will be compelled to annex to some district next year because they have been closed three years.

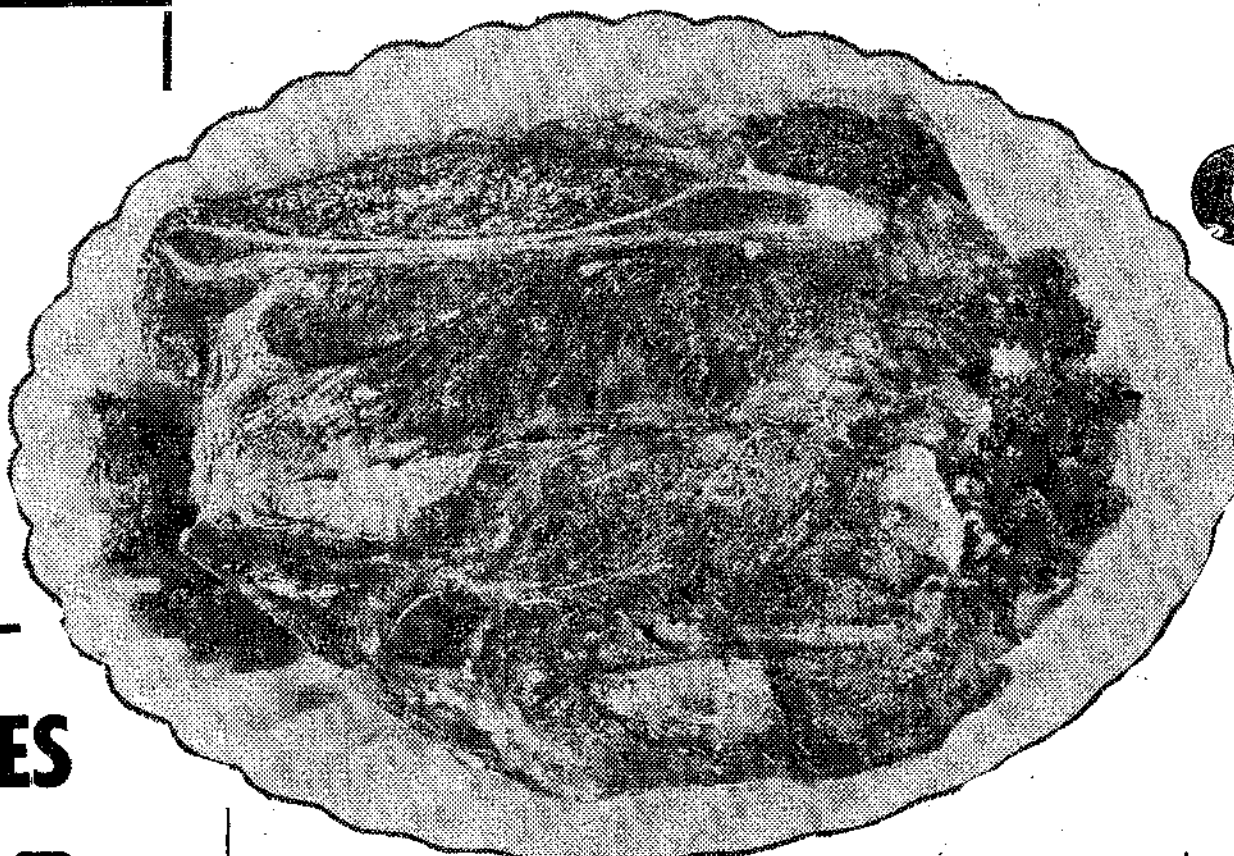

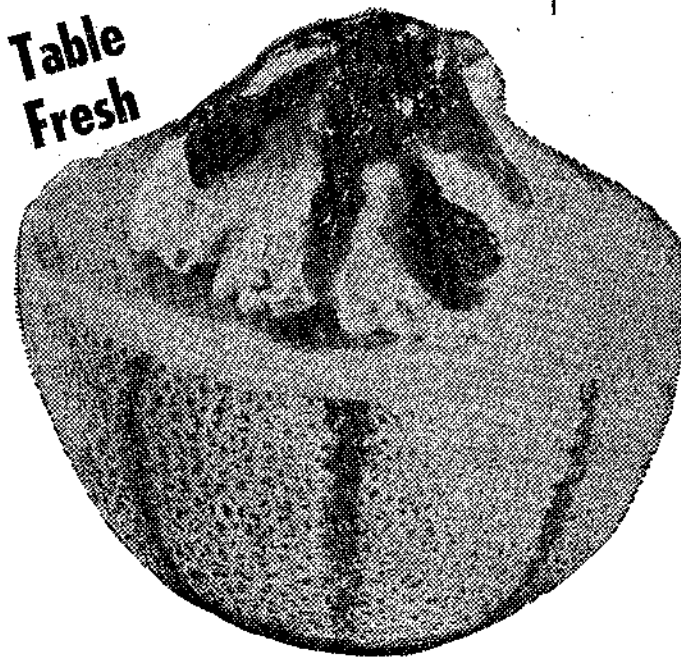
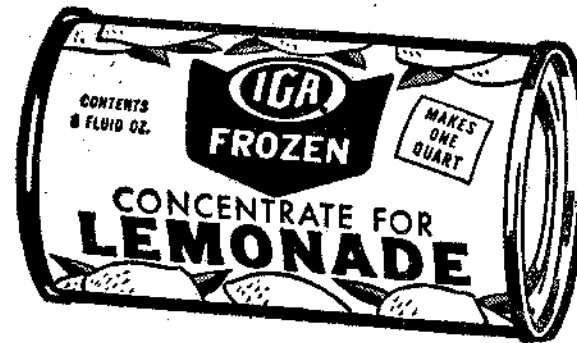
