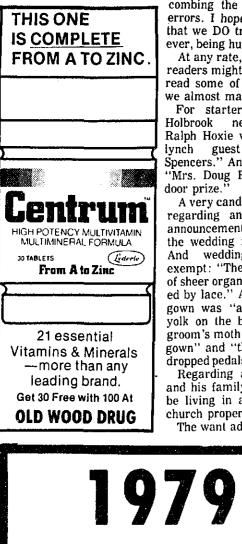
### **Deadline** extended
