Officials doubt lower drunken driving limits will deter drivers

Area law enforcement officials say they doubt proposed legislation that would lower Michigan's legal intoxication limit for drunken driving will serve as a further deterrent for motorists who are likely to drink and then get behind the wheel of-

Bills in both the state House and Senate would lower the blood alcohol limit for OUIL (operating while under the influence of liquor) offenses from .10 to .08. The senate bill would also lower the limit for impaired driving from .08 to .05.

The legislation was prompted by the threat of losing some \$12 million annually in federal highway funds. States that don't implement the lower drunken driving standard by

July 15 stand to lose 5 percent of federal highway funds each year.

Tuscola County Prosecutor Mark Reene said it's unlikely a lower limit would result in fewer drunken driving cases. "I just don't see that," he added.-

"I think it's an excellent idea that .08 be against the law," Reene said. "The whole issue is a little strange, and for this reason: it's already illegal in Michigan to drive with a .08 alcohol content.

"The feds somehow are hung up on the title of the offense. They're not addressing any conduct that was legal before and now it's illegal. It's a distinction without a difference, and it's a little confusing."

Reene said there's little difference in the penalties for OUIL and impaired driving both are misdemeanors punishable by up to 93 days in jail. The primary difference, he said, is the drivers convicted of OUIL face a 30-day "hard" license suspension, meaning they are not eligible for a restricted license. In contrast motorists convicted of impaired driving are immediately eligible for

a restricted license.

Reene pointed out that changes in the law have already stiffened penalties. For example, it used to be that drivers with multiple impaired driving convictions would not be charged with a felony. Today, a driver with 3 such convictions faces a felony charge punishable by up to 5 years in prison.

Still, some people are going to drink and drive regardless of the penalties, said Tuscola County Sheriff Tom Kern, who doesn't believe a lower intoxication limit would significantly affect drunken driving numbers in the county.

"To drop it from .10 to .8 is not going to make an impact anywhere. I don't think that's a big problem because most of our drunks are .15 or. higher," he added. "I don't think that (the number of arrests) would change much.

"What I don't like is the arm twisting by the feds. They do the same thing at the state level when it comes to the Office of Highway Safety Planning."

"I don't see that there's a need to reduce it," Cass City Police Chief Gene Wilson

"Is it going to prohibit (drivers)? No. People are going to drink. People may drink a bit less, but basically, it's not going to make any difference," he added.

"Will there be a deterrent effect? I doubt it," agreed Tuscola County District Court Judge Kim Glaspie.

"I don't think it's going to change the number of. drunken driving cases we have," Glaspie said, adding many of the defendants he sees have been arrested with blood alcohol levels range from .15 to .19 - far exceeding the legal limit of .10.

Glaspie already has his hands full, coming off a year that saw an unusually high Bid lower than expected

Council awards contract for '03 paving projects

A number of Michigan municipalities, including the village of Cass City, are enjoying a buyer's market when it comes to road construction projects this year.

That's according to Cass City Village Manager Frank Sheridan, who told Village Council members Monday that a number of municipalities are seeing projects bid at 20 to 30 percent below projections.

Sheridan said 5 contractors submitted bids for the Cass City 2003 pavement improvement program. The bids ranged from \$64,852 to

The council accepted the low bid, which was submitted by Saginaw Asphalt Pav-ing Co. of Carrollton Town-

Cass City officials budgeted \$93,620 for street work, according to Sheridan, who suggested the village should be able to get more bang for its buck this summer. "The lower than expected costs for this work allows the village to 'pull forward' anticipated street improvements," he

Paving projects scheduled this year are: Pine Street, Seeger to Oak (\$6,010); Oak Street, Pine to Third (\$7,342); Huron Street, Seeger to Ale (\$16,763); Virginia Street (\$9,516); Hospital Drive, Beechwood to Tendercare (\$19,050); and Spruce Street, Beechwood to terminus (\$6,169).

In addition, the council authorized Sheridan to negotiate for an additional \$17,000 in road improvements due to the low bid submitted by Saginaw Asphalt. Tentative plans call for \$7,000 worth of alley paving and \$10,000 for additional street improvements.

Turning to other matters. the council reviewed the 2002 audit with Joel Chamberlain of Yeo and Yeo, who gave village finances a clean bill of health.

Chamberlain noted village officials enjoyed a year with

revenues coming in just monthly meeting, the coun-\$6,300 under budget, and expenditures coming in under budget in every department. The project year-end general fund fund balance was set at \$370,000, but the actual year-end total was \$420,000, she said.

Chamberlain told the council her only concern is a lack of cross training within village departments. That is, she explained, the village would run into difficulties if the clerk or a department head were to retire, because those individuals are the only ones familiar with their specific duties.

Chamberlain acknowledged the size of the village staff and time constraints make cross-training a challenge, but she urged the council to look into ways to better prepare for future turnover at key positions. In other business during the

Ellington approves budgets

The Ellington Township Board approved a new budget, road improvements and a handful of capital improvement expenditures during the township's annual meeting

Bardwell reported the board budget include \$26,000 for approved a new spending the purchase of 5 acres surplan totaling \$255,307, including a fund balance of \$103,536. "At the end of the year it should be about \$84,261," he said.

The clerk noted he's anticipating state revenue sharing will be reduced by about \$5,000 this year.

The budget is considerably smaller than last year's spending plan of about \$451,000, but Bardwell explained the difference was about 2 year's worth of backlogged road construction due to county and state delays.

The township will also pay its treasurer \$1,200 more in the coming year due to an increased workload related

to extended summer tax collections. "Instead of collecting from December through March, she's now going to be collecting July through March," Bardwell explained.

Capital improvement ex-Township Clerk Fred penditures built into the new rounding the township hall. "We're sitting on less than one acre now," he noted, adding \$5,000 has been set aside for future expansion of the parking lot.

The board also approved the purchase of software to keep track of cemetery plot records, and an expenditure of \$7,000 to fence the town-

ship cemetery. Overall, Bardwell said, "basically the budget is pretty much the same thing as last year until you get to roads.'

The township spent more than \$280,000 on delayed road work last year. Typically, he noted, the township's annual road budget ranges from \$105,000 to \$120,000 thanks to a 10year, 3-mill road millage that brings in more than \$56,000

This year's road budget totals \$104,000, including \$45,000 from the township's general fund budget.

Planned projects include touch-up work on 2 miles of Hurds Corner Road, from Shabbona to Dutcher. The project will cost up to \$38,000 and will include seeding and gravel. The township also plans to prepare the next mile of Hurds Corner Road, from Deckerville to Gilford, for





Cox alleges that, beginning April 30, 2001, Stickney began to engage in a pattern of criminal sexual assault against patients while they were under anesthesia. The incidents allegedly took place April 30 in Oakland County, May 15 in Tuscola County and Dec. 5 in Genesee County.

Court records indicate the charge in Tuscola County stems from an incident in which Stickney allegedly used force or coercion and had reason to believe the victim was physically helpless or mentally incapable of re-

Cox said the state Department of Consumer and Industry Services summarily suspended Stickney's nursing license Nov. 7 based on an administrative complaint issued by the Health Professionals Division on that same date. His license remains suspended.

If convicted on the criminal sexual conduct charge, he faces up to 15 years in prison.

Police identify homicide victim

Law enforcement authorities have released the name of a Saginaw teen whose body was discovered by 2 fishermen early last week in Tuscola County's Tuscola Township.

Police said the body was that of Kevin Jerome Amos, 19, who had been missing since just after Christmas. His body was found on the banks of the Cass River in an area near the intersection

The death is being treated as a homicide, although preliminary reports state investigators found no stab or gunshot wounds on the body. Final autopsy reports are expected sometime in the next week.

Troopers from the Michigan State Police post in Caro said early indications are that Amos died somewhere else and his body was dumped at the Tuscola Township location. Investigators identified the victim through fingerprints.

The case is being investigated by state police detectives from the Caro and Sandusky posts as well as Saginaw headquarters and the Bridgeport Crime lab.

Tuscola F.B. members lobby in Washington

As war with Iraq was just beginning, Michigan Farm Bureau (MFB) members carried out their own mission of educating Michigan's elected leaders in Washington, D.C., about the benefits of increased renewable fuel use, tax reform, and improved crop insurance and risk management programs.

Tuscola County Farm Bureau was among the 47 county Farm Bureaus that sent members to Washington, D.C., March 19-21, for the annual Michigan Farm Bureau (MFB) Washington Legislative Seminar. John Somerville of Unionville and Jeremy Somerville of Cass City represented the county Farm Bureau.

"The fact that you took time to come here for 3 days in this particular war environment is admirable," MFB President Wayne H. Wood told the nearly 120 county Farm Bureau participants at the seminar's conclusion. "It's so much more impressionable to have the entire group here, and your presence will be remembered as Farm Bureau continues to lobby on crucial agricultural issues during future fly-ins to Washington, D.C."

Wood added that "in this very difficult time, we have to feel good about what happened here and take comfort in knowing that our elected officials took time from all their other pressing duties to come here and talk to us."

Upon arriving in the capital, members were briefed on key legislative issues by American Farm Bureau Federation (AFBF) staff and given tips on how to communicate effectively with the 108th Congress.

Issues focused on the need for America to implement a Renewable Fuels Standard that would boost the use of renewable fuels such as ethanol and biodiesel and help decrease the country's dependence on foreign oil. Other priority issues were tax reform, including total elimination of the estate tax, and

improved risk management tools, such as making crop insurance products available to producers of all commodities.

Most of Thursday was committed to lobbying on these issues. First, members ate breakfast with their representative at a group MFB breakfast. Discussions on the issues continued that afternoon when members met with their elected official and/or congressional aide on Capitol Hill.

That afternoon the entire delegation re-grouped to hear Virginia Rep. Bob Goodlatte, new chairman of the House Agriculture Committee, outline the Committee's priorities and goals. Later in the day, the group traveled to the Chinese Embassy were they heard Chinese officials discuss trends and opportunities for trade with China and were treated to a reception of authentic Chinese food.

Before heading home Friday, members heard Michigan Sens. Carl Levin and Debbie Stabenow discuss, among other things, how the war with Iraq may affect the U.S. budget and possible implications for the agriculture industry.

Also during the seminar, participants presented "Friend of Farm Bureau" awards to Michigan congressmen recognized by AFBF as being supportive of Farm Bureau priority issues. Plaques were presented to Reps. Peter Hoekstra, Vern Ehlers, David Camp, Fred Upton, Nick Smith, Mike Rogers, and Joe Knollenberg.
