Butter is in fairly good supply and holds a steady position. Eggs are firming up somewhat. Receipts are not so large, and frequently require careful handling, and outside markets are also a shade firmer. Poultry supplies are relatively good, and the market is just about steady. The vegetable list is active, and prices lower in parts of the list. Strawberries are plentiful, but the demand is good and prices are steady. Pineapples are beginning to run low, but the Florida crop will be in the market shortly.

 At a session of the Probate Court for said County of Tuscola held at the Probate Office in the Village of Caro, on Tuesday the 21st day of May, A. D. 1901. Present, Hon. John M. D. 1901, at 10 o'clock in the forenoon of that day, as the time, and the place of the hearing upon such application, and where a hearing upon such application would be had, and did there and there order that all persons whose lands were to be traversed by the proposed Drain, and who had not released right of way in all damages on account thereof, to appear at the time and place designated and to be heard with respect to such application, if they so desire, and to show cause, if any there be, why said application should not be granted.
