PLENTY OF WILD GAME IN IDAHO

So Writes T. H. Ahr in Letter to the Chronicle.

He Was Fortunate in Locating a Good Claim and Likes the Country.

T. H. Ahr, formerly a resident of Cass City, has written quite a lengthy letter to the Chronicle regarding his new home and surroundings at Ferrell, Idaho. The following extracts from the epistle will prove interesting reading for Mr. Ahr's friends here:

I suppose you think that I have en-I suppose you think that I have entirely forgotten you. But if you do, it's a mistake. I have been trying to get at it for the last three months, but kept putting it off. Weil, if you will pardon me, I will try to write you a long one to make up.

The claim we are on was taken up about 12 or 13 years by a man by the

about 12 or 13 years by a man by the name of Richie. He lived on it a little over six years and he and another man started to Couer D'Alene to prove up (or make final proof), but they both got drunk on the way, upset their row boat and both drowned. While he was on the land he lumbered continually and had all the trees cut off the low or flat land and part of the hills. The cedar stumps average about four or five feet across the top and they are cut about ten feet from the ground.


The claim then laid here until last

The claim then laid here until last year when a man by the name of Thos. Hay, located it. He had no homestead right, but he contested it. As Mr. Hay contested it, he had a thirty day preferenca right to dispose of his relinquishment which I bought for \$300. When he relinquished his claim to the government, it was then open for another person to file, which I did. When one buys a relinquishment, they are obliged to live on the land the full five years the same as any other homesteader.

Well, we have about 55 or 60 acres of valley (gulch) land. The balance is hills. There is about \$2,000 worth

is hills. There is about \$2,000 worth of green timber on it yet; also a lot of dead timber, mostly cedar. We got settled most too late to get in much garden this year. We have some potatoes on the hillside which are doing picely in gate of heing planted. potatoes on the hillside which are doing nicely in spite of being planted about two or three weeks late. We also spaded a patch for cabbage, peas, lettuce and beans. I have about 25 fruit trees out on the hillside. They are all doing nicely. We planted 125 strawberry plants on the hillside, but it was too dry for them and they it was too dry for them and they nearly all died. This fall I will reset what is left of them on the bottom land and I know they will do well as this is a strawberry country. I also expect to set out some raspberries and

Rivers and Freight Rates.

The October voyage of President Roosevelt down the Mississippi river from Keokuk to Memphis as the honored guest of the inland waterways commission promises to contribute considerably toward arousing general interest in the proposed deepening of the river channels with an ultimate view to the opening of a ship route from Chicago to the gulf.

Years ago Mr. Roosevelt wrote the history of "The Winning of the West." The west of which he wrote lies east of the Mississippi. The middle west, through which that splendid stream flows as the main artery of water commerce, is now far east from the greater west which touches the Pacific. Within a hundred years the United States has added several wests to its domain. The winning of these wests. one after the other, should make splendid serial chapters in the epic of American achievement.

The middle west, through which Mr. Roosevelt's route lies, is the great agricultural domain of the country. The Mississippi valley extends from Pennsylvania to Colorado. It is the richest farming region in the world. The system of rivers which waters this magnificent area, flowing into the parent stream and thence to the gulf, is to be studied by the inland waterways commission with reference to its possibilities for transportation purposes. Of late years the whistle of the steamboat has been heard less and less on these rivers, the railroads having monopolized the traffic. There is a growing belief that with improvement in the waterways so that navigation may be resumed the excessive railroad freight rates obtaining in many sections will be reduced to meet the competition of the steamboats.

We have many fine rivers lying idle, hung up on the fence to dry out, so to speak. The Missouri river, which for many years was the artery of a great commerce, now is practically abandoned. Even the Mississippi's steamboat trips are as few and far between as angels' visits. A few forlorn vessels Illinois, but for the most part river traffic on the Mississippi's tributaries is a thing of the past.

The revival of this traffic is a matter which has engaged the efforts of a number of earnest persons who held that it is a sheer waste of opportunities and a criminal neglect of resources to permit those streams to flow to the sea unvexed by the paddle wheel of the eraft which Robert Fulton devised just a hundred years ago. The president's voyage with the waterways commission may be counted upon to call wide attention to the potentialities of these rivers as regulators of freight

Gunners' Patron Saint.





LEGISLATURE

Up Next Session.

AND PLENTY

New Constitution Calls For Altering of Many Laws-Attorney General to Offer-Quite Colony of State Officials Will Be Permanent Residents of Lansing.

Lansing, Mich., Nov. 10.—The legislature which meets the first of next year will have more important legislation to consider than in any session in recent years.

Through the necessity of amending and revising the statutes to conform to the revised constitution the schedule adopted by the convention directed the attorney general to advise the legislature relative to the necessary changes in existing laws to make them comply with the constitution as well as to suggest new laws needed to put and probably 131 of the 132 meminto force the directory sessions of bers of the legislature. The one Dem-the new constitution. The legal decision of having been elected is F Keppler for representative in partment has started work on its task, the Second district of Houghton. and already it has a list of thirty-five measures to call to the attention of the legislature.

In some cases the attorney general will present bills for consideration for the legislature and in other cases will simply call the attention to needed enactments. One important measure Drunken Grand Rapids Man will be that to provide home rule for cities and villages; another is a law to prevent the use of streets by public utility corporations without the consent of the localities interested, and another will restrict franchises to thirty-year terms. One subject which will require careful consideration will be a law providing for a uniform accounting in state, county and municipal offices

Appeal of Criminal Cases. The constitutional provisions relative to the initiative and referendum will require a statute to carry out the plan provided. Provision must be made for the appeal of criminal cases in the supreme court where the respondent is without funds to carry his franchise is granted to woman taxpayers on all propositions to tax property owned by them.

The state officers and legislators secure a raise in salary which must be provided for.

The constitution also provides for the election of members of the board of state agriculture. Reforestration must be provided for by the legislature and also regulations relative to the deposit of state money in state banks. In the future members of the state board of education must be elected in the spring, which will require some change in the election law.

The state railroad commission must be given increased power relative to regulating freight rates in the state. Certain other acts will be required to provide several legislations, and the entire list is not complete.

With the increased pay for members of the state legislature, many now find themselves able to live at Lansing during the session of the legislature this winter, and, according to reports, Lansing will have quite a colony of state officials during the cold months. Governor Warner and Auditor General Elect Fuller, the latter of Iron River, upper peninsula, will move here for the legislature session.

PATIENTS BADLY TREATED.

Health Officers So Report After Visit to Tuberculosis Sanitarium.

Grand Rapids, Mich., Nov. 11.-The Grand Rapids tuberculosis sanitarium, heralded as one of the best, if not the best in the country, has come in for its share of criticism, and this time to be so bad that the attention of the authorities has been attracted and a rigid investigation made.

Health Officers De Lano and Commissioner Welsh make a visit to the sanitarium. Here is what they found, according to their report:

Patients were compelled to sit in rooms as cold as ice while dressing; cracks as large as barrel slats gave the cold wind a chance to make a clean sweep of the building; the food given the sick patients was of inferior getting enough; relatives and friends were permitted to make visits to patients only between the hours of 3 and 5 on three days in the week. The complaints are outrageous, say the authorities

Chief Justice Fuller has announced that beginning on next Monday the supreme court of the United States would be in recess for two weeks. The recess is for the purpose of permitting the members of the court to prepare opinions on cases which have been argued or submitted.

Princeton, Ill., Professor Peter Kramer of St. Louis was dashed against the chimney of the Methodist church and killed while making a balloon ascension at the Farmers' carnival. Glen Hayden, a seven-yearold boy, who was standing near the church, was struck by a brick falling from the chimney, which was wrecked by the balloon and his skull fractured. He may die.

During the winter months-that is to say, between October and May-the postal authorities will not take bulky packets, even if paid for at letter rate, to places in the Yukon district beyond the railway which terminates at White Horse; but postcards, letters and single copies-no one packet to weigh over an ounce-of newspapers are regularly carried over all the frost-bound expanse that extends from the town of Edmonton on the Saskatchewan river to Fort McPherson, on the Mackenzie.

The man in charge of the mail has to travel 1,954 dreary miles in each direction. He is a picked man, named Cornwall, who has had a long experience as a fur trader and intrepid ad-



Definite plans have been drawn up in London for a Norwegian north pole expedition under the leadership of Amundsen, who took the first ship through the northwest passage. Amundsen plans a drift voyage across the North Polar ocean. The central idea is the same as Nansen's, but the lesson of that explorer's voyage led to the conclusion that a vessel entering the ice considerably east of the point where the Fram was not frozen would probably drift further north and be carried over quite close to the pole.

William H. Flictner, a lawyer, with offices in Wall street, in New York, has been sentenced to one year's imprisonment in the penitentiary for grand larceny. Flictner is sixty-six years old and has been prominent as a churchman. Hundreds of letters asking for clemency were submitted in his behalf. Despite these, the

court said: "As a warning to others, I will sentence him to one year. Lawyers who take their clients' money have no right to expect mercy." Flictner was convicted for diverting to risky speculation \$8,000 entrusted to him for safe investment by two women.




