

THE STRANGE STORY SIN.

Text, "Sin is the transgression of the

One thing requires no argument—sin is here. It doesn't take much proof to with snapped masts, torn rigging, gaping holes in the side, is a wreck. The bodies washed ashore bear mute evidence that something has happened. The revelations of the police court, the moan of the prisoner, the quivering form in the electric chair, the poor scarlet girl of the street, the ghastly contents of the morgue, show a wreck somewhere. Let him who will deny The Bible proceeds from Genesis to Revelation with that assumption. If sin isn't a real thing, a veritable cancer eating at the vitals of humanity, then the Bible has no meaning and is a book of fables. The gospel then becomes the queerest hallucination that ever deluded this race of mortals, and the crucifixion was a suicide-nay, a fearful burlesque. Indeed, civilization begins its calculations with sin as a principal integer. They are cutting prison stone now for boys not yet born. Horrible to contemplate, the hemp is growing to make the noose for the little fellow now nursing at his mother's breast. Is sin inherent or part of our growth? Have we fallen from "a little lower than the angels," or have we risen from "a little higher than the brute?" The Bible says the former, science the latter. The good book gives only a few verses to the fall, but whole chapters to the fallen. That seems sensible. The important thing is not, Did a storm strike the vessel? but What

Sin Is Suffering.

Sin is life's deepest malady. Not the "white plague" nor pneumonia nor cancer has the most victims, but sin. The devilish part is that that wasn't the bargain. Beginning bright as the morn, it ends dark as the midnight. Sin promised life pleasure and profit, but we find its wages are death, torment and destruction, with the epitaph "Thou fool." We think of sin as adultery, uncleanness, murder, drunkenness-things that belong down in the slums, and that mustn't be mentioned except with a quick look around and a guarded tone. Christ began his list with evil thoughts and from that worked out toward the surface. But you are alone. That is fearful. Prisoners sentenced to solitary confinement go mad, and Matteawan spells hell. We read of Judas that after supper he went out and it was night. He went out. Out-note! Inside were light and warmth and gladness and fellowship, the best on earth. There's a stroke of genius in the writer's pen, "It was night." No push, no curse, drove him out-just the momentum of sin. His bed that night was in hell. So, too, Peter went out from the court, having lied and sworn that he didn't know his Lord. He went out into the darkness and wept bitterly. When your father's door is shut upon you, when friends cross to the other side of the street, when there's no door open save the trapdoor of perdition, then it's night-the blackest night of your soul's eclipse. Sin is solitude-it shuts out. The saddest words that ever fell from Christ's lips are, "Depart from me." Departure into the blackness of darkness forever. The iron curtain of

IF YOU'RE FURNISHING.

Two Things to Be Shunned Are Confusion of Colors and Monotony.

Two extremes to be avoided by a woman who is furnishing a room, be it a chamber or formal reception, are confusion of colors and monotony. If there were any rule which might be laid down homely houses would cease to exist, but one can only give generalizations. Be it said, however, that a woman will find it more than worth while to huv wall napers, unholstery materials and the like at places where the salesman's taste can be relied show that the poor hulk in the surf upon. It is a pity when spending money not to get the best results from it, and this is possible only when one has professional advice or unusual natural taste.

A color scheme being arranged for the living room of a simple house is chiefly brown. The room is square and has a mantelpiece. The woodwork is plain and painted white.

On the walls is to be put a plain paper, almost cafe au lait in shade. It has a decided crape finish, which prevents the surface being flat and entirely differentiates it from cartridge. A couch and three side chairs are to be done in a silk and linen material. striped in self colors, which vary from brown to cream, the whole having a moire effect

So far the scheme is utterly lacking in design or vividness and if continued would give a most uninteresting room. Relief and color will be introduced by the use of a printed linen, the design of which is bold in execution, and carried out in dull blues, old reds and very little green. The ground of the linen is coffee color and has a tiny self pattern suggestive of old chintz.

Were the whole room done in this the eve would be positively dazzled. but it is to be used on a large chair which is entirely upholstered, on a cushion for a black oak bench and for cushions for two wicker chairs.

So is the brown furniture lightened. and that the walls may not be somber the linen will be employed as window hangings, going straight to the sills. finished at the top with short valances.

This room is an excellent example of combining plain effects with bold patterns. Striking as is the linen, the coffee color ground "binds" it to the prevailing brown, so that all harmonize and do not conflict. This is a point to be remembered in all furnishing-that, while striking combinations are desirable, there must be one color which is dominant and to which all others must conform.



Another artistic pattern which expresses the vogue of art and simplicity is the colonial, which, if less exclusive than the Tudor, is charming nevertheless, considerably cheaper and more readily obtained.

Baking Powder Biscuit. Sift two cupfuls of flour into a basin Add half a teaspoonful of salt and three teaspoonfuls of baking powder; then sift it again; then rub one tablespoonful of butter and one tablespoonful of lard finely into it with the tips of the fingers. Add gradually enough sweet milk to make a soft dough. Knead a little on a floured board. Do not handle much. Roll out half an inch in thickness and cut into rounds with small cutter. Lay on a greased baking tin and bake till ready in a hot oven, usually about twenty min-

Maple Chocolate Nougatines.

Put one pound (two eups) of maple sugar, one cupful of brown or granulated sugar, one cupful of glucose and one cupful of water on the back of the range, cover and let stand, stirring now and then until sugar is dissolved. Then stir occasionally until cooked to the soft ball degree, or about 238 degrees F. Have ready the whites of two eggs, beaten dry. Pour half of the sirup in a fine stream upon the eggs, beating constantly meanwhile. Return the rest of the sirup to the fire and cook to the crack degree, or

between 280 and 290 degrees F. During the last of the cooking the mixture must be stirred constantly. Pour this sirup upon the egg mixture in the same manner as the first. Add two cupfuls of blanched almonds, chopped and browned in the oven, and two teaspoonfuls of vanilla extract. Mix thoroughly and turn into two bread pans, buttered or lined with paper. When cold cut in strips about an inch long and three-eighths of an inch thick and wide. Dip these in "Dot" chocolate and finish as the French creams.

By Mrs. Janet McKenzie Hill, Editor of the Boston Cooking School Magazine

Baking Powder Biscuits made by this recipe are so far ahead of ordinary ba-king powder biscuits that, if once tried, you will never use any other recipe. Try it the next time you run short of bread. Save this recipe.



K C Baking Powder Biscuits

Three cups flour; ¼ to ½ cup short-ening; 3 level teaspoonfuls K C Baking Powder; about 1 cup milk or water; 1 teaspoonful salt.

Sift three times, the flour, salt and baking powder. Work into the flour the shortening, using lard or butter for shortening. Then mix to a very soft dough with the milk. The softer the biscuit enters the oven, the lighter it comes out. Never knead baking powder biscuits; press the dough into shape and roll lightly. Cut in small shapes and bake on a sheet or very shallow pan in a hot oven. In placing biscuits in the pans place well apart, not allowing edges to touch. Small biscuits are better than large ones.
