

FARMERS REWARE

The experiment station of the Agricultural college is out with a warning to farmers regarding beans. The bulletin says in part:

"The wet conditions which prevailed generally over the state during the fall months from late September until after heavy frosts, presented the most unfavorable conditions for harvesting the bean crop which has been experienced in Michigan in many years.

"All farmers are cautioned about planting any beans that are badly discolored, as it will be impossible to get a normal stand and growth even by thick planting. Many tests of beans showing no discoloration have likewise resulted in a very low germination, probably due to the fact that they were frozen while in a wet condition.

"The farmers of the state have not usually made germination tests of their beans under normal conditions, but it is especially important this year. It is important not only on account of getting a good grade of beans which will show a good percentage of germination, but as will bean growers know it is important to have seed that will make a quick, vigorous germination. The beans showing slow germination and retarded growth seldom, if ever, make a

"All bean growers are urged to make simple germination tests of their seed beans, as follows: Plant 100 beans in some sand or loamy warm place outside. After the first beans have been up for two or three days make a count of those that percentage. The germination test may also be made by placing the
